

CELEBRATING FIFTY YEARS

The Sisters of Saints Cyril and Methodius in Danville, PA, claim a unique legacy that has been entrusted to them by their founder Reverend Matthew Jankola (1872-1916), an immigrant priest from Slovakia who established the Religious Congregation of Sisters in 1909 with the purpose of promoting and preserving Slovak faith and culture. He distinguished himself as a promoter of Slovak intellectual and literary interests and inspired his American-Slovak Sisters to esteem and cherish all that relates to scholarship and multiculturalism.

On July 2, 1968 the Congregation of the Sisters of Saints Cyril and Methodius established Jankola Library and Slovak Archives Center to promote the legacy of Father Jankola and to name the Library in his honor. The concept for beginning this Library began when the congregation became the recipient of a collection of Slovak books that were valued as tools for learning and supplementary materials for teachers. As the public gradually came to know that the Sisters were interested in acquiring Slovak related materials, the collection increased in volume and worth.

1968-1992

Sister M. Martina Tybor, SS.C.M. an outstanding scholar, teacher, poet, translator and author was appointed to Jankola Library as its Director-Librarian from 1968 to 1992 with a mission to organize and catalogue all the valuable Slovak and English works that relate to Slovak and Slavic history, language, literature, fine arts, spirituality and learning. There was a need for a place to do this task. In 1971 the closure of the Magnificat Chapel at the Motherhouse gave space for Jankola Library.

Over the years notable scholars from home and abroad contacted Jankola Library which had become an internationally renowned research center. The services and cooperation of Jankola Library had been sought by scholars and students of at least forty-five American Universities and centers of learning as distant as Texas, California, and Hawaii, and as close by as Danville and Bloomsburg. Contacts had also been made by a number of foreign centers in places like Amsterdam, Lisbon, Padua, Rome, Munich, London, Ottawa, Bratislava, Victoria and Toronto. Information sought by researches could only be

found at Jankola Library.

During twenty-four years building and solidifying the legacy of Father Jankola, Sister Martina Tybor had laid a firm foundation for the Congregation's mission to promote and preserve the Slovak faith and culture. By 1991 Sister Martina's health declined and she needed to receive medical care at Maria Hall in Danville until August 12, 1998.

Solemnity of the Ascension

At the end of His earthly life Jesus ascends triumphantly into heaven. The Church acclaims Him in His holy humanity, invited to sit on the Father's right hand and to share His glory. The ecclesiastical provinces of Boston, Hartford, New York, Newark, Philadelphia, and the State of Nebraska have retained the celebration of the Ascension of the Lord on Thursday, May 10th, while all other provinces have transferred this solemnity to May 13th, the Seventh Sunday of Easter.

April 29, 2018 - 5th Sunday of Easter Lectionary 53

An appreciation for humor, irony, and laughter are authentic signs of a Christian, I believe, since we are only able to truly laugh—to laugh with joy, not the nervous bluster of the arrogant or insecure—because in Jesus Christ we see the definitive answer to the otherwise confounding inanity and tragedy that so often mark our

world. The frustrations, sufferings, embarrassments, and missteps that leave many people who have no faith despondent can be seen by Christian believers as part of the irony of human existence.

by Christian believers as part of the irony of human existence. We have the chance to see a bit of "divine humor" in today's readings when Paul, having just made one of the most dramatic religious conversions in history, from Pharisaical Judaism to Chris-

tianity, struggles to find acceptance among his new Christian fellows. "When Saul arrived in Jerusalem he tried to join the disciples, but they were all afraid of him, not believing that he was a disciple" (Acts 9:26). One can hardly blame those who shunned Paul's first inroads into the Church community; after all, till recently, he had been an energetic persecutor of these very same Christians. Still, his situation has something of a tragi-comic cast to it as he tries to meet and affirm new friends in Christ while they desperately flee from him. Some earnest intervention from Barnabas saved the day for Paul, and he eventually became a pillar of the early Christian Church.

The humor we might find in Paul's plight in Jerusalem gives us a chance to reflect on coming into the Church and the way we are welcomed when we try to do so. Catholics are rightly proud of our home parishes and churches, our schools, our Altar Guilds, Men's Clubs, and our CYO leagues, all of which ought to remind us of the catholicity and universality of the Church. Yet we may have experienced less than an opened-armed welcome at one point or another when joining a new parish or a group within our parish. Catholics are famous for this sort of territoriality, which is very often built on lines of ethnic identity and which can be seen in the proliferation of small Catholic churches in an ethnically rich area like our own.

A sure way to celebrate our rightful Catholic identity and to make sure that it does not become parochial or unwelcoming is to see to it that our identity is rooted first in Christ, "the true vine" (John 15:1) and then in the more particular cultural or regional expressions of our Christian identity. This proper ordering of values gives the Church its catholicity—the unity in diversity that has been part and parcel of its existence from the earliest days and which continues to strengthen the Church today.

The "mark" of catholicity (do you remember the four "marks" of the Church?) should be kept in mind both when we graft ourselves onto a new branch of the Church by joining a new parish or Catholic organization, and when we encounter others trying to make their way in the Church. If we do this faithfully we show that we properly understand the relationship between Christ, the vine, and the many branches that make up his living body, the Church. Welcoming others into the Church is eventually part of the experience of every Catholic, and doing so consciously is a sharing in the apostolic work Paul himself began with great difficulty in Jerusalem. His evangelical efforts eventually paid off in spite of his humorous misadventures, and ours will be sure to "bear much fruit" (John 15:8) if we keep our eyes centered on Christ the true vine.

May 6, 2018 – Sixth Sunday of Easter John 15; 9 – 17

This Gospel for today is part of the Last Supper Discourse of Jesus that is found in the Gospel of John. It is a lengthy instruction that covers four chapters of the Fourth Gospel. This discourse does not include all that Jesus said and did at the Last Supper but begins after the washing of the feet, the revelation that one would betray him, the New Commandment "As I have loved you, so you should love one another," and that Peter would deny him. The discourse begins with Jesus telling them that He must go to the Father's house, He will send the Holy Spirit, and that we are connected to Jesus as the branches of a vine are connected to the vine. After all this Jesus Returns to the commandment He began with, Love one another.

The love that surrounds us is easy to talk about. Both the word love and its meaning have been so trivialized that love has been

reduced to a feeling, infatuation or craving about or for someone or something that is often merely for one's own satisfaction. True love, which is the love Jesus speaks of, is quite different. It is does more than surround us, it fills us and touches us at the very core of our being. It's the love that consumes our heart. True love involves first and foremost our giving of ourselves totally to another without expecting anything in return. True love is given without condition. In the 23rd chapter of Saint Paul's first letter to the Corinthians he describes love as being, patient, kind, not jealous or pompous, not inflated or rude, not selfish, quick tempered or brooding over injury, it rejoices in the truth and not wrongdoing. Love never fails.

When we hear Jesus speak of this love in the Gospel He does so while giving us the example of what true love is. Saint John describes this in his First Letter; "In this is love: not that we have loved God, but that he loved us and sent his Son as expiation for our sins." (I JN 4: 10) In order to truly understand the love that Jesus speaks of and calls on us to live, we must first be open to being loved by God. One always falls short in trying to analyze and explain God's love, for it is something that only takes on meaning when we experience it. This is the experience each of us is called to have as a beloved son or daughter of a loving, Heavenly Father. God's love for us is not affected by our acceptance or rejection, our Godly living or Sinful living for God's love is the perfect and unconditional love that never fails.

During the Easter Season we are reminded over and over again of the great love God has for us in sending his Son, Jesus, to die for us to forgive our sins, and to rise for us so as to lead us to heaven. It's a message we need to hear over and over again so as to continue to be open to the experience of God's love which is unlike any other experience of love that might touch us. In two weeks we celebrate Pentecost. Let us take these final two weeks before we end the Easter Season as a time during which we prayerfully and intentionally open our hearts to receive and be renewed by a deeper experience of God's love in our lives. It is in this way that we can truly understand and live the command Jesus gives to us to Love one another as He loves us.

1992 - 2007

To advance the legacy of Father Jankola, Sister M. Mercedes Voytko, SS.C.M. accepted the appointment to be the new Director of Jankola Library from 1992 to 2007. She welcomed the opportunity to promulgate the preservation of the rich culture and history of the Slovak people. Her background in history and theology as well as her ability to communicate in Slovak were invaluable assets for taking on this responsibility.

Considering that numerous holdings of Jankola Library were still in storage, Sister Mercedes realized there was a critical need for space to integrate about 10,000 books and Slovak artifacts into our resources. Subsequently, in 2000 Saint Cyril Academy allocated several available rooms to Jankola Library for expanding and maintaining the contents of the Library. The original Saint Cyril Academy Library became the main room for Jankola Library's collection of literary, historical and religious works in the Slovak language and the former Audio- Visual Aids Room was changed to be a Periodical Room where valuable Slovak magazines, periodicals, newspapers, and archival material are available for research.

The space for expanding the facilities for Jankola Library became a reality for Sister Mercedes. She set about the gigantic task of organizing and categorizing books and artifacts for display. With the generous and dedicated assistance of Sister Mercedes' sister, Ms. Catherine Voytko and the volunteers from the members of the Northeast Pennsylvania Slovak Heritage Society of Wilkes-Barre, Pennsylvania, Sister Mercedes achieved her major goal of relocating and transforming the new site for Jankola Library.

Since the original area which held Jankola Library was vacant, there was space to accept a magnificent donation of many valuable Slovak items from the Slovak Museum at Jednota Estates in Middletown, Pennsylvania which closed and relocated its contents to Villa Sacred Heart in Danville, Pennsylvania in 2002. The acquisition of many Slovak artifacts, glassware, ceramics, crystal, dolls, folk costumes on mannequins, paintings, woodcarving, and handiwork, enabled Sister Mercedes to create a beautiful Slovak Museum that is a component of Jankola Library.

For fifteen years, Sister M. Mercedes, SS.C.M. faithfully and assiduously expanded and enriched the belongings of Jankola Library and Slovak Museum. She was devoted to her Slovak heritage and performed her tasks with love for Slovak culture and traditions. In 2007 Sister Mercedes moved to Maria Hall in Danville, Pennsylvania to receive medical care until September 8, 2016.

2007 - 2010

Father Jankola's legacy to the Sisters of Saints Cyril and Methodius became the focus for Sister M. John Vianney Vranak's, SS.C.M. ministry as the new Director of Jankola Library and Slovak Museum from 2007 to 2010. She wholeheartedly dedicated her time and energy to continue promoting the faith, culture and traditions of Slovak heritage. Sister M. John Vianney perceived the need to make improvements to Jankola Library and Slovak Museum.

Catherine Labouré Bresnock, SS.C.M. received the appointment to be the Director of Jankola Library and Slovak Museum and Sister Loretta Marie Hrubec, SS.C.M. accepted the position as Librarian for Jankola Library. Both Sisters have been missioned to this ministry from 2010 to 2018.

LIGHT ONE CANDLE

A short film entitled "Tree" depicts a traffic jam in India caused by a large tree that has fallen across the middle of the road. People sit and wait, honking their horns in frustration and beginning to argue with each other. Police officers stand by, unable to effect any change on the situation. A dignitary is escorted from his car, beyond the tree to another car on the other side, where he continues on his way. Rain begins to fall in symbolic fashion, like tears from heaven.

Then a boy walking to school makes his way through the traffic, comes to the tree, and stops. Rather than going around the tree, he drops his school bag, puts his hands against the wet bark, and begins to push with all his might. Children from a school bus stuck in traffic smile as though amused but also understanding his gesture. Then other children from the street join him, lining up in front of the tree, trying to push it all at once. Of course, the tree doesn't budge. But then adults get out of their cars and rush to help, and soon droves of people are heaving the tree, lifting it just enough to move it out of the way. The rain stops and the sun peaks out from behind the clouds, like God smiling down on the boy and all those who joined him in this small effort to improve their world. Traffic begins to flow again, and people get on with their day.

What a beautiful message this is about the power of one person to initiate change in the world. In that moment when the boy dropped his bag and began to try to push the tree, he looked eccentric in comparison to everyone else. Have you ever felt like doing the right thing would be so contrary to people's expectations that it would make you look like an oddball?

Defying convention shouldn't be a goal in and of itself. That's nonsensical and often vain. But we must be willing to take the first step in the right direction when others seem unwilling or even ignorant of the truth. We must be willing to look like that boy pushing against the giant tree in order to show others the path God wants us to walk.

Many saints of the Church have been known for their ability to go against the tide when they felt God was calling them to a role of leadership. St. Francis of Assisi ventured across the battle lines during the Crusades to initiate peace talks with the Sultan of Egypt. Francis greeted the Sultan by saying, "May the Lord give you peace," echoing the Muslim greeting "Assalam o alaikum," which translates to "Peace be upon you." Francis proceeded to share his faith in a way that did not offend the Sultan, who was impressed by his peacefulness and courage. After this encounter, the Sultan treated his Christian prisoners with greater respect and sought peace with the Crusaders.

We can never fully predict the outcome of our actions, which is a good reason to not despair before we have even tried to do what is right. Humility demands that we be willing to take the first step. There's always a chance others will see our actions and be inspired in some small way. Good deeds plant seeds of hope, and those seeds can grow into mighty movements that can change the world one person at a time.

They finished a promotional video in English and are working on one which will be available in Slovak. They are also working on ideas to improve communication between the home office and the branches to educate them on our insurance and annuity products An extensive recruitment program to increase our number of independent agents is still in progress. Emails along with postcards are being sent to possible agents in the states we are currently licensed in. This correspondence is to inform them who we are, our rates, and the products we offer. A review of our website traffic with our marketing firm has shown that our top pages that are viewed are: Homepage, Forms, Annuities, Contacts, and Newspaper. The in-house marketing team will work with the marketing firm on increasing traffic to other pages and to increase the average number of time spent on our site. They are also working on updating our presentation that will be used at our seminars.

Activities

Some of my activities in the year 2017 were: Attended all monthly Executive meetings as well as meetings called by the President. Wrote articles pertaining to insurance and had them published in the Jednota. Inform all Regional Directors of their districts insurance and annuity production. 2017 Annual Report of the National Treasurer

Dear Fr. Nasta, President Rajec, Executive Board Members and Board of Directors:

I am pleased to report that all financials and other reports required by the various states where the First Catholic Slovak Union is licensed to do business have all been properly filed by March 1, 2018.

The last year has not been much different than past years as each brings investment challenges in the American and World economies. Quantitative easing will continued in 2028 even though it continued at a slower pace in 2017. The stock markets has performed extremely strong since the election of 2016 posting several all time highs; as the equity markets continued to soared this past

year. Commercial bond interest rates have not reacted to the rise in the Government Securities interest rates during 2017. All insurers include the FCSU are continuing to be challenged by acquiring quality bonds with moderate durations. The International economies continue to struggle in the current economic climate. The stable price of oil and oil production affected the economy in 2017. The FCSU's bond portfolio activity has changed from purchasing CMO's to divesting them from the portfolio with pay downs and sales. There were no new purchases of CMO's and GNMA's in 2017 while disposing of almost \$3,000,000. As note in prior reports, this is reference to the FHLB's ruling that it no longer requires only Federal Government issues securities, but that some municipal government securities are now acceptable for the purpose of retaining membership and to obtain loans. In 2017 the Society almost purchased \$30.4 million dollars in Industrial and Miscellaneous bonds, while disposing of almost \$18.5 million. Combined with the CMO and GNMA trading, investment activity resulted in the value of bonds owed increasing by over \$6,200,000 during 2017. Total Investment Assets increased over \$13.5 million. A portion of the Society assets are in cash, cash equivalents and short term investments (over \$30,800,000, which is an increase over the prior year by \$6,850,000). The level of 2017 premium income was 9.4% lower than 2016 production.

In 2017 the FSCU showed positive results as Surplus increased by almost \$2,700,000, or +9.5%, raising total surplus to \$30,782,846 and the solvency ration increased to +108.4%. Hedge Fund investments increased in 2017 with no new purchases reporting a fund value of an increase of \$528,666. Total Hedge Fund-type investments remain well within the Ohio Insurance regulation standards.

The Society's investment portfolio remains well diversified with an emphasis on medium period maturities; and no new CMO purchases because the need for cash flow is reduced. The Executive Board is assisted by the Society's Investment Manager (AQS) in their purchase and guidance of security purchases. The Society continues to utilize low interest funds that are available as a result of the Society's membership in the Federal Home Loan Bank. The 2017 economy proved not to be a barrier and the Society's 2017 Investment Income results were favorably stable.

The net investment rate of return was almost the same as it was in 2016. The current year's income released from the IMR has been included as part of the reported net investment rate of return. The Society's net investment rate of return will rank in the middle among fraternal insurers. One of the factors contributing is due to the higher investment expenses associated with the FHLB funds. Bonds will make up 89.1% of the investment portfolio which is approximately -1.5 less than last year. Investment grade bonds (NAIC 1 & 2) are 97.0% of the bonds owned. That is slightly higher than the pervious year. The Society owns no bonds in the lowest 2 rating categories, and only 0.6% are in NAIC Class 4. The Society owns no Preferred stocks and Common stocks remain at 0.7% of the investment assets. Common stocks include the Society's investment in Jednota Holding Company

(\$1,014,480, an increase of \$238,164). Cash and cash equivalent products were at 7.9% of invested assests, which are +1.6% higher than last year. The diversification of security classes, although modest in some areas, helps stabilize the investment portfolio. The Society is positioned itself to take advantage of investment opportunities by having additional cash reserves.

Realize capital losses are shown as \$151,689. The Society realized \$884,333 of capital gains on the sale of bonds, but gains were off-set by a bond write-down of \$175,212, and \$869,812 was transferred into IMR as required by the regulations. These bond gains helped to build the IMR balance, which increased to \$1,128,866 from \$753,160. The IMR funds will be released in annual increments each year. The unrealized gain on Hedge Funds was bolstered by gains in stock of \$17,570 and Jednota increase of \$238,164.

The Asset Valuation Reserve (AVR) required by regulation for purposes of mitigating market swings increased \$305,475 and reduced surplus by that amount. The increase resulted due to the increase in bonds, common stock, and hedge funds acquired. The maximum Asset Valuation Reserve for 2017 is \$2,925,222, and the Society balance for 2017 is 99.6% of the maximum. As the Society's assets and bonds grow, the AVR maximum will increase accordingly. The ADV is to guard against large swings in the economy. All components of the reserve are consistent with the 2017 requirements.

The Interest Maintenance Reserve (IMR) requires that most profits and/or losses realized from bonds or preferred stocks that mature, are called, or sold must be placed in the (IMR) reserve and amortized to the original maturity date of the security. This requirement does not apply to bankrupt Bonds & some Preferred Stocks. The FCSU primarily holds bonds for income and does not actively trade these securities. The current IMR schedule provides that profits from prior years will be released to income for several years. The Executive Board review the IMR figures on a monthly basis. The amount currently scheduled to be released annually are shown in the Annual Statement on page 25. In 2017, \$484,088 of prior years'

bond/preferred stock profits were included as a part of the 2017 income for the Society.

The Society purchased over \$31,700,000 of securities in the 2017, while over \$24,500,000 of securities were matured, called or sold. The combined total of \$56,200,000 equals 15.9% of the 2016 invested assets. The continuing large volume of activity results from the large number of calls, especially government sponsored entities such as FNMA, FHLMC, and pay downs on GMNA's. The continuing challenge for the Society is to find replacement bonds of equal value that have high interest rates while maintaining quality. Earning sufficient investment income to support the competitive interest rates on the Society's annuity products is the challenge. The average year to maturity of bonds was 15.0 years at the end of 2017. The current volatile economic climate and large premium production has results in the volume of trading activities for the Society in the past year.

The Society's Executive Board and the Board of Directors are faced with constant reinvestment activity and having to make the proper decisions that move the First Catholic Slovak Union of America and Canada in the right direction. Engaging certified and qualified firms to assist them in making these decisions can be viewed as a wise and prudent decision.

Portfolio as of December 31, 2017

MAI Wealth Fund – the attached performance is through December 31, 2017 showed a positive and steady return for the month of December of +.45%. Performance numbers for the year-to-date return show a +8.77%. This reflects a positive return of \$184,404.82 for the year 2017. Based on MAI's strategy and investment guidelines this performance is well within the range that they forecasted and is very acceptable. MAI reported a performance since inception of +5.19%.

The objective of the Fund is to achieve performance through stock appreciation, dividend income, and premiums on options written. The Fund's investment strategy is to provide consistent returns, relative to the markets, generally by employing an actively managed option overlay strategy on a high quality, value based portfolio. The Fund will generally consist of about 30 underlying equities with above-average dividend yields that have consistently grown their dividends at attractive levels. The Fund expects to sell covered calls and cash secured puts. In order to avoid the use of leverage, it will maintain a significant cash and/or money market funds balance, typically 40-60% of partners' capital, in the event puts are assigned.

Clutterbuck Fund – performance numbers are through month ending December 31, 2017. AS reported through the year this particular fund had an extremely good performance record for 2017 producing a Year to Date return of +28.376 closing our 2017 with a month to date return of +2.243. The year to date net income from the Clutterbuck fund is +\$296,236. The ending balance is now \$1,340,204 which reflect a positive return for the 2017 year of \$348,458. (The yearend balance also reflects an addition allocation of \$500,000 by the FSCU in 2017)

Special Situation Fund, LP invests primarily in stressed and distressed fixed income securities and capital structure arbitrage opportunities. The fund seeks to take advantage of the broadest opportunity set, focused on public and liquid U.S. Credit markets, which its core competency areas.

The managers employ a deep value investing discipline generating attractive absolute returns while maintaining the risk of capital loss and having a low correlation tot the broader capital markets. The fund has moderate diversification and turnover. There is an intense focus on risk management and protecting capital.

UBS - The UBS portfolio as of December 31, 2017 is reporting that the overall account has returned a MTD of -0.04%, and a quarter to date of +0.08%. The yearend return is reflecting a return of +1.81% and a return since inception of +0.66%. This account has a ending balance of approximately \$4,882,254.22 with a cash balance of approximately \$2,165, 836.92 at closing of Dec. 31, 2017. The executive board has been in discussion with UBS to real-locate our positions within several alternative funds. This has or will take place within the first one or two months of 2018. These investment options should assists in providing a better return for this allocation of the portfolio.

The initial proposal is to reinvest approximately \$2,163,793 in a Multi-Strategy, Long/Short Equity and/or Event Driven products. Of the initial allocation there still remains approximately \$662,185 for investment. In addition authorization has been given to sell the Amber Global Opportunity Fund current at \$951,899 which should occur in late March or mid-April.

AQS has rewritten the Investment Policy Statement and Guidelines for the Board of Directors to adopt at their March Directors meeting. The Executive Board reviewed the proposed changes and made recommendations where were appropriate. A copy of the proposed IPS will be forwarded to the Board members for their review prior to the meeting. It is my recommendation to adopt the IPS as stands.

I have attended seminars throughout the past year that were presented by the Fraternal Alliance, The Greater Pittsburgh Fraternal Society and AQS (the FSCU's Professional Asset Management Firm) where discussions and presentations were presented that centered on trends in both the fraternal and final aspects of the Society world.

We had 63 Golfers compete in the tournament. 28 members attended the banquet, and 34 attended the barbecue on Sunday afternoon. There were many positive comments about the tournament. The golfers really enjoyed the putting contest and the hospitality night at the course. Thank you to Larry White of AQS Asset Management who donated \$1,000.00, to Ed Depersis of Endepersis who donated \$300.00 and Br. 254 who donated \$100.00. The money from the sponsors was used to sponsor the hole in one contest and for other skill prizes for the tournament. Paul Ritz, Activity Director Emeritus, donated \$50.00 to be awarded to the senior with the best actual score. It is disappointing that no other sponsors from any Officer, District, Branch, or individual was received in support of the tournament.

This year's golf tournament is set for the weekend of July 20-22, 2018 at Chestnut Ridge in Blairsville, PA. Details will be made available soon.

The 2017 photo contest had 29 entries in the 12-18 age group, and in the 18+ age group there were 90 entries for a total of 119 participants. The photos were judged by an Art Institute of Pittsburgh graduate. Letters of congratulations were sent along with checks to all the winners.

I have also prepared a financial report for each event which is sent to Secretary Arendt and the chair of the auditors as per the by-laws. Twice a year a financial report of the fraternal Activities account is prepared and given to the internal auditors for their review and audit of the account.

A symposium is planned for the afternoon of May 31st from 1:30pm to 3:30pm at the University of Pittsburgh in room 4130 of Posvar Hall.



The Battle of Dukla Pass, 1944

The 1944 Battle of Dukla Pass ranks among the least known major battles of the Second World War. Bill Tarkulich termed it "the largest battle you may never have heard about." Compendiums such as World War II: The Encyclopedia of the War Years 1941-1945 do not even mention the battle! David Glantz's study of the Soviet front affords it a mere two pages. In fact, the Battle of Dukla Pass counted more casualties than any battle ever fought on Slovakia soil. Casualties on all sides amounted over 138,000 in 50 days of intense fighting.

To obtain a perspective on the scale of losses, one might compare it to other major battles of World War II. While casualties were less than some other major battles, they were extremely high for a 50-day battle. Some have gone as far as calling Dukla "the D-Day of the Eastern Front." Here we can see some comparisons which Tarkulich provided, which contrasts the losses and days fought with other major battles.

Casualties (Killed, Missing or Wounded)

- 138,000 Dukla Pass in 50 days
- 160,000 Battle of the Bulge in 40 days
- 200,000 Battle of Budapest in 47 days
- 400,000 Battle of Normandy in 80 days
- 1.6 million Battle of Stalingrad in 150 days

The 1944 Battle of Dukla Pass obviously deserves more attention than most books about the war published in the West provide.

The Kukučka Memorial Lecture

Bill Tarkulich presented his findings of his research at the Thomas Kukučka Memorial Lecture at the University of Pittsburgh on March 25, 2018. The Kukučka lecture is held annually as a tribute to journalist Tom Kukučka, who died in a tragic auto accident in 1988. Formerly on Ebensburg, PA, Tom had always wished to visit his ancestral homeland of Slovakia, and had been studying Slovak at the University of Pittsburgh. In his memory, his former co-workers established a fund to help students study in Slovakia, and started an annual lecture on Slovak topics. At this year's event, four Pitt students received scholarships for study in Slovakia this summer.

This year's presenter, Bill Tarkulich, has Rusyn origins and is not a historian by profession. He is one of the few ethnically conscious Rusyns living in the Boston area. A graduate of the Rochester Institute of Technology, he also attended Northeastern University and spent his career working as an engineering manager working for Hewlett Packard and several other firms. Like many of us, he maintained a curiosity about his people's past, and noted that his parents would not talk much about their origins or teach him their language; they had wanted to be Americans and fit in here.

When he traveled to Slovakia, he spent a couple of weeks living with his 3rd generation cousins and their children who wanted to learn English. In the course of learning about village life, he became curious about the Dukla battle. It has been one of his passions ever since, and he highlighted the need to look at all perspectives of the various combatants in the battle. There is very little written about it in English, and most sources are in Slovak, Czech or Russian. A contact in Moscow helped him with Russian sources, and he has continued his research full steam since then.

Background to Dukla

For the Soviet Red Army, the Battle of Dukla marked an important struggle to break through the Carpathian Mountain pass and was part of a larger westward Soviet offensive against the Germans known as Operation Bagration, launched by Army Group Center on June 23, 1944, spearheaded by the First and Second Ukrainian Fronts, which were moving swiftly across Belarus, Ukraine and Poland. Officially the Soviets termed the Battle of Dukla "The East Carpathian Strategic Offensive Operation".

The main thrust of the operation speared into Poland, and would push southwest toward Hungary and into Slovakia, with the aim of hooking up with Slovak partisans and soldiers who sympathized with the Allies. Particularly after the successful Normandy landing and Soviet Army advances, Slovaks realized the days of Nazi dominance were nearing an end. Thus partisans and some Slovak army contingents launched the Slovak National Uprising in late August 1944 in order to support the Allied cause and push the Germans out of Slovakia.

The Dukla Pass lies on the border between Poland and Slovakia, and is just south of the village of Dukla, which is situated in the former Lemko region of Poland (These peoples were forcibly removed from the region after the war and replaced by ethnic Poles.). In Slovakia, mainly Carpatho-Rusyns live in the region. The area features a topography with plateaus and mountains that mostly range from 1300-1600 feet elevation, with the highest standing at around 5600 feet. Until the 1940s, sheep grazed these bucolic hills that transformed into a bloody battleground hills with the thunderous sound

of guns and cannon fire.


Thus defenders would have an edge if they entrenched themselves on high ground, as Germans were prone to do in both world wars, as I found out during my visits to France and Belgium. North of Dukla in Poland was Krosno, a strategic area known for its oil fields, which fulled the German war effort. The Soviets bombed the region to soften it and cut off vital fuel supplies.

Dukla Pass had seen armies pass through before. Russian troops used the pass on their way to suppress the Hungarian Revolution in 1849. In World War I, the Imperial Russian army mounted an offensive through the pass with the aim of striking at Budapest, but that failed due to Austro-Hungarian re-

sistance and a horrible winter.

Tarkulich noted that the Slovak army proved lukewarm in cooperating with the Germans throughout the war, and German officers considered them to be unreliable. For instance, when Germany invaded Poland in 1939, three armies moved into southern Poland, and the Slovakia contingent just followed the Germans – with lackluster enthusiasm. Just 38 Slovak troops died in the action, and few Poles. (Slovakia's army consisted of various ethnic groups -- Rusyns, Ukrainians, Poles and Magyars (Hungarians) in addition to Slovaks).

From the perspective of my own past research, Slovaks were more interested just in obtaining back the Spiš and Orava villages which Poland had annexed from Slovakia in 1920. But during most of the war, Slovakia remained relatively quiet until the guns of August commenced in 1944.

A Stout German Defense

The Germans badly wanted to defend this area around the Dukla Pass and sent 20,000 troops there and fortified with 200 pieces of artillery. They would construct a three-tiered defensive line north of the Carpathian Mountains (in Poland) to stop any possible Soviet advance: the Hunyadi, St. Laszlo, and Árpád Lines. The strongest line of defense was the so-called "Árpád Line," which Hungarians had built hundreds of years earlier. Germans called it the Karpatenfestung ("Carpathian fortress"). The defenses were comprised of a series of military fortifications and obstacles in the northern foothills of the mountains and extended from Poland, to parts of what today lie in Ukraine. Conscripting locals in Poland for additional labor, they cut down forests, made tank traps, set wire traps, laid down thousands of mines, dug trenches, and built bunkers and lookout towers in order to present a formidable barrier to stop any Red Army offensive.

The Battle of Dukla Pass, 1944

The Germans made a special effort to fortify oil-rich Krosno and surrounded the area with trenches, minefields, and rock houses equipped with machine-guns. They barricaded the streets of Krosno with obstacles looming 1.5 meters high, composed of stone and logs.

Stavka, the Soviet High Command, gave the order to begin the assault on September 2, 1944. Anti-German partisans had planned the Slovak National Uprising (Slovenské národné povstanie, or SNP) to begin around the same time. The Soviets had also expected the East Slovak Army Corps (Slovak State Army, 1939-1944) of 32,000 troops to defect and take part in the Dukla offensive from the south, but that never happened, for the officers got cold feet. According to the memoirs of General Konev, Stavka decided that operations would commence on September 8, 1944; and due to poor intelligence and coordination with partisans and the failure of the Slovak Army to advance, the Soviets had estimated it would take four days to punch through the Pass and move rapidly westward into Slovakia, meeting up with the SNP forces. Instead the Soviets met a formidably entrenched opponent, which would drag fighting on until October 28, when they finally liberated the town of Svidník, Slovakia.

The Leadership

Leading the Soviet offensive was General Ivan S. Konev, the "brutal" Soviet commander of the First Ukrainian front. He would throw people into battle even if short of weapons. Commanding the Soviet 38th Army was General Kiril Moskalenko, a career officer of the Red Army since 1920. With experience in heading an Anti-Tank Brigade at the Battle of Kursk, he had also fought at Moscow and Stalingrad. In 1944, he would lead the 38th Army.

Teaming with the Soviets was the First Czechoslovak Army. It originated in late 1941, after the Soviet Union had agreed to cooperate with the London-based Czechoslovak government-in-exile. The Soviets began training a Czechoslovak Independent Battalion in Buzuluk, Russia. Many of its members consisted of Carpatho-Rusyns and Slovaks coming from the Soviet gulags, and those who had illegally crossed the border from Slovakia. Shortly after the start of the Dukla Battle, General Ludvík Svoboda had assumed command of an army of 10,000 soldiers of the First Czechoslovak Army. He replaced a less competent General Kratochvil. Svoboda proved an excellent leader, was familiar with terrain, and inspired his troops by embedding himself with them on the front lines, much to the frustration of Soviet leaders, who often had difficulty locating him.

Leading the German army was General Gotthard Heinrici, a career officer who hailed from a family with centuries old military tradition. Commanded to head what was called Army Group "Heinrici", he headed the First 1st Panzer Army and the Hungarian 1st Army. A master of defense, Heinrici would slow the Soviet advance to a crawl. Recognizing his extraordinary talents, Hitler would later use him in the defense of Berlin itself.

The Soviets had planned to hook up with the East Slovak Corps consisting of 32,000 troops. However, the Germans considered the Slovak army unreliable, and had arrested its leader, General August Malar, disarmed the three Slovak divisions, sent them to the west, and assigned mainly labor jobs to Slovakia's soldiers. Henrici considered the Slovak officers second rate and unreliable. Partisans provided the Soviets with some information, but poor intelligence about the strength of the Germans would thwart the original plan, as Germans doubled their forces and later moved through the Dukla Pass, undetected by the Soviets. The Soviets had banked on success using an attack on the Dukla flanks, but as Tarkulich noted, "a battle plan is only good to the first day." Then one had to adapt to the real circumstances.

The Battle for Dukla

When the Soviets launched their attack on September 8, they preceded it with a more than 2 hour heavy artillery bombardment on the German army in Poland. Initially, the Soviets met little resistance, and advanced 14 kilometers on day one. But by dusk, the Germans intensified their resistance and had a decided advantage with its broad vistas from occupying the high ground. Communications proved difficult for the Allies and the Czechoslovak Army troops could not help on the first day due to congested roads. Fighting intensified and the Germans were standing strong.

When General Konev noticed a gap of about 2,000 yards west of the village of Dukla, he ordered a flanking attack on the night of September 12th. It failed miserably. The Germans swiftly closed the gap, encircled, and nearly trapped the Soviets, who suffered 60 percent losses as they fought hard to escape annihilation.

By September 20, the Soviets took the Polish village of Dukla and continued to advance toward the Pass. That same day, a small incursion liberated the village of Kalinov, the first Czechoslovakia village to be reached.

To address the stalled offensive, the Soviets had numbers on their side and reinforced their forces "with the 4th Tank Corps, additional Czechoslovak pilots, the 2nd parachute brigade (700 men, 104 tons equipment), and the 1st Czechoslovak fighter regiment" (Tarkulich).

By September 20, the Soviets took the Polish village of Dukla and continued to advance toward the Pass. That same day, a small incursion liberated the village of Kalinov, the first Czechoslovakia village to be reached. By September 26, the Soviets had successfully pierced the Árpád Line of defense. But the front had bogged down at Vyšný Komárnik and could not continue south of Dukla Pass. The start of heavy autumn rains in early October further hindered advances. It took until Octo-

ber 5 to finally take the Dukla Pass, almost a month from the start of the offensive.

The most important battle around Dukla Pass occurred on October 25-27, after the rains subsided. To this day, military strategists at West Point study the battle, for it marked the first time in history that tanks were part of a military assault over forest and mountains, and it caught the Germans by surprise. Air power and artillery supported the attack of T-38 tanks. A fierce 3 day battle ensued in what Slovaks call the Valley of Death (Údolie smrti).

Bill Tarkulich was a featured presenter at the Thomas Kukučka Memorial Lecture, University of Pittsburgh, on March 25, 2018. When it had ended, 28 Soviet tanks were destroyed. Recognizing the situation had become untenable, Heinrici retreated with his army about 200 km toward the west. Soviet troops took 31,360 Germans as prisoners.

The same day that they defeated the Germans, the Soviets advanced to the town of Svidník, which was totally destroyed. But also that day, the Germans had suppressed the Slovak National Uprising, so there would be no joining of forces possible.

The Price of Victory

The Soviets had succeeded, but paid a high price in human lives and material destruction for local civilians. Over 138,000 were dead, wounded or missing. Over 46,000 Soviet, Czechoslovak and German soldiers were killed, including 6,500 from the 1st Czechoslovak Army Corps, (60% of the unit). Also, not to be overlooked was the failure of the Soviet troops to participate in the Slovak National Uprising, which resulted in the loss of at least 17,000 partisans.

The Snina region suffered the brunt of the damage. Tarkulich listed the damage.

- 918 homes were totally destroyed
- 2,217 homes heavily damaged
 - 11 villages were 90% destroyed
- 14 villages 50% destroyed
- 55 bridges destroyed
- 250 civilians killed during battle
- 180 civilians seriously injured by land mines

The destruction and damage would affect the residents for years to come. Many had fled the war scene as refugees and others hid in the hope of surviving in the battle area. Following the battle, poverty and unemployment increased and poor healthcare resulted in high number of deaths among infants and their mothers. Diseases such as tuberculosis, whooping cough, scarlet fever, diphtheria, and intestinal typhoid ravaged the isolated population. Education suffered and a quarter of the population was illiterate. Bandits roamed the countryside and stole at will. Many people were still living in tents as late as 1947. Not until 1948 did the long process of rebuilding homes commence. It was a bitter pill to swallow.

Postwar Memorials

The Dukla Pass Memorial became a site of pilgrimage which the Soviets insisted that school children memorialize every year. There exist many huge and impressive monuments to this day, and destroyed tanks still line the Valley of Death and the surrounding hillsides. Svidník built a war museum in 1965, and in 1974, the communist regime raised a high tower for tourists at Dukla. Over 9,000 soldiers lie buried in a Soviet cemetery and 2,648 Germans repose in the pristinely kept cemeteries decorated regularly with fresh flowers at Hunkovce. Another 1,137 Germans lay in repose at a cemetery in Zborov. And 565 Czechoslovak soldiers are buried at Vyšný Komárnik. A host of other smaller cemeteries in Poland and Slovakia exist which one can see a list of on Tarkulich's website.

Today the region around the Battle of Dukla is surrounded by peaceful parks, forests, and nature preserves. They are popular among naturalists and visiting hikers and tourists.

I have previously visited the area on two occasions, and plan another more extensive trip there this summer. Hiking the mountainsides, one must still take care not to step on unexploded bombs and live ammunition. But the area is still well worth a visit, and in few other places can one see tanks still emplaced on the original sites where they fought.

When this time expired, unfortunately there was not another available location and the museum's artifacts had to go into storage. Mr. Otto Rada was very generous and offered to store the museum's artifacts for one year. This gave the SCHM board of directors some time to find a location. A small store front in Oshawa that was once in a very Slovak neighbourhood was offered to the SCHM for rent for two years. The offer came with the option to purchase the property and the museum board of directors and Margaret had hoped that with a Slovak church across the road and some volunteers, enough fundraising could be done to buy the SCHM this property. She did not foresee the stroke she was about to suffer. Needless to say, without a leader the funds were not found and the lease term once again was up. The Slovak community was urging Margaret and the museum's board of directors to bring the museum closer to the larger Slovak population in Mississauga. The SCHM had approached Mississauga Heritage and Mississauga Muse-

ums in their search for an appropriate location but nothing was found. During the next four years, the SCHM participated in about 20 library exhibits, two Carassauga threeday Festivals of Cultures, annual Doors Open events in St. Catharines, Culture Days in Mississauga, and Easter and Christmas events in Richmond Hill. The highlight for the museum was the SCHM's 10th Anniversary celebration at the 'Grange' the home office building of Mississauga Heritage with a 2 months exhibit with a very special feature speaker Esther Bryan, creator of the 'Quilt of Belonging'. Not bad for working out of a small storage unit. The museum's time and efforts were noticed and the CSL offered the SCHM to share their hall. A proper agreement was drawn up and an opening celebration was planned to introduce the Mississauga and the Slovak communities to the new Home of the Slovak Canadian Heritage Museum.

For the future, it was Margaret's hope to capture the history of the Slovaks in Canada. Those that have immigrated to Canada can leave a legacy so that their children and grandchildren will know where their parents, grandparents and great grandparents came from. Coming to a new country is not easy for anyone. Some struggles may be similar but every ones' story is unique. The SCHM's genealogy committee had prepared a questionnaire to help people write their family history. It is a two-part document. The first is the facts, the names, dates and places. The second is for the personal stories of joys, sorrows, struggles and accomplishments. It is these stories that define us as Slovak people in a multicultural society and our stories need to be heard. If you would like help from the SCHM to guide you in writing your family history you may get this questionnaire by contacting a member of the museum's board of Directors: Luba Henderson, Helen Bucic, Joe Radvansky, Mary Sirotnik, Anne Smith, Anne Mitro, Rev. Marek Novicky or Alena Melas.

The Slovak Canadian Heritage Museum's opening was a big success because people with good hearts came to celebrate this occasion. It is a museum for all Slovaks. We hope to continue for many years to share and showcase the contributions that Slovaks have made to Canada our new homeland.

Before we knew it, it was time to collect the flags, take down the tent and roll up the red carpet! The Opening Celebration was complete, and was a big success. The visitors were happy, the comments were all positive and we hope to see you all again at the next SCHM event.

Branch 853's Charles Boone Holds World Record

Charles Boone of Dormont, PA completed another item from his 'bucket list". In being a member of the Class of 2018 at Keystone Oaks High School, Charles senior year is proving to be exciting.

Charles is now a World Record holder.

Guinness confirmed that Charles is the Guinness World Records Title Holder for the Longest Chain of Carabiners.

Charles is an Eagle Scout and credits starting his collection of carabiners during his years in Boy Scouts. As a scout, Charles attended many local camps and also out-of-state high adventure camps in which he used various types of carabiners for events – thus his collection innocently started.

On Sunday February 25, 2018, Charles linked together his carabiners, one by one, all 1856 of them. The chain reached 250 feet, 10 $\frac{1}{2}$ inches long. Connecting all of the carabiners took 2 hours and 10 minutes.

Striving for an official world record is a feat that requires documentations, verifications and working within the very specific guidelines of Guinness including witnesses with specific qualifications. Charles asked neighbors and educators for their assistance. Retired corrections officer and neighbor Jeff Neiport and Keystone Oaks High School accounting educator Beth Smith, served as two witnesses for the event. Charles also needed a qualified person to measure the finished chain. Charles asked Parkway West Career Center educator Kevin Lewis. Charles picked Mr Lewis as the person for this feat because he knew

the best person for measuring the chain would be someone who teaches the precision of measuring as a career trade. Charles' parents photographed and video the event. Longtime friend Barb Otoole assisted Charles by placing 20 carabiners at a time in a basket, so that Charles can take them out one, by one to be attached.

Walmart in Carnegie, PA also assisted Charles in his adventure. They sectioned off a portion of their parking lot to help Charles accomplish his World Record. The completed carabiner chain stretched from the building, across the parking lot, all the way to the other side.

Charles thanks all who helped him achieve this World Record. With the record confirmed, Charles generosity will not forget how he started his collection. He will give the majority of the carabiners to the Boy Scouts to distribute them to other scouts at day camp or summer camp.

Congratulations Charles Boone on your World Record of the Longest Chain of Carabiners.



M. Mark Stolarik Reached Major Milestone

On April 22, 2018, M. Mark Stolarik, of Ottawa, Ontario, will celebrate his 75th birthday.

Marián (Mark) Stolarik was born in the picturesque central Slovak town of Turčiansky Sväty Martin to Imrich and Margita Stolárik. As the Russian front approached in the winter of 1945, Mark's parents decided to evacuate with their family of six children into Austria along with thousands of other Slovaks, to escape the fighting and possible retribution by Communists who were persecuting supporters of the first Slovak Republic (1939-1945). The refugees then languished in one room in Austria until 1950. In 1951 they immigrated to Canada, first settling in Hull, Quebec and later in Ottawa, where Mark grew up and graduated from the University of Ottawa with honors in history (1965) and with an M.A. in history (1967). He subsequently published his M.A. thesis on The Role of



American Slovaks in the Creation of Czecho-Slovakia, 1914-1918, in the annual Slovak Studies, 8, 1968.

After graduating from the University of Ottawa, Mark decided to enroll in the Ph.D. program at the University of Minnesota. There in 1963 his professor Timothy L. Smith had established the first Immigrant Archives in the USA. Mark helped Smith collect archival materials from Slovak communities in the USA and Canada while working on his dissertation, Almmigration and Urbanization: The Slovak Experience, 1870-1918" (Ph.D., 1974). The dissertation was published by AMS Press in New York with the same title in 1989.

Mark Stolarik's professional career began as a Lecturer in History at the Cleveland State University (1972-1974), and as an Assistant Professor (1974-1976) at the same university. In 1976 he decided to return to Canada, to work for the National Museum of Man (later the Canadian Museum of History). During this period he visited many Slovak communities in Quebec and Ontario, collected numerous material artefacts pertaining to Slovak history and culture and deposited them into the collections of the Museum, the National Library and the National Archives. He also interviewed on tape such Slovak pioneers as Ján Frajkor, Štefan Hreha, Štefan Jesenák, Hermina Krállovicová Andrej Potocký, Michal Sinčák, Jozef Tokár and others. In 1977, while at the National Museum of Man, Mark also established the Slovak Studies Association, which attracts scholars in the USA and Canada into one organization that sponsors scholarly presentations at the American Association for the Advancement of Slavic, European and Eurasian Studies. The SSA also issues an occasional Newsletter informing its members of their activities. Stolarik served as the Secretary-Treasurer and Newsletter editor for the first ten years of this organization, which still exists.

In 1979 Mark returned to the United States to become Executive Director (later President) of the Balch Institute for Ethnic Studies in Philadelphia. It was a library, museum and education centre dedicated to collecting, displaying and interpreting material artifacts, library and archival collections on all of America's ethnic groups. While there he established three departments, increased the staff from seven to 25 and recruited 50 volunteers. During his thirteen years as head of the Institute, Stolarik raised millions of dollars from various individuals, corporations and foundations in order to fund the Institute's operations, exhibits and programs. The trustees of the Institute were so satisfied with his work that they told him that he could stay on until he decided to retire. While in Philadelphia Stolarik also joined the Slovak community and he and his family became active members of the Slovak parish of St. Agnes-St. John.

Meanwhile, in the 1980's the Slovak community in Canada and the USA raised \$500,000, which the Canadian government matched with another \$400,000 in order to establish a Chair in Slovak History and Culture at the University of Ottawa. The Chair was formally inaugurated in the History Department in May of 1990. After a competition for the position of Chairholder was announced, Mark Stolarik was among those who applied and he won the competition. In January of 1992 Stolarik began his career as Professor and Chairholder of the Chair in Slovak History and Culture at the University of Ottawa. Since then he has regularly taught courses on the history of the Slovaks, on Central European history and on the history of Immigration to North America. In addition, he has established a Slovak Archives at the University with collections from prominent Slovak personalities and institutions in the USA and Canada. With additional funds raised in the last twenty-six years, Stolarik has established seven scholarship funds at the University, to promote the study of Slovak history, to allow outside scholars to do research in the Slovak Archives, and to invite guest speakers to address matters of interest to the scholarly and local Slovak community. He also organized three major international conferences at the University, one of which (in 2002) was opened by the President of the Slovak Republic. The papers of all three conferences have been published. Altogether Stolarik has published ten books and over sixty articles in scholarly journals pertaining to Slovak or immigrant history. His most recent publication is: The Czech and Slovak Republics: Twenty Years of Independence, 1993-2013 (Budapest: Central European University Press, 2016).

In addition to his professional interests, Stolarik continues to actively participate in North American Slovak communities. Besides being a member of the First Catholic Slovak Union, the National Slovak Society and the Slovak Catholic Sokol, Stolarik has been a member of the Canadian Slovak League since 1958. In 1993 he was elected National President and served for two terms. In 2007 he was elected President of Branch 63 in Ottawa, a position which he still holds. In 2016 he was re-elected National President of the Canadian Slovak League.

Officials in Slovakia have recognized Mark Stolarik's achievements with various awards.

In 1992 the Matica slovenská gave him its silver medal. In 1998 the Ministry of Foreign Affairs of the Slovak Republic awarded him its silver medal. The President of the Slovak Republic awarded Stolarik the Presidential Medal in 2002. Finally, in 2013 the Minister of Foreign Affairs of the Slovak Republic inducted Mark Stolarik as a "Goodwill Envoy" of the Slovak Republic.

Mark Stolarik is married to the former Anne Ivančo of Oshawa and has two sons: Andrej and Matthew.

Správy zo Stovenska

Bratislava – Z rúk ministerky školstva, vedy, výskumu a športu SR Martiny Lubyovej (nominantka SNS) si v utorok v Bratislave prevzali pedagógovia a odborníci z oblasti školstva z celého Slovenska ocenenie. Veľké i Malé medaily sv. Goražďa a ďakovné listy dostalo celkovo 61 učiteľov a pracovníkov v školstve. Ministerka školstva vo svojom príhovore vyzdvihla význam a poslanie učiteľského povolania. "Slovensko je krajinou, ktorej úspech závisí od ľudského kapitálu, a preto potrebujeme dobrých učiteľov, odborníkov, akými ste vy," povedala Lubyová.

Bratislava – Spoločnosť Uber musí prestať prevádzkovať taxislužby na Slovensku prostredníctvom osôb a vozidiel, ktoré nesplňajú zákonné požiadavky. Rovnako nesmie sprostredkúvať taxislužby osobám, ktoré nevyhovujú podmienkam kladeným na vodiča taxislužby. Rozhodol o tom v polovici februára Okresný súd Bratislava I v konaní o návrhu na nariadenie neodkladného opatrenia. Znamená to, že spoločnosť bude musieť svoju aplikáciu na Slovensku, ktorá funguje zatiaľ len v Bratislave, vypnúť.

Žilina - Žilinský samosprávny kraj (ŽSK), Žilinská univerzita (ŽU) a mesto Žilina podpísali Memorandum o spolupráci pri rozvoji Letiska Žilina, v ktorom deklarujú snahu zachovať prevádzku letiska, obnoviť pravidelnú linku a naštartovať jeho ďalší rozvoj. Informoval riaditeľ odboru informácií a zahraničných vzťahov Úradu ŽSK Lukáš Milan.

Bratislava - Dovolanie českého premiéra v demisii Andreja Babiša v spore s Ústavom pamäti národa (ÚPN) o tom či bol, alebo nebol agentom ŠTB sa na Najvyššom súde (NS) SR v blízkej budúcnosti neuzavrie. Spis a dovolanie Babiša sa totižto stále nachádza na Okresnom súde Bratislava 1 a nebol postúpený na NS SR.

Bratislava - Roman Chocholáč si za dvojnásobnú vraždu svojej tety Ivety Čubňovej a sesternice Ivany Krčulovej z novembra 2009, ktorá sa odohrala v katastri obce Kotešová – Oblazov, odpyká definitívne doživotný trest odňatia slobody. Rozhodol o tom v utorok trojčlenný senát Najvyššieho súdu (NS) SR, ktorý tak zamietol jeho dovolanie. "Formálne podmienky na podanie dovolania splnené boli, ale neboli splnené podmienky, aby sa dovolaniu vyhovelo," uviedol predseda senátu NS SR. Chocholáčove dovolanie obsahovalo takmer 50 bodov a prísediaci sudca ich čítal približne hodinu. Proti rozhodnutiu NS SR nie je prípustný opravný prostriedok.

Bratislava - Slovenskí vojaci, policajti a ďalší experti sa v roku 2017 zúčastnili 20 aktivít v oblasti medzinárodného krízového manažmentu. Najviac z nich vyplývalo z členstva v EÚ a Organizácii pre bezpečnosť a spoluprácu v Európe (OBSE), ďalšie organizacia NATO a OSNI Informacia produce literálnosti podávne vláda vzala na vadomich podávne v nizovalo NATO a OSN. Informuje o tom správa, ktorú nedávno vláda vzala na vedomie. Slovensko - súhlasí, aby všetky členské štáty prispievali do rozpočtu EÚ viac ako v súčasnosti. Bude sa však zasadzovať o to, aby sa pravidlá pre realizáciu projektov spolufinancovaných z rozpočtu EÚ zjednodušili. Vyplýva to z materiálu, ktorý schválila vláda.

Budapešť/Bratislava - Krajiny regiónu strednej Európy sú v téme obrany a bezpečnosti jednotné, zaznelo v stredu v Budapešti na rokovaní ministrov obrany krajín Stredoeurópskej obrannej spolupráce (CEDC). Hovorkyňa Ministerstva obrany SR Danka Capáková uviedla, že šéfovia rezortov obrany Česka, Chorvátska, Maďarska, Rakúska, Slovinska, Slovinska a Poľska ako pozorovateľskej krajiny tejto spolupráce sa dohodli na pokračovaní ďalšej spolupráce s dôrazom na positivaní prokajovaním za positivaním spolupráce. zom na posilňovanie reakcieschopnosti a prevenciu vzniku bezpečnostných hrozieb

Bratislava - Ministerstvo školstva, vedy, výskumu a športu (MŠVVŠ) SR splnilo iba desať cieľov zo 118, ku ktorým sa zaviazalo. Vyčíslil to nezaradený poslanec Národnej rady SR Martin Poliačik (Progresívne Slovensko), ktorý o tom hovoril na tlačovej konferencii v parlamente. Prácu rezortu školsťva hodnotí známkoú nedostatočná a odporúča, čím by učiteľom reálne pomohol.

Bratislava – Zamestnávatelia a stredné odborné školy (SOŠ) nie sú spokojné so vzdelávaním v oblasti informačných a komunikačných technológií (IKT). Budúcnosť prináša výzvy v tejto oblasti, na ktoré pracovný trh na Slovensku nie je pripravený. Poukázali na to na tlačovej konferencii v Bratislave zástupcovia zamestnávateľov a škôl, ktorí zároveň predstavili niektoré návrhy na riešenie tejto situácie.

Bratislava - Každý rok stúpa počet pacientov, ktorým nádej na zdravý život prináša transplantácia krvotvorných buniek. Klinika hematológie a transfúziológie v Univerzitnej nemocnici Bratislava (UNB) vlani transplantovala vyše 100 pacientov, čo lekári považujú za úspech, zväčša ide o nepribuzenské transplantácie. Pred približne desiatimi rokmi to bolo vyše 25 transplantovaných pacientov.

Bratislava – Deklarovaný oficiálny termín dokončenia nového futbalového stánku na bratislavskom Tehelnom poli ostáva nezmenený – koniec roka 2018. V rámci kontrolného dňa výstavby Národného futbalového štadióna (NFŠ) to oznámil predseda predstavenstva akciovej spoločnosti NFŠ Pavel Komorník.

Bratislava - Desať rodín, ktoré sa ocitli v núdzi, dostali od prezidenta SR Andreja Kisku po 478,60 eura. Rozdelil im svoj plat. Prezident vybral adresátov pomoci na základe návrhov neziskových organizácií, ktoré sa dlhodobo venujú ľuďom v núdzi – Plamienok, Úsmev ako dar, Liga proti rakovine, Dobrý anjel a Organizácia muskulárnych dystrofikov v SR. Robí tak každý mesiac.

Viedeň/Bratislava - V súčasnosti sa nachádza vo väzbe v rakúskej metropole Viedni až 18 mladých Slovákov v kauze mladých prostitútov, ktorí páchali aj rozličnú inú závažnú trestnú činnosť. Uviedol to hovorca viedenskej polície Harald Sörös. Podľa jeho slov sú všetci títo väzobne stíhaní mladí Slováci z okolia Lučenca. Obvinení sú okrem sexuálnych deliktov, krádeží, lúpežných prepadnutí a majetkovej trestnej činnosti aj z vraždy v štádiu pokusu. Ako uviedol hovorca, prípad by mohol byť uzavretý za týždne až mesiace a niektorým hrozí trest až do 15 rokov odňatia slobody.

Bratislava – Zámer zavedenia zákonného percenta domácich hudobných diel vo vysielaní slovenských rozhlasových staníc sa naplnil, v éteri je naozaj počuť viac pôvodnej slovenskej hudby. Myslí si to nová ministerka kultúry Ľubica Laššáková (Smer-SD). Za každú cenu konzervovať súčasný stav však nemieni. "Diskusii na túto tému sa nebránim," uviedla v súvislosti s pripomienkami časti rozhlasových vysielateľov, ktorí napríklad upozorňujú, že zavedenie kvót "neprípustným a neodôvodneným spôsobom retroaktívne zasiahlo do vlastníckych práv vysielateľov rozhlasovej programovej služby." rozhlasovej programovej služby".

Bratislava - Zúženú mozgovú tepnu začali v Bratislave operovať modernejšie a bezpečnejšie ako doteraz. Ide o novú metódu, zákrok už úspešne podstúpili prví pacienti. Operácie trvajú kratšie ako predtým, špeciálna zdravotnícka pomôcka, ktorú na to lekári používajú, je hradená zdravotnými poisťovňami.

Bratislava - Slovensko prejavilo solidaritu so Spojeným kráľovstvom v súvislosti s útokom nervovoparalytickou látkou na bývalého ruského špióna Sergeja Skripaľa a jeho dcéru Juliju a v otázke adekvátnej reakcie na tento čin sa správa zodpovedné a uvážlivo. V rozhovore pre Hospodárske noviny to uviedol minister zahraničných vecí Miroslav Lajčák (nominant Smeru-SD).

Banská Bystrica - Prevencia nadváhy a obezity je témou tohtoročného Svetového dňa zdravia, ktorý si pripomíname 7. apríla. K aktivitám téjto celosvetovej kampane sa pridáva aj Regionálny úrad verejného zdravotníctva (RÚVZ) v Banskej Bystrici. Jeho pracovníci obyvateľom poradia, ako predchádzať obezite.

A.Kiska: Krajina bude ekonomicky úspešná, ak investuje do vzdelania

"Pred 50 rokmi bola Južná Kórea jednou z najchudobnejších krajín sveta. Dnes patrí medzi 11 najvyspelejších ekonomík sveta. Veľa sme diskutovali o tom, ako sa to dá dosiahnuť, "spresnil.

Zároveň zdôraznil, že Južná Kórea je pre Slovensko nesmierne dôležitý partner. "Viac ako 50 percent investícií z mimoeurópskych krajín prišlo práve z Južnej Kórey. Bolo investovaných viac ako 2,5

miliardy eur a viac ako 100 spoločností vytvorilo tisíce pracovných miest. Veľmi dôležité je, že aj Slovensko je tu vnímané ako veľmi úspešná krajina a ako krajina, o ktorú sa môže Južná Kórea opierať," konštatoval Kiska.

V otázke blížiaceho sa medzikórejského summitu, ktorý sa uskutoční 27. apríla, sa Kiska a Mun zhodli na tom, že dialóg je nesmierne potrebný a prospešný. "Nie zastrašovanie, ale dialóg a nachádzanie mierových riešení," uzavrel slovenský prezident.

Mun počas rokovania ocenil, že v krátkej histórii bilaterálnych vzťahov ich Slovensko a Južná Kórea konzistentne rozvíjali. Vyjadril potešenie nad tým, že mnoho kórejských firiem, vrátane Kia Motors a Samsung Electronics, aktívne podnikajú v domovskej krajine, pričom dosahujú spoločne prospešné výsledky taktiež na Slovensku.

"Slovensko po vstupe do NATO a EÚ bolo schopné dosiahnuť politickú stabilitu a prudký ekonomický rast. Dostali ste prezývku "Tatranský tiger", vaša krajina taktiež prispieva k medzinárodnému mieru a bezpečnosti," uviedol juhokórejský prezident, pričom poukázal na slovenské predsedníctvo v Rade EÚ a na súčasného predsedu Valného zhromaždenia OSN Miroslava Lajčáka.

Následne si Andrej Kiska na Národnom cintoríne v Soule uctil prostredníctvom ceremónie kladenia vencov vojakov padlých v kórejskej vojne.

Anna Kolesárová sa narodila 14. júla 1928 vo Vysokej nad Uhom v okrese Michalovce. Jej život poznačilo rozhodnutie, ktoré si sama zvolila - radšej smrť než stratu panenstva. V závere druhej svetovej vojny ju zastrelil sovietsky vojak, ktorému sa odmietla podvoliť. Zomrela 22. novembra 1944 vo svojej rodnej obci, kde je aj pochovaná.

Vo farskej kronike v Pavlovciach nad Uhom sa o jej smrti nachádza zápis z roku 1944, ktorý urobil tamojší farár - dekan Anton Lukáč. Svedectvo podpísalo päť svedkov. Pri tomto hrdinskom čine ju podľa zápisu posilňoval eucharistický Kristus, lebo predtým pristúpila k svätej spovedi a k svätému prijímaniu. Jej hrob je dodnes cieľom pútnikov z celého Slovenska, najmä z radov mládeže.

Európska komisia vyčíta Slovensku najmä korupciu

Za posledný rok Slovensko v boji proti korupcii nedosiahlo žiadny viditeľný pokrok. Vyplýva to z najnovšej Správy o Slovensku z dielne Európskej komisie (EK).

"Zatial' vidíme, že sa nemení vnímanie korupcie medzi občanmi. Súčasne sa znížila reálna fyzická kapacita špeciálnej prokuratúry na riešenie korupčných prípadov, ktorých pritom bolo v trestnom stíhaní menej. Z toho vychádza to hodnotenie, že tam nebol dosiahnutý žiadny viditeľný pokrok. Uvidíme, či opatrenia, čo vláda prijala, budú mať nejaký efekt na hodnotenie v nasledujúcom roku," uviedol vedúci Zastúpenia EK na Slovensku Ladislav Miko.

EK podľa správy nie je spokojná ani so závislosťou šéfa polície a policajnej inšpekcie od ministra vnútra. Zároveň radí zlepšiť ochranu pri nahlasovaní korupcie. Pozitívne naopak vníma zapojenie mimovládnych organizácií do monitorovania korupcie.

Správu EK potvrdzuje aj prieskum Eurobarometru. Ukazuje, že vnímanie korupcie v niektorých oblastiach je na Slovensku výnimočne vysoké. Ide napríklad o korupciu v zdravotníctve, na polícii, súdoch, úrade prokuratúry či v sektore vzdelávania. Vnímanie korupcie v politike je vysoké vo všetkých krajinách EÚ.

"Správa o Slovensku 2018 - Slovensko očami Európskej komisie" je nezávislý analytický dokument, ktorý opisuje stav krajiny vo viacerých oblastiach. Na základe správy a stretnutí s predstaviteľmi krajiny EK v máji uverejní svoje odporúčania pre členský štát.

Slovenskí biskupi podporili snahu verejnosti o slušnejšie Slovensko

Podľa pražského kardinála Dominika Duku je tak ako na Slovensku aj v Čechách situácia v spoločnosti turbulentná. "U nás sa politická scéna rozdrobila na množstvo strán a je pre mňa záhadou, ako je možné, že sú v demokratickom parlamente strany, o ktorých média hovoria, že sú fašistické alebo pronacistické," uviedol Duka. Podľa jeho slov by pri takýchto podozreniach mali konať príslušné orgány a tieto strany zakázať. "Ale keď im dávame dokonca možnosť zostavovať vládu, tak sa pýtam, kde je pravda a aký by mal byť postup do budúcna? My môžeme pokojne povedať, že cirkev sa nikdy nestotožnila s nacizmom ani s fašizmom, ale ani s marxizmom a komunizmom. To sú skutočnosti, na ktorých musí cirkev stáť, aby mohla byť skutočným hlásateľom slobody a rovnosti všetkých ľudí," zdôraznil kardinál.

Predstavitelia slovenskej a českej biskupskej konferencie okrem toho rokovali aj o výsledkoch niekoľkoročnej práce na revízii Kódexu kánonického práva z roku 1983, do ktorého boli vložené dodatky vydané pápežmi sv. Jánom Pavlom II., Benediktom XVI. a Františkom. Zaoberali sa tiež elektronizáciou cirkevných procesov, prípravou na nové legislatívne pravidlá pri ochrane osobných údajov a vypočuli si správu o aktuálnej situácii Pápežského slovenského kolégia svätých Cyrila a Metoda v Ríme. Zaoberali sa aj aktivitami Slovenskej katolíckej charity i príprave Národného stretnutia mládeže P18, ktoré sa uskutoční na konci júla v Prešove.

Na UK bude v letnom semestri študovať 115 nových študentov

Na Univerzite Komenského v Bratislave bude v rámci letného semestra akademického roka 2017/2018 študovať 115 nových študentov prostredníctvom programu Erasmus+. Ako uviedla prorektorka UK pre medzinárodné vzťahy Daniela Ostatníková, študenti pochádzajú z 19 krajín Európy.

Najviac ich prichádza z Portugalska. Za nimi nasledujú študenti z Turecka, Francúzska a Talianska. "Najväčší počet zahraničných študentov bude študovať na Fakulte managementu UK, ale aj na Filozofickej fakulte a Právnickej fakulte," skonštatovala Ostatníková. Dodala, že v ostatných rokoch vidieť výrazný nárast študentov, ktorí prichádzajú študovať na Slovensko. Okrem študentov z krajín EU, do Bratislavy pricestovali aj študenti z Ukrajiny a Srbska v rámci rôznych projektov. Letný semester sa začína v pondelok 19. februára, dovtedy sa budú mladí ľudia zo zahraničia s krajinou zoznamovať a zvykať si na nové podmienky.

"Môj priateľ bol na Slovensku a páči sa mi váš jazyk," poveďala Cornelia z Viedne s tým, že sa chce slovenčinu aj naučiť. Podľa jej ďalších slov na Slovensku bola už pred troma rokmi na prázdninách. ,' Na UK prišiel študovať aj Sebastian z Nemecka, ktorý sa chce tiež naučiť niečo po slovensky a okrem štúdia chce aj cestovať. "Chcel som mať trošku viac času na cestovanie a spoznať Slovensko lepšie. Lákala ma aj Bratislava ako mesto a blízkosť Rakúska a Maďarska," uviedol Dávid z Českej republiky, ktorý prišiel študovať do Bratislavy geografiu. Slovensko si vybral na základe odporúčania kamaráta, ktorý študoval v hlavnom meste vlani.

"V zimnom semestri študovalo na UK 350 zahraničných študentov," povedala Ostatníková. Z nich zhruba sto zostáva v Bratislave na celý akademický rok. "Mnohí z tých, ktorí prídu k nám na jeden semester, si to rozmyslia a požiadajú aj o ďalší semester pobytu," vysvetlila prorektorka. Opačným smerom idú študenti z UK. V tomto akademickom roku je ich 600, najviac mladých ľudí do zahraničia vyslala Fakulta managementu.

Jediné, čo zatiaľ na Slovensku nie je dobré, je politika

Na to, aby sme posunuli krajinu dopredu, potrebujeme, aby politici brali svoje povolanie ako službu. Podniky na Slovensku nachádzajú najvyššiu kvalitu a najlepších ľudí, jediné, čo nie je dobré, je politika. Na utorkovom podujatí Forbes 30 pod 30 v Bratislave to zdôraznil prezident SR Andrej Kiska.

Podľa neho treba hovoriť o tom, aké chceme Slovensko v tom okruhu, na ktorý máme dosah. Ak chceme posunúť SR dopredu, politici by mali brať svoje povolanie ako službu a nebrali to ako svoju pozíciu pre získavanie moci, dodal.

Na otázku, či bude opäť kandidovať za prezidenta SR, priamo neodpovedal. "Určite spravím všetko pre to, čo je v mojich silách, aby bolo Slovensko krajinou, kde stojí za to žiť," deklaroval.

Na Slovensku podľa Kisku podniky nachádzajú najvyššiu kvalitu a najlepších ľudí. "Jediné, čo zatiaľ nemáme stále dobré, je, žiaľ, politika," poznamenal prezident. Krajina podľa neho musí byť viac v rukách ľudí, "nie v rukách zopár vyvolených".

"Každý jeden, kto chce zmeniť Slovensko, by mal začať s tou zmenou okolo seba," skonštatoval prezident s tým, že takýmto spôsobom sa môže SR posunúť. Pripomenul však, že Slovensko už úspešné je a za posledných 25 rokov má za sebou obrovský kus cesty.

Zahraničná politika nikdy nebola taká turbulentná ako v súčasnosti

Zahraničná politika nebola nikdy taká turbulentná, ako je teraz, a preto je potrebné hovoriť o veciach otvorene i kriticky. Uviedol to minister zahraničných vecí SR Miroslav Lajčák pri príležitosti Hodnotiacej konferencie zahraničnej a európskej politiky SR za rok 2017 v Bratislave.

Zdôraznil, že konferencia nesie názov hodnotiaca nielen preto, aby sme sa obzerali dozadu, ale aby sa Slovensko vedelo pripraviť do budúcnosti. "Hodnotíme hlavne preto, aby sme sa dokázali pripraviť na náročné obdobie. Viac ako kedykoľvek

predtým potrebujeme hovoriť realisticky, otvorene aj kriticky, keďže zahraničná politika nebola nikdy taká turbulentná," povedal Lajčák. "Svet nikdy nebol taký plný paradoxov ako dnes," doplnil.

Pripomenul tiež, že na jednej strane počet konfliktov vo svete klesá, na druhej strane však už siedmy rok sledujeme jeden z najhorších konfliktov v Sýrii. "Obliehanie Aleppa alebo východnej Ghúty trvá dlhšie než obliehanie Leningradu či Sarajeva," uviedol.

Upozornil tiež, že svet je v súčasnosti najbohatší v histórii, ale stále "mnoho ľudí žije pod hranicou chudoby".

Na 18. ročníku konferencie sa na paneli s názvom 25 rokov zahraničnej politiky SR zúčastnia aj bývalý minister medzinárodných vzťahov SR Pavol Demeš, bývalí ministri zahraničných vecí SR Pavol Hamžík a Eduard Kukan. Na konferencii sa bude hovoriť aj o prioritách slovenskej zahraničnej a európskej politiky či nástrojoch a komunikácii slovenskej zahraničnej a európskej politiky.

Americká zbrojovka prezentovala v Bratislave stíhačky F-16

Ponuku na nákup stíhacích lietadiel F-16 pre Slovenskú republiku prezentovali 10. apríla 2018 v Bratislave zástupcovia amerického zbrojárskeho a leteckého koncernu Lockheed Martin. Spresnili, že ak sa SR pre ich ponuku rozhodne, prvé stíhačky by mohli dodať koncom roka 2022.

Na Slovensku sa už dlho hovorí o potrebe vymeniť ruské stíhačky MiG-29 za flotilu modernejších bojových lietadiel. Jednou z možností sú stíhacie lietadlá F-16, verzia BLOCK 70, ktoré ponúkajú Spojené štáty a ďalšou možnosťou sú švédske stroje Gripen.

Predstaviteľ americkej zbrojovky Michael Kelley priblížil, že cena ponúkaných stíhačiek "bude konkurencieschopná švédskym gripenom a bude súčasťou celého balíka, ktorý zahŕňa výcvik i zbrane," no presnú sumu povedať nechcel, pretože o predaji sa stále rokuje.

Zástupca Lockheed Martin taktiež neuviedol presné náklady za letovú hodinu. Spresnil, že gripeny môžu mať na jednej strane náklady nižšie, no menšia bude v porovnaní s F-16 aj ich životnosť.

Termín dodania nebude skôr ako v roku 2022, dôležitá je príprava infraštruktúry na Slovensku. "Plánované dodanie je pred koncom roka 2022," spresnil Kelley s tým, že v tom čase by na Slovensko mali dodať prvé štyri stroje. Niektoré pre výcvik personálu ostanú v USA, dodal.

Ponuka by mala zahŕňať i tréningový program pilotov. "Keďže proces predaja je ešte len v procese riešenia, je ťažké stanoviť presný čas tréningu." Craig Dalle, bývalý pilot vzdušných síl USA, ktorý lietal na F-16-kach podľa vlastných skúseností to odhadol na tri roky. Zdôraznil, že dôležitý je aj výcyik technického personálu, ktorý bude vykonávať údržbu.

dôležitý je aj výcvik technického personálu, ktorý bude vykonávať údržbu. Stíhacie lietadlá F-16 BLOCK 70 má v súčasnosti v prevádzke 25 štátov, ku ktorým patrí napríklad Taliansko, Nórsko či Poľsko.

Nadzvukové lietadlá F-16 sú podľa Kelleyho "najúspešnejšie stíhačky na svete, čo je overené aj v bojových podmienkach". Tieto stíhacie lietadlá majú lepšiu dobu strehu vo vzduchu, vyššiu maximálnu nosnosť lietadla a taktiež dlhšiu životnosť, tvrdí predstaviteľ Lockheed Martin. "Modernizácia konštrukcie zaisťuje, že F-16 budú lietať minimálne do roku 2045".

Zdôraznil, že jednou z najväčších devíz týchto stíhačiek je radar typu AESA, ktorý ponúka lepší rozsah detekcie a umožňuje sledovanie viac ako 20 cieľov naraz. Rovnako je schopný snímať väčšie objemy dát a používa sa aj v lietadlách 5. generácie.

Kongres Spojených štátov amerických začal 4. apríla na základe požiadavky Ministerstva obrany SR s procesom schvaľovania ponuky na nákup stíhacích lietadiel F-16 pre Slovenskú republiku (tzv. Letter of Offer and Acceptance) v rámcovej sume 2,91 miliardy amerických dolárov

Slovenský rezort obrany vysvetlil, že finančná čiastka je navýšená o približne miliardu eur z dôvodu, aby sa v prípade ďalších potrieb objednávateľa nemusel opätovne realizovať proces schvaľovania.

Ministerstvo obrany SR zároveň upozornilo, že ak Kongres ponuku schváli, v žiadnom prípade to neznamená, že vedenie rezortu už rozhodlo o nákupe tohto typu stíhacích lietadiel. Slovensko kandiduje na predsedníctvo v Rade OECD

Slovensko chce byť v roku 2019 krajinou, ktorá na ministerskej úrovni predsedá Rade Organizácie pre hospodársku spoluprácu a rozvoj (OECD). Kandidatúru musí odobriť vláda, ktorá to má v programe stredajšej schôdze. V poradí tretia významná kandidatúra Slovenska za sebou je podľa ministerstva zahraničných vecí potvrdením záujmu byť aktívnou krajinou na medzinárodnej scéne.

OECD je prestížnou organizáciou, ktorá pravidelne vypracováva a publikuje odborné štúdie a ekonomické analýzy pomáhajúce realizovať reformy a politiky hospodárskeho rozvoja. Kandidatúra Slovenska na čele jej rady prichádza potom, ako SR v druhom polroku 2016 predsedalo v Rade EÚ a následne sa rozhodlo aj o predsedníctve SR v Organizácii pre bezpečnosť a spoluprácu v Európe (OBSE) v roku 2019.

Kabinet v stredu uskutoční i výmenu zástupcov štátu v Hospodárskej a sociálnej rade SR v súvislosti s rekonštrukciou vlády. Predsedom rady ostane minister práce Ján Richter (Smer-SD). Opúšťajú ju exministri Robert Kaliňák (Smer-SD), Lucia Žitňanská (Most-Híd) a bývalý podpredseda vlády pre investície a informatizáciu Peter Pellegrini (Smer-SD), ktorý sa stal premiérom. V rade ho nahradí podpredseda vlády Richard Raši (Smer-SD), pribudne v nej však i nový minister spravodlivosti Gábor Gál (Most-Híd).

Ministri budú mať na stole rad informačných správ. Ministerka kultúry Ľubica Laššáková (Smer-SD) predkladá štvrtú správu o používaní štátneho jazyka na území SR. Vláda jej uloží úlohu prijať opatrenia na zlepšenie úrovne ovládania štátneho jazyka v regionálnom školstve. Školskí inšpektori napríklad zistili, že na prvom stupni ZŠ s vyučovacím jazykom maďarským učitelia slovenčiny nedostatočne dbali na správnu výslovnosť. Ústny prejav bol u väčšiny žiakov jednoduchý, u niektorých sa prejavovala komunikačná bariéra.

Ministerstvo hospodárstva pripravuje druhý antibyrokratický balíček na zlepšenie podmienok pre podnikateľov na Slovensku. Uvádza sa to v Správe o stave podnikateľského prostredia v SR. Pri vypracovaní balíčka sa rezort opiera o viac ako 150 podnetov od podnikateľov a ministerstiev. V balíčku, ktorý chce rezort predložiť v priebehu druhého štvrťroka, chce reagovať aj na najnovšie výsledky ankety Byrokratický nezmysel za rok 2017. Opatrenia budú pokrývať predovšetkým oblasti elektronizácie, zjednodušovania procesov či získavania povolení a znižovanie byrokracie.

Na využívanie elektronických služieb štátu by nemusela byť potrebná takzvaná čítačka eID v takej miere, ako je tomu dnes. V informačnej správe o plnení Národnej koncepcie informatizácie verejnej správy na Slovensku to uvádza podpredseda vlády Richard Raši. Prihlasovanie a vyjadrovanie vôle pomocou eID čítačky označil za poslednú bariéru po tom, ako je od začiatku roka možné platiť kartou za elektronické služby verejnej správy. Na zjednodušení používania čítačky eID sa podľa správy "intenzívne pracuje".

Na podujatí sa zúčastnili študenti, profesori, predstavitelia diplomatického zboru, mimovládnych organizácii a think tankov a zástupcovia médií. V následnej diskusii sa zaujímali o politický vývoj na Slovensku, stav rokovaní o brexite, ale aj o modernizáciu ozbrojených síl a záväzok SR zvýšiť obranné výdavky.

Počas pracovnej návštevy Spojených štátov rokoval štátny tajomník s námestníkom Ministerstva zahraničných vecí USA pre Európu a euroázijské záležitosti Wessom Mitchellom. I. Korčok sa tiež stretol s predstaviteľmi Slovensko-americkej rady pre obchod a inovácie (SA-BIC) vo Washingtone, ktorej členmi sú významné slovenské a americké spoločnosti ako Honeywell, AT&T, ESET, Virtual Reality Media a Lockheed Martin. Predstaviteľov SABIC zaujímalo najmä vytvorenie konkrétnych príležitostí pre podporu rozvoja slovenských inovačných firiem a startupov v USA. Napokon sa I. Korčok stretol s predstaviteľmi viacerých popredných washingtonských think tankov ako Brookings Institution, Centre for European Policy Analysis a Atlantic Council.

"Slovensko a Spojené štáty sú strategickí partneri. Sme hodnotovo a ekonomicky prepojení," povedal štátny tajomník Ministerstva zahraničných vecí a európskych záležitostí SR Ivan Korčok 27. marca 2018 na pôde prestížnej americkej univerzity George Washington University. Na podujatí pod názvom "Talking EU and Transatlantic Relations" I. Korčok vyjadril jednoznačné presvedčenie, že Európsku úniu a Spojené štáty spája dlhá história úzkej spolupráce, ktorá bola dôležitá v minulosti, ale dnešný rozkolísaný svet ešte výraznejšie podčiarkuje jej nevyhnutnosť.

Vystúpenie štátneho tajomníka na univerzite sa symbolicky koná v deň 15. výročia od schválenia pristúpenia k Sveroatlantickej zmluve vládou SR (27. marca 2003). V tomto roku si tiež pripomíname viaceré výnimočné výročia: 25 rokov vzniku samostatného Slovenska a nadviazania diplomatických vzťahov medzi Slovenskou republikou a Spojenými štátmi, ako aj storočnicu založenia Československa. V tejto súvislosti I. Korčok vyzdvihol aktívnu úlohu Spojených štátov pri budovaní moderného a demokratického Slovenska od prezidenta W. Wilsona pri zakladaní spoločného štátu s Čechmi až po transformačnú pomoc po vzniku samostatného Slovenska. Cez jednoduché posolstvo "Európa celistvá, Európa slobodná a Európa mierová", si Spojené štáty zadefinovali obsah svojej misie v 90. rokoch na Slovensku a v celej strednej Európe. Podľa Korčoka však tento slogan nestratil význam ani dnes. Dnes je Slovensko plne integrované v euroatlantických štruktúrach. "Naša orientácia na Západ je náš slovenský záujem. Členstvo v EÚ a NATO posilňujú náš vplyv a postavenie vo svete," konštatoval I. Korčok.

Slovenskí biskupi podporili snahu verejnosti o slušnejšie Slovensko

V Nitre sa 11. apríla 2018 skončilo 89. plenárne zasadnutie Konferencie biskupov Slovenska (KBS), ktoré bolo spojené aj s plenárnym zasadaním Českej biskupskej konferencie (ČBK). Od 9. apríla sa na ňom zúčastňovalo 14 slovenských biskupov, ktorí sa spolu s českými hodnostármi zaoberali nielen vnútornými záležitosťami cirkvi, ale aj súčasnou vnútropolitickou situáciou v oboch krajinách.

Podpora snáh o spravodlivejšiu spoločnosť a boj proti korupcii sa dostali aj do spoločného záverečného vyhlásenia. "Spája nás spoločná minulosť, počas ktorej sme zápasili aj za náboženskú slobodu a občianske práva. Na útlak a obete mnohých kresťanov nesmieme zabudnúť. Táto skúsenosť nás naučila vážiť si slobodu, rozpoznať nové ideológie a brániť skutočné hodnoty. Poslušnosť voči evanjeliovým hodnotám nás vyzýva k zápasu o skutočne slušnú spravodlivú spoločnosť, v ktorej odmietame korupciu a nespravodlivosť a usilujeme sa o úctu a pomoc starým, chorým a cudzincom," konštatuje sa okrem iného vo vyhlásení.

Bratislavský arcibiskup a predseda KBS Stanislav Zvolenský potvrdil, že odpoveďou cirkvi na aktuálnu situáciu v spoločnosti je podpora celospoločenského hnutia, ktoré sa usiluje o slušné Slovensko. "Je to vyjadrené v našom vyhlásení, že sa usilujeme o slušné Slovensko i slušnú Českú republiku a, samozrejme, že na prvom mieste je to odmietnutie korupcie a podpora všetkých aktivít zameraných na to, aby sa miera korupcie znížila," povedal arcibiskup.
