




## St. Vincent Archabbey — Homily, Father Edward Mazich, O.S.B., Father Killian Loch, O.S.B.

#### July 14, 2019 – Fifteenth Sunday of Ordinary

Time Luke 10: 25 - 37

We know from reading the Gospels that the Pharisees and Scribes regularly looked for opportunities to test Jesus. Jesus would answer with the truth that originated from God, was expressed in the Scriptures, and was brought to fulfillment by Jesus, the Word made flesh. The antagonist in this



The first appears to be a very basic question, "Teacher, what must I do to inherit eternal life. There are many passages in the Old Testament that Jesus could have referred to, or he could have given

his own teaching. Had Jesus done this it was likely that the scholar would have turned his answer around and told the officials that Jesus said that other passages from the Law and Prophets are not important, thus, portraying Jesus as being unfaithful to the Law, and questioning his credibility as a teacher. Jesus' response is to ask the scholar what he thought; "What is written in the law?" The scholar knows that the foundation of the Mosaic Law is found in the book of Deuteronomy when Moses prepared the Israelites to enter into the Promised Land, and that all the laws can be summed up in Deuteronomy 6:5; "You shall love the Lord, you God, with all your heart, with all your being, with all your strength, and with all your mind, and your neighbor as yourself." Jesus agrees with him, for it is when we love God fully that we open our hearts to accept the unconditional love that God is pouring out to us, and in doing so we have a desire to do all we can to please God, including following his laws. It is in this relationship of love between God and us that we freely accept the gift of eternal life God desires us to have. From this love we are able, and many times challenged, to love our neighbor. To inherit everlasting life is to see and experience how much God loves us, and to return that love to God, and express it to our neighbor.

The scholar makes a second attempt to trip up Jesus by asking, "Who is my neighbor?" One such rivalry was between the Jews and the Samaritans. Jesus answers the scholar by telling him a parable we know as the "Good Samaritan." The only one who stopped to help the man who was robbed and beaten and left for dead was a Samaritan. At the time of Jesus Jews and Samaritans had nothing to do with one another. When Jesus finishes the parable he asks the Scholar, who was the victims neighbor? The Scholar couldn't get himself to say, "the Samaritan," rather he said, "the one who treated him with mercy."

Jesus makes a simple point: neighbor is not defined by geography, race, nationality, or the labels often used to define others. Our neighbor is anyone who is in need. The point is simple: the unconditional love God extends to all is the love we should strive to extend to one another. As simple as this is, we still struggle with accepting his clear teaching on this. It is as though we say; "Everyone is my neighbor, except – and then we list those we have difficulty with. Usually it is those who are poor and dispossessed. Those from different backgrounds, cultures and ethnicities. The immigrants and refugees that we try to justify in ignoring. Yet, Jesus does not include exceptions with this teaching. Instead, Jesus challenges us to look at people through his eyes, the eyes of unconditional love.

July 21, 2019 – 16th Sunday of the Year – 108

The gist of this Sunday's scripture readings is evident: the responsibility to show authentic hospitality to visitors is highlighted through two famous incidents, and a further lesson about the responsibility to exercise a sort of "spiritual hospitality" is drawn from these accounts.

First we encounter Abraham and Sarah dwelling by the "terebinth of Mamre," which was likely near Hebron, south of Jerusalem. Today, as in ancient times, the region of Hebron is not absolutely parched as much of the Judean desert is, but it is not nearly as fertile as certain nearby lands are, and so travelers passing through Hebron would be in great need of the hospitality of the local residents.

Three mysterious guests appear before elderly Abraham as he rests at the entrance to his tent at Mamre. One of the guests ap-

pears to be a man but turns out to be the Lord himself (Gen 18:1-2) and the two others also appear to be men but are actually angels (Gen 19:1). Later Christian tradition has at times seen the three figures as representing the Holy Trinity, as has been famously depicted in Christian art.

After proceeding through the elaborate rituals of near eastern hospitality—rituals which underline the important nature of offering welcome to all—one of the travelers predicted that Abraham and Sarah, both of whom were elderly, would have a child within a year's time. The prediction came true with the birth of Isaac, who carried on his father's line and was the bearer of the promises the Lord had made to Abraham (Gen 21:1-3).

It is interesting that Abraham and Sarah's actions of hospitality toward their visitors is followed by his intercession for Sodom and Gomorrah, recounted in detail in Genesis (Gen 18:16-33). Here Abraham, perhaps moved by the exercise of the virtue of welcoming the stranger, engages in a further virtuous action on behalf of others by praying that the residents of Sodom be spared from the Lord's judgment.

In the next chapter of Genesis, in a passage which is never read in Church, we hear how the citizens of Sodom grossly mistreated the same two travelers (angels) who had been welcomed by Abraham and Sarah earlier. By so violently disregarding their obligation to receive travelers hospitably they brought condemnation upon themselves, despite Abraham's intercession for them.

In the Gospel we find another example of hospitality being offered, this time by Martha and her sister Mary, and we note that this account of properly welcoming a guest—in this case, Jesus himself—is followed by a discourse from the Lord on prayer, much as the Genesis narrative on hospitality was followed by Abraham's prayerful intercession for Sodom.

The connection between welcoming others in a Christian manner and a prayerful disposition—we might call it "spiritual hospitality"—is a natural one; extending hospitality means opening oneself and giving of oneself generously, just as we open up to the Lord and give of ourselves through prayer, especially through prayerful intercession for others. Whether we take our lesson from Abraham and Sarah, who welcomed the Lord himself to their humble abode, or from busy Martha, who was trying as we often do to tend to every detail without losing sight of the point of her efforts, we should remember that there is an innate connection between hospitality and prayer.

Moved by today's scriptural lesson, let us resolve to show authentic hospitality both literally and spiritually through our intercession for others, that we too might be said to have "chosen the better part, and it will not be taken from us" (see Luke 10:42).

## FCSU Helped Celebrate 50th Anniversaries of Byzantine Catholic Eparchy & Metropolitan Church

Fifty years ago the Holy Father Pope Paul VI issued a decree on February 21, 1969, which elevated the Byzantine Catholic Church in America to the status of the Metropolitan Church. At the same time, the Byzantine Catholic Eparchy of Parma was created. To observe these dual anniversaries, a Divine Liturgy of Thanksgiving was celebrated the same weekend in June – in Parma, OH, at St. John the Baptist Byzantine Catholic Cathedral on Saturday, June 22, and in Munhall, PA, at St. John the Baptist Byzantine Catholic Church on Sunday, June 23, 2019. At each Mass, bishops and archbishops from across the country as well as from Slovakia and Rome gathered for the Liturgy and all attendees enjoyed a banquet afterward.



## First Catholic Slovak Union National Golf Tournament

Men's And Women's Official Rules and Regulations

1. The tournament is open to all members of the First Catholic Slovak Union (FCSU).

2. United States Golf Association (USGA) and host golf course rules will govern play. Improve your lie anywhere, except for hazards. Out of bounds shot, drop where ball went out and 1 stroke penalty

3. Handicaps will be determined as follows:

A. All golfers will compete as determined by handicap. The golfer's first handicap will be determined after he has completed 54 holes of play in the FCSU National Golf Tournament. The handicap will be recalculated each year based on 54 holes of FCSU National Tournament play. From the latest 5 rounds, the highest and the lowest will be discarded and 90% the average of the remainder will be the handicap assigned for the tournament. 90% of an official USGA handicap may be substituted if a golfer does not have an FCSU Tournament handicap. The maximum handicap will be 40 strokes for 18 holes.

B. Any golfer who has not completed 54 holes of tournament play in the FCSU National Golf Tournament will be entered in a separate division using the FCSU version of the Callaway scoring system.

C. Male golfers, competing in the 18-hole event, age 65 or over and with a handicap larger than 10 may use the forward tees.

4. Classifications:

A. A medal play champion will be determined in each of the following Divisions:

- 1. Men's A flight (0-10) 5. Women's Flight
- 2. Men's B flight (11-17) Callaway Flight
- 3. Men's C flight (17-30) 7. Senior Flight
- 4. Men's D flight (31 +)
- B. Winners will be determined by low net score in each flight after 36 holes of medal play.

5. The division between the men's A-D flights may be adjusted to equalize the flights. A second women's flight may be added if entries warrant such addition.

6. In case of tie for first place in any Flight, tie will be broken by match of cards using gross score starting on #1 handicap hole followed by #2 handicap hole, #3 handicap hole and so forth until the tie is broken.

7. All other ties will split the applicable prize money. (e.g., two people tied for second will split second and third place prize money. Three people tied for second would split second, third and fourth place prize money.)

8. The prize list will be determined by the tournament manager using the money contributed by the contestants and matching money contributed by the FCSU for all golfers. As nearly as possible, there will be one prize for each four entries.

9. The tournament manager will schedule pairings. Both Saturday and Sunday schedules will be e-mailed to participants prior to the tournament.



## **In Memoriam**

The last several months have been exceptionally difficult for me and my family. I received a phone call the evening of April 6, 2019 which started a series of events that will never be forgotten. My son-in-law called to inform me of the death of my 28-year-old daughter, Anna.

It was a blessing that my Director of Lay Mission-Helper, Association, Janice England, was in Ghana visiting SAGISS, the High School at which my fellow missionary, Diane Yongo and I serve. Diane and Janice were of great support. Janice immediately started to schedule my travels back to Pennsylvania, while Diane's arms were there to hold me as the tears flew.

Support from the entire Diocese of Damango was immeasurable. The very morning after the call, Bishop Peter Paul, and Head Mistress Pauline arrived at my home. Condolences were given and the rosary, one of the most cherished prayers of the Catholic Church, was recited. Later teachers arrived to give their condolences and sit with me in silence. The girls at SAGISS seemed a bit uncomfortable in showing their feelings, not knowing how to act, but those whom I associated with on a more personal level were very supportive. I felt the love of the entire school around me.

The first two weeks back in the United States was a blur. My sister, Barbara Spencer, stepped in even before my plane landed in Pittsburgh and started arrangements for the Memorial Service. The Mass, celebrated by Father John Sedlak at St. Florian Church, United, PA was beautiful. My sister read letters from her two daughters, Anna's cousins with whom she spent her entire childhood. The eulogy was given by me. I felt it important that those attending hear what a beautiful, creative, intelligent and talented woman my daughter had become. I also felt it important that everyone know how hard Anna fought, but lost, her battle with mental illness, a disease that can affect anyone, no matter how smart, talented or beautiful they may be. Anna's suffering was unbearable, therefore I asked the congregation to pray with me that Anna be comforted in Mary's arms while she waits to meet or Lord and savior, Jesus Christ.

Many asked of me "Now what, are you going back to Africa?" My response was a definite "Yes, I am going home." In a few short months, Saint Anne's Girl's High School in Damango, Ghana, had become my home. I missed the girls. I missed them running after me as I leave my office for the day asking to carry my purse and computer case. I missed attending Mass with them every Tuesday and Friday morning, watching as the sway, clap and sing to the beat of the drums. I missed the goats and pigs walking with me every morning as I trekked to the office. I missed going to town and having the children run up to shake my hand, and the young boys wanting to carry my bags, never accepting the coins I try to give them for their assistance. I missed the smiles from the vendors when I buy their bread, apples, onions or garlic.

On Sunday, May 12, 2019, Mother's Day, I left for my trip back to St. Anne's in Damango, Ghana, Africa. I couldn't wait to be HOME!

## Dr. Milan Rastislav Štefánik: The 100th Anniversary of his Tragic Death: Part II

May 4th 2019 marked the 100th anniversary of the tragic death of one of the founding fathers of the first Czecho-Slovak Republic, General Milan Štefánik. He perished in a terrible plane crash in 1919 that claimed his life and that of his two Italian crewmates. To this day, Štefánik is considered one of the most important individuals in the history of the Slovak nation and its people, even though he died at the relatively young age of 38. To the point, without his hard work and connections, Czecho-Slovakia might never have existed.

[Editor's Note: above, the opening remarks of Dr. Kopanic's speech "Dr. Milan Rastislav Štefánik: The 100th Anniversary of his Tragic Death" which was delivered on May 19, 2019, at the Slovak League of America dinner commemorating this historic event. What follows is Part II of that speech]

#### Štefánik's Personality

Who was Štefánik? What sort of man was he? What was his personality like? Why do many Slovaks consider him the one who exerted the most impact on their history?

Current Slovak Prime Minister Peter Pellegrini believes that Slovakia today could use a dose of inspiration from Štefánik, for he never allowed his poor health and recurring failures to stop him from moving forward to achieving his goals. "Whenever he fell, he raised again and again, and kept fighting relentlessly. His will prevailed over his weaknesses."

Without reservation, one can say that Milan Štefánik did more than any other Slovak to make the state of Czecho-Slovak a possibility as the Austro-Hungarian Empire was crumbling. One can very well argue that without his active assistance, the First Czecho-Slovak Republic would not have ever existed.

When most of us think of legendary national leaders, we think of tall, strong and even handsome men with an affluent background. Štefánik was just the opposite; he was short (5.38 feet. or 1.64 meters), had a pockmarked face (from suffering a severe case of small pox as a child), and started becoming bald from the time he was a child. That is why you usually see him portrayed wearing a cap in a smartly attractive French army uniform!

He was also somewhat frail and ill for much of his life, suffering from a severe stomach disorder. Over the course of his life, he underwent a series of operations.

The many huge statues erected to him and the photos that one sees do not reflect his real appearance.

An April 2019 conference at the University Library in Bratislava entitled Veľký malý muž, The Big Little Man, reflected this reality.

Ironically, despite his looks, he was also somewhat of a ladies' man, and would acquire a vaulted reputation among prominent young French ladies. While in the hospital, he flattered beautiful and wealthy influential women. One Czech author went so far as to say that he had as many as 100 girlfriends over the years and termed him "Erotoman" (The Erotic Man). It was hardly an accident that he would later become engaged to the young and ravishingly beautiful Italian, 18 year-old Baroness Giuliana Benzoni.

His love life aside, Štefánik possessed a brilliant mind, an engaging personality, an authoritative manner, and a skill for making friends among influential people. Without a doubt, he was the most influential Slovak in

the world during World War I.

Historian Dušan Kováč has called "Štefánik "mužom železnej vole" (a man of iron will) who dedicated his life and all his strength to the struggle for the liberation of the Slovaks and Czechs and the creation of a common state. His lifelong motto stated: 'Ja sa prebijem, pretože sa prebiť chcem' (I will prevail, because I want to prevail.).

Political theologian Michal Havran termed Štefánik "the first true Slovak European." Despite his humble origins, he became a man of education and intellectual curiosity. Havran goes as far as to say that he single-handedly tried to "modernize Slovak thought."

Despite all this praise, this presentation is not intended to be a hagiography (a saint's bioigraphy), but rather a realistic portrait of a man who changed history. A human being, he had unique qualities and foibles as well. Unlike most Slovaks, he was not a religious man, and belonged to the Masons, a secret free-thinking society which many founding fathers of the USA also belonged to, such as George Washington.

The recent studies of primary sources by historian Michal Kšiňan has shed new light on the character of Štefánik. In addition to being a great leader, a tireless worker, and a man who knew how to make connections with people in the upper echelons of society, Štefánik was also somewhat stubborn and intolerant of what he viewed as ignorant and dishonest. Yet he did have the skill and tact to know when to compromise.

Štefánik evolved and he became more secular over time. Though from a family of a Lutheran priest and a devout believer in early life, university studies in Prague changed him. Confronted with new modern views on faith and religion, his perception of the role of the Church and faith changed. One of Štefánik's closest wartime friends, General Maurice Janin, described him as "an agnostic, a man not denying the existence of God, but denying the opportunity to prove it."

All this aside, let us look at his life's background and achievements.

#### Background

Milan Rastislav Štefánik (1880-1919) lived a full and active life, and lived abroad for half of it. A truly Renaissance man, he pursued a variety of interests – first as student, then as an astronomer, international traveler, and photographer. And during the Great War (World War I), he served as a skilled pilot, a brave soldier, and an effective diplomat and politician.

He spearheaded the formation and training of the Czecho-Slovak Legion, which fought for independence from Austria-Hungary. As the vice-president of the Czecho-Slovak National Council (in exile), he used his contacts in high diplomatic circles to influence Allied governments to support Czecho-Slovak independence. Though appointed Minister of War in the new Czecho-Slovak government, he never had the chance to assist his new country due to the 1919 airplane crash.

To the end, he worked tirelessly at science and for the causes he believed in. He lived by his personal motto: (veriť, milovať, pracovať) "To Believe, To Love, To Work".

#### Early Life

Born in Košariská on July 21, 1880, Milan Rastislav was sixth of 12 children of a Lutheran preacher, Pavel Štefánik and Albertína (Jurenková). He was the sixth child in a large family of 12 siblings. Today the village houses a museum in his honor, and humongous Memorial at his Tomb on Bradlo Mountain towers over the valley below. It is hallowed ground for all Slovaks.

Stefánik was a born learner with a great curiosity to explore the world and understand. He was a star student and attended schools in Hungary, where he was compelled to study in the Magyar language.

In one unsavory incident while in school at Sarvaš in 1896, Hungary was celebrating its millennium of existence as a state. A group of inebriated Magyar classmates, familiar with Štefánik's Slovak patriotism, tried to compel him to praise Louis Kossuth, the leader of the 1848 Revolution who promoted the Magyarization of other nationalities. When Milan refused, they grabbed his arms and feet and held him head-first over the rail of a balcony. They demanded that Milan cry out "Éljen!" (Hurray!). Ironically, Milan got scolded for his lack of Hungarian patriotism. But the incident stuck with him all his life and further fired up his Slovak nationalism.

For this reason, in 1898, he continued his studies in Bohemia. He first majored in construction engineering at the Czech Technical University in Prague, and then transferred to Charles University, where majored in mathematics and attended lectures on astronomy, physics, optics, and philosophy. He also spent the summer 1902 at the university in Zürich.

During his university studies, he attended continued on page 21

lectures by Tomáš Garrigue Masaryk, the future first president of Czechoslovakia. Masaryk inspired Štefánik to consider the future cooperation of Czechs and Slovaks, and would influence his activism in later promoting the creation of an independent Czecho-Slovakia.

Active in the Slovak student association, Detvan, Štefánik promoted Slovak culture, poetry, and folk songs. Here he also met the politician Vavro Šrobár, the future minister for Slovakia after independence. While Štefánik had some conflicts in the club, he learned to compromise and went on to become its president. He published articles to promote awareness of the dire situation of Slovaks pressured by Magyarization.

Štefánik graduated in 1904 with a doctorate in philosophy and wrote a thesis on astronomy based on the observations of Danish scientist Tycho Brahe.

#### Fallout with his father

Starting in 1900, Štefánik's changing religious beliefs resulted in a serious dispute with his father, a devout, conservative Lutheran pastor. Ján Juríček's popular biography on Štefánik points out that the conflict concerned religious more than national issues. Štefánik disagreed with the approach of the majority of Slovak intellectuals from the Martin school, who engaged in passive resistance against Magyarization. Influenced by Masaryk and Hlasists in Prague, Milan preferred a strategic alliance with the Czechs as the best way to preserve the Slovak identity.

He also diverged from the dogmatic traditional Christian stance of his father Pavel. Milan rejected belief in the divine nature of Jesus, and even doubted the existence of God. He came to think that religion put man and science in a straightjacket. His father regarded such thinking as heretical, and threw the young rebel out of his house.

As a result, after graduation, Milan moved to Ružomberok and barely managed to scrape by. On the suggestion of his Czech professor, Štefánik wished to travel to France in 1904 to pursue his passion -- astronomy.

#### France

In 1904, Štefánik arrived in Paris with just a suitcase and his desire to pursue his dreams. He did not know French, had little money, and lived precariously. His old friend from his Prague student days, Šrobár, helped get him a loan from a Ružomberok bank so he could stay in Paris.

Štefánik wished to work with, Pierre Janssen, was one of the cofounders of astrophysics and director of the Meudon Observatory on Mount Blanc. Janssen took on Štefánik as an assistant, and the young man became a mountain climber who studied the Moon, Venus, and Mars. As he published his research, he won several awards, including the Prix Jules Janssen, the top award of the French astronomical society.

When Professor Janssen died in late 1907, Štefánik lost his sponsor, mentor, and his position. He lived precariously, borrowing money to make ends meet. His largely self-financed missions sent him to Algeria, the Sahara Desert, Morocco, Turkistan, Russia, India, the United States, Panama, Brazil, Ecuador, Australia, New Zealand, Tahiti (where he observed Halley's Comet), the Fiji Islands, and Tonga. He even engaged in a lively conversation with the novelist Leo Tolstoy in 1907. When he became a French citizen in 1912, it was mainly to obtain funding

denied to non-citizens. Partially subsidizing his research, French authorities sent him on diplomatic missions across the globe

According to Kšiňan, the majority of Stefanik's planned projects did not succeed for various reasons, including overcast weather and inadequate funding. Still despite many setbacks, Stefánik pressed on and received numerous acclaims for his work in astrophysics and solar physics.

Stefánik maintained a close relationship to his Slovak homeland, and often made trips home between his travels. His final trip home was for his father's funeral in 1913, and the two had reconciled their opposing views somewhat before his father's death. But his heart always yearned to help his homeland, and World War I would provide that opportunity.

#### The Great War

The outbreak of War in 1914 interrupted Štefánik's career in astronomy. He scurried back to France to join the army. Starting at the rank of private, he flew reconnaissance missions in northeast France near Arras, and established the foundations of military weather-forecasting. He continually rose in rank, and was eventually awarded the rank of Brigadier General in the French army.

A new Austro-Hungarian offensive against Serbia in 1915 sent him to the Balkans, where he flew 30 missions for the Serbs. Surviving a plane crash, a seriously injured Štefánik made a hasty retreat march toward the Adriatic Sea. He might not have survived without the assistance of his friend Louis Paulhan, who is credited with undertaking the world's first airplane "medevac" evacuation. Štefánik was rushed to a Rome hospital where he underwent a stomach operation.

#### The Making of a State for Czechs and Slovaks

Though never fully recovered from his crash, Štefánik returned to France, where he found his new vocation – working with Masaryk and Edvard Beneš to promote the cause of an independent Czechoslovakia to

the Allies. He introduced them both to influential people in French circles, including the Prime Minister. This would ultimately lead to official recognition of the Czechoslovak National Council and an autonomous Czechoslovak Legion.

Once healthy enough, he resumed a busy schedule, visiting Russia, Italy and Romania to organize the Legion, raise morale among troops, and engage in diplomacy with host countries. In July 1917, Štefánik attempted to recruit Czech and Slovak compatriots in the USA, and successfully secured the backing of Washington officials. He also visited New York and Chicago to deliver recruitment speeches for the Czechoslovak Legion. Here in New York, he came in contact with members of the Slovak League of America where he discussed the role of Slovaks in the proposed state. He also met with Roman Catholic priests to assuage their concerns about religious freedom in Czecho-Slovakia.

Although he only initially managed to get about 500 volunteers, eventually that number would swell to 2,000. Apparently, American citizens preferred joining the US Army since it paid a much better wage.

The efforts of Masaryk, Beneš, and Štefánik, as the Allies finally recognized creation of Czecho-Slovakia to become a new state in 1918,

But troubles were brewing beneath the surface among the triumvirate. Beneš envied the success of a soldier in a perfectly fitting elegant uniform of a French Army General. Small of stature, Beneš had an unusually high pitched voice that resembled a bank clerk; he perceived Štefánik as a threat to his position and sought to gain Masaryk's favor. Štefánik believed that he deserved a better position than Beneš, and hidden jealousy boiled beneath the surface of gentlemen's respect.

Their personality conflicts came to a head when the two engaged in a heated argument before Štefánik's last departure from France. Štefánik also threatened Beneš personally because he intended to take him to court for allegedly embezzling money from expatriate collections, i.e, from money donated by American Slovaks and Czechs! Štefánik claimed he had evidence that Beneš had lost \$100,000 gambling in Monte Carlo. The two also had major disagreements about foreign orientation of the new state, including relations with France, Italy, and Bolshevik Russia.

While Štefánik was in Russia to straighten out problems of the Czechoslovak Legion in Siberia, Masaryk and Beneš appointed new ministers for the new country. Surprisingly, Štefánik did not receive an appointment that reflected his importance. He was to head the Ministry of War, which organized the Czecho-Slovak Army abroad, but the Czech Václav Klofáč was selected as Minister of Defense, with supervision of all the armed forces in the new country. His old friend Šrobár became the chief minister for Slovak affairs.

French journalist Louise Weiss, who was Štefánik's former girlfriend, stated quite bluntly that Beneš could not stand Štefánik. He referred to him as "a peasant impersonating an aristocrat." In addition, Beneš wrote a note to Masaryk saying, ""I had a conflict with Štefánik. Everything is over between us. I mean absolutely."

#### Death of a Fighter

Before returning to Slovakia, Štefánik visited his Italian fiancée Giuliana Benzoni, and set a wedding date for June 6. To avoid the Austria he detested, he decided to fly home. He borrowed a Caproni airplane and set off with two Italian pilots. Just as they were trying a second landing attempt, the plane crashed near Ivanka pri Dunaji on May 4, 1919, killing all aboard.

Mystery shrouds the reasons for the crash, but the weather was not a factor as Prague claimed. Some posited that the plane was shot down because it was mistaken for a Hungarian plane. Others have cited a possible mechanical failure of radio wires getting tangled in the control cables. Given Štefánik's weak health, it was also possible that he fainted and fell on the controls. Other conspiratorial writers even accused the Czechs of shooting down the plane to minimize Slovak influence in the new state.

Slovak historian Ivan Kamenec believes that the very idea that Czechoslovak officials ordered the plane to be shot down does not make sense. While Masaryk and Beneš may have disagreed with Štefánik on a number of issues, ordering his assassination was "just not their style."

An Italian eyewitness, First Lieutenant Martinelli-Scotti, noticed the cooling water was leaking, overheating of the engines and causing them to explode. Most historians seem to concur with this explanation, though the precise cause may never be clear. Oddly, the official investigation did not take place until seven years later. By then, the eyewitnesses had either mysteriously passed away or were shipped abroad to some foreign posts.

Interestingly, no government official was on hand to greet Štefánik. Even more inexplicable, neither Masaryk nor Beneš nor his old friend, Vavro Šrobár, the Minister Plenipotentiary of Slovakia, the highest ranking post in Slovakia. Why?

Fate had dealt a terrible blow, for no one possessed the talent, skill, energy, and dedication which Štefánik had displayed in promoting the cause independence for Czecho-Slovakia. The nation was in mourning.

#### Annuity Rates:

The President led a review of the current annuity rates. It was decided the rates remain the same and be reviewed at the next Executive Committee meeting in June.

#### SALES AND MARKETING:

The Vice President gave a production report on our agents to the Executive Committee. He stated we are still recruiting and adding new agents, and at present have over 300 agents. The Home Office is sending the independent agents monthly updates on our products. The independent agents are also in frequent contact with Andrew P. Rajec, Director of Independent Agents. The Home Office continues an extensive Facebook ad recruiting campaign to recruit agents in the states we are licensed in.

The Executive Secretary stated that the Home Office is working with our marketing firm to develop new seminar presentations.

The Executive Secretary reminded the Executive Committee that we are required to use the new 2017 CSO starting 1/1/2020. This will involve a complete review of all our products and repricing done by our actuary and to be filed with the 27 states we are licensed in for approval. Once this is completed we will be required to update all our marketing materials and illustration software. We are reviewing proposals from two current vendors.

The Executive Secretary gave an update on the referral program for recommenders. He plans to send out information to all branch officers in August and have this program available September 1, 2019.

**Bratislava** - Komunikácia je veľké, ale zvládnuteľné umenie. Učiť sa komunikovať je potrebné už od mladého veku. Nedávno to uviedol na tlačovej konferencii v Bratislave poslanec Národnej rady SR Karol Farkašovský (SNS), ktorý stojí za myšlienkou zavedenia komunikačnej výchovy do škôl a vzdelávacieho systému. Podľa Farkašovského celospoločenským cieľom projektu je kultivovať medziľudské vzťahy nielen na úrovni pedagóg – žiak, ale aj v tom najširšom kontexte. Farkašovský tvrdí, že komunikáciu je potrebné učiť sa počas celého života, ale základ musí človek dostať práve v školách.

**Bratislava** - Minister obrany Peter Gajdoš (SNS) odcestoval do Francúzska. Zúčastnil sa na 61. medzinárodnej vojenskej púti v Lurdoch. Spolu s ním odcestovala aj ministerka vnútra Denisa Saková (Smer-SD) a viacero vojenských predstaviteľov. Ministri sa podvečer zúčastnili na otváracom ceremoniáli v podzemnej Bazilike sv. Pia X. Počas dňa ich čakala prehliadka viacerých miest, napríklad jaskyne Zjavenia či Múzea sv. Bernadety. Absolvovali aj spoločnú omšu v slovenskom jazyku, ktorú celebroval vojenský ordinár František Rábek.

**Bratislava** - Ministerka zdravotníctva Andrea Kalavská (nominantka Smeru-SD) absolvuje osobný rozhovor s generálnym riaditeľom Univerzitnej nemocnice Louisa Pasteura (UNLP) v Košiciach, v ktorej pacient zomrel po nesprávne podanej transfúzii krvi. Uviedla to po rokovaní vlády.

**Bratislava** – Migrácia ako existenciálna hrozba pre strednú Európu je najčastejší naratív, s ktorým na Slovensku, v Českej republike a Maďarsku pracujú pred voľbami do Európskeho parlamentu (EP) dezinformačné stránky na sociálnej sieti. Na tlačovej konferencii na to poukázali zástupcovia mimovládnej organizácie Globsec, vychádzali pritom z monitoringu kampaní, ktoré zverejňujú kanály považované za zdroje dezinformácií

**Piešťany** - Súčasťou tohtoročného otvorenia Letnej kúpeľnej sezóny v Piešťanoch bude prvýkrát aj možnosť nazrieť do kuchyne výroby piešťanského bahna. Slovenské liečebné kúpele Piešťany (SLKP), a. s., otvoria svoje zázemie pre verejnosť, ktorá si bude môcť pozrieť, čo všetko sa deje, kým sa kúpeľný hosť môže dať zabaliť do bahenného zábalu. Návštevníci uvidia miesto ťažby, dozvedia, kde sa bahno pripravuje, prečo je unikátne a klientmi z celého sveta vyhľadávané, pozrú si tiež, odkiaľ kúpele čerpajú termálnu minerálnu vodu, cestu, ktorou prejde až ku zákazníkom. Sprievodcovia porozprávajú, ako sa vyvíjali terapie, prečo majú SLKP bahnisko.

**Bratislava** – Ministerka zdravotníctva (MZ) SR Andrea Kalavská (nominantka Smeru-SD) tvrdí, že nový CT prístroj v Národnom ústave srdcovo-cievnych chorôb (NÚSCH) je jeden z najšpičkovejších v Európe. Nové CT podľa nej zlepší diagnostiku a skráti čakanie pacientov.

**Bratislava** – Majstrovstvá sveta v ľadovom hokeji boli v Bratislave bez závažných narušení verejného poriadku, či iných foriem trestnej činnosti. Informuje o tom Krajské riaditeľstvo Policajného zboru v Bratislave na sociálnej sieti. Počas už uplynulého hokejového šampionátu zaznamenali policajti len na bratislavskom zimnom štadióne, v jeho okolí a vo fanzóne viac ako 100 udalostí.

**Bratislava/Lány** - Slovenský prezident Andrej Kiska absolvoval na zámku v stredočeských Lánoch schôdzku s prezidentom ČR Milošom Zemanom. Do Lánov Kiska pricestoval v rámci rozlúčkovej návštevy Česka pred koncom svojho mandátu, informoval spravodajský server Novinky.cz. "Budeš mi chýbať, Andrej," rozlúčil sa Zeman s Kiskom. Zdôraznil pritom, že aj napriek občasným názorovým rozdielom si s dosluhujúcim slovenským prezidentom dôverovali a nevystupovali proti sebe. Kiska po stretnutí ocenil vzájomné vzťahy oboch krajín.

**Bratislava** - Nastupujúca prezidentka SR Zuzana Čaputová chce viac spolupracovať s menšinami, čo tvrdila aj počas predvolebnej kampane. "Zakladám novú tradíciu a rozhodla som sa prizvať k spolupráci aj zástupcov a zástupkyne národnostných menšín a odborníčku pre oblasť nových menšín a menšinových práv," uviedla na sociálnej sieti. S expertným poradným výborom sa podľa vlastného vyjadrenia bude pravidelne stretávať.

**Bratislava** - Mestom kultúry 2020 sa stali Nové Zámky. Rozhodla o tom hodnotiaca komisia Fondu na podporu umenia (FPU verejnej prezentácii projektov 7. júna 2019 troch finálových miest, ktoré sa o titul a s ním spojenú podporu uchádzali.

**Banská Bystrica** – Exprezident Andrej Kiska nedávno oficiálne oznámil založenie novej politickej strany, ktorá sa bude volať Za ľudí. Urobil tak na tlačovej konferencii v Banskej Bystrici. V prípravnom výbore sú s ním bývalá europoslankyňa Jana Žitňanská, exhovorca iniciatívy Za slušné Slovensko Juraj Šeliga, bývalá štátna tajomníčka ministerstva spravodlivosti Mária Kolíková a poradca exprezidenta pre vnútornú politiku Michal Luciak.

**Spišské Podhradie** – Po lokálnej povodni vyhlásili v Spišskom Podhradí v nedeľu 16. 6. mimoriadnu situáciu. Primátor mesta Michal Kapusta potvrdil, že lokalitu najprv podvečer zasiahla veterná smršť, následkom čoho popadalo viacero stromov a zatarasilo cesty 2., 3. triedy i miestne komunikácie. Následne prišla prietrž a vytopilo nám asi 50 nehnuteľností, vrátane rodinných domov, bytových aj nebytových priestorov a dva mestské bytové domy. V dôsledku nahromadenej vody sa zosunul aj približne 70 metrov dlhý úsek cesty aj s chodníkom na Galovej ulici. Autom sa tam v súčasnosti nedá prejsť. Rodinné domy vytopilo v štyroch lokalitách, kde sa nahromadilo najviac vody.

**Bratislava** - Pomôcť v obnove národných kultúrnych pamiatok na Slovensku by mal aj rozvoj tradičných stavebných remesiel. Naznačuje to Ministerstvo kultúry (MK) SR v Koncepcii stratégie rozvoja miestnej a regionálnej kultúry a kultúry národnostných menšín Slovenskej republiky do roku 2030, momentálne predloženej v medzirezortnom pripomienkovom konaní.

**Praha/Bratislava** - Vo svojom sídle na Pražskom hrade privítal 20. júna 2019 predpoludním český prezident Miloš Zeman prezidentku SR Zuzanu Čaputovú. Slovenská hlava štátu je na svojej prvej oficiálnej zahraničnej návšteve, ktorá sa podľa tradície koná v Českej republike. Po privítaní a osobnom rozhovore oboch prezidentov sa Zeman i Čaputová zúčastnia na plenárnom rokovaní delegácií, čaká ich spoločný obed i tlačová konferencia. Slovenská prezidentka sa stretne i s predsedom Senátu Parlamentu Českej republiky Jaroslavom Kuberom a s predsedom Poslaneckej snemovne Parlamentu Českej republiky Radkom Vondráčkom.

**Praha/Bratislava** - Český dom v Bratislave má byť realitou do konca roka 2019. Na spoločnom brífingu to potvrdili prezidenti Slovenskej a Českej republiky Zuzana Čaputová a Miloš Zeman. Čaputová pripomenula slová predsedu vlády SR Petra Pellegriniho, že ostáva vyriešiť len technické záležitosti. Zeman plánuje na otvorenie Českého domu pozvať aj Čaputovej predchodcu Andreja Kisku.

rozlišovať medzi dobrým a zlým - a to práve preto, aby vedel správne viesť svoj ľud. Boh na Šalamúnovu prosbu odpovedal darom múdreho a rozvážneho srdca. A z dejín vieme, že práve obdobie Šalamúnovho kráľovstva bolo výnimočným časom pokoja a požehnania, obdobím mieru a zlepšenia vzťahov s okolitými národmi. To všetko vďaka pokore dobrého kráľa, ktorý nebažil po moci ani po majetku, ale z Božej milosti sa učil rozvíjať múdrosť srdca.

V tomto duchu sme prosili aj v responzóriovom žalme: "Nauč nás, Pane, rátať naše dni, aby sme získali múdre srdce." Aby sme pamätali na to, že sme tu len do času, že počet našich dní nie je nekonečný, a raz sa budeme musieť zodpovedať pred naším Stvoriteľom. Toto pripomenutie, toto "počítanie dní" nám pomáha, keď chceme robiť rozvážne rozhodnutia, a múdro viesť aj ostatných.

Štedrým darcom púdrosti a ďalších darov je Boží Duch Svätý, o ktorého príchod a pomoc sme prosili v speve na začiatku našej slávnosti. A práve zoslanie Ducha Svätého na 50. deň po Veľkej noci sme oslávili aj v liturgii v našich chrámoch minulú nedeľu. Svätý Otec František pri tej príležitosti vo Vatikáne predniesol krásnu homíliu, z ktorej krátky úryvok by som rád ponúkol aj na tomto mieste.

Pápež František sa zamyslel nad rôznorodosťou, ktorá preniká náš svet, avšak pre Ducha Svätého nepredstavuje prekážku, keď dáva veci do súladu a vytvára obdivuhodnú harmóniu. Tento súlad a spájanie je dielom jeho múdrosti, a my ľudia sme pozvaní s Duchom spolupracovať: nenechať sa pomýliť, ani znechutiť tým, keď naokolo vidíme množstvo rozličnej disharmónie.

"V dnešnom svete sa disharmónie stali skutočnými rozdeleniami," podotýka Svätý Otec a dodáva: "Sú takí, čo majú priveľa, a takí, čo nemajú nič. Sú takí, čo chcú žiť sto rokov, a takí, čo sa nemôžu ani len narodiť. V čase počítačov sme si vzdialenejší: stali sme sa viac "social", ale menej sociálni. Preto potrebujeme Ducha jednoty, aby nás znovuzrodil: ako Cirkev, Boží ľud, aj ako celé ľudstvo."

"Veľmi často sa ľudia snažia definovať svoju identitu proti niekomu alebo proti niečomu," hovorí pápež František, a môžeme k tomu s trpkosťou skonštatovať, že tento postup je stále častejší nielen v politickom, ale aj v spoločenskom a kultúrnom živote. "Boží Duch Svätý, naopak, spája rozdelených, privádza bližšie vzdialených... pretože vidí na prvom mieste dobro: pozerá skôr na človeka, než na jeho chyby."

"Možno povedať, že žijeme v kultúre adjektív, prídavných mien, ktorá zabúda na substantíva, teda na podstatné mená," podčiarkuje pápež - a pritom si môžeme uvedomiť, že už náš jazyk nám tu pripomína, čo by malo byť podstatné. "Dnes je v móde adjektivizovať," pokračuje, sústrediť sa na prídavné mená, "a žiaľ aj urážať. Žijeme v kultúre urážok, ktoré sú prvou odpoveďou na názory odlišné od našich."

"Až neskôr si uvedomíme, že to škodí – a nielen tomu, kto je urážaný, ale aj tomu, kto uráža. Keď sa zlo odpláca zlom, z obetí sa stávajú páchatelia - a nežijeme dobre. Naopak, kto žije podľa Božieho Ducha Svätého, prináša pokoj tam, kde je nesúlad, porozumenie tam, kde sú konflitky. Duchovní ľudia oplácajú zlo dobrom, na aroganciu odpovedajú miernosťou, na hurhaj tichom, na ohováranie modlitbou, na pesimizmus úsmevom."

"Aby sme boli duchovní, aby sme zažili harmóniu Ducha Svätého, potrebujeme jeho pohľad posunúť pred ten náš," hovorí František. "Potom sa veci zmenia! Boží Duch Svätý stvárňuje Cirkev, stvárňuje svet ako miesto pre synov a dcéry, pre bratov a sestry: to sú substantíva, podstatné mená, ktoré majú prednosť pred akýmkoľvek adjektívom." ## Ešte v tomto roku by mohla byť prijatá novela volebného zákona

Novela volebného zákona umožňujúca Slovákom v zahraničí voliť v budúcich prezidentských voľbách aj na zastupiteľských úradoch SR by mohla byť prijatá ešte počas roka 2019. Prezidentka SR Zuzana Čaputová to naznačila na tlačovom brífingu 20. júna 2019 počas svojej oficiálnej návštevy Českej republiky.

"Plne sa stotožňujem s tým, že občania SR žijúci v zahraničí by mali mať právo voliť v prezidentských voľbách bez toho, aby museli cestovať na Slovensko," uviedla Čaputová. S myšlienkou umožniť legislatívnou úpravou voľbu na zastupiteľských úradoch v zahraničí sa podľa nej stotožňuje aj predseda vlády SR Peter Pellegrini. "Zhodli sme sa, že takáto zmena je zmysluplná, a dokonca pán premiér vyjadril presvedčenie, že ešte počas tohto kalendárneho roka by takáto zmena právnej úpravy mohla byť prijatá v parlamente," dodala.

Na svojej prvej oficiálnej zahraničnej návšteve, ktorá podľa tradície mierila do Českej republiky, má nová slovenská prezidentka za sebou stretnutie so svojím náprotivkom, prezidentom ČR Milošom Zemanom. Čaputová sa v rámci programu stretne tiež s predsedom Senátu Parlamentu Českej republiky Jaroslavom Kuberom a s predsedom Poslaneckej snemovne Parlamentu Českej republiky Radkom Vondráčkom.

Prezidentka SR v Prahe tiež položila vence k soche generála Milana Rastislava Štefánika, kyticu prinesie na hrob prezidenta Václava Havla. Stretne sa i s krajanmi a zúčastní sa na koncerte, ktorý pod názvom "Zuzana není sama doma" na jej počesť odohrajú slovenskí i českí hudobníci, napríklad Dan Bárta, Jiří Stivín či Dorota Nvotová.

## Repliky starých krojov, ktoré vyrába KC, uvidia ľudia na slávnostiach v Detve

Niekoľko replík tradičných ľudových odevov z konca 19. a prvej polovice 20. storočia, ako aj tri prenosné objekty ľudovej architektúry sú doposiaľ výsledkom práce neziskovej organizácie Komunikačného centra (KC) Detva, ktorú realizuje v rámci európskeho programu Interreg V-A Program spolupráce Slovenská republika - Maďarsko 2014 - 2020. Doterajšie výsledky predstavili účastníci projektu v stredu v Kriváni v okrese Detva.

"Tých krojov bude celkom 30. Výsledky predstavíme v júli počas folklórnych slávností v Detve. Tam uvedieme aj naše stavby, ako aj publikáciu, ktorá mapuje ľudovú architektúru na Podpoľaní. Na konci roku k nej pribudne ďalšia, ktorá zachytáva práve ľudový odev v regióne," povedala zástupkyňa centra Elena Jankovičová.

Vyrobené repliky krojov chcú potom ponúkať na výstavy po celom Slovensku. Zámerom centra je okrem statickej prezentácie odevov či stavieb vytvárať aj zážitkové ponuky, ako napríklad výrobu syra či prezentáciu výšivkárok. "Všetko toto môže slúžiť napríklad pre oblastnú organizáciu cestovného ruchu ako produkt pre ponuku návštevníkom regiónu," pripomenula Jankovičová.

Slovensko-maďarský projekt sa zameriava na zachovanie a prezentáciu kultúrneho dedičstva v regiónoch v blízkosti spoločnej hranice. Projekt sa realizuje v šiestich partnerských územiach, tri sú na Slovensku a tri v Maďarsku. Okrem KC Detva sú súčasťou projektu na slovenskej strane obec Hrušov a SNM - Múzeum Maďarov na Slovensku - Kaštieľ v Dolnej Strehovej. V Hrušove sa realizujú stavby na prospech známeho hrušovského podujatia Hontianska paráda, v Dolnej Strehovej zase budujú park v okolí tamojšieho kaštieľa.

U našich južných susedov sa realizácia dotýka takmer 50 obcí, ktoré sú v regióne Palóc, v blízkosti hraníc zo Slovenskom.

Projekt s názvom Palóc - Hont - Podpoľanie: Rozvoj turisticky prístupných tematických trás so zameraním na spoločné kultúrne dedičstvo, získal z európskych fondov viac ako 1,53 milióna eur. TASR

Pozornosti sa podľa nej tešili i sprievodné podujatia Dnes tovariš, zajtra majster, ktoré priniesli ukážky tradičnej výroby v prácach študentov stredných škôl z Ružomberka, Kysuckého Nového Mesta, Turčianskych Teplíc a Martina. Študenti priblížili niektoré tkáčske techniky, zhotovenie drevenej hračky, kováčske práce a mnoho iného. Ďalšími podujatiami boli vernisáž a výstava literárno-výtvarnej súťaže Turiec maľovaný a jarmok tradičných remesiel.

## V júni uplynulo 70 rokov od Levočskej vzbury

Od Levočskej vzbury uplynulo v mesiaci jún 70 rokov. Takmer 300 ľudí z mesta i okolitých dedín prišlo v júni 1949 pred faru chrániť vtedajšieho levočského farára Jozefa Vojtasa pred zatknutím a odvedením. Dekan levočského dekanátu František Dlugoš pripomína, že komunisti chceli ľudí vyprovokovať k násilnostiam a prekaziť tak púť na Mariánsku horu. "Aj keď sa púť v tom roku nakoniec konala, vo väzniciach s neprimerane tvrdými trestami skončilo 52 ľudí," uviedol.

Po zavedení totalitného režimu po roku 1948 sa terčom útokov zo strany vlády stala cirkev. Komunisti sa snažili získať kontrolu najmä nad činnosťou katolíckej cirkvi, ktorá kládla najväčší odpor. Národné zhromaždenie prijalo zákony, ktoré mali viesť k priamej likvidácii cirkvi. "Udalosti z júna 1949 sa radia k najdramatickejším konfliktom monopolnej socialistickej politickej moci nielen s cirkvou, ale aj s kresťanskou tradíciou a katolíckym vierovyznaním slovenského národa. Spiš bol už v tom čase štátnou ideológiou obviňovaný z klérofašizmu a protištátnych aktivít," vysvetlil Dlugoš.

V máji 1949 začali miestní funkcionári zbierať podpisy na vyhlásenie tzv. katolíckej akcie. Tým, ktorí ju nepodpísali, hrozilo prenasledovanie. Tento počin viedol biskupov k vydaniu pastierskeho listu, v ktorom označovali akciu za nezákonnú, rozvratnícku a protikresťanskú. V nedeľu 19. júna 1949 väčšina kňazov aj napriek hrozbe trestného stíhania tento list prečítala veriacim počas bohoslužieb. Po návštevách štátnych úradníkov na farách sa veriaci začali obávať zatýkania kňazov, čo vyvolalo otvorené vzbury v približne 50 slovenských obciach. Najväčšou z nich bola Levočská vzbura. "V Levoči išlo o protiprávne a ničím ne-odôvodnené zatknutie levočského farára, kanonika Jozefa Vojtasa. Takmer 300 ľudí prišlo pred faru brániť svojho obľúbeného a uznávaného dušpastiera. Pre zbytočnú horlivosť vtedajšieho predsedu komunistickej strany v Levoči sa spočiatku pokojný protest "rozhorel" do otvoreného incidentu. Privolané policajné posily reagovali na spravodlivé rozhorčenie levočských veriacich neprimerane tvrdo a samy spôsobili chaos. Ešte tvrdší postup zvolili vtedajšie súdy, ktoré účastníkom Levočskej vzbury vymerali také vysoké tresty, ktoré boli v rozpore s vtedajším zákonmi," priblížil Dlugoš.

Do väzenia sa dostali mladí chlapci, matky malých detí či živitelia rodín. Mnohí si celé tresty odsedeli vo väzniciach v Leopoldove či Ilave. Niektorí dostali v roku 1950 amnestiu, iným boli odpustené časti trestov. Po prepustení im na úrade pridelili nútené práce v bani a iné ťažké práce. Farára Jozefa Vojtasa počas vzbury neobvinili, Štátna bezpečnosť ho však zaistila v júli 1950 a väznený bol až do roku 1969.

Levočský dekan spoznal počas svojho pôsobenia v tomto meste takmer polovicu účastníkov odsúdených v vzbure. "Týchto farníkov som s úctou vyprevádzal aj do večnosti. Poslednou z nich bola pani Mária Repáková, najmladšia účastníčka dramatických udalostí. Mária Vilkovská dostala desať rokov tvrdého žalára napriek tomu, že bola v tom čase matkou niekoľkomesačného dieťaťa. Z otcov, ktorí svoju statočnosť zaplatili nesmiernym utrpením, si zaslúži spomienku Michal Hasaj. Bol uväznený a doma zostala manželka s dvomi maličkými deťmi," upozornil Dlugoš, ktorý dal pri príležitosti 50. výročia udalostí osadiť v Bazilike sv. Jakuba pamätnú tabuľu s menami a výškami trestov odsúdených. Práve v blízkosti kostola sa Levočská vzbura odohrala. "Tieto udalosti zostávajú stále platnou výzvou, aby sme sa nehanbili vyznať svoju vieru, hlásiť sa bez obáv k drahocennej mariánskej úcte a byť príkladom čistého kresťanského života," uzatvára levočský dekan.

## Nemali sme názorový rozpor, zhodli sa prezidenti ČR a SR M. Zeman a Z. Čaputová

V diskusii prezidentov Slovenskej a Českej republiky Zuzany Čaputovej a Miloša Zemana nedošlo napriek pomerne širokému spektru tém k názorovému rozporu. Hlavy štátov to deklarovali po spoločnom rokovaní, ktoré sa uskutočnilo v rámci oficiálneho programu štvrtkovej návštevy slovenskej prezidentky v Prahe.

"Netvrdím, že niekedy v budúcnosti nebudeme mať na veci iný názor, v tomto úvodnom rozhovore však k niečomu takému neprišlo," uviedla Čaputová. Zeman to potvrdil vyhlásením, že v diskusii "nenarazili na jedinú konfliktnú otázku". Napriek tomu to nebolo podľa neho nudné. "Lebo priateľská atmosféra, v ktorej sa viedla diskusia, je vždy inšpiratívna a môže viesť k zaujímavým názorom," upozornil.

Zeman sa Čaputovej poďakoval za ústretovosť k jeho "neochvejným snahám a myšlienke" zriadiť v Bratislave Český dom. Čaputová opätovala uznanie pripomenutím faktu, že súčasný prezident sa z pozície vtedajšieho českého premiéra zaslúžil o ukončenie slovensko-českých majetkových sporov po rozdelení niekdajšieho spoločného štátu. "V tomto roku je to dvadsať rokov, čo sa veci vyriešili, a myslím, že aj toto dalo základ neskorším konštruktívnym a nadštandardným vzťahom medzi oboma krajinami," poznamenala Čaputová.

Obaja prezidenti vyjadrili na krátkom brífingu ochotu participovať na spoločnej príprave a realizácii osláv 30. výročia Nežnej revolúcie.

Zeman Čaputovej na brífingu poblahoželal k zajtrajšku. Nemyslel ale len podporu vo vykonávaní budúcich úloh vo funkcii prezidentky, vyslovil tým aj osobné želanie k Čaputovej piatkovým (21.6.) narodeninám. Prezidenti by sa mali stretnúť aj na Slovensku, Čaputová pozvala Zemana na recipročnú návštevu.

Informovala o tom Alexandra Mikulášová z Oravského kultúrneho strediska (OKS) v Dolnom Kubíne.




