as of March 31, 2019 were \$390,129,345 and surplus was at \$32,983,214 a record high. As a comparison, in 2007 FCSU assets as of January 1, 2007 were \$197,310,824 and surplus was \$11,355,594.

In the last 12 years our assets have increased \$145,8 million and more importantly our surplus has almost tripled.

We continue to provide our Members with competitive insurance products and some of the best annuity rates in the fraternal and insurance world while also continuing our policy of paying dividends.

St. Vincent Archabbey -- Homily, Father Killian Loch, O.S.B.

#### June 16, 2019 – Solemnity of the Most Holy Trinity

This solemnity of the Most Holy Trinity is one that we celebrate after completing ninety days of Lent and Easter during which we recalled and entered more deeply into the Paschal Mystery. The mystery of the Trinity has been written about for two millennia and numerous attempts have been made to try to explain it. It is best to begin with the definition found in the Catechism of the

Catholic Church; "The mystery of the Most Holy Trinity is the central mystery of Christian faith and life. It is the mystery of God in himself. It is

therefore the source of all the other mysteries of faith, the light that enlightens them. It is the most fundamental and essential teaching in the "hierarchy of the

truths of faith." The whole history of salvation is identical with the history of the way and the means by which the one true God, Father, Son, and Holy Spirit, reveals himself to men and reconciles and unites with himself those who turn away from sin. But it is a mystery and can never be fully understood." While the catechism doesn't explain the mystery it gives us a good foundation on which to

build our Faith as we celebrate the mystery. We might be tempted today with getting bogged down with trying to wrap our minds around an unsolvable mystery, rather let us allow the mystery of God to wrap himself around our hearts and souls and fill us with a deeper experience and appreciation of God. There are numerous resources and Religious Education Classes that provide us with opportunities to wrestle with understanding this mystery.

Through Baptism we are all united with God and one another. The mystery of the Triune God fills us with the Love of the Father, the Peace of Christ, and the unity of the Holy Spirit. We are united with God who draws us into His family, He is the loving Father, He is the Son, our Brother, who brings us Peace, and the Holy Spirit who sanctifies us.

We first experienced the Trinity at the moment of our conception when God breathed into the act of love of our parents' life and soul. God has been with us from our conception and remains with us forever. We were Baptized in the name of, The Father, and of The Son, and of the Holy Spirit, and became a member of God's Family. We went on to receive Jesus in Holy Communion, and the Holy Spirit at Confirmation.

In addition to these Sacraments there are the times we encounter the Trinity in other ways. It could be the silent prayers at home or at some retreat or spiritual gathering were the words of someone, a song, or a prayer, struck the heart with the reassurance that God is with us. It could be the unexpected encounter with someone in need, whether it be a kind word and encouragement, or a simple ride somewhere, or even a loan, that we realize that we just helped Jesus. The Trinity is itself a mystery that we will never solve, and it is also a mystery how God can be so attentive to us at every moment of our lives. God is a Trinity of persons who is always with us. The mystery of the Holy Trinity is one to behold with awe and to celebrate with joy. May we experience the unity of the Most Holy Trinity in a way that unites us more closely with the three persons of our One God, and with each other.

### An American Leader

"While we have time, let us do good." Frank Siller heard that quote, attributed to St. Francis of Assisi, from his parents when he was growing up. Decades later, those words got him through the worst tragedy of his life and motivated him to become a force for good for those enduring their own brand of horrific loss and suffering. It's the reason he won our 2019 Christopher Leadership Award - and it's a mission that began with his brother Stephen's death 18 years ago.

On Sept. 11, 2001, firefighter Stephen Siller got the call that a plane had hit the North Tower of the World Trade Center. Stationed in Brooklyn, he drove the truck to the Battery Tunnel to get into Manhattan, only to find it shut down for security reasons. So Stephen strapped 60 pounds of gear to his back and ran through the tunnel to join rescue efforts at the Trade Center. The husband and father of five was killed when the Towers collapsed.

Stephen's six siblings were determined to keep his memory alive in a way that would help others. In 2002, they created the Stephen Siller Tunnel to Towers Foundation, initially as a New York City-based charity run that retraced Stephen's steps on 9/11. But under the leadership of Chairman/CEO Frank Siller, Stephen's brother, the Foundation has grown into a national force for good.

They build specially adapted smart homes for catastrophically injured members of the military who have lost arms and legs, pay off mortgages for families of first responders who have been killed in the line of duty, pay off mortgages for Gold Star families whose loved ones made the ultimate sacrifice in service to their country, and support a variety of community programs around the country. Since its inception, the Foundation has raised over \$125 million dollars.

During an interview on "Christopher Closeup," Frank recalled that his parents, George and Mae, were devout Catholics who were a part of the Third Order of St. Francis. He said, "My parents had seven kids. We were very poor, but we were never too poor to do something for our neighbors. One Thanksgiving – my oldest brother, Russ, told [us] that the neighbor didn't have anything for Thanksgiving, and [my father] took our turkey dinner and gave it to our neighbor." Frank also remembered that his father used to visit the local hospital to talk or pray with the sick. He said, "This is the foundation of our family, of seeing these acts of kindness and love that we were all brought up with that enabled my brother to make that ultimate sacrifice.'

For Frank, his commitment to the Foundation goes deep because he relates to the people they're helping. He concludes, "I understand each point they're at because I lived it... After 9/11, so many people were there for our family. It lifts you to know that people care and are praying for you. This is the message that we send to all these great families...We don't want to just pay off the mortgage or build them a smart home; we want to be part of their lives. They join us on our mission and are our greatest ambassadors because they want to pay it forward to the next person...The more they do for somebody else, the better they're going to feel. And they do. It does lift you, it does heal you, and it does give you a great purpose that's bigger than [yourself]."

1) Proper dress/golf attire is required at all times.

Tank tops, sleeveless shirts, fish net shirts, tube tops, etc. are not permitted.

2) Collared shirts with slacks or suitable length shorts or skirts are required.

3) "Soft Spike" Golf Shoes only.
4) Proper conduct is expected by all players while at Cedarbrook Golf Course.

#### Men's And Women's Official Rules and Regulations

- 1. The tournament is open to all members of the First Catholic Slovak Union (FCSU).
- 2. United States Golf Association (USGA) and host golf course rules will govern play. Improve your lie anywhere, except for hazards. Out of bounds shot, drop where ball went out and 1 stroke penalty
  - 3. Handicaps will be determined as follows:
- A. All golfers will compete as determined by handicap. The golfer's first handicap will be determined after he has completed 54 holes of play in the FCSU National Golf Tournament. The handicap will be recalculated each year based on 54 holes of FCSU National Tournament play. From the latest 5 rounds, the highest and the lowest will be discarded and 90% the average of the remainder will be the handicap assigned for the tournament. 90% of an official USGA handicap may be substituted if a golfer does not have an FCSU Tournament handicap. The maximum handicap will be 40 strokes for 18 holes.
- B. Any golfer who has not completed 54 holes of tournament play in the FCSU National Golf Tournament will be entered in a separate division using the FCSU version of the Callaway scoring system.
- C. Male golfers, competing in the 18-hole event, age 65 or over and with a handicap larger than 10 may use the forward tees.
- 4. Classifications:
  - A. A medal play champion will be determined in each of the following Divisions:

1. Men's A flight (0-10) 5. Women's Flight

2. Men's B flight (11-17) 6. Callaway Flight

36 holes of medal play.

3. Men's C flight (17-30) 7. Senior Flight

4. Men's D flight (31 +)

B. Winners will be determined by low net score in each flight after

- 5. The division between the men's A-D flights may be adjusted to equalize the flights. A second women's flight may be added if entries warrant such addition.
- 6. In case of tie for first place in any Flight, tie will be broken by match of cards using gross score starting on #1 handicap hole followed by #2 handicap hole, #3 handicap hole and so forth until the tie is broken.
- 7. All other ties will split the applicable prize money. (e.g., two people tied for second will split second and third place prize money. Three people tied for second would split second, third and fourth place prize money.)
- 8. The prize list will be determined by the tournament manager using the money contributed by the contestants and matching money contributed by the FCSU for all golfers. As nearly as possible, there will be one prize for each four entries.
- 9. The tournament manager will schedule pairings. Both Saturday and Sunday schedules will be e-mailed to participants prior to the tournament.

# Annual Report of Region 1 Director

Dear Rev. Thomas Nasta, President Andrew Rajec, Executive Officers, and fellow members of the FCSU Board of Directors:

It is my honor to represent Region 1 as Regional Director. I would like to thank the Executive Board and my fellow board members for their guidance, collaboration, and support. I am eager to continue to work collaboratively to grow our society and present new ideas which can rejuvenate and revitalize the way we work.

I would like to take this opportunity to thank Jednota members in my region for their support, encouragement, and enthusiasm this past year. I am honored to be your Regional Director and humbled that, once again, you expressed your confidence and trust in my work by electing me for a second term. I look forward to supporting and working together with branches throughout 2019 on various initiatives and activities which are important to you.

This past year I have performed all the duties required of me as stipulated in the bylaws of the First Catholic Slovak Union to the best of my abilities. As part of those duties and responsibilities as a Regional Director, I've attended all Board of Directors meetings personally or via teleconference (as requested) and, in addition, participated in meetings by invitation of the President.

Moreover, I've attended all of Msgr. John E. Rura, District 4 meetings as well as District 16 meetings when possible and look forward to also visiting District 1 in 2019. I have attended all Branch 746 meetings and events. In addition, I happily contribute to the Jednota newspaper by providing articles and photos. I also have engaged and kept abreast of the activities of the branches under my region and when possible attended such events. I would like to extend my appreciation to branches for the fruitful cooperation throughout the year and the kind invitations to meetings and events.

2018 was a commemorative year with the celebration of the 100th anniversary of the birth of Czechoslovakia and the 25th anniversary of Slovak Independence. Many events were organized to celebrate these occasions, starting with a reception in January at the Library of Congress hosted by H.E. Ambassador Peter Kmec. Additionally, the 1918 "Pittsburgh Agreement" was commemorated halfway through the year with a gala reception celebrating a century of Slovak-American ties and 25 years of bilateral diplomatic relations. I was honored to have been a part of these historic events. Born in Slovakia and immigrating to the United States in the late 1980s, I feel a deep sense of pride to be a Slovak-American and have had the opportunity to see how far Slovakia has come as an independent country. I was also honored to represent the First Catholic Slovak Union at many events organized by Slovak and/or Czech non-profit organizations such as the Slovak League of America, Friends of Slovakia, Slovak Catholic Sokol, and the Slovak-American Cultural Center. I supported various Slovak church events including fundraisers and 'zabavas' (dances) as well as receptions and activities hosted by representatives of the Slovak government in the United States at the Embassy in Washington, DC, Consulate General of the Slovak Republic in New York, and the Permanent Mission of Slovakia to the United Nations. I also attend the monthly Young Adult Masses organized by the Archdiocese of New York.

At the end of 2018, I represented the First Catholic Slovak Union at the 2018 Freedom Lecture with former Slovak Prime Minister Mikulas Dzurinda at the Woodrow Wilson Center organized by Friends of Slovakia with a reception dinner hosted by the newly appointed Slovak Ambassador to the United States, H.E. Ivan Korčok. At a gala ceremony at the Slovak Embassy in Washington, DC, Friends of Slovakia and its Chairmen were honored for their significant contributions to the development of the Slovak-American relations with a commemorative medal bearing the name of the 28th President of the United States, Woodrow Wilson. - Slovak violin virtuoso concert On October 15th Jednota members from Branch 746, 45, and 716 attended a concert featuring Slovak violin virtuoso Filip Pogady which was organized by the Slovak-American Cultural Center in conjunction with the New Jersey Festival Orchestra (NJFO) at Drew University. Filip's performance of the Bruch Concerto was dreamy and contemplative as well as passionate and powerful. Both performances elicited prolonged standing ovations from the audience, prompting Pogady to return to the stage with encores by Bach and Kreisler. A reception followed at the historic Mead Hall. - LUX New York Jednota members value the contributions of LUX New York to the Slovak Catholic community. On Sunday, May 19, 2019, the Slovak League of America along with the area's local Slovak fraternal lodges hosted a dinner commemorating the centennial of the death of the noted Slovak scientist, diplomat, politician, and co-founder of the first Republic of Czecho-Slovakia, Dr. Milan Rastislav Stefanik. # "Dr. Milan Rastislav Štefánik: The 100th Anniversary of his Tragic Death"

May 4th 2019 marked the 100th anniversary of the tragic death of one of the founding fathers of the first Czecho-Slovak Republic, General Milan Štefánik. He perished in a terrible plane crash in 1919 that claimed his life and that of his two Italian crewmates. To this day, Štefánik is considered one of the most important individuals in the history of the Slovak nation and its people, even though he died at the relatively young age of 38. To the point, without his hard work and connections, Czecho-Slovakia might never have existed.

In a recent contest in Slovakia about who is the najvačší Slovák, the greatest Slovak, Štefánik's name loomed to the top of the list. When the contest ended in early May, Štefánik won, followed by Ľudovít Štúr, the codifier of the literary Slovak language, and then Rev. Anton Svrholec, the Roman Catholic priest who suffered persecution under the former communist regime.

Perhaps Štefánik had an unfair advantage. With the anniversary of his death approaching, many communities across Slovakia were preparing commemoration ceremonies, and articles about Štefánik flooded the newspapers, radio talk shows, and TV commentaries.

On May 4, 2019, in a steadily pouring rain, a huge crowd from across Slovakia paraded on "a torch-lit march from (his native village of) Košariská to Bradlo, symbolizing his short life, but also the cohesiveness and unity of the Slovak nation." Slovak armed forces saluted him with an artillery salvo and performed military music. A flyover of contemporary and historical aircraft also paid him tribute.

After the fall of communism, many people in Slovakia had learned about Štefánik for the first time. They developed a genuine affection for him, even referring to him as naš Milanko (an endearing diminutive of his Christian name). There are always fresh flowers at his grave.

Štefániková ulica in Bratislava replaced Leninová ulica (Lenin Street) as a main thoroughfare from the center of town to the main railway station. I used to ride my bicycle on the street every day on the way to Slovakia's Central State Archives.

The Bratislava airport near where he died was renamed M. R. Štefánik Airport (Letisko M. R. Štefánika) in 1993.

Why was a fantastic, gargantuan monument designed by the renown Slovak architect Dušan Jurkovič, built on his mohyl (burial mound) at the top of Bradlo Mountain, above Košariská? It truly is a sight to behold and when we first visited the weed-covered site in 1983. It even impressed my wife Rebecca, who is not so easily bowled over.

There are many other monuments and statues honoring Štefánik, for instance, in Prague on Petrín Hill, where there is also an observatory named after him. Other statues or busts of him appear in many places across Slovakia, including Trnava, Trenčín, Košice, and the huge statue in front of the new Slovak National Theater on the Danube, a replica of the one which used to stand in front of the Reduta, the Slovak National Concert Hall. There is also a similar statue of Štefánik in southern France in Paulhan, and in Paris a memorial plaque at a square called "Place du Général-Stefanik".

One cannot end the statuary list without mentioning the 10 feet tall Štefánik statue which used to adorn Wade Park in Cleveland, which was moved to the Slovak Cultural Garden in nearby Rockefeller Park in 2013.

Finally, right here in the East Village of New York City, is a bronze memorial plaque to General Štefánik at St. Mark's Place and Avenue A in Tompkins Square Park. The Slovak Welfare Club Tatra dedicated the plaque on May 3, 1942, during the Second World War.

# Branch 746's Lois Schmidt Performs with Choral Art Society of New Jersey





# Focus on Heritage

Coming to America

Our family story begins in July 1929, when my grandfather, Lucian Gregoricka, having an opportunity to travel to America to seek out a better life to support his family, boarded a train to Cherbourg, France, from his home in Podedim, Slovakia [Editor's note: Pobedim is a village and municipality in Nové Mesto nad Váhom District in the Trenčín Region of western Slovakia]. It was in France that he booked passage on the SS Aguitania, sailing to America. From New York City, after Ellis Island, trains again transported him to his final destination in Owosso, MI.

He traveled alone because that was all he could afford. His wife and five children remained in Slovakia until enough money was saved and sent back for their passage. It took five years during the U.S. Depression to save enough so that the family could be reunited. Finally, in February 1934, my grandmother sold all her worldly possessions except for the luggage needed to transport the family's clothes. The trip to America with her children followed on the SS Berengoria.



My grandfather worked a number of odd jobs during his time in Michigan. His goal was to buy a small farm. When he worked in Slovakia, he was - in essence - a migrant farm worker, working the fields in (what is now) Slovakia, Moravia, and the Czech Republic. Once in America and reunited with his family, he saved every penny he could and eventually purchased a small 60-acre farm in the 1940s.

My grandfather's children all became successful. His oldest daughter married an auto worker. The second daughter married a farmer. His oldest son fought in WWII, then owned a bakery until his retirement. The youngest son bought the family farm and continued his father's legacy of successful farming. And my father, Cyril, started as an engineer and eventually started his own manufacturing business, which his four sons still operate today.

Because one man dared to cross the globe for a better life for his five children - and eventually 17 grandchildren and over 30 great-grandchildren - all were blessed with an abundance from his adopted country, the United States of America.

The FCSU has been a part of our extended family for as long as I can remember. My grandfather and father were both officers in Branch 756, District 5, in Michigan. Although there are fewer and fewer native Slovak speakers left in our locale, it is with pride that we continue the tradition of this great organization.

#### **AQS MANAGEMENT. INC.:**

Larry White and Stephen Gonzalez, representing AQS Management, Inc., presented an extensive Investment Portfolio Transaction Report by telephone and WebEx to the Executive Committee. Each member of the Committee received a copy of the presentation in advance for his review. Mr. White and Mr. Gonzalez also led a discussion of the new investment opportunities that we may take advantage of. Following the report, Mr. White and Mr. Gonzalez answered the Committee's questions.

The President reported that the FCSU sold two equity positions for realized profit of \$25,000 on the recommendation of UBS. Mr. Matta stated that he was not informed prior to this transaction but voiced no objection to the trade.

The Executive Secretary and Treasurer submitted a written report to the Executive Committee on the investments and transactions with the Federal Home Loan Bank (FHLB), UBS, MAI Fund, and Clutterbuck Fund. #### Portfolio Review

The Executive Secretary updated the Executive Committee on the report from our portfolio custodian, Key Bank, found everything in order, and answered the Committee's questions.

#### Mortgages and Overdue Mortgages

The Executive Secretary presented the report for the month of March for the Committee's review and answered their questions.

## Správy zo Stovenska

**Bratislava** - Rakúsky kancelár Sebastian Kurz prekračuje svoje právomoci. Tvrdí to slovenský premiér Peter Pellegrini (Smer-SD). Reagoval tak na vyhlásenie kancelára, ktorý chce všetkými prostriedkami zabrániť dostavbe jadrovej elektrárne Mochovce. Pellegrini vníma tieto slová so znepokojením a deklaruje, že nedovolí, aby sa príslušník iného štátu pokúšal zasiahnuť do suverénnych rozhodnutí Slovenska. Predseda vlády to uviedol na tlačovej konferencii s tým, že Kurza pozýva na Slovensko.

Banská Bystrica – Za veľkú výzvu, ale aj obrovský záväzok označil nedávno banskobystrický primátor Ján Nosko zorganizovanie Európskeho olympijského festivalu mládeže (EYOF), ktorý sa má uskutočniť v lete 2021 v meste pod Urpínom. Po tom, ako sa Košice vzdali organizácie tohto sedemdňového podujatia, záujem prejavila Banská Bystrica a vyšla spomedzi iných slovenských miest ako najlepší hostiteľ prestížneho športového podujatia.

**Bratislava** - Kampaň Do práce na bicykli zaznamenala na začiatku mája rekordnú účasť, aktívne ju podporilo 12.687 zamestnancov. V porovnaní s rokom 2018 je to o 1626 ľudí viac, ktorí na cestu do práce zvolili ekologický spôsob dopravy. Informovalo Ministerstvo dopravy a výstavby (MDV) SR. Hovorkyňa rezortu Karolína Ducká avizovala, že v polovici mája sa začne i kampaň určená pre žiakov a študentov.

**Bratislava** – Slovensko je voči hybridným hrozbám značne zraniteľné. Tvrdia to tvorcovia najnovšej publikácie neziskovej organizácie Globsec, ktorej výsledky prezentovali na tlačovej konferencii v Bratislave pracovníci programu Strategická komunikácia Globsec-u. Prijatie Koncepcie boja proti hybridným hrozbám vládou Slovenskej republiky minulé leto je prvý a dôležitý krok, máme však v tejto oblasti ešte veľa medzier," uviedol vedúci programu Strategická komunikácia Globsec-u, analytik Daniel Milo.

**Zvolen** – Vedieť sa postaviť zlu, nebáť sa ho pomenovať, bojovať s ním a nelegalizovať zlo spoluprácou s ním, tak ako sa to napríklad teraz deje v parlamente, je náš záväzok voči ľuďom, ktorí nám vybojovali slobodu. Uviedol to pri príležitosti 74. výročia ukončenia druhej svetovej vojny vo Zvolene v príhovore prezident SR Andrej Kiska.

**Bratislava** - Predseda Národnej rady (NR) SR a SNS Andrej Danko ocenil gesto Slovenského zväzu ľadového hokeja (SZĽH) v súvislosti s dresmi slovenských reprezentantov na svetovom šampionáte. Zväz avizoval, že slovenskí hokejisti sa predstavia v dresoch so štátnym znakom. Fanúšikmi obľúbené logo bude na ramenách.

**Bratislava** - Prezident SR Andrej Kiska sa pripája k výzve 21 prezidentov pred voľbami do Európskeho parlamentu. "Európa potrebuje silný hlas národov. Preto vás vyzývame, aby ste uplatnili svoje právo voliť. Ide o našu spoločnú európsku budúcnosť," uviedol Kiska na sociálnej sieti. Kiska doplnil, že Európska únia čelí viac než kedykoľvek predtým vážnym výzvam. Medzi tie zahrnul túžbu časti obyvateľstva EÚ zvrátiť jeden alebo viacero integračných krokov. Takisto spomína brexit a na druhej strane hlasy volajúce po väčšej integrácii.

**Bratislava** – U Slovákov vidieť v súčasnosti oveľa väčší záujem o voľby do Európskeho parlamentu (EP) ako pred piatimi rokmi. Pri príležitosti Dňa Európy to povedal zastupujúci riaditeľ Kancelárie EP na Slovensku Dionýz Hochel. Podľa neho možno na Slovensku stále hovoriť o tzv. európskom paradoxe, pri ktorom je väčšina Slovákov spokojných s členstvom Slovenska v Európskej únii a v eurozóne, no voliť nejdú. "Máme nádej, že tieto voľby prinesú obrat. Aj podľa prieskumu Eurobarometra je 20 percent Slovákov presvedčených, že pôjdu voliť a 19 percent občanov to silne zvažuje. Vidíme aj väčší záujem strednej a staršej generácie a vysokoškolsky vzdelanej populácie," povedal Hochel.

Bratislava - Predseda parlamentu Andrej Danko (SNS) otvoril výstavu venovanú 100. výročiu tragickej smrti generála Milana Rastislava Štefánika s názvom Veriť, milovať, pracovať. Výstava je inštalovaná vo vestibule Národnej rady SR. "Slováci takú osobnosť, akou bol Milan Rastislav Štefánik, vo svojom čele potrebovali. Osobnosť, ktorá bola komplexná, bol človekom, ktorý mal dvere otvorené, a to najmä preto, že bol všade bezprostredný. …Bol človek, ktorý bol v spoločnosti a v kolektíve veľmi rýchlo obľúbený. Nadväzoval známosti, ktoré potom prispeli k tomu, že mohla vzniknúť Československá republika. O jeho charizme, ľudskosti svedčí aj to, že dokázal presvedčiť množstvo ľudí, ktorí mohli žiť v komforte ďalej, aby išli v rámci légií bojovať za Československú republiku," pripomenul Danko.

**Bratislava** – Na bezpečnosť počas majstrovstiev sveta v ľadovom hokeji bude v Bratislave a Košiciach dohliadať viac ako 100 profesionálnych vojakov a vojenských policajtov. Uviedla to hovorkyňa rezortu obrany Danka Capáková. Vojaci budú v prípade potreby pomáhať príslušníkom Policajného zboru s "udržiavaním bezpečnosti, verejného poriadku, ochranou života, zdravia a majetku, ako aj v rámci boja proti terorizmu a organizovanému zločinu", spresnila Capáková.

**Trnava** - Trnava obhájila svoju kandidatúru a v roku 2020 ponesie titul Európske mesto športu. Toto ocenenie jej udelila hodnotiaca komisia ACES Europe (Federácia európskych hlavných miest a miest športu) pri Európskej únii v Bruseli. O výsledku rozhodnutia komisie samosprávu informoval prezident ACES Europe Gian Francesco Lupattelli

**Bratislava** – Dosluhujúci prezident SR Andrej Kiska prijal nedávno v Prezidentskom paláci nastávajúcu hlavu štátu Zuzanu Čaputovú. Obaja diskutovali o prebraní úradu a deklarovali vzájomnú kooperáciu. Čaputová sa podľa vlastných slov momentálne pripravuje na inauguráciu, ktorá bude 15. júna, buduje si tím poradcov a plánuje prvé zahraničné cesty.

**Bratislava** – Medzinárodná asociácia lekárov na Slovensku bude pomáhať lekárom z krajín tretieho sveta uplatniť sa v slovenskom zdravotníctve. Ako tvrdí, radi by v SR pracovali, no stojí proti nim legislatíva, ktorá komplikuje situáciu s uznávaním nadobudnutého vzdelania na zahraničných univerzitách. V susednom Česku takýto problém nemajú. Na na tlačovej konferencii v Bratislave na to upozornili lekári z krajín tretieho sveta.

Hanušovce nad Topľou - Projekt Európskej únie (EÚ) je pre Slovensko prínosom a vďaka nemu sa rozvíjajú aj najvýchodnejšie časti Slovenska. V Hanušovciach nad Topľou, kde sa v utorok 14. mája konalo výjazdové rokovanie vlády, to povedal premiér Peter Pellegrini (Smer-SD).

**Vysoké Tatry** - V rámci ukončenia slovenského predsedníctva vo Vyšehradskej štvorke (V4) sa v Tatranskej Lomnici zišli na pozvanie náčelníka Generálneho štábu Ozbrojených síl (OS) SR Daniela Zmeka na pravidelnej konferencii generáli z Českej republiky (ČR), Poľska a Maďarska. Počas spoločného vyhlásenia Zmeko symbolicky odovzdal predsedníctvo vo V4 českému kolegovi a obaja deklarovali pripravenosť spoločnej bojovej skupiny Európskej únie v rámci V4, ktorá bude od 1. júla v pohotovosti na nasadenie.

# M. Šefčovič hovoril s D. Trumpom o plyne, aj o vzťahoch USA so strednou Európou

Podpredseda Európskej komisie (EK) pre energetickú úniu Maroš Šefčovič bol prvým cudzím štátnym príslušníkom, ktorý bol pozvaný na palubu amerického prezidentského špeciálu Air Force One počas úradovania prezidenta Donalda Trumpa.

Šefčovič spolu s prezidentom USA absolvoval v utorok cestu z Washingtonu do mesta Hackberry v štáte Louisiana, kde sa nachádza terminál na vývoz skvapalneného zemného plynu (LNG) do Európy.

"Európska únia a USA sú partnermi a spojencami, pričom otvorením LNG terminálu v Louisiane štartujeme novú etapu v našej strategickej spolupráci," vysvetlil Šefčovič v správe pre médiá. Spresnil, že terminál Cameron LNG má prispieť k vyššej energetickej bezpečnosti Európskej únie (EÚ), vrátane Slovenska, pretože sa touto cestou obohatí ponuka dovozu plynu.

Slovenský eurokomisár zdôraznil, že energetická bezpečnosť, vrátane diverzifikácie dodávok v oblasti zemného plynu, je jeden z kľúčových cieľov energetickej únie, za ktorú zodpovedá v exekutíve EÚ. Cieľom eurokomisie je, aby každý členský štát EÚ mohol nakupovať plyn priamo alebo nepriamo z niektorého LNG terminálu na území Únie. Komisia potrebnú infraštruktúru doteraz podporila sumou okolo 656 miliónov eur.

"Cez novú infraštruktúru, či už ide o plynovody, alebo o LNG terminály na skvapalnený plyn, zvyšujeme konkurenciu na trhu, od čoho si sľubujeme aj nižšie ceny plynu. Toto bolo osobitne dôležité pre strednú a juhovýchodnú Európu, kde sme podporili aj projekty, ako plynové prepojenie medzi Poľskom a Slovenskom alebo LNG terminál na severe Poľska. Takže aj Slovensko by vďaka tomu malo mať tri rôzne zdroje plynu: ruský plyn prúdiaci cez Ukrajinu, nórsky plyn prúdiaci cez baltický plynovod a skvapalnený plyn prichádzajúci cez Poľsko," zhodnotil situáciu Šefčovič, podľa ktorého si nikto v EÚ neželá zopakovanie energetickej krízy z roku 2009, keď došlo k prerušeniu dodávok ruského plynu do Európy.

Šefčovič tvrdí, že strávil na palube Air Force One približne šesť hodín, čo mu umožnilo otvorene sa pozhovárať o viacerých dôležitých témach priamo s Trumpom a aj s členmi jeho tímu. "Vážim si veľkorysé privítanie prezidentom Trumpom na palube Air Force One. Jeho prístup bol veľmi bezprostredný a otvorený, rád diskutuje, zaujíma sa o názory okolia. Vďaka tejto atmosfére sme mohli prediskutovať celý rad aktuálnych otázok," uviedol.

Podľa jeho slov sa počas rozhovorov dotkli aj témy intenzívnejších vzťahov americkej administratívy so strednou a východnou Európou, a to aj v kontexte nedávnej úspešnej návštevy predsedu vlády SR Petra Pellegriniho (Smer-SD) v Bielom dome.

Pracovný program podpredsedu EK v stredu pokračoval sériou stretnutí vo Washingtone. Šefčovič mal naiskôr na programe prejav na pôde Centra pre strategické a medzinárodné štúdiá (CSIS) na tému geopolitickej dimenzie energetiky. Následne bolo naplánované stretnutie so zástupcami obchodnej komory a v priestoroch Bieleho domu bolo dohodnuté prijatie u Trumpovho hlavného ekonomického poradcu Larryho Kudlowa.

Slovenský premiér dodal, že to nie je len česť pre neho, ale pre krajinu, že môže byť v Bielom dome. Americký prezident uviedol, že by raz rád prišiel na Slovensko, bližší termín však nekonkretizoval.

Návšteva premiéra Pellegriniho prebiehala na pozvanie amerického prezidenta aj pri príležitosti 30. výročia Nežnej revolúcie a 15. výročia vstupu Slovenska do NATO. Z oblasti strednej Európy tento rok už absolvovali návštevu Bieleho domu rakúsky kancelár Sebastian Kurz a český premiér Andrej Babiš. Americký minister zahraničných vecí Mike Pompeo bol na Slovensku vo februári.

Asociácia súkromných lekárov (ASL) upozorňuje na akútny nedostatok lekárov a sestier v ambulanciách a ďalšie problémy ambulantného sektora. "Keby dnes všetci lekári v dôchodkovom veku išli do penzie, viac ako pol milióna detí by nemalo zabezpečenú zdravotnú starostlivosť," priblížil na tlačovej konferencii v Bratislave pediater Martin Olej.

Podľa ASL dochádza k rušeniu ambulancií, a to nielen na vidieku, ale už aj vo veľkých mestách. Podľa štatistík Národného centra zdravotníckych informácií medzi rokmi 2012 a 2017 v celom ambulantnom sektore ubudlo 1160 lekárov. "Počet ambulantných lekárov klesá a počet vyšetrených pacientov stúpa," hovorí prezident ASL Marián Šóth. Jeden lekár musí podľa neho denne vyšetriť o tri až päť pacientov viac. "Čas, ktorý môže lekár venovať jednému pacientovi, sa skracuje. Máme zdokumentované, že je to priemerne osem minút u všeobecného lekára pre dospelých a 12 minút u pediatra," doplnil. Ministerstvo zdravotníctva podľa neho problém bagatelizuje.

V jednej pediatrickej ambulancii podľa Oleja vyšetria za deň priemerne 30 detí. V čase vyššej chorobnosti ich môže byť 60 až 80. "Priemerný vek všeobecných lekárov pre deti a dorast je dnes 58,8 roka a keďže často pracujú aj nad rámec svojich ordinačných hodín, už sú preťažení," hovorí Olej.

"Čo sa týka špecializovaných ambulancií, na neurologické vyšetrenie sa v niektorých ambulanciách čaká radovo tri až štyri mesiace," tvrdí Šóth. Mladí lekári podľa neho pre zlé podmienky nemajú záujem o prácu v ambulanciách.

Preto ASL v súčasnosti realizuje kampaň Musí nás byť počuť – Lekári bojujú aj za pacientov. V rámci nej požadujú spravodlivosť v odvodoch zdravotného poistenia. Štát totiž prispieva na svojich poistencov, teda deti, nezamestnaných či dôchodcov, výrazne nižšou sumou ako ekonomicky aktívni občania. Odvodová sadzba pre nich je 14 percent z vymeriavacieho základu, kým štát v súčasnosti prispieva iba 3,2 percenta a od júla by to malo byť 3,44 percenta. Úhrady za zdravotnú starostlivosť podľa lekárov nezodpovedajú reálnym nákladom a situáciu by umožnilo riešiť zvýšenie platieb za poistencov štátu. Podľa lekárov by ambulantný sektor v roku 2019 potreboval celkové dofinancovanie 50 miliónov eur na stabilizáciu zdravotnej starostlivosti v ambulanciách všeobecných lekárov pre dospelých aj pre deti, gynekológov aj ďalších špecializovaných lekárov.

Ďalšou požiadavkou ASL je zníženie administratívnej záťaže lekárov a poskytovateľov zdravotnej starostlivosti. Tiež vytvorenie stabilného legislatívneho prostredia, v ktorom sa jednotlivé predpisy nebudú novelizovať niekoľkokrát ročne, a efektívny systém špecializačného vzdelávania.

Kópia Turínskeho plátna je na Slovensku

## Na Bojnickom zámku vystavili jediný exponát svojho druhu

Slovenské národné (SNM) -Múzeum Bojnice sprístupnilo v priestoroch zámockej kaplnky kópiu Turínskeho plátna. Do expozície mu ju zapožičal súkromný zberateľ z Českej republiky. Exponát má byť jedinou hodnovernou kópiou Turínskeho plátna na svete a na Slovensku ho vystavujú po prvý raz.

Výroba kópie Turínskeho plátna za niekoľko miliónov českých korún, ktoré má šírku 111 centimetrov a dĺžku 436 centimetrov, trvala takmer päť rokov



a podieľalo sa na nej niekoľko desiatok ľudí. "Pre nás to bola výzva, pretože vlastníme výstavu mučiacich nástrojov a jej súčasťou je i ukrižovanie. Pretože jednou z relikvií je Turínske plátno, chceli sme túto časť výstavy obohatiť, preto sme sa rozhodli, že vytvoríme akúsi jeho kópiu," povedal majiteľ kópie Turínskeho plátna Robert Pospíchal.

Tvorcovia si podľa neho začali postupne zisťovať informácie o plátne a pretože ich bol nedostatok, zisťovali viac a dostali sa k tomu, že vytvoria identickú kópiu Turínskeho plátna. "Kópia je urobená skutočne podľa originálu, ktorý je od roku 1578 uložený v Turíne. Vytvorená je podľa štruktúry, skenu plátna, ktorý bol vytvorený, keď ho skúmali. Je na ňom každý odtlačok, detail, záplata, prepálená diera, identická s originálom. Dokonca je tam i krv, ktorá je skupiny AB ako na origináli plátna," priblížil.

Výroba plátna nebola podľa jeho majiteľa jednoduchá, keďže jeho tvorcovia k nej potrebovali kompletnú dokumentáciu. Nakoniec sa im podarilo získať dokumentáciu od tímu, ktorý pracoval na výskume na origináli plátna. "Problémy boli od začiatku až do konca a v podstate so všetkým, s informáciami, stavom, na ktorom by sa plátno utkalo, materiálom z Egypta. Bolo to skoro päť rokov práce, než sa nám to podarilo dotiahnuť do konca," podotkol.

Kópií Turínskeho plátna má byť na svete asi 40, podľa Pospíchala však ide o maľby autorov v priebehu niekoľkých storočí podľa ich predstavivosti. "Toto je jediná kópia na svete, o ktorej sa dá povedať, že je identická a iná neexistuje," vyhlásil.

O originále Turínskeho plátna existujú domnienky, že z obdobia ukrižovania Ježiša Krista nepochádza, a teda na ňom nie je on. "Je to otázka, na ktorú nie je jednoduché odpovedať, pretože nebolo preukázané, že to je on a tiež nebolo vyvrátené, že to je on. Pokiaľ toto nikto nevyvráti, tak sa môžeme domnievať, že skutočnosť, že na plátne je Ježiš, je možná. Prebehli rôzne výskumy, ale žiadny zatiaľ s určitosťou nedokázal povedať, nie je to on," vysvetlil

Originál Turínskeho plátna mal podľa ďalších tvrdení namaľovať Leonardo da Vinci. "Hovorí sa, že Leonardo mal motív, prostriedky, že to mohol vytvoriť, mal i znalosti. Z môjho pohľadu sú tam nejaké nezrovnalosti. Zaoberáme sa touto otázkou, spustili sme projekt, ktorý by na to mal odpovedať," dodal majiteľ kópie plátna.

Kópiu Turínskeho plátna, ako i rúšku z Ovieda a relikvie, ktoré súvisia s ukrižovaním Krista, si návštevníci SNM- Múzea Bojnice môžu pozrieť od 23. mája do 31. júla v rámci galerijného okruhu na zámku. Múzeum nevylučuje, že výstavu predĺži, ak o ňu bude záujem.

# ÚSŽZ v roku 2018 podporil dotáciami 543 projektov krajanov v zahraničí

Úrad pre Slovákov žijúcich v zahraničí (ÚSŽZ) v roku 2018 podporil 543 projektov krajanských spolkov dotáciami vo výške 1.137.889 eur. Úrad o tom informuje v Správe o štátnej politike vo vzťahu k Slovákom žijúcim v zahraničí o poskytnutej podpore krajanských komunít.

Najviac podporených projektov sa týka oblasti kultúry (328 projektov z 21 krajín podporených sumou 776.688 eur), v oblasti vzdelávania, vedy a výskumu poskytol úrad 250.451 eur na 147 projektov krajanov v 25 štátoch sveta. Vydavateľskú činnosť podporil ÚSŽZ sumou 81.500 eur, ktorú prerozdelil medzi 53 projektov v 17 štátoch. Dotáciami vo výške 33.450 eur prispel i na realizáciu 18 mediálnych výstupov tlačových i elektronických médií.

Najviac podporených projektov v každej zo spomínaných oblastí pochádza z činnosti krajanskej komunity v Srbsku, v prípade kultúrnych, vzdelávacích a vydavateľských aktivít to bola viac ako tretina všetkých podporených projektov (v oblasti kultúry 123 z 328, v oblasti vzdelávania 51 zo 147, pri vydavateľskej činnosti 18 z 51 podporených projektov).

Práve v súvislosti so Slovákmi v Srbsku konštatuje ÚSŽZ "vážny zásah do podstaty slovenskej národnostnej menšiny vo Vojvodine". Poukazuje pritom na fakt, že pretrváva záujem Slovákov z Vojvodiny o vydanie osvedčenia Slováka žijúceho v zahraničí (v roku 2018 bolo pre nich vydaných najviac, 1708 osvedčení), s čím súvisí migrácia za prácou na Slovensko. Osvedčenie totiž jeho držiteľovi umožňuje v SR požiadať o prechodný pobyt a získať prácu bez ďalších administratívnych povolení. "Podľa sčítania v roku 2011 žilo v Srbsku 52.750 osôb slovenskej národnosti, aktuálne odhady hovoria o poklese približne o 7000 osôb," informujú predkladatelia správy.

Podľa oficiálnych údajov žije v zahraničí približne 1.070.000 ľudí hlásiacich sa k slovenskej národnosti, odhady samotných krajanov hovoria o tom, že je ich približne o 600.000 viac. Ide o autochtónne slovenské národnostné menšiny v krajinách strednej a východnej Európy, slovenské komunity v zámorí a slovenské komunity v západnej Európe formované hlavne v dôsledku novodobej emigrácie. Z týchto troch skupín v súčasnosti podľa zistení ÚSŽZ narastá počet slovenských imigrantov v zámorí (najmä v USA), ktorí tam prichádzajú za prácou či štúdiom.

Počas slávnostných bohoslužieb si veriaci pripomínajú udalosť, keď na 50. deň po Kristovom zmŕtvychvstaní a desať dní po jeho Nanebovstúpení Duch Svätý zostúpil v podobe ohnivých jazykov na apoštolov zhromaždených v Jeruzaleme. Duch Svätý bol zoslaný, aby ich posilnil a usmernil, ako majú šíriť národom svedectvo o Ježišovi Kristovi. Duch Svätý bol zároveň zjavený ako tretia božská osoba Svätej Trojice.

Následne po Zoslaní Ducha Svätého apoštol Peter predniesol v Jeruzaleme kázeň, na základe ktorej sa dalo pokrstiť asi 3000 ľudí. Preto je dnešná Svätodušná



nedeľa aj pamätným dňom založenia prvého kresťanského zboru v Jeruzaleme. Svätodušné sviatky sú po Vianociach a Veľkej noci tretie najvýznamnejšie kresťanské sviatky cirkevného roka.

Duchovní počas týchto sviatkov veriacim pripomínajú, aby sa viac spoliehali na Ducha Svätého, na jeho dary. Duch Svätý aj dnes posilňuje cirkev a veriacich.

Sväté písmo chápe Ducha Svätého ako tvorivú silu všetkého života. Podľa učenia cirkvi je Duch Svätý poslaný do sveta ako Oživovateľ, aby neustále oživoval osobu, slovo a dielo Ježiša Krista. Duch Svätý je tretia božská osoba Svätej Trojice a vzdáva sa mu tá istá poklona ako Otcovi a Synovi.

Veriaci si počas svätodušných sviatkov pripomínajú sedem darov Ducha Svätého - Dar múdrosti, Dar rozumu, Dar rady, Dar sily, Dar poznania, Dar nábožnosti a Dar bázne Božej.

Pri príležitosti sviatku Zoslania Ducha Svätého sa na Slovensku konajú tradičné turíčne púte. V gréckokatolíckej cirkvi sa v túto Nedeľu Päťdesiatnice, vo sviatok Zostúpenia Svätého Ducha, slávi v chrámoch svätá liturgia.

# Slávenie sviatku Dňa otcov

O zavedenie Dňa otcov do kalendárov sa postarala Sonora Smartová Doddová zo Spokane v americkom štáte Washington a prvýkrát sa slávil 19. júna 1910. Tento deň pripadá na tretiu júnovú nedeľu,

Sonora Louise Smartová Doddová (1882-1978) sa v roku 1909 dopočula, že existuje Deň matiek, ktorý sa slávi z iniciatívy Anny Marie Jarvisovej (1864-1948). Smartová Doddová bola presvedčená, že mala mimoriadneho otca. Henry Jackson Smart bol veteránom občianskej vojny. Keď jeho žena po pôrode zomrela, sám vychoval šesť detí. Podľa Doddovej bol jej otec odvážny, obetavý a milujúci muž.

Otec Smartovej Doddovej sa narodil v júni, preto voľba na oslavy prvého Dňa otcov v meste Spokane pripadla na 19. júna 1910. Jednotlivé štáty USA a organizácie začali robiť nátlak na Kongres, aby oficiálne vyhlásil Deň otcov so zámerom sláviť ho každý rok. V roku 1924 americký prezident Calvin Coolidge z tejto myšlienky urobil celonárodnú záležitosť, aby vznikli užšie vzťahy medzi otcami a ich deťmi a upozornil otcov na plnenie si záväzkov voči ratolestiam.

Sviatok nadobudol oficiálny charakter za 36. amerického prezidenta Lyndona Johnsona (1908-1973). Politik, ktorý prezidentský úrad zastával v rokoch 1963-1969, podpísal v roku 1966 výnos, ktorým zaviedol oslavy v tretiu júnovú nedeľu. Avšak 37. americký prezident, v rokoch 1969-1974, Richard Nixon (1913-1994) v roku 1972 potvrdil trvalé slávenie Dňa otcov na celonárodnej úrovni v tretiu júnovú nedeľu zákonom.

# Vo Vysokých Tatrách stretnutie ministrov zahraničných vecí účastníckych štátov OBSE

V polčase tohtoročného slovenského predsedníctva v Organizácii pre bezpečnosť a spoluprácu v Európe (OBSE) sa 9. júla uskutoční vo Vysokých Tatrách neformálne stretnutie ministrov zahraničných vecí účastníckych štátov OBSE. Toto podujatie je príležitosťou na zhodnotenie prvého predsedníckeho polroka a zároveň na určenie smerovania pre ďalších šesť mesiacov predsedníctva. Na závery tohto stretnutia nadviaže decembrová Ministerská rada OBSE, ktorá bude zároveň vrcholným predsedníckym podujatím.

Hlavnou témou neformálneho ministerského stretnutia bude "From the action to the future prevention: the OSCE's niche in fostering stability in Europe and beyond" - "Od minulých aktivít k prevencii v budúcnosti: miesto OBSE v zaisťovaní stability v Európe a za jej hranicami." Slovenské predsedníctvo plánuje uskutočniť v rámci tohto podujatia rozsiahle konzultácie s účastníckymi štátmi. Na schôdzku pricestujú zástupcovia 57 účastníckych štátov organizácie, ako aj predstavitelia OBSE. Dejiskom konferencie je Grand Hotel Kempinski High Tatras na Štrbskom Plese. Oficiálna tlačová konferencia bude za účasti úradujúceho predsedu OBSE Miroslava Lajčáka a generálneho tajomníka OBSE Thomasa Gremingera a bude otvorená pre všetkých zástupcov médií.
