We can remember the best of times, and in a way remember our Mothers as we did as children, the center of our universe with their unlimited love.


I extend a Happy and Blessed Mothers' Day to all Wives and Mothers, both alive with us today and in Eternity.

# Insights and Viewpoints

Sunday, May 20, 2018 - Pentecost John 20: 19-23

We are told in Acts that on Pentecost the Apostles and Disciples were gathered in the upper room. The same upper room were the Apostles shared the Last Supper with Jesus, where they fled to and hid in fear after Jesus was arrested, crucified, died and was buried. It was behind the locked doors of this Upper Room where the Risen Lord appeared twice to the Apos-

the Risen Lord appeared twice to the Apostles, greeting them each time by saying; "Peace be with you." This Upper Room that contained so many memories for them seemed to have become their refuge, and even after their experience of seeing the Risen Lord it seems like it was their tomb. They continued to return there and lock themselves away until Pentecost.

At the Ascension Jesus told the Apostles to return to Jerusalem "until you are clothed with power from on high." Luke 24; 49. Tradition has it that they returned to Jerusalem where they gathered in the Upper Room, and scripture tells us that, "they were continually in the temple praising God." Luke 24; 53. At the Ascension Jesus didn't tell them how long they were to wait until the Holy Spirit would be given to them, just to wait and to pray. I imagine that every day after the Ascension as they gathered together they wondered, "is this the day?" They did this for 49 days during which nothing extraordinary happened, and on the 50th day everything changed. This was the Jewish Feast of Pentecost, which was celebrated fifty days after Passover. Jerusalem was full of pilgrims from everywhere who came to celebrate the Feast. It was on this day that the Apostles and Disciples experienced the great outpouring of the Holy Spirit. It changed them instantly and they left the tomb they had made in the upper room and went out to boldly preach the Risen Lord. The Holy Spirit took away their fear and blessed them with the gifts they needed to boldly proclaim the message with great joy. This first Pentecost is sometimes referred to as the birthday of the Church, and we joyfully celebrate our birthday as church every year.

It was in the unity of the gift of the Holy Spirit that the believers faith in the resurrection of Jesus, and the love of the Father. Their experience of each person of the Triune God was life changing in such a powerful way that not only were their lives changed, but they couldn't keep their experience to themselves. They went forth to tell everyone, and - as Jesus instructed them before He ascended - they baptized in the Name of the Father, and of the Son, and of the Holy Spirit.

As we celebrate this great outpouring of the Holy Spirit today it is important for us to keep in mind that the Holy Spirit that came to the early church never left the church. This Holy Spirit has been with the church for two thousand years and continues to bless us with the gifts we need and to call us to unity. In the Sacraments of Baptism and Confirmation we received and experienced the Holy Spirit so the gifts and power are within us. This Feast is a time for us to give the Holy Spirit permission to work more powerfully in our lives, and to call upon the Holy Spirit to take away anything that stands in the way of us experiencing his presence more in our lives. To help us come forth from whatever tombs might be holding us back. The Holy Spirit did great and marvelous things to those first Christians, and he can do great and marvelous things for us. Come, Holy Spirit and fill our hearts!

#### May 27, 2018 – Trinity Sunday Matthew 28: 16–20

Today is Trinity Sunday, the first Sunday following both Pentecost and the entire Easter season. Through the fifty days of Easter culminating with Pentecost, we rejoice in the resurrection of Christ from the dead, the foundational event of Christian faith and the source of all authentic Christian hope. As that Easter season approached its crescendo in the days of the feasts of the Ascension and Pentecost, we heard a clear and consistent theme in both the scripture readings at Mass and in the prayers said at Mass that directs us to take up the mission of sharing with the whole world the Trinitarian faith we treasure as believers in the risen Lord.

Now that we pass into the long season of the Church year that is called "ordinary time"—a somewhat unfortunate name—we are urged once more by the readings to commit ourselves to the mission theme announced at the Ascension and Pentecost, and a Trinitarian catechesis launches us on our way.

The first reading today comes from Deuteronomy, and it extolls God for creating the world and all that is in it, for revealing himself to the people of Israel, and for leading them forth in triumph from their slavery in Egypt. Deuteronomy reflects at length on God's loving words and deeds as they were made know to Israel, and in one of its most profound passages teaches that there is One God only (Deut 6:4-5). This is a touchstone of both Judaism and Christianity, and for Catholics it is a critical point to recall on Trinity Sunday: we do not worship three "Gods"—Father, Son, and Holy Spirit—but rather one God, revealed to us as the three Persons of the Holy Trinity.

Having learned that there is only one true God, the Psalms then teach us to call out to God not as some sort of abstract entity, but as One who genuinely loves us: "See, the eyes of the LORD are upon those who fear him, upon those who hope for his kindness, To deliver them from death and preserve them in spite of famine" (Ps 33:18-19). Next, in today's excerpt from the Letter to the Romans, Saint Paul teaches us that "we are children of God... and if children, then heirs, heirs of God and joint heirs with Christ"—witnessed to by the very Spirit of God (Rom 8:16-17). Thus we are affirmed in our faith that the one true God reveals himself to us as Father, Son, and Spirit, whom we normally call the Holy Spirit—and that we are considered by God to be his children, adopted in Christ the Son.

So then we rejoice in our adopted sonship or daughterhood and set out to live in the light of this joyous mystery. To do that, we return to the theme that ran strongly through the readings for the last two Sundays, that of mission. In the Gospel reading for Trinity Sunday Saint Matthew tells us: "Go, therefore, and make disciples of all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Spirit, teaching them to observe all that I have commanded you. And behold, I am with you always, until the end of the age" (Matt 28:19).

Strengthened by the love of God which is made visible to us in the risen Christ, let us resolve to enter into the long summertime of the Church year, living as though we truly believe that which we profess each week in the Creed, and thus helping to make the Good News of the Father, Son, and Holy Spirit come alive both in our own homes and neighborhoods—and to the ends of the earth.

My goal is to reverse the trend of the past 50 years and increase membership by putting the "fraternal" back in the F.C.S.U.! We will give our youth reasons to embrace membership. We will institute a comprehensive marketing program. Past administrations worked hard, but limited their efforts to advertising, not marketing. And there is a BIG difference. Our focus must be on our chief product. And that product is our fraternal purpose.

I have worked diligently the last four years to enhance the growth and financial stability of our Society. As a member of the Finance Committee, I have worked with our Executive Team and our professional investment manager to implement and adapt successful procedures that maintain annuity premiums at current levels while maintaining a balanced portfolio. The Society shows a surplus gain for 2017 of \$2,683,450 (+9.5%), which created the highest level in the history of the Society at \$30,782,846. Maintaining and growing surplus is necessary to support and grow new business. The Society has achieved a new record in assets for 2017 at \$395,965,421, an increase of \$13,574,040 over last year and a +12.67% gain over the last 3 years. The FCSU's solvency rate as of December 31, 2017, was over 107%, which is higher than many of the largest insurance companies in the United States.

Over the last four years, I with the Executive Board have updated the Investment Policy Statement to be in compliance. I have made recommendations to establish programs that create parameters that will increase the return on investment income within our portfolio. I continue to seek ways to make changes that decrease our investment expenses. I sought ways to ensure that financial matters are disclosed in a transparent manner to our membership.

If re-elected, I plan on working to develop programs to look at new and innovative ways to attract new members to invest with the FCSU. I will continue to aggressively market annuities while maintaining the proper spread between credited rates and net investment income and implement effective sales strategies.

My understanding of business practices, investment policies, investment procedures and investment philosophy makes me well rounded and equipped to serve the FCSU and to be your Treasurer. I humbly ask for your vote of confidence to serve the FCSU and work with you as we develop a financially strong and stable Society.

# The Immigrant Mother Revisited

The following article first appeared in the May 1, 1996 issue of Jednota. Since the positive response was so great, I periodically have it reprinted from time to time.

Several years ago, my sister gave me a copy of an article entitled "The Immigrant Mother." From the stories our parents used to tell us, the publication was indeed true to life.

Every time I ran across the article, I would read it and start reminiscing about my own mother. She too was an immigrant. She was born in a mountain village called Vondriesel in Slovakia, and came to this country at the age of 19. She married and bore 10 children.

When I was growing up, I can remember she would never eat a meal until my fathers, brothers and sisters and I had finished eating. She wanted to make sure everyone had enough to eat before she would sit down. Many, many times she deprived herself and went without for the sake of her children.

With Mother's Day approaching, I thought it would be a fitting tribute to have this article printed in honor of all our mothers.

#### The Immigrant Mother

For all eternity America is indebted to the immigrant mother, whether she is Italian, Slovak, Jewish, Polish, Austrian, German, Russian, English, Greek,

Bulgarian, Irish, Slovenian, or Ukrainian.

Born in the old country, she usually married at a young age the young boy with whom she worked in the fields. While still a young bride and sometimes with child, she remained and waited while her man left for America – that distant land filled with promises of a better life.

The days, months, and sometimes years, passed slowly, while she patiently waited for word from her husband. Finally, when the letter came with the passage fare for the long boat ride to America, she gathered up her few possessions and children, and boarded a ship to join her husband.

She found him working in the steel mills, brickyards, iron mines, coal mines, slate mines, and on the railroad. She found him living in a shack, shanty, railroad car, or even in a tent. But at least this was a start, a foundation for a new life. Here in America, with her husband at her side, she prepared for the years ahead.

Our country was young; it needed laborersl she gave five, six or more children from her body and of her soul. While her husband worked in the bitter cold of winter, or the blistering heat of summer, in ditches laying sewers, and deep in the ground mining coal or iron ore, the mothers worked from early morning to late at night, cooking on a coal stove, washing the clothes with a washboard, and heating the water in a big copper tub on the same coal stove. At the same time, she took care of the children, preparing breakfast, making lunches, and sending them off to school.

Now, the freshness of young womanhood is gone. By the flickering oil lamp she sews and irons clothes late into the night. She scrimps and saves to dress her children decently, while she wears an old dress and stays at home. Her children must have an education, so that they may be respected and amount to something someday.

And then at last, when her children are grown, as her cup of joy runneth over, we see how want, deprivation, and hardship have taken their toll. All worn out, her bones aching from so many ills, she lays helplessly in her sick bed, and her children gather around her. She turns to kiss them and to bless them – and then she is gone.

She is the unsung hero and pioneer of America. No statue can be built high enough with which to sculpture a fitting memorial to the immigrant mother.

She, who with her breast nurtured us, with her arms raised us, with her ideals inspired us, with her tears washed us clean, with her devotion saved us, and then on the altar of love, laid out her worn spent body. She found her place in heaven and sends down her blessing on America for what America has offered to her children in this great land.

May the people of America never forget what they owe to that sweet and blessed soul – the immigrant mother of us all.

## 2017 Annual Report of National Auditors

The Internal Audit team consists of a Chairman and three Auditors elected by the Convention. Our responsibility is to conduct audits of documentation, processes and procedures of the First Catholic Slovak Union. Quarterly audits are conducted allowing confirmation that numbers are precise and truthful. This report covers the fiscal year January 1, 2017 through December 31, 2017

The audits are performed in accordance with the bylaws of the First Catholic Slovak Union of the United States and Canada, effective January 1, 2015. The necessary information to complete reviews are provided by the First Catholic Slovak Union.

Below is a list of the processes chosen for audit. Our responsibility is to report on the areas chosen thus our review would not necessarily disclose all weaknesses in the organizations internal controls.

THE AUDIT PURPOSE/OBJECTIVES INCLUDED, BUT WERE NOT LIMITED TO THE FOLLOWING:

- > Review expense vouchers submitted.
  - o Ensure expense vouchers
    - contain required and relevant documentation
    - calculations are correct
    - approvals are obtained
    - checks are properly issued and documented
- > Test death claims processed.

o Ensure death claims

- contain required and relevant documentation
- are processed correctly according to FCSU
- checks are properly issued and documented
- > Test payroll and personnel procedures.
  - o Ensure payroll and personnel
    - procedures are in place and functioning properly
    - calculations of earning, special payments, taxes and voluntary/ involuntary deductions are accurate complete and timely
    - transactions are accurately reflected in the accounting system
- Test bank reconciliation process.
  - o Ensure bank reconciliations
    - are performed in a timely manner
    - verify cleared and outstanding checks
    - account for deposits, transfers, withdrawals and bank fees
    - are reconciled to the accounting system
- > Test certificate loan process
  - o Ensure certificate loans
    - contain proper approvals and signatures

- invoices are mailed in a timely manner
- interest is calculated properly
- Review corporate credit card procedures
   o Verify proper internal controls are being utilized to ensure
  - relevant documentation present
  - approval follows designated chain of authority
  - mathematical calculations are correct

#### **METHODOLOGY**

Audit procedure programs written by the auditing team are used throughout the year to evaluate the key operations of the specific areas chosen to be audited. Discussion with management and staff, observation, and analytical testing is completed. All results are presented to the President and Executive Secretary prior to closing the audit.

#### **OVERALL EVALUATION OF AUDITS**

All auditors agree that no abuse or irregularities were discovered during the audits performed for the period January 1, 2017 through December 31, 2017. Controls are adequate, keeping errors to a minimum. It is my professional opinion that the home office operates effectively and with high standards.

#### **ADDITIONAL MATTERS**

#### RECOMMENDATIONS TO THE BYLAWS COMMITTEE

Prior to each Convention of the FCSU, auditors are required to submit recommendations or proposals to the Bylaws Committee. Twelve recommendations were submitted to the committee in hopes of making it to the Convention floor for consideration.

#### SUPREME COURT HEARING

The Supreme Court of the First Catholic Slovak Union met on September 21, 2017 to rule on complaints filed by Robert Kristofik (see article on page 11 of the December 6, 2017 issue of JEDNOTA). Three of the four complaints were dismissed, with one being withdrawn by Mr. Krsitofik because of lack of merit.

While the complaint of improper and/or incomplete filing of 990 forms were, by a unanimous vote, found to be "filed and amended in good faith", it was ordered that an outside agency, selected by the Chairwomen of Auditors, be secured to audit the 990 forms for the years 2013–2016.

Bids were solicited from three accounting firms. Schneider Downs of Pittsburgh was chosen to review and report on the findings.

#### **FINDINGS**

FCSU meets all requirements and operates in a manner that is consistent with its exempt purpose in order to ensure that the IRS cannot challenge its exempt status.

There are two areas in which Schneider Downs suggests we consider amending the 990 forms, and there are items in which they suggest FCSU report differently in future years.

The agency's overall conclusion is: "As with almost any Form 990 items could be reported differently. However, we believe the returns have been consistently filed on a timely basis in a complete and accurate manner."

# New York Area Slovaks Celebrate the Centennial of the Pittsburgh Agreement

On Sunday, April 15, 2018, the Slovak League of America, a civic and cultural federation of Americans of Slovak ancestry, hosted a program commemorating the 100th anniversary of the signing of the Pittsburgh Agreement at St. John Nepomucene Parish in New York City. The agreement was an important document which led to the establishment of the first Czecho-Slovak Republic in 1918. The celebration also honored the 25th anniversary of Slovakia's independence. The program opened with a Slovak Mass celebrated by the Rev. Igor Kral, S.V.D. in the majestic church. The pastor, the Rev. Richard D. Baker offered a warm welcome to the Slovak League and guests.

Following the impressive liturgy, nearly 200 guests enjoyed a dinner and cultural program in the parish social hall. Slovak League President, Daniel F. Tanzone served as the afternoon's toastmaster. The program opened with the anthems of the United States and Slovakia, led by the young tenor, Andrew Pulver. The guests then enjoyed a delicious dinner featuring Slovak culinary specialities under the direction of Jan Skrkon ,Branch 716 President of the First Catholic Slovak Union.

Principal speaker at the dinner was Cynthia M. Maleski, Esq. national president of the First Catholic Slovak Ladies Association. President Maleski recalled the rich history of the Pittsburgh Agreement signed on May 31, 1918 and the role played by American Slovaks and Czechs in the liberation of Slovaks and Czechs in their ancestral homeland a century ago which led to the establishment of the first republic of Czecho-Slovakia.

Greetings were extended by Ladislava Begec, Consul General of the Slovak Republic. She lauded the work of the New York area Slovak community in helping preserve the rich history, culture and heritage of Slovakia.

Remarks were offered in the name of Assembly 1 of the Slovak League in New York by Dr.

Ladislav Korcek. Dr. Korcek, president of Assembly 182 of the Slovak Catholic Sokol, also spoke on behalf of the local lodges of the First Catholic Slovak Union and the First Catholic Slovak Ladies Association. He recalled the rich history of Assembly 1 over the years.

Greetings were then offered by Stephen J. Kubasek, Jr., president of Branch 41 of the First Catholic Slovak Union in Yonkers, N.Y. and a former city council member there. His late uncle, the Rev. John J. Kubasek, long-time pastor of the former Most Holy Trinity Slovak Parish in Yonkers, was a signator of the Pittsburgh Agreement in his capacity as national president of the Slovak Catholic Federation at the time.

A cultural interlude then followed and included the artisty of the young tenor, Andrew Pulver who was accompanied on the piano by his mom, Tanya Ferencko Pulver. Andrew, who has performed at New York's famed Metropolitan Opera and is active in area theatre groups, offered favorite Slovak folk selections. Offering a lively selection of traditional Slovak music and dance were members of The Lipka Slovak Folk Ensemble of Holy Family Parish in Linden, N.J.

The pastor and well-known Slovak cultural and religious activist, Father Richard D. Baker then offered remarks in which he commended the Slovak League of America for its efforts in helping to preserve our rich cultural heritage among the current generations. He thanked the local Slovak fraternal societies for their loyalty and support of the United Parish of St. John Nepomucene, St. John Martyr and St. Frances Xavier Cabrini - the East River Catholics.

The response followed offered by W.Nina Holy, national secretary-treasurer of the Slovak League of America. She thanked all who had a hand in the success of the celebration. She especially thanked our member Slovak fraternals for their continued support. In addition to Cynthia M. Maleski who represented the First Catholic Slovak Ladies Association, also present were Scott T. Pogorelec, F.I.C., supreme secretary of the Slovak Catholic Sokol and Sabina Sabados, regional director of the First Catholic Slovak Union. Also participating in the celebration were representatives of the Slovak Catholic Media Productions – Lux, which is headquartered at the New York Slovak parish.

The program concluded with the benediction offered by the Rev. Richard D. Baker followed by the singing of Kto za pravdu hori and God Bless America.

# Reflections on the Centennial of the Pittsburgh Agreement

On May 31, 1918, representatives of the Slovak League of America, the Czech National Federation and the National Alliance of Czech Catholics met in Pittsburgh with Thomas G. Masaryk to discuss the future union or federation of the Czechs and Slovaks in Europe. The important question of autonomy for the Slovaks was uppermost in the minds of the American Slovaks. The provisions of the Pittsburgh Agreement were initially considered, agreed to, and subsequently disavowed by Masaryk who would become the first president of the Czecho-Slovak Republic. The accord possessed all the elements of a contract accepted by two responsible groups.



Masaryk later told the Slovak leader, Msgr. Andrew Hlinka that the agreement was meant for America and for American conditions. In response, Hlinka said it was difficult to not laugh in the President's presence. A total of 17 Slovaks and 12 Czechs were signatories of the agreement which was signed at the Loyal Order of Moose Hall in downtown Pittsburgh. They represented Slovaks and Czechs from various parts of the United States.

The translated text of the agreement said that "Slovakia shall have its own administration, her own assembly, and her own courts. The Slovak language shall be the official language in the schools, in public offices and in public life in general. The Czecho-Slovak State shall be a republic; its constitution shall be democratic. The cooperation of the Czechs and Slovaks in the United States shall be intensified and regulated by mutual consent, according to need and changing situations. Detailed provisions relating to the organization of the Czecho-Slovak State shall be left to the liberated Czechs and Slovaks and their legal representatives...." The name of the proposed state shall be "Czecho-Slovakia," as found in the treaties and all official documents at the time of the creation of the Republic. The name of the Republic implied the idea of a "dual" republic. Sadly, none of the promises of the Pittsburgh Agreement regarding the Slovaks were realized. Instead a strong central government emerged with the Czechs commanding the upper hand. Then in 1923, the name of the republic was officially changed to "Czechoslovakia" signaling the further development of a fictional Czechoslovak idea.

The American Slovaks supported the Million Dollar Drive of the Slovak League of America which had begun in 1916 under the capable leadership of the Rev. Joseph Murgas in support of the Slovak and Czech cause abroad - in France, Russia, Italy and later in Czecho-Slovakia. More than one million dollars funneled through the Slovak League aided the new Czecho-Slovak Republic in its early years.

# The Patroness of Slovakia: Our Lady of Sorrows

Many of us know that Our Lady of Sorrows is the patroness of Slovakia, and May is a month of special devotions to the Virgin Mary. We celebrate her feast on September 15, and her feast day is a national holiday in Slovakia, with most businesses closed. But often we do not know the story of how the Virgin Mary and her sufferings came to be identified with the people of Slovakia. The identification of the sorrowful Mother with the Slovak nation stems from a miracle which occurred long ago in the 16th century.

It all started in Šaštín, a town in the Trnava region of western Slovakia; the town lies between the Myjava Hills and the Záhorie Lowland, not far from Moravia. It is about 18 km from Senica and 65 km from the Slovak capital, Bratislava. In 2001, the town was renamed Šaštín – Stráže, a city of around 5,000 inhabitants. Today it is the home of one of largest and most popular shrine for Christians - the Monastery and Church of the Seven Sorrow of the Virgin Mary (Kláštor a Kostol Sedembolestnej Panny Márie).

#### **Historical Background**

Historians have found evidence of settlement in the Šaštín area from the second half of the 10th century until about 1250. The town's official history dates back to the early 13th century; its oldest record dates from 1218, when the Hungarian King Emeric II (Imrich, in Slovak) gifted the property of the Lebéný Benedictine Monastery to the Györ family. The name of the town derived from the Magyar word "sás," (meaning šašina or tŕstie in Slovak), a reference to the marshy grass with solid stems in the marshy wetlands area where the town started.

In the late 14th century, Šaštín acquired the formal privileges associated with the status of a town. Aside from serving as the site of several battles and the home to a thriving craft industry, Šaštín did not have any special economic significance until the 18th century. Acquired by the emperor due to outstanding debts, Maria Theresa's husband, Francis of Lorraine, used his new estate for business purposes. He had calico textile factory (kartúnka) established that became one of largest enterprises in central Europe. By acquiring a monopoly of the business in the empire, it soon employed over 20,000 domestic spinners and foreign skilled workers. The crown sold the factory to the Viennese banker, Johann Puthon, in the 1780s. It continued to prosper until the late 19th century, when the business declined due to competition.

#### **Apparitions of the Virgin Mary**

Šaštín had no special religious significance until 1564, when the Virgin Mary, as Our Lady of Sorrows, first appeared to Angelika Bakičová, the wife of the landowner named Imrich Czobor. The apparition occurred while she was praying for help to deal with some personal trials in her life.

In thanksgiving for hearing her prayers, Pani Bakičová commissioned an unknown artist to sculpt a wooden statue at the place of the apparition. Soon word spread of her vision, and the faithful from nearby towns and villages began to visit the site as a place of pilgrimage. Before long, pilgrims from far away heard of the apparition and also started to make longer journeys to Saštín in order to pay homage to Our Sorrowful Mother. A triangular Marian Chapel was then built to house the statue in the late 16th century.

During the Turkish wars, the statue was moved in 1654 for protection to the Chapel of St. Imrich, in a nearby manor house. It did not return to its original chapel until 1710, and soon attracted throngs of pilgrims who credited Our Lady of Sorrows for many spiritual and physical miracles of healing.

#### Official Church Recognition

Not until the early 18th century did the Church officially grant its approval for public worship of the statue of Our Lady of Sorrows. But further recognition involved an extensive official Church investigation. On August 25, 1732, the statue was moved to

the Loreto Chapel of the town church. In the meantime, an official Church commission found that as many as 726 miracles were associated with the statue.

Finally, Archbishop Imrich Estzterházy in Esztergom, the center of Catholicism in Hungary, sanctioned the chapel in Šaštín as an official place of pilgrimage. The statue returned to its original location in the triangular chapel, under the care of Rev. Ján Schon. A throng of over 20,000 people gathered to celebrate the first Holy Mass at the chapel. This sealed its sanctity as place of worship for centuries to come.

#### **Building a Basilica and Monastery**

The Pauline religious order received responsibility to minister and take care of the shrine starting in 1733. Upon arriving in Šaštín, the Paulines decided to build a basilica to accommodate pilgrims and a monastery to house the clergy. The cornerstone for the new church was laid on July 16, 1736. Johann Damian and later Matej Vepý from Vienna directed its construction. The builders completed construction of the main part of the basilica and its roof in 1748, and three years later, the adjoining monastery was finished.

Once the building was finished, attention turned to the decoration of the interior. In 1757, the Austrian court painter, Jean-Joseph Chamant, adorned the basilica ceiling and the side altars with a series of colorful frescoes and murals. Another important Austrian master of the era, Johann Lucas Kracker, painted three side altars of the basilica.

During the reign of Empress Maria Theresa, the renowned Habsburg imperial architect, Franz Hildebrand, recommended additional adornments, including the construction of a main altar made of red marble and the decoration of the façade of the basilica. The donations of thousands of ordinary people of Slovakia and Maria Theresa's personal contribution funded the project. All was done to prepare for the 200th anniversary of the apparition in 1764.

The official blessing and dedication of the basilica occurred on August 15, 1764. The culmination of the ceremony featured the presentation of the statue at the main altar. In addition to the many thousands of pilgrims who came for the grand event, the attendees at the event sounded like a list of "who's who" in the Habsburg Empire – the Esztergom Archbishop Barkoczi, Empress Maria Theresa and her husband Francis of Lorraine, and many other clergy and dignitaries.

Other improvement continued in the ensuing years. Just a year later, the bells were blessed and the domes finished. In 1771, a lectern was completed, as well as a magnificent organ with 25 variations to fill the basilica with heavenly music. Gradually over time, construction workers completed the side altars and finished the project.

# Fr. Marek Višnovský named Protosyncellus for the Eparchy of Parma, OH

On the fourth Sunday of the Great Fast (Lent), March 11, 2018, it was announced that His Grace, Bishop Milan Lach SJ, the Apostolic Administrator of the Byzantine Catholic Eparchy of Parma, OH, appointed Fr. Marek Višnovský, pastor of St. Mary Church in Cleveland, OH, as the new Protosyncellus of this Eparchy. Fr. Višnovský was named Protosyncellus, effective March 9, 2018, and additionally Vocation Director as well as Syncellus for Clergy, effective March 12, 2018.

This strange-sounding title of Protosyncellus is in fact an equivalent position to the Roman Catholic title of the Vicar General, sharing the executive power of the eparchial bishop. But what are origins of this title and what does it mean for our Byzantine-Slovak priest, serving in the USA with his family? The term itself has its origins in Greek, where proto

means the first one and syncellus derives from words syn (with) and kellion (a monastic cell). Originally a syncellus was a monk assigned to be obedient to the superior, to live with him in one cell and thus be a witness to his purity of the life. In our modern context, the closest analogous relationship is that of a co-worker to the ruling bishop.

The Code of Canons of Eastern Churches (Canons 245-250) stipulates that in each eparchy a protosyncellus is to be appointed, in order to assist the eparchial bishop in governing the whole eparchy. Usually the protosyncellus is to be a celibate priest, but exceptions are possible. The custom of celibacy is probably closely connected with a fact that where there is an auxiliary bishop, he automatically becomes protosyncellus (Vicar-General) of that specific bishopric – and, in the Eastern Rite, only celibate priests are eligible to advance to the level of bishop. In every case, the protosyncellus should be not less than thirty years of age and ideally should have a doctorate in theology, or at least to be an expert in some sacred discipline. The protosyncellus should be also of sound doctrine, upright, prudent and to have experience in handling matters. It is prohibited for an eparchial bishop to name any blood relatives up to the fourth degree.

Fr. Višňovský is a native of Dlhé Klčovo, near Vranov nad Topľou in Slovakia. He received his priestly formation in Prešov, where he finished his theological studies in 2004. Before his diaconal ordination he married his wife – Mrs. Miriam Višňovský, well-known to many of the Jednota readers, as she is currently member of the FCSU staff. Together they are proud parents of three. The entire family are members of the First Catholic Slovak Union.

Fr. Višňovský was ordained a priest in the Cathedral of St. John the Baptist in Prešov by laying of hands of the now Metropolitan Ján Babjak SJ in 2004. A few weeks after his ordination, he came with his wife to the Eparchy of Parma, thanks to the interest and good-will of the then bishop of Parma, the Most Reverend John Kudrick. Since then he has ministered in Holy Spirit Parish, Parma; St. Emilian Parish in Brunswick, OH; and currently at St. Mary Church in Cleveland, OH. In 2009 Fr. Višňovský did officially transfer into the Eparchy of Parma from the Archeparchy of Prešov. Fr. Višňovský loves soccer and is a gifted iconographer, whose works adorn many of our Byzantine Catholic churches and homes on both sides of the Atlantic.

Because of this new assignment and in accordance with the local custom for a protosyncellus, Fr. Višňovský was granted the title of Mitered Archpriest and was given a miter as a symbol of his office. In the USA, one of the first priests to receive a miter was the late Fr. Eugene Chromoga, who received his miter in 1969, when the Eparchy of Parma was established and he was named its first Protosyncellus. The Miter was solemnly conferred to Fr. Višňovský by Bishop Milan Lach SJ, during the liturgy at the Cathedral of St. John the Baptist on Holy Thursday, March 29, 2018.

We invoke on Fr. Višňovský in his new assignment the strength and courage of the Holy Spirit, and we wish him, his wife Miriam and their children peace, health and happiness for many happy and blessed years, Christos Voskrese!

# Saints Cyril & Methodius Sisters Speak at Vocation Awareness Day



# April Celebrations for Branch 716












#### **Decline and Revival**

When the reforming Emperor Joseph II (1780-90) dissolved the monasteries in the empire, the basilica became government property. The Paulines fled to Poland in 1786. The Saštín pastor Jakub Schneider and four chaplains then closed their parish church, moved to the monastery quarters, and took over administering the basilica. The Salesian Order would later take over the ministering of the shrine when the monastery was later reopened after Joseph II's reign.

The next notable event occurred in 1864 – the 300th anniversary of the apparition. In preparation for the event, Deacon Stefan Hrebiček contracted Jozef Bárta from Hodonín to raise the two towers to their current height and renovate the basilica. A grand ceremony took place on September 8, 1864, at which 300 clergy and over 120,000 pilgrims attended. Presided over by the Esztergom Archbishop, Cardinal Ján Scitovsky, he placed on the statue a crown of gold blessed by Pope Pius IX.

Sastín appeared in the news again when the Emperor Franz Joseph paid a visit to the shrine in 1902. But details were lacking about this historic visit.

Next mention of the shrine is during World War I, when the bells were hidden to protect them from possible damage or melting down to make weapons. After the war in 1926, the basilica had four more large bells consecrated.

#### **Patroness of Slovakia**

The greatest moment for the shrine came the following year in April 1927, when Pope Pius XI declared that Our Sorrowful Mother would be the patroness of Slovakia. In order to acknowledge the Holy See's decision, this patronage, three bishops celebrated a Holy Mass on May 22, 1927, attended by over 40,000 pilgrims.

Improvements to the basilica continued over the next couple decades: in 1929 a new national bell to Our Lady of Seven Sorrows weighed about 5,000 pounds. The next year the basilica acquired electric lighting. During World War II, renovations improved the sanctuary. the organ, and the building itself. Slovaks living in Vienna donated the Stations of the Cross for the shrine.

#### **Communist Suppression**

After the Second World War, the communist dictatorship attacked all Holy Orders and in 1950, state police forcefully expelled the Salesians from the shrine. The shrine once again came under the administration of the diocese and the local parish. Nonetheless, the pilgrims continued to flock to the shrine and a new grander organ was even completed.

On the occasion of the 400th anniversary of Angelika Bakičová's apparition, Pope Paul VI declared in 1964 the church in Sastín would be a minor basilica. Trnava's Bishop Lazik presided at the celebration Mass shortly after Christmas in that year.

When Slovak leader Alexander Dubček relaxed many of the anti-religious in Czechoslovakia during 1968, the Salesians could return temporarily to minister the shrine. While shortlived, further improvements to the bells and church included a new marble altar completed in 1975.

Another great moment in the history of the shrine was the visit of Mother Theresa of Calcutta, who made a pilgrimage to Saštín in 1987. The then newly appointed Archbishop-Metropolitan of Trnava, Ján Sokol, hosted the occasion.

#### Renewal in a Free Slovakia

The fall of communism after 1989 meant the final return of the Salesians to take care of the shrine in February 1990. The Rev. Ján Malženický continued to renovate the basilica and monastery in preparation for the first national pilgrimage after years of totalitarian rule. During his sojourn to Bratislava, Pope John Paul II flew over the shrine in a helicopter during April on his first visit to Slovakia and blessed it, promising to return personally to pay homage to Our Lady of Sorrows. The faithful of Slovakia responded with a massive celebration, which counted 900 priests and many thousands of pilgrims at the May event.

The Pope fulfilled his promise to Our Lady and the people of Slovakia in 1995, when he made an afternoon visit to the shrine on July 1. Over one half million pilgrims attended for the papal visit. There he concelebrated Holy Mass with 48 high Church dignitaries, but his sermon addressed the poor, whom he said gave him strength to carry on his mission. He repeatedly mentioned how he joined with the poor in prayer. The pope also blessed 20 cornerstones from which new churches would be built across Slovakia.

The papal visit in 1995 was indeed the culmination of the revitalization of the Sastín shrine to Our Lady of Sorrows. Since then, the annual pilgrimages continue to take place annually

on September 15 and on the Feast of SS. Cyril and Methodius on July 5. Improvements to the basilica continue and the slow process of restoring the beautiful interior and Chamant's frescoes is ongoing.

In 1998, the Slovak Republic also issued a stamp with the Pieta statue from main altar of the Marian Basilica of Our Lady of Sorrows. The picture included shows the stamp.

#### Visiting the Shrine

If one is interested the shrine of Our Lady of Sorrows in Slovakia, the basilica holds daily Masses and devotions for pilgrims. Special ceremonies occur on special feast days such as May 24, the feast of Our Lady Help of Christians (Panna Mária, Pomocnica kresťanov). There are also huge processions for pilgrims held on Pentecost Sunday (Turíce or Svätodušná nedeľa; Greek-Catholic and Orthodox Churches traditionally called Pentecost, The Descent of the Holy Spirit (Zostúpenie Svätého Ducha). And the biggest celebration and pilgrimage occurs on September 15-16 (Our Lady of Sorrows). Special Fatima devotions regularly take place on the first Saturday of every month. All masses are in Slovak, but it might be possible for special arrangement to be made for pilgrims from abroad. The website is supposed to have an English translation tab, but it did not function when tried: http://bazilika.sk/.

#### The Jednota Chapel in Washington

Here in the United States, Slovak Americans also have remembered Our Lady of Sorrows. In 1965, our First Catholic Slovak Union contributed the funds to build the Jednota Chapel in Our Lady's honor at the Basilica of the National Shrine of the Immaculate Conception in Washington, D.C. Our Lady of Sorrows is also the patron of the First Catholic Slovak Union.

The shrine depicts the seven sorrows of Mary in a series of bronze reliefs and a lifesized sculpture of the Mary holding the crucified Christ (most often called a "Pieta," meaning

> "mercy"). The theme resembles that of the famous statue by Michelangelo which rests at St. Peter's Basilica in the Vatican. Ernest Morenon sculpted the statue for the Washington shrine. The statue is notable for its simple and realistic lines, which reveal the depths of Mary's sorrows and grief at the death of her Son.

A Slovak language inscription above the altar with the statue reads:

"Our Mother of Sorrows, patroness of Slovakia, pray for us."

(Matka naša Patrónka Slovenska – oroduj za

#### **Annual Pilgrimages**

Members of the First Catholic Slovak Union often gather in Washington around September 15 in order to pay homage to Our Lady of Sorrows at the chapel in the National Basilica.

Many Slovak parishes also hold special Masses each year to honor Our Lady on and around September 15. It is important that Slovak Americans continue to pay homage to Our Lady and remember her sufferings when we face our own trials in life. One such Mass and pilgrimage which this author has attended several times takes place annually at the National Shrine of our Lady of Lebanon, in North Jackson, not far from Youngstown. Special prayers, confessions, and the Holy Rosary pre-

cede a solemn Mass said in Slovak.

# Water with Blessings

Members of the Prayer Shawl Ministry at Queen of the Most Holy Rosary Parish in Elysburg, PA, partnered with the Sisters of Saints Cyril and Methodius to provide clean drinking water to families in communities torn by war and natural disaster, in under-developed neighborhoods, in refugee camps and in villages threatened by water contamination. Sister Jeanne Ambre, SSCM, serves as Parish Visitor, and Reverend Joseph Scanlin is Pastor. Working with the Water with Blessings Program, the group crocheted more than 800 Water Filter Socks, which fit over and protect water filter units. Mothers in developing countries are trained in the use of the filters, and that mother will generally provide clean water for her own family and at least three others. The group also collected for the purchase of four of the water filter units. Thus, the work done by these volunteers at Queen of the Most Holy Rosary Parish will help provide clean water to at least 3,200 families, protecting them from dysentery, intestinal parasites and other water-borne illnesses. It's fitting that we celebrate Mother's Day during May, a month that we also dedicate to the Blessed Virgin Mary. Knowing a good mother opens a window onto a spiritual relationship with Mary. And for those who have not been blessed with that earthly relationship, Mary can fill the void when our hearts are open to her tender guidance.

During this month, parishes and schools around the world will honor Mary with crowning ceremonies, processions, and prayers all aimed at calling to mind her holiness. Similarly, on Mother's Day, we will honor mothers for the sacrifices they make in bringing new life into the world and nurturing that life with love and devotion.

Mary both embodies the ideals of motherhood and serves as a role model for all mothers. When the angel Gabriel announced to her that she would conceive the Son of God, her response was, "Behold, I am the handmaid of the Lord; let it be to me according to your word." The catalyst for drafting and signing of this agreement was the visit to Pittsburgh of Professor Thomas Masaryk, who later became the first President of Czechoslovakia. The agreement was also signed by leaders of local and national Slovak and Czech fraternal organizations.

### Správy zo Stovenska

**Bratislava** - Napriek tomu, že Ústava SR garantuje národnostným menšinám právo na vzdelanie v ich jazyku, v praxi sa ukazuje, že toto právo sa neuplatňuje vždy tak, ako by sa malo. Uviedla to verejná ochrankyňa práv Mária Patakyová, argumentujúc pritom pretrvávajúcou segregáciou rómskych detí a faktom, že ani jedna štátna škola na Slovensku neposkytuje vzdelávanie v ich materinskom - rómskom jazyku.

**Kuchyňa** - K lietadlám Ozbrojených síl (OS) SR patrí aj druhé dopravné lietadlo C-27J Spartan. Viacúčelové transportné lietadlo pristálo na letisku Dopravného krídla generála M. R. Štefánika Kuchyňa. Priamo na mieste ho privítal minister obrany Peter Gajdoš (SNS) spolu s ďalšími zástupcami rezortu a OS SR. Gajdoš označil prílet druhého Spartana za výnimočnú udalosť. "Aj tento stroj, podobne ako ten prvý, je pripravený plniť úlohy v rámci domáceho i medzinárodného krízového manažmentu," uviedol minister s tým, že prvý Spartan, ktorý majú vzdušné sily od konca minulého roka, už bol využitý pri preprave materiálu a výstroja slovenského kontingentu pôsobiaceho v rámci mierovej misie UNFICYP na Cypre.

Spišská Nová Ves – V spišskonovoveskej nemocnici vykonali prvú operáciu na to, aby mohli neskôr pacienta liečiť jeho vlastnými bunkami. Tým sa budú lekári snažiť odvrátiť amputáciu nohy. "Nedostatočným prietokom krvi, ktorý je spôsobený zužovaním ciev napríklad pri cukrovke alebo ateroskleróze, začnú tkanivá postupne odumierať. Nedostávajú totiž dostatok kyslíka a živín, a tak nastáva nedokrvenie končatín, teda ischémia," vysvetľuje cievna chirurgička zo spišskonovoveskej nemocnice Jana Javiľaková.

Bratislava - Základným životným priestorom pre Slovenskú republiku ostáva Európska únia. Debata o budúcnosti EÚ je diskusiou o nás samých. Na 18. ročníku Hodnotiacej konferencie zahraničnej a európskej politiky SR za rok 2017 to vyhlásil premiér Peter Pellegrini (Smer-SD) s tým, že NATO vnímame ako základný pilier našej bezpečnosti, ktorý zvyšuje svoj význam a nemá alternatívu. Pellegrini zdôraznil, že zahraničná a európska politika sú dôležité súčasti nášho života. "Vláda, ktorá nedávno vznikla, je vládou, ktorá chce pokračovať. A platí to aj pre oblasť zahraničnej politiky," uviedol.

Zahraničná politika nebola nikdy taká turbulentná, ako je teraz, a preto je potrebné hovoriť o veciach otvorene i kriticky. Uviedol to v stredu minister zahraničných vecí SR Miroslav Lajčák pri príležitosti Hodnotiacej konferencie zahraničnej a európskej politiky SR za rok 2017 v Bratislave. Zdôraznil, že konferencia nesie názov hodnotiaca nielen preto, aby sme sa obzerali dozadu, ale aby sa Slovensko vedelo pripraviť do budúcnosti.

**Nejednotné** vystúpenia verejných činiteľov škodia slovenskej zahraničnej politike a vyvolávajú v zahraničných partneroch myšlienku nedôveryhodnosti. Zhodli sa na tom bývalí šéfovia rezortu diplomacie Pavol Demeš, Pavol Hamžík a Eduard Kukan na stredajšej 18. Hodnotiacej konferencii zahraničnej a európskej politiky SR za rok 2017 v Bratislave. "Je potrebné hovoriť to isté v Bruseli, Bratislave, New Yorku, Washingtone či v ruskej Dume v Moskve," upozornil Kukan. Hamžík taktiež vyzdvihol dôležitosť jednoznačnosti na vládnej úrovni.

**Bratislava** - Slovensko bude kandidovať na Predsedníctvo Rady Organizácie pre hospodársku spoluprácu a rozvoj (OECD) na ministerskej úrovni (MCM). Preto personálne posilní svoju stálu misiu pri OECD a riadiaci odbor, ktorý pokrýva agendu OECD v ústredí. Zároveň vytvorí medzirezortný orgán, ktorý bude predsedníctvo koordinovať. Vyplýva to z materiálu, ktorý v stredu schválila vláda.

**Slovenskou** prioritou v oblasti bilaterálnych medzinárodných zmlúv je zamedzenie dvojitého zdanenia slovenských podnikateľov aj zahraničných investorov a ochrana investícií v krajinách mimo EÚ. Vyplýva to z materiálu Ministerstva zahraničných vecí a európskych záležitostí SR, ktorý v stredu schválila vláda. Medzi ďalšie priority patrí napríklad dosiahnutie dohôd o cezhraničnej železničnej doprave s ČR, Poľskom a Maďarskom alebo dohoda o vzájomnom uznávaní dokladov o vzdelávaní s Cyperskou republikou a Svätou stolicou.

**Európsky** súd pre ľudské práva v Štrasburgu rozhodol v roku 2017 celkovo v 41 prípadoch týkajúcich sa Slovenska. V 12 rozsudkoch, ktoré zahŕňali celkom 18 sťažností konštatoval, že SR porušila Dohovor o ochrane ľudských práv a základných slobôd. Informuje o tom zástupkyňa SR pred týmto súdom Marica Pirošíková, jej správu vzala vláda v stredu na vedomie.

**Bratislava** - Verejnosť na Slovensku najviac dôveruje v pozícii lídra prezidentovi SR Andrejovi Kiskovi (67 percent) a najmenej Marianovi Kotlebovi z ĽSNS (76 percent). Vyplýva to z aprílového prieskumu agentúry AKO. Druhým najdôveryhodnejším politikom sa stal premiér Peter Pellegrini zo Smeru-SD (41 percent), na delenej tretej priečke sú Béla Bugár z Mosta-Híd a Richard Sulík zo SaS (obaja 37 percent).

Bratislava - Vyšetrovatelia Policajného zboru (PZ)SR nepretržite konajú vo veci objasnenia vraždy novinára Jána Kuciaka a jeho družky. "Chceme zdôrazniť, že vyšetrovatelia PZ SR vo veci priebežne nepretržite konajú a vykonávajú procesné úkony za účelom odhalenia a potrestania páchateľa, páchateľov tohto trestného činu. Zo zrejmých dôvodov nie je možné procesné úkony v súčasnosti špecifikovať," uviedla v stredu médiám hovorkyňa Úradu špeciálnej prokuratúry Jana Tökölyová.

Londýn/Bratislava - Siedmich členov slovenského gangu, ktorý si urobil "rodinný podnik" z privádzania bezdomovcov zo Slovenska a Česka do Spojeného kráľovstva, uznal britský súd tento týždeň za vinných z toho, že obchodovali s ľuďmi a nútili ich pracovať v otrockých podmienkach. Členovia slovenskej rodiny žijúcej v meste Newcastle na severovýchode Anglicka kupovali a predávali svoje obete za sumy dosahujúce niekedy len 200 libier, vyplýva zo žaloby, ktorú posudzoval korunný súd v meste Middlesbrough.

**Bratislava** - Na starom koryte Dunaja sa bez odbornej diskusie a v tichosti pripravuje zámer na prehradenie starého koryta Dunaja vodnými dielami. Tvrdia to vodáci, ochranári i niektorí komunálni politici. Poukazujú pritom aj na čerstvý výrub brehových porastov Dunaja. Proti zámeru je už spustená petícia, pod ktorú sa doteraz podpísalo vyše 3600 ľudí. Splnomocnenec vlády však považuje tieto obavy za neadekvátne.

**Bratislava** - V minulom roku mohlo pracovať takmer 6600 slovenských väzňov z necelých 11.000 odsúdených a obvinených osôb. Priemerný počet obvinených vo výkone väzby a odsúdených vo výkone trestu bol v minulom roku 10.270 osôb. V porovnaní s priemernými počtami za rok 2016 je to nárast o 154 osôb (nárast obvinených o 38 osôb a odsúdených o 116 osôb), uviedol riaditeľ Kancelária generálneho riaditeľa Zboru väzenskej a justičnej stráže (ZVJS) Adrián Baláž.

Bratislava - Predstavitelia kresťanských cirkví a židovských náboženských obcí na Slovensku píšu premiérovi Petrovi Pellegrinimu. V otvorenom liste odmietajú korupciu a zdôrazňujú potrebu vyšetrenia úkladnej vraždy novinára Jána Kuciaka a jeho snúbenice Martiny Kušnírovej. "Pre zachovanie dôvery obyvateľov Slovenska v právny štát a v demokraciu je dôležité, aby táto úkladná vražda bola čím skôr vyšetrená a aby jej páchatelia boli potrestaní," uvádzajú v liste predstavitelia kresťanských cirkví a židovských náboženských obcí.

Matky deťom oživili ducha viery a zbožnosti. Pri tom sú známe aj ozajstné obrátenia, ktoré sa odohrali v duši niektorých ľudí Fatima začína takmer prevyšovať počtom pútnikov druhé známe mariánske mestečko, francúzske Lurdy (Lourdes). Niektoré cestovné spoločnosti sa snažia aj spojiť návštevu do Lourdes a do Fatimy do jednej púte. Cieľom týchto púti nie je nejaký zárobkový "svätý turizmus", ale posilnenie viery u pútnikov. Potvrdzujú to aj Cirkvou schválené spoločné modlitby veriacich.

Pri liturgickej spomienke Božej Matky vo Fatime prosíme Boha, "aby všetci veriaci pocítili mocný príhovor Panny Márie, Matky Cirkvi". Fatimskí pútnici prosia tiež nebeského Otca týmito slovami: "Panna Mária ukázala deťom hrôzy pekla; ochraňuj ľudstvo od mravnej skazy a obráť ho na cestu svätosti". V ďalšej modlitbe vzývajú Boha Otca: "Panna Mária sa zjavila spolu s anjelom; pošli svojich anjelov priviesť k pravej viere hriešnikov, ktorí znesväcujú Oltárnu sviatosť". Prosia tiež o "silu k vytrvalej a vrúcnej modlitbe", lebo "Panna Mária si želala, aby sme sa modlili ruženec"; "ona povedala deťom, že prídu do neba", preto sa vo fatimskej spomienke pripája modlitba o večný odpočinok pre našich zosnulých. Kňazi môžu takto a podobne osviežiť ľubovoľnou spomienkou pri oltári eucharistickú liturgiu, na osoh veriacich aj vlastnej mariánskej zbožnosti.

Keď začíname mesiac máj, ktorý často nazývame aj ako "mariánsky", rád by som upozornil na inú možnosť duchovného vzrastu a osvieženia. Je to osoba sv. Jozefa. Jeho postava sa ľahko stráca pred veľkosťou a poslaním Panny Márie, tým viac pred Ježišom. Svätosť človeka sa meria jeho blízkosťou k Bohu. Ježiš Nazaretský aj ako človek je najsvätejší, lebo je to vtelený Boh, teda Boho-človek. Jeho Matka, Mária z Nazaretu, je presvätá, lebo z nej a iba z nej dostal Boží Syn Ježiš, nazývaný Kristus, svoju ľudskú prirodzenosť. Tu sa pohybujeme v oblasti Božieho tajomstva, ktorý si takto otvoril cestu vtelenia, keď – podľa slov evanjelistu – "Slovo (NB. to je Boh) sa stalo telom", čiže človekom, dieťaťom. Tak malý Ježiš ako aj Mária potrebovali ochranu pred ľudskými zákonmi, ktorú mal poskytnúť Jozef. Jemu odhalil Boh tajomstvo Kristovho vtelenia a ustanovil ho za strážcu Svätej rodiny a on prijal túto obetavú úlohu: stal sa pred zákonom a pred ľuďmi ženíchom Panny Márie a legálnym otcom Ježišovým.

Jozef bol povolaním tesár, ako nám to prezrádza kronikár evanjelista Matúš, keď opisuje údiv nazaretských spoluobčanov, keď prijmú a počujú mladého Ježiša v synagóge: "Skade má tento takú múdrosť a zázračnú moc? Vari to nie je tesárov syn? Nevolá sa jeho matka Mária?" (Mt 13, 54-55). Ježiš, Mária a Jozef vytvárajú teda robotnícku rodinu tesára. Klasickí svätopisci a umelci predstavujú Jozefa ako starca pri mladučkej Márii a malom Ježiškovi, čo však nemá nijaký historický podklad.

Priznám sa, že som dlho hľadal obraz Švätej rodiny so sv. Jozefom v mladistvom alebo plnom veku, ktorý by azda viac zodpovedal skutočnosti. V Cirkvi sa rozšírila k nemu úcta najmä pod vplyvom kanadských horliteľov v minulom storočí, ktorí sa pričinili, aby sa meno sv. Jozefa dostalo do liturgických textov ešte pred inými svätými, ako to poznáme zo sv. omše. Liturgickú slávnosť k jeho úcte oslavujeme dňa 19. marca. K tomu si ho uctievame ľubovoľnou spomienkou ako vzor robotníkov dňa 1.mája, keď sa dôstojne pripomína deň práce. Rozširuje sa aj úcta k sv. Jozefovi ako patrónovi dobrej smrti, pravdepodobne v náruči Ježiša a Panny Márie. Liturgia nám ho predstavuje najmä v spomínanej slávnosti dňa 19. marca ako ženícha Panny Márie a strážcu Svätej rodiny.

Dve oblasti nášho života si teda pripomíname v mesiaci máji: rodinu a prácu. Spomienka na sv. Jozefa nám pripomína jednu i druhú. Liturgické čítania a spoločné modlitby nám ponúkajú aj vhodné krátke prosby k Bohu na príhovor tohto mlčanlivého, starostlivého ochrancu. Vybral som pre vás nasledovné:"Pre zásluhy svätého Jozefa, vzor robotníkov, nauč nás usilovne plniť si svoje pracovné povinnosti."

# Trnavská arcidiecéza bude mať na svojom území druhú baziliku

Slávnostné vyhlásenie povýšenia farského Kostola sv. Ondreja na baziliku minor. sa uskutočilo v Chráme sv. Ondreja v Komárne v nedeľu 22. apríla. K vyhláseniu tohto daru Svätej stolice pre Trnavskú arcidiecézu príde na základe dekrétu Kongregácie pre Boží kult a disciplínu sviatostí s názvom "Tyrnaviensis", skrze ktorú prefekt kongregácie kardinál Robert Sarah v mene Svätého Otca Františka povýšil doterajší farský Kostol sv. Ondreja na baziliku. Bude mu tak prislúchať titul "Basilica minor", informoval Arcibiskup-



ský úrad v Trnave a Róbert Kiss, dekan v Komárne.

Slávnostnému vyhláseniu s prečítaním dekrétu predsedal trnavský arcibiskup Mons. Ján Orosch. Na slávnosti sa zúčastnil aj apoštolský nuncius v Slovenskej republike Mons. Giacomo Guido Ottonello.

Prvým takýmto chrámom v Trnavskej arcidiecéze je od roku 2008 Bazilika sv. Mikuláša v Trnave. Postavenie baziliky minor (menšej) umožňuje používať pápežský znak skrížených kľúčov na zástavách chrámov, chrámovom náradí a pečiatke.

Kostol svätého Ondreja je jednou z dominánt mesta Komárno. Bol postavený v rokoch 1723-1734, na jeho výstavbu použili materiál z novozámockej pevnosti. Svätostánok mal neľahký osud, v roku 1848 počas veľkého požiaru mesta horel tri dni a sedem zvonov vo veži sa roztopilo a odtrhlo. Ďalšie škody napáchalo ťažké bombardovanie v roku 1849 a ľadochod. Obnova kostola trvala dvanásť rokov a skončila vysvätením ostrihomským arcibiskupom Jánosom Sczitovským. Interiér kostola bol obnovovaný v roku 1975 a strecha v rokoch 1990-1992. Na pamiatku veľkého zemetrasenia z roku 1763 sa každý deň o 15. hodine rozozvučia jeho zvony. Kapacita kostola je viac ako 7000 veriacich.

Naozaj si svätý, Otče, ty prameň všetkej svätosti tieto slová Eucharistickej modlitby vyjadrujú dve základné pravdy: Božiu a našu svätosť. Božia svätosť je absolútna; tá naša je účasťou na Božej. Je akoby svetlom mesiaca, ktoré odráža žiaru slnka. Serafini v nebi volajú: Svätý, svätý je Pán zástupov, celá zem je plná jeho slávy (Iz 6, 3).

Slovom svätý sa vyjadruje absolútna odlišnosť Pána Boha od všetkého stvoreného: Komuže ma teda chcete prirovnať? Budem mu podobný? – vraví Svätý, veď som ja Boh, a nie človek, Svätý uprostred teba (Iz 40,

O Ježišovi archanjel Gabriel povedal Panne Márii, že Duch Svätý zostúpi na ňu a jej dieťa bude sa volať svätým, bude to Boží Syn (Lk 1, 35). Skúsenosť a poznanie apoštola Petra je nasledujúce. Vraví Ježišovi: My sme uverili a spoznali, že Ty si Boží Svätý (Jn 6, 69). Morálne dokonalý, plný dobroty, pravdy a lásky.

Prítomnosť Ducha Svätého umožňuje človeku byť svätým. Skutky apoštolov potvrdzujú, že na Turíce všetkých naplnil Duch Svätý (Sk 2, 4), ktorý s veriacimi zostáva naveky a prebýva v nich (Jn 14, 16; Rim 8, 9)

Svätosť sa stáva vlastnosť ou všetkého, čo má úzky súvis s Bohom, čo bolo Ním dotknuté alebo Jemu zasvätené, venované. Písmo hovorí, že miesto okolo horiaceho kríka je zem svätá (Ex 3, 5), že chrám je svätý (Ž 5, 7), sväté piesne sú tie, ktoré sa spievajú pred Božím zákonom (Múd 18, 9). Svätý Boh teda umožňuje človeku účasť na svojej svätosti, ba vyzýva ho k nej: Buďte svätí, lebo ja, Pán, váš Boh, som svätý! (Lev 19,2; 1Pt 1, 16).

Co to znamená pre nás? Svätosť veriacich je úplne založená na Božej svätosti a z nej pramení. Je prítomnosťou posvätného dobra, ktoré je nezlučiteľné so zlom a hriechom. Byť svätý znamená byť dokonalý a milosrdný ako je dokonalý a milosrdný nebeský Otec (Mt 5, 8; Lk 6, 36), byť bez úhony vo svätosti pred Bohom, byť živou, svätou a Bohu milou obetou, zapojený do služby a budovania Kristovho tela (1Sol 3, 13; Rim 12, 1). Príliš náročné? Určite náročné, ale nie nemožné, ako nás o tom presviedčajú mnohí svätí a sväté – naši nebeskí patróni. Božia svätosť je nedosiahnuteľná, preto o Bohu vyznávame: iba Ty si svätý.

Na druhej strane ide o dobrodružstvo, na ktoré nás Boh vyzýva, ba umožňuje mať účasť na jeho svätosti. Netreba sa toho báť; skôr sa denne usilovať žiť dokonalejšie a byť milosrdnejší. Prinajmenšom takmer denne si povedať: Chcem byť svätý

Hrad Devín má významné špecifikum v našej histórii, kde štúrovci osobnou prísahou vyjadrili svoj vzťah k slovenskému národu, sú nám vzorom. Zanechali nám spisovnú slovenčinu a veľké kultúrne dedičstvo."

# Na Bratislavskom hrade výstava k 100. výročiu založenia Československa

Bez znalosti historického zázemia ľudia len ťažko porozumejú premenám, ktorých sú svedkami. Pripomenul to vo štvrtok 26. apríla slovenský prezident Andrej Kiska pri príležitosti otvorenia výstavy k 100. výročiu založenia Československa. Spoločne s ním sa otvorenia výstavy zúčastnili i slovenský premiér Peter Pellegrini a jeho český partner Andrej Babiš.

Kiska zároveň poznamenal, že na hodinách dejepisu sa väčšinou dejinám Československa nevenuje dostatočná pozornosť. Práve výstavy ako táto preto majú veľký prínos. "Osvojenie si, precítenie a pochopenie histórie môže pomôcť súčasným generáciám lepšie uvažovať o prítomnosti a budúcnosti a primerane tomu robiť zodpovednejšie rozhodnutia," povedal Kiska.

Český premiér hovoril najmä o budúcnosti spolupráce. "Sto rokov je určite veľmi dôležitých, ale myslím si, že ešte dôležitejšia je naša budúcnosť," konštatoval Babiš. Podľa neho je úlohou Česka aj Slovenska spoločne bojovať za bezpečnosť občanov a za to, aby sa zachovala európska kultúra. "Som presvedčený, že tu sme na jednej lodi," povedal.

Pellegrini vyzdvihol príkladné vzťahy aj po rozdelení spoločného štátu. "V dnešnom svete zmietanom regionálnymi konfliktmi, občianskymi vojnami a plnom separatistických hnutí je náš vzťah čímsi príkladným. Výročia v tomto osmičkovom roku sú príležitosťou posilňovať toto pozitívne vnímanie našich vzťahov nielen doma, ale aj v zahraničí," poznamenal. Dodal, že v týchto zložitých časoch sa Česko a Slovensko navzájom veľmi potrebujú.

Kiska na záver svojho prejavu vyjadril podporu mladým ľuďom, ktorí na Slovensku organizujú protesty. "Organizátori výstavy sa vyslovili, že chcú predstaviť príbeh ako sa spočiatku nereálny projekt Československa stal skutočnosťou. Dnešní mladí ľudia na slovenských námestiach tiež možno nerealisticky požadujú zásadnú zmenu, obnovu krajiny, túžia po slušnom Slovensku. Verím, že niekto raz v budúcnosti urobí výstavu o tom, s akým nasadením a energiou sa do toho pustili, aké ťažkosti pri tom prekonávali a čo ich úsilie prinieslo," povedal.

Výstava na Bratislavskom hrade mapuje život Čechov a Slovákov v spoločnom štáte, zobrazuje úspechy a radostné momenty, ale aj krízy a ťažké chvíle vzájomného spolužitia. Na Slovensku si ju návštevníci môžu pozrieť do konca septembra, potom sa premiestni do Historickej budovy Národního muzea v Prahe.


