

Eighty (80) ONE-TIME SCHOLARSHIPS will be awarded to the winners.

- 75 scholarships in the amount of \$1,000.00.
- A "Philip Hrobak Scholarship" and "Stephanie Husek Scholarship" in the amount of \$1,250.00 each will be awarded to the highest ranking male and female applicants respectively.
- Three Scholarships of \$1,000.00 each will be given from the "John A. Sabol Nursing Scholarship Fund" to applicants who have been accepted into either an approved three or four year hospital nursing program or a fully-accredited college of

In addition, upon proof of college graduation and completed insurance application, each recipient will be issued a paid up \$3,000 Single Premium Life Insurance

#### THE RULES AND REQUIREMENTS ARE AS FOLLOWS:

- 1. Applicants must have: a minimum of \$5,000.00 reserve insurance (Ordinary Whole Life, Twenty Pay Whole Life, or Single Premium Whole Life); or minimum of \$10,000.00 JEP Policy; or minimum of \$1,000 annuity with the FCSU for at least four years prior to April 1st of the year of graduation from high school. All scholarship winners must maintain this insurance in force during their college years. Applicants must be insured prior to April 1, 2014 to be eligible under the rules of this period.
  - 2. Applicants must apply for grants in the Spring of their senior year of high school, between the ages of 17 and 19.
  - 3. Applicants must have applied for the Fall term of 2018 at a qualifying institution. Please note that applicants should include the qualifying institution(s) to which they have applied even if they have not yet received formal acceptance from

# Insights and Viewpoints

#### November 5, 2017 Thirty-First Sunday of Ordinary Time Mal 1:1b-2:2b, 8-10, 1 Thes 2:7B-9, 13, Mat 23:1-12

A familiar sight in my hometown were the ungated railroad crossings with the signs that said; "Stop, Look, Listen." These were the instructions or maybe even the warnings to approach the crossings with caution and to use your eyes and ears to

make certain no train was coming. The readings today brought back memories of these signs and how their basic message should be very much part of our lives as Christians. It is important for us to stop, look and listen so as to be attuned to the presence and message of God in our lives. It seems that our "To Do" lists are never completed because for every item we check off two more items appear on the list. Stop and put aside the lists, clear our minds of thinking about what else must be done, and quiet our souls so that

we become aware of God's presence. It is during the times when we stop and sit in stillness that we are able to look and listen to what God is saying to us and showing us. We become less focused on doing, and more aware of being.

There is the old saying, "practice what you preach," that is usually used when someone boldly and freely gives advice to others who take it to heart and work at making changes in their lives so as to follow this advice. Then, their eyes are opened and they realize that the person giving the advice is not living it themselves. This can lead to becoming disheartened and disillusioned. Jesus calls on us to keep our eyes open and not to follow the bad example, or hypocrisy we see in those who instruct, but to take their good teachings to heart. Seeing what others do is only part of the message. Look at what we are doing in our lives. Do we see what we would like to be, or is the reality different than our hopes. Jesus words about the Pharisees are words that we should be mindful of. They talked a good talk and Jesus advised the crowds to listen to their teachings, but do not follow their example. It's a word of caution to us that we can get caught up in saying the right things and giving the correct teachings, while not living them ourselves.

The first word in the Rule of Saint Benedict is; "Listen," and he goes on to say, "listen with the ear of your heart." True listening involves not only hearing what is said, but also allowing our hearts to absorb the message so as to truly listen and understand. In Mark's Gospel Jesus asked the question to the crowds who were seeking a sign, but not listening to his teachings; "Do you have eyes and not see, ears and not hear?" (Mark 8;18) How well do we listen? We hear the Word of the Lord in the Sacred Scriptures and if we listen with our heart something might strike us as the Lord speaking in a very personal way. It might be a word that brings us comfort during some trying time, or a word that helps put some decision we are struggling into perspective, or a word that reminds us of God's faithfulness to us at all times. There are many other ways that God's word can speak to us and guide us, but in order for this to happen we have to listen.

May we take to heart the message of these readings and take time to stop, look, and listen so as to me more attuned to God in our lives.

#### November 12 - 2017 Thirty-second Sunday of Ordinary Time

In November, as the leaves fall from the trees, as the days become shorter and darker, and as we observe All Souls Day and Veterans Day, it is only natural to think about things that are of abiding value: life itself, our faith, family members present and past, the self-sacrifice of our military veterans. The same movement is afoot in the readings we hear at mass in these days: as the rhythm of the Church year draws toward its conclusion the scriptures at mass lead us to reflect on the most fundamental matters of life, ultimately bringing us to a reflection on the mystery of death, judgment and eternal life.

To this end, this Sunday we are presented with an interesting series of readings that begin in the wisdom literature of the Old Testament. In the book of Wisdom, also called the Wisdom of Solomon, we find an exhortation to seek the gift of wisdom and to

practice it faithfully. We hear: "wisdom...is readily perceived by those who love her, and found by those who seek her." Later the inspired author adds: "taking thought of wisdom is the perfection of prudence, and whoever for her sake keeps vigil shall quickly be free from care" (Wis 6:12, 14-15).

First, this passage tells us that the sort of wisdom needed to make one's way through life is not out of reach for anyone—we have no excuse for failing to pursue it. Next it tells us that when we live according to the principles of wisdom we will be free from unnecessary concerns; that is, when a truly wise person faces life and its challenges they are filed with hope and are at peace. Though they "walk through the valley of the shadow of death, they fear no evil" (Ps 23:4).

The second reading, from Saint Paul's First Letter to the Thessalonians, continues this same theme. Since the Thessalonians like many early Christians expected Christ to return before the present generation had passed they were concerned that some of their loved ones had already died. Paul tells them not be shaken since whenever Christ returns both the living and the dead will share in the resurrection. A healthy dose of Paul's Christian wisdom and the hope that stems from it served to shore-up the Thessalonians' worried spirits.

The reflection on wisdom and Christian life continues in the Gospel, in the account of the wise and the foolish virgins. Together with the parable of the talents which we will hear next Sunday, this passage serves as the preface to the powerful and frightening last judgement scene of Matthew's Gospel, which we will hear at mass in two weeks' time, on the feast of Christ the King.

The ten virgins, five wise and five foolish, are attendants at a wedding banquet, responsible to greet the groom when he arrives. When the groom arrives much later than expected and it is already evening, the five foolish virgins are left without enough oil for their lamps. The five virgins who brought extra oil represent those who have heard the call of the Lord to faith and who have responded in a wise manner, preparing themselves for the task at hand. Their prudence and foresight in bringing extra oil served them well, and is intended to be an admonition to all hearing the parable to imitate their alertness and wisdom.

As we live out these pensive days of late autumn and look ahead to Advent, let us prepare ourselves by seeking the gift of wisdom so as to have no fear of death or judgement, and to live ever more joyfully the life we have at present, in firm hope of the life to come.

## Message from the National Chaplain:

The third and final part of the series summarizing Pope emeritus Benedict XVI's encyclical Saved in Hope centers on that which one can learn to have hope, namely, prayer, suffering, judgment.

Prayer is the first essential setting Benedict states for learning hope. Proper prayer is achieved when we undergo a process of purifying our desires and hopes that brings about an openness to God and others. In prayer, we learn what we can truly ask of God. We also learn not to pray against others, and not to ask for the superficial and comfortable things we desire at the moment. Prayer of this nature is a very personal and intimate encounter with God. At the same time, it must be constantly guided and enlightened by the prayers of the Church, the saints, and liturgical prayer. Prayer always involves the intermingling of public and

Regarding suffering, Benedict notes the unending quest of people trying to limit or prevent it, but suffering can never be eliminated. We are healed from our suffering not by avoiding it, but rather by accepting it and finding meaning through our union with Jesus, who suffered with infinite love. Benedict points out a society unable to accept its suffering members and incapable of helping to share their sufferings is a cruel and inhuman society. He offers three fundamental elements of humanity: to suffer with the other and for others, to suffer for the sake of truth and justice, to suffer out of love and in order to become a person who truly loves. Our Christian faith has shown us that God himself, Truth and Love in person, desired to suffer for us and with us.

From the beginning of Christianity, the idea of a Judgment has influenced people's conscience and daily life, and at the same time their hope in God's justice. Benedict reminds us that the image of the Last Judgment is not primarily one of terror, but of hope. The overwhelming power of God's love over all the evil in the world and in ourselves is experienced at the moment of judgment.

Benedict cannot write about Judgment without saying something about Purgatory. In particular, he poses this question made by those who have a hard time with the effect of others praying for the dead: If Purgatory is simply purification through fire in the encounter with the Lord, Judge and Savior, how can a third person intervene, even if he or she is particularly close to the other?

His answer is simply this: Every person does not live in complete isolation from another. No one really lives alone or sins alone. One's thoughts, words, actions and achievements are influenced by others and others' influence oneself. This interconnectedness of Being, one's gratitude and prayer for the other, can play a small part in the purification of another's soul.

Benedict offers these reminders. It is never too late, nor is it ever in vain, to touch the heart of another. Our hope is always essentially hope for others; only thus is it true hope for ourselves, too. As Christians we should never limit ourselves to asking: How can I save myself? We should also ask: What can I do in order that others may be saved?

### The Unlikeliest Hero of Hacksaw Ridge

On Veterans Day, we salute all those who've served in our Armed Forces, and we hopefully come to appreciate the stories of how and why they served. Thanks to producer Terry Benedict and his Christopher Award-winning film "Hacksaw Ridge," the world can now learn from and be inspired by the courageous and selfless life of Desmond Doss.

During an interview on "Christopher Closeup," Benedict recalled that he read books voraciously growing up because his parents didn't have a TV in the house. His favorite story was "The Unlikeliest Hero" about Doss, who so deeply believed in the commandment "Thou shalt not kill" that he refused to pick up a gun after joining the Army during World War II. Doss was, however, willing to serve as a medic who saved lives on the battlefield.

Doss's convictions earned him intense abuse from his fellow soldiers and superiors, who branded him a coward and unworthy to serve. Yet at the battle of Hacksaw Ridge in Okinawa, Doss saved 75 lives without firing a single shot. Soon after, he earned the Congressional Medal of Honor because of praise from the same soldiers who had once persecuted him.

As a child, Benedict met Doss, and then reconnected with him years later when Benedict was working in Hollywood. The budding filmmaker knew this was a story meant to be shared with the world, so he produced a documentary about Doss called "The Conscientious Objector." Last year, he went on to coproduce the feature film "Hacksaw Ridge."

Though Doss passed away in 2006, Benedict's admiration for him hasn't wavered. He told me, "Desmond led a simple life growing up, and after the war he led a simple life. He was disabled. He lived on one lung and was deaf because the Army gave him too much of an antibiotic that made him deaf overnight. When you go through a war experience like that, you're forever changed. But the thing that remained in Desmond that was so amazing was he never became jaded. He had this innate unconditional love for humanity that was a godly kind of thing. I would call him 'the magnet' because people would go right to him. It was because of his effusiveness of love."

Benedict believes that Doss's life has special meaning in today's world. He said, "People talk about 'tolerance,' and we get so judgmental about it – 'If you don't fit into my cookie-cutter mold, then you can't be offering anything that's worthwhile.' What Desmond brought was a different ideology than what the Army was looking for. And the Army thought he was the weakest link. In fact, he became the strongest link. Just because somebody believes differently than we do, we ought not write them off. We ought to consider what they bring to the table and work in a more collaborative mode."

Doss's religious beliefs, of course, were the other key part of the story. This was a man willing to suffer insults, indignities, and even violence in order to follow God. His opponents nearly broke him, but he held onto his faith and won a victory. Benedict concludes, "All of us, on our journey of life, will usually come upon some incredibly challenging time, some tragedy. [Desmond] wanted people to know that if we lived a life that had the faith element as a priority, our faith in God could and would get us through the day. He was always a source of encouragement for me as a result of that."




# Slovak Catholic Federation's 59th National Convention

The 59th National Convention of the Slovak Catholic Federation was held September 17-19, 2017 in Youngstown, OH. Activities began with Mass on Sunday at 4pm at the Cathedral of Saint Columba with Abbot Gary Hoover, OSB, of Saint Andrew Svorad Abbey in Cleveland and the Moderator/Protector of the SCF as the principal celebrant. He was joined by several officers of the federation, Reverend Andrew S. Hvozdovic, V.F., SCF National President, Very Reverend Monsignor Peter M. Polando, J.C.L., Past National President and Rector of the Cathedral, Reverend Thomas A. Nasta, First National Vice President, and Reverend Monsignor Thomas A. Derzack, National Chaplain, along with numerous priests from the Diocese of Youngstown and others representing the broad geographic scope of the federation. A dinner was held at the Basilica of Our Lady of Mount Carmel Hall following the Mass with more than 200 people in attendance.


The actual business component of the convention began on Monday, September 18th, with opening prayer, the Pledge of Allegiance and the singing of the National Anthems of the United States and Slovakia. The various committees of

site and regular updates of the Facebook page; Evangelization and Spirituality, responsible for the development of resources to assist pastoral ministries and make recommendations regarding future SCF Pilgrimages of Faith; Heritage and Culture, responsible for suggesting ways to celebrate Slovak heritage, especially at the local level, identifying and encouraging possible partnership with other Slovak Catholic organizations; Membership, responsible to review the membership renewal process, including layout of the brochure, the success (or limitations) of the current regional structure of the SCF, review of the success of the chapters, offer suggestions on how to increase membership; Nominating and Resolutions, responsible for presenting candidates for various offices and positions on the SCF National Board, compose and recommend formal communications from the 59th National Convention.

Only minor changes were proposed for the constitution, mostly related to titles, roles and terminology to better reflect the current construct of the National Board and the involvement of various officers.

The Nominating Committee created a slate of individuals to serve in the elected roles of the National Board of Directors. The entire slate was accepted by the delegates and consists of: Moderator/Protector, Rt. Rev. Gary Hoover, O.S.B.; President, Rev. Andrew S. Hvozdovic, V.F.; Past President, Msgr. Peter Polando, J.C.L.; First Vice President, Rev. Thomas Nasta; Second Vice President, Ms. Marie Golias; Secretary-Treasurer, Ms. Dolores Evanko; and Spiritual Advisor, Msgr. Thomas Derzack.

After considering several operational and procedural issues the convention adjourned. The date established for the Spring Meeting of the

National Board is April 30th and May 1st, in Danville, PA, with the session being held at the Mother-house of the Sisters of Saints Cyril and Methodius. The Fall Meeting will return to Youngstown on September 17th and 18th to accommodate the subsequent meeting of the Conference of Slovak Clergy.

The level of support provided by the Slovak Catholic community from the broader Youngstown area was very gratifying. From the opening Mass through the well-attended initial dinner, capped with the convention dinner on Monday night in the social hall of the Cathedral of Saint Columba, the out-of-town visitors were treated to a truly memorable and enjoyable stay. The convention attendees expressed their heartfelt appreciation for the planning, work and success of the entire endeavor involved in hosting the 59th National Convention of the Slovak Catholic Federation.



# Glowing Cemeteries: All Saints and All Souls Days in Slovakia

The atmosphere is hushed, despite the number of people. Families walk slowly, stopping for a moment here or there with a candle or flowers. Candles and more candles flicker in the dark, illuminating a portion of chrysanthemums or the leaves on the tree above.

"May perpetual light shine upon them ..." Prayers for the dead

I'm in a cemetery. So are many others.

In the Catholic calendar, November 1st is All Saints Day and November 2nd All Souls Day. They are days specifically set aside to remember and pray for the dead.

In Slovakia, those are the busiest days on the road. They are both bank holidays, which usually means a four or five day holiday, except this year when it happened to fall on the weekend.


On both those nights, Slovaks flock to graveyards with candles and flowers. Though it has religious origins, it's become a cultural tradition for everyone, religious or not.

I love this Slovak tradition, due in no small part to the aesthetics. But I appreciate, as well, the remembering of the dead as a community. Nobody is untouched by death; all of us have loved ones

"See, this is my aunt, Dedushko's sister," my husband tells the children. "She was very good to me."

The recent grave of our friends' young son chokes my throat. We leave him some white chrysanthemums, he who is now beyond the sadness of this world. The children try to adjust the flowers just so, set the candle in the perfect spot.


One twin tries to smell the candles, the other has one tightly clenched in his fist until he decides it's his candle's turn to be lit. They delight in blowing out the matches



During the day the cemetery is transformed from quiet and eerie to a boisterous colorful garden. A few candles still soldier bravely on. I wish I could get an aerial view, it's hard to find an angle that captures all the color.

It seems fitting: dark and quiet for the sadness that loved ones are no longer with us; joyful that they are now (or hopefully soon will be) celebrating in heaven.

## November: An Appropriate Time to Review the Church's Funeral Rituals

Texas Ranger Jake Cutter, a character portrayed by John Wayne in the 1961 movie The Comancheros, said, "I always figured to die. The question is when." It is this unknown that causes, or should cause, us to prepare for that eventuality. All of us with a First Catholic Slovak Union Life Insurance policy have taken that step. However, we should give consideration to something more. We should have an awareness of what is involved regarding the Church's Funeral Liturgy and make our wishes known about our own funeral.

Since November is the month traditionally dedicated for us to remember the faithful departed in prayer, it is appropriate to offer a few reminders and answer some answers questions you may have about funerals. Guidelines for funerals are generally found in the Order of Christian Funerals, the church's ritual for funerals, and the third typical edition of the Roman Missal.

#### **Funeral Mass or Funeral Service**

The Order of Christian Funerals contains rituals for a Funeral Mass and a Funeral Service Outside Mass, which can be used if most of the deceased's family is not Catholic or does not practice the faith. The Funeral Service Outside Mass can be led by a priest, a deacon, or a lay minister and usually takes place at a Funeral Home or a location other than a church.

#### **Preparing for the Funeral Mass**

Two decisions that need to be made for a Funeral Mass are the choice of readings from Scripture and hymns. You may wish to make your choices known to members of your family.

The Lectionary for Mass from the Roman Missal has several options available for Scripture readings. There are 7 for the First Reading from the Old Testament, 15 for the Second Reading from the New Testament, and 19 for the Gospel. One of 4 readings from either the Acts of the Apostles or Revelation is substituted for an Old Testament reading when a Funeral takes place during the Easter Season. Selecting a reading from Scripture other than what the Church has already provided for a Funeral is discouraged.

The Lectionary for Mass also offers a choice of 10 Responsorial Psalms. The Responsorial Psalm is to be taken from the appropriate liturgical text and ought to be sung by the Leader of Song. Hymns that are paraphrases of psalms or based on a psalm are not appropriate.

It is fitting to select family members of the deceased to assume the role of lector and to bring forward the bread and wine for the celebration of the Eucharist. Since a Funeral Mass is no different from a regular Sunday Mass, people chosen for these duties are to be Catholic.

Most parishes have an instrumentalist and a soloist provide music for a Funeral Mass. The choice of familiar hymns may encourage congregational singing at a Funeral Mass. Again, since a Funeral mass is no different from a regular Sunday Mass, songs or music of a secular nature is to be avoided.

Sometimes Catholics are confused or uncertain about their posture at a Funeral Mass. There is no difference when to stand, sit or kneel for a Funeral Mass. It is the same as it is at any other Mass.

#### The Viewing

It is possible for a public viewing of the body to take place in church before a Funeral Mass, provided the pastor grants permission. The viewing is to take place in an area of the church other than directly in front of the altar and sanctuary. This is so the altar, a symbol of Christ himself, remains in plain view of all who enter the church.


#### **Connection with Baptism**

Three symbols present at a Baptism are also present at a Funeral Mass. The Easter Candle, which reminds us of Jesus, who conquered death by his resurrection, is lit and placed near the location of the casket. A candle lit from the Easter Candle was given to us on our day of Baptism.

Mass begins with priest sprinkling the casket with holy water, the most direct visual connection with Baptism. Family members then may assist with the placing of a white pall on the casket. The pall recalls the white garment the deceased was clothed when he or she was baptized.

#### **Final Commendation**

The Funeral Mass does not conclude with the blessing and dismissal, as you normally find on Sundays. Rather, after the distribution of Holy Communion, the Final Commendation takes place. The priest invites the congregation to prayer and then incenses the casket. The use of incense is a twofold symbol of reverence for the earthly remains of the deceased, for those remains were a Temple of the Holy Spirit, and of our prayers for the deceased rising to God. After a brief prayer, all depart church for the place of internment.



#### **Eulogy vs. Words of Remembrance**

There is no obligation for someone to speak about the deceased at a Funeral Mass or Liturgy Outside Mass. However, the Order of Christian Funerals allows for a family member or friend of the deceased to offer words of remembrance before the Final Commendation. These words should not take the form of a eulogy, whereby the deceased is given tribute and praise.

Due to several past experiences with eulogies that are longer than a homily and/or with inappropriate subject matter that is sometimes mentioned, some pastors will highly encourage families to share their stories and memories of their beloved deceased at a location other than at the Funeral Mass or Liturgy Outside Mass. Suggested places for these stories and memories to be told are at the Funeral Home during the viewing, at the cemetery following the Rite of Committal, or at the gathering following the burial.

Words of Remembrance, on the other hand, are meant to be very brief and recall the deceased's life lived in Christ Jesus. It is recommended that if Words are to be offered, they are to be spoken by one person, who reads from a one-page script that has been reviewed by the officiating priest or deacon. It is becoming commonplace for the

Words of Remembrance to be offered in the church before the Funeral Mass begins, especially when there is a public viewing of the deceased in the church immediately prior to Mass.

One ought to remember that while we remember the deceased in prayer before the Lord, the main focus at a Funeral Mass or Funeral Liturgy Outside Mass is Jesus, who by his death and resurrection promises eternal life to all who are faithful to Him.

#### Burial

Catholics are not required to be buried in a Catholic cemetery, but are very highly encouraged to be. Burial at a cemetery in consecrated ground or internment in a mausoleum or columbarium that is sanctified reflects our common faith and hope that on the Last Day we will as one rise with Christ to share in His gift of eternal life.

Rite of Committal

The Rite of Committal takes place at location of internment and can be led by a deacon or lay minister. The Order of Christian Funerals views the Funeral Mass (or Funeral Liturgy Outside Mass) and the Rite of Committal one continuous event. Under certain situations when neither a Funeral Mass nor Liturgy Outside Mass is celebrated beforehand, the Final Commendation and Committal can be done at the place of internment.

If the decision is made for the deceased to be cremated, the Church prefers the Order of Christian Funerals be celebrated in the presence of the body of the deceased, and then have the body taken for cremation. However, it is permitted for an urn containing the ashes to be brought into a Catholic church for a funeral. The urn is placed on a table in front of the sanctuary, without the display of photos or other mementos. A white pall is not placed on the urn.

The Congregation for the Doctrine of the Faith, under the authority and with the approval of Pope Francis, issued an instruction entitled "To Rise with Christ." This October 2016 document clarifies questions people may have about cremation and contains a set of directives.

The primary principle that runs through "To Rise with Christ" is the never changing Church teaching that human remains are to be given and shown proper respect and dignity. Here is a summary of the

- The Church prefers the ancient practice of burying the bodies of the deceased.
- · Ashes of the deceased are to be buried in a cemetery or laid to rest in a columbarium.
- Ashes of the deceased are forbidden to be:
  - o Scattered in the air, on land, or at sea
  - o Preserved in mementos, pieces of jewelry, or in other objects
  - o Reserved in a home
  - o Reserved in a home while awaiting another person (usually a spouse) to die so both can be buried together at the same time
  - o Divided among family, friends, or others
  - o Commingled with the ashes of another person or pet.



# Britain's Prince Edward to Visit Slovakia in November

Bratislava, October 22 (TASR) - Britain's Prince Edward, the youngest of the four children of Queen Elizabeth II and Prince Philip, is set to visit Slovakia for the first time in early November.

Prince Edward, the Earl of Wessex, will present awards to more than 50 Slovak pupils who have successfully completed the DofE educational program, which is aimed at young people who set an objective and then meet the goal step by step under the guidance of an adult tutor.

As part of his visit to Slovakia the Earl of Wessex, 53, is set to hold talks with Slovak President Andrej Kiska on why the elite should help young people to achieve their goals. In addition, he'll hold discussions with students and teachers from all over Slovakia who have participated in the DofE program.

The Duke of Edinburgh's Award was founded in the UK in 1956 by Prince Philip, the Duke of Edinburgh, who has been its patron since then. As many as 1.3 million young people ages 14-24 from 140 countries participate every year.

The DofE's National Office in Slovakia has been in operation for two years. There are currently more than 1,000 young people, 600 volunteers and more than 150 secondary schools and institutions involved in the program in Slovakia.

Prince Edward also took part in the program when he was young.

# Record Number of Investors Means Good Business Environment in Slovakia

Nitra, October 21 (TASR) - A record number of investors is coming to Slovakia, a fact thanks to which the unemployment rate has been decreasing in the country and the real salaries are forced to go up, stated Economy Minister Peter Ziga at a governing Smer-SD party conference, which took place in Nitra on this date.

According to Ziga, the investors' interest proves that Slovakia has a good business environment. "It has been proven by the fact that new investments make up 50 percent, while another 50 percent are companies that want to expand their business in Slovakia. The fact that we have a suitable business environment here is also proven by the arrival of such investors as Amazon, who came without any state support," said Ziga.

The economy minister went on to say that the Government has prepared several measures aimed at simplifying the life of companies and employers. These include, for example, reducing red tape, prolonging the deadline on registering new employees and monitoring the effectiveness of certain laws

Furthermore, the Government also wants to deal with the implementation of various EU regulations. "It's often the case that much stricter rules are being introduced in the country than it's imposed by the EU. We'll address this issue and make sure that our rules aren't more complicated than European legislation," said Ziga.



Zlom v tejto ich činnosti nastal po zániku demokracie v Československu a nastolení totalitného socialistického štátu, ktorému aktívity rehoľných sestier boli v rozpore s jeho politickým programom, a preto boli zrušené. Po Barbarskej noci z 13. na 14. apríla 1950 nasledovala akcia "R" 28. – 31. augusta 1950, kedy bolo násilne vyvezených 1962 rehoľných sestier a umiestnených v rôznych kláštoroch v bývalej ČSR. Niektoré z nich mladšie, zdravé a schopné telesnej práce, boli rozmiestňované na poľnohospodárskych usadlostiach , štátnych majetkoch, a pracovali ako chovateľky a ošetrovateľky hospodárskych zvierat alebo v rastlinnej a živočíšnej výrobe, či v závodných jedálňach, kde pracovali ako kuchárky alebo ich pomocníčky. Boli izolované od kostolov a znemožňoval sa im výkon náboženských obradov.

Tento neblahý stav trval až do zániku totalitného socialistického štátu (1991), do rehabilitácie reholí a obnovenia ich činnosti. V súčasnosti už rehoľné sestry, ľudovo nazývané mnišky, nepracujú v nemocniciach a v ústavoch pre mentálne a duševne postihnutých, ale sa venujú výchovnovzdelávacej činnosti na cirkevných školách, v internátoch, pôsobia v charitatívnej oblasti, v misiách pri šírení kresťanstva v rozvojových krajinách (Afrika, Ázia, Južná Amerika, Čína...) často aj obtiažnych podmienkach.

Na Slovensku pôsobí pomerne veľa ženských reholí. Rehoľníčky môžeme stretnúť v mnohých mestách, ale aj vo viacerých obciach. Líšia sa od sebe farbou odevu, jeho časťami alebo doplnkami. Podobne ako mnísi aj ony sa zriekli svetského spôsobu života zasvätiac ho Bohu. Žijú v pokore, cnosti a skromnosti.

Ich počet (okolo 50) poukazuje na skutočnosť, že katolícka cirkev na Slovensku, najpočetnejšia spomedzi ostatných, má u nás silné zázemie, dobré pozície a podmienky aj pre rehoľníctvo.

## Slovenská ekonomika od vstupu do EÚ vzrástla o 60 %

Slovenská ekonomika od vstupu do EÚ vzrástla o 60 %. Uviedol to 16. októbra na brífingu na Ekonomickej univerzite v Bratislave (EUBA) podpredseda Európskej komisie (EK) pre Energetickú úniu Maroš Šefčovič, za účasti rektora EUBA Ferdinanda Daňa, v rámci konferencie "60 rokov európskej integrácie: úspechy a výzvy".

Pripomenul, že Slovensko je mimoriadne priemyselná krajina, ktorá väčšinu produkcie vyváža do krajín EÚ. "Pomohla by preto lepšia spolupráca napríklad v oblasti boja proti daňovým únikom, karuselovým podvodom, či rôznemu zneužívaniu cezhraničnej spolupráce," zdôraznil. Odstránenie týchto neduhov by podľa jeho slov bolo na prospech ako ekonomike SR, tak aj ekonomike EÚ.

"Presadzovanie takejto politiky vytvára pre našich absolventov väčšie príležitosti a možnosti uplatniť sa nielen na slovenskom, ale aj na celoeurópskom trhu práce. ## Úvahy o rozširovaní V4 len svedčia o jej sile

To, že sa v Rakúsku po voľbách opätovne hovorí o chuti pridať sa k Vyšehradskej štvorke (V4), len svedčí o sile tohto zoskupenia a ukazuje, že V4 ide "správnou cestou". Myslí si to slovenský premiér Robert Fico (Smer-SD), ktorý sa takto vyjadril vo štvrtok, 19. októbra krátko po svojom príchode na zasadnutie Európskej rady v Bruseli.

Predseda vlády SR zároveň zdôraznil, že by nebolo dobré meniť originálnu fungujúcu značku. Do úvahy teda podľa neho pripadá formát V4+, rozhodne však nijaké V5.

"Pokial' ide o rozširovanie V4, my chceme zachovať unikátny formát V4, ale sme pripravení ísť do formátu V4+. My sme predsa preukázali množstvami stretnutí, že lídri iných štátov sú pripravení s nami komunikovať. Zostávame ale na formáte V4, maximálne V4+," odpovedal Fico na otázku o možnom rozšírení V4 o Rakúsko, ktorá zaznela na tlačovom brífingu v Bruseli.

Fico ďalej zdôraznil, že sila a jednota V4 sa prejavila aj na stredajšej (18.10.) pracovnej večeri lídrov V4 s predsedom Európskej komisie (EK) Jeanom-Claudom Junckerom. Tam sa totiž podľa jeho slov ukázalo, že lídri V4 zachovávajú v principiálnych otázkach zahraničnej politiky "absolútne jednotné stanovisko".

O možnom rozšírení V4 sa v Rakúsku začalo opäť diskutovať po nedeľňajších (15.10.) parlamentných voľbách. Je totiž možné, že predseda víťaznej Rakúskej ľudovej strany (ÖVP) Sebastian Kurz zostaví vládu s euroskeptickou a populistickou Slobodnou stranou Rakúska (FPÖ), ktorej líder Heinz-Christian Strache sa za vstup Rakúska do V4 vyslovil ešte vlani.

## Úroveň digitálnych zručností Slovákov rastie

Slováci potvrdili záujem zdokonaľovať sa v digitálnych zručnostiach. Od minulého leta sa ich len vďaka vzdelávaciemu programu Digitálna garáž, ktorú Google spustil v rámci svojej iniciatívy Pomáhame Slovensku rásť, vyškolilo vyše 27.000. Uviedli to nedávno na stretnutí s novinármi predstavitelia spoločnosti Google na Slovensku.

Na základe údajov majú najväčší záujem o získanie týchto znalostí ľudia z Bratislavského, Košického a Žilinského kraja. Najsvedomitejšie k štúdiu pristúpili ľudia z Trnavského kraja. Počas jednej návštevy online platformy Digitálna garáž si prezreli najväčší objem študijných materiálov a samotným štúdiom strávili v priemere aj najdlhší čas.

Práve digitálne zručnosti budú v budúcnosti podľa odhadov Európskej komisie vyžadované pri výkone až 90 % pracovných pozícií. S využitím internetu je navyše oveľa jednoduchšie a menej rizikové uskutočniť svoj podnikateľský sen či nájsť odbyt pre svoje produkty. Internet totiž otvára priestor a poskytuje možnosti na podnikanie pre každého. Aj vďaka online sa na Slovensku podarilo oživiť a podporiť mnohé slovenské tradície a remeslá a dostať ich opäť do povedomia verejnosti.

V súčasnosti sa úroveň nezamestnanosti na Slovensku pohybuje okolo 7,6 %, avšak v skupine mladých je až na úrovni 17,6 %. Spoločnosť Google preto vlani v júni spustila vzdelávací program Digitálna garáž, ktorý je súčasťou širšej iniciatívy Pomáhame Slovensku rásť. Tento program zahŕňa online školenia aj prednášky, vďaka ktorým najmä mladí ľudia získajú cenné poznatky o tom, ako funguje napríklad webová analytika, komunikačné nástroje, vyhľadávanie, mobilný marketing a tiež ďalšie vedomosti z oblastí ako online predaj a propagácia.

ľa T-Systems pýtal, ako je spokojný na Slovensku v porovnaní s inými krajinami, tak povedal tú vetu, ktorú ako prezident najradšej počúvam, a to, že na Slovensku sú úžasní ľudia a táto pobočka tu na Slovensku patrí medzi najúspešnejšie z celého sveta," povedal

Ako prezidenta ho príjemne prekvapilo, za čo všetko je 4000 ľudí vo firme zodpovedných. "Sú zodpovední za to, aby napríklad Shell nemal problémy v dodávke, ťažbe nafty, aby Mercedes plynulo vyrábal autá, aby Heineken plynulo vyrábal pivo a ďalšie a ďalšie," vysvetlil Kiska.

"Na prístupe tejto spoločnosti k regiónu, na tom, ako myslí na spoluprácu s vysokými školami vidieť, že táto spoločnosť myslí na tento región. Je úlohou aj vlády myslieť na to, aby v tomto regióne pomáhala takýmto zamestnávateľom, aby myslela na školstvo, na zdravotníctvo a na celý život tu v tomto regióne," uviedol prezident SR.

Výkonný riaditeľ T-Systems Slovakia Daniel Giebel povedal, že za 11 rokov pôsobenia v Košiciach sa im podarilo vybudovať silnú základňu. "Vyrástli sme z firmy, ktorá začínala s 22 ľuďmi na firmu, ktorá má v súčasnosti viac ako 4000 ľudí. Tak, ako pán prezident povedal, zabezpečujeme kritické služby, ktoré sú kritické pre fungovanie mnohých firiem po celom svete. Práve preto si myslím, že asi ten najsilnejší pocit, ktorý ja osobne mám a myslím si, že ho majú aj členovia môjho tímu, lebo som sa s nimi o tom rozprával, je tá hrdosť, že nám niekto vyjadril uznanie za dobrú prácu, ktorú odvádzame," skonštatoval Giebel.

Na otázku, či je ľahké nájsť dostatok kvalifikovaných odborníkov v tomto regióne odpovedal, že vždy sa ich snažia hľadať hlavne v regióne. "Musím priznať, že v súčasnosti je to čoraz náročnejšie, ale aj tak si myslím, že tím ľudí, ktorý tu máme, robí úžasnú prácu, aby k nám pritiahol tých najlepších," dodal výkonný riaditeľ T-Systems Slovakia.

## Ocenenie pre Oravskú Polhoru v súťaži Dedina roka 2017

Okrem Oravskej Polhory, ktorá získala právo v budúcom roku reprezentovať Slovenskú republiku v súťaži o 15. Európsku cenu obnovy dediny, si ocenenie prevzalo aj ďalších 12 obcí. "Chcem zagratulovať všetkým, ktorí sa zúčastnili," povedal minister Sólymos. Súťaž má podľa jeho slov predovšetkým povzbudiť obyvateľov k aktívnej účasti na rozvoji svojho domova s ohľadom na tradície a ducha dediny. "A hoci víťaz môže byť len jeden, ani snaha ďalších by nemala byť prehliadnutá," ozrejmil.

Do 9. ročníka súťaže Dedina roka sa zapojilo 20 obcí. Tie si zmerali sily v prezentácii výsledkov dosiahnutých pri ich obnove a rozvoji. Cieľom je prezentácia krás, jedinečnosti a úspechov vidieka a prestíže slovenských obcí.


## Minister P. Gajdoš rokoval s americkým veľvyslancom A. Sterlingom

Minister obrany SR Peter Gajdoš 13. októbra na pôde rezortu obrany rokoval s veľvyslancom Spojených štátov amerických Adamom Sterlingom. Hovorili o aktuálnych témach vzájomnej spolupráce.

Šéf slovenského rezortu obrany informoval amerického veľvyslanca o strategických dokumentoch, ktoré smerujú do Národnej rady SR. "Záleží nám na tom, aby modernizácia ozbrojených síl bola systémová a systematická a nie na báze ad hoc rozhodnutí. Dlhodobý plán rozvoja predstavuje plán investícií až do roku 2030," uviedol Gajdoš.

Témou spoločného stretnutia boli aj výdavky na obranu, minister potvrdil záväzok zo summitov vo Walese a vo Varšave a oboznámil veľvyslanca s navýšením rozpočtu už aj pre budúci rok. Hovorili spolu aj o vyslaní slovenských vojakov do Iraku, ktorí majú na výcvikovú aktivitu odísť ešte v tomto roku. V tejto súvislosti Gajdoš ubezpečil amerického veľvyslanca, že boj proti terorizmu patrí medzi priority Slovenska. Informácie poskytla hovorkyňa rezortu Danka Capáková.

## UK v Bratislave sa umiestnila medzi 2,4 percentami najlepších univerzít sveta

Univerzita Komenského v Bratislave (UK) sa podľa rebríčka CWUR (Center for World University Rankings) zaradila medzi 2,4 percentami najlepších univerzít sveta. V rankingu, ktorý hodnotil 27.700 svetových univerzít, obsadila 658. miesto.

Najlepšou univerzitou v rebríčku sa stala americká Harvardova univerzita, ďalšie dve priečky obsadili tiež americké školy, a to Stanford a Massachusetts Institute of Technology. Na štvrtej priečke je Cambridge, piaty skončil Oxford. UK, ktorá obsadila 658. miesto, sa tak zaradila medzi 2,4 percenta najlepších univerzít sveta. V rebríčku išlo o jediného slovenského zástupcu. Spomedzi českých univerzít najlepšie dopadla Karlova univerzita v Prahe, skončila na 255. mieste.

Hodnotenie prebiehalo na základe ôsmich indikátorov, a to kvality vzdelávania, kvality pedagógov, zamestnania absolventov, publikácií, vplyvu, citácií, dosahu a patentov.

Rebríček CWUR meria kvalitu vzdelávania a prípravy študentov, ako aj kvalitu výskumu, nezávisle od prieskumov a dát dodaných univerzitami. Je jedným z viacerých medzinárodných rebríčkov, ktoré hodnotia univerzity po celom svete. Prvýkrát bol publikovaný v roku 2012.

Program zabezpečilo viac ako 50 folklórnych súborov, ktoré zaplnili priestor Trojičného námestia i City Arény. Krajanské súbory v tomto roku prišli z Chorvátska a Ukrajiny. V sobotu vo večerných hodinách MNS vyvrcholili galaprogramom, v ktorom sa prelínal odkaz minulosti s dôrazom na významné slovenské osobnosti Trnavského kraja, s folklórom i moderným umením. Vzácnymi hosťami podujatia boli činovníci Matice chorvátskej a Matice slovenskej zo Záhrebu, ktorí dostali ocenenia za celoživotnú pronárodnú činnosť a dielo. Počas slávností dostalo priestor i divadlo, a to v podaní hry Jána Palárika: Dobrodružstvo alebo zmierenie pri obžinkoch.

Počas NMS prebiehal aj IX. Národný zraz Mladej Matice, na ktorom krajanskú mládež reprezentovala delegácia mládežníkov z Poľska a Rumunska.

Slávnosti boli aj v tomto roku tradične zakončené službami božími a slávnostnou omšou, po ktorých nasledovalo pietne zhromaždenie pri soche M. R. Štefánika a položenie vencov pri reliéfe Štefana Moysesa.

Epidémia moru sa rozšírila v Košiciach a okolí v roku 1709. Asi polovica obyvateľstva Košíc podľahla tejto smrteľnej chorobe. Na najstaršom fungujúcom cintoríne sú viaceré staré historické honosné hrobky, ktoré doplnili aj novšie hroby.

# Slovensko sa pripravuje na Dušičky

Sviatok všetkých svätých a Dušičky

Katolícka cirkev si 1. novembra tradične pripomína prikázaný Sviatok všetkých svätých a 2. novembra Spomienku na všetkých verných zosnulých, ľudovo nazývanú Dušičky. Obidva tieto dni charakterizujú spomienky na tých, čo už nie sú medzi nami, návštevy cintorínov, zapaľovanie sviečok na hroboch blízkych a ich zdobenie kvetmi.

Od roku 1994 je 1. november v Slovenskej republike dňom pracovného pokoja. Cirkev a veriaci si v tento deň spomínajú a modlia sa za všetkých svätých, ale aj za našich predkov, ktorí neboli vyhlásení za svätých, ale žili statočným a čestným životom a vedeli sa obetovať za iných. Cirkev oddávna spája s týmto sviatkom nádej na vzkriesenie. Duchovní obvykle pripomínajú, že tento deň má byť dňom radosti a nádeje a nie strachu či smútku.

Na Sviatok všetkých svätých sa okrem sv. omší v kostoloch konajú aj omše a pobožnosti za zosnulých na viacerých cintorínoch.

Sviatok všetkých svätých sa prvýkrát slávil v Ríme 13. mája 609, keď pápež Bonifác IV. prebral od cisára Fokasa pohanský chrám všetkých Bohov, tzv. Panteón a zasvätil ho Panne Márii a všetkým svätým mučeníkom. Neskôr pápež Gregor III. (731-744) zmenil slávenie všetkých svätých z 13. mája na 1. november, keď v Bazilike sv. Petra slávnostne posvätil kaplnku k úcte všetkých svätých.

Na Sviatok všetkých svätých nadväzuje deň Pamiatky všetkých verných zosnulých, známy aj pod názvom Dušičky, ktorý pripadá na 2. novembra. V roku 998 opát Odilo v benediktínskom kláštore Cluny zaviedol tradíciu 1. novembra večer vyzváňať a spievať žalmy za mŕtvych a na druhý deň slúžiť veľkú zádušnú omšu. Tento zvyk sa čoskoro rozšíril v celej západnej cirkvi. Na znak nesmrteľnosti duší a Božieho milosrdenstva sa na cintorínoch zapaľujú sviečky.

# Slovenskú republiku zvolili do Rady OSN pre ľudské práva

Slovenskú republiku 16. októbra zvolili počas 72. zasadnutia Valného zhromaždenia SN v New Yorku za člena Rady OSN pre ľudské práva na obdobie rokov 2018–2020. Informoval o tom Tlačový odbor Ministerstva zahraničných vecí a európskych záležitostí

Rada so sídlom v Ženeve je najvýznamnejším ľudskoprávnym orgánom systému OSN, v ktorom je zastúpených 47 štátov volených Valným zhromaždením OSN na základe regionálneho kľúča. Rada rokuje a hlasuje o ľudskoprávnej situácii v krajinách a o ľudskoprávnych témach. Prostredníctvom svojich mechanizmov napomáha prevencii konfliktov vo svete. Slovenská republika podporuje ich efektívne a včasné využívanie.

Zvolenie SR do rady je výsledkom aktívneho pôsobenia slovenskej diplomacie, ako aj ocenenie predchádzajúceho členstva Slovenskej republiky v rade v rokoch 2008 – 2011.

Prioritami členstva Slovenskej republiky v rade bude najmä boj proti všetkým formám rasizmu, xenofóbie, aktívna implementácia cieľov udržateľného rozvoja, vrátane podpory práv detí a podpora náboženského vyznania alebo viery a náboženskej tolerancie.
