The Need for Life Insurance Spans Generations

The two largest generations today are the millennials (86 million) and baby boomers (77 million). Baby Boomers, also known as the Me Generation, were born following World War II, when increased birth rates were observed during the nation's post–war baby boom. The general range of this generation is from the early-to-mid 1940s to around 1964. To define Millennials, also known as Generation Y, researchers typically use the early 1980s as starting birth years and the mid-1990s to early 2000s as ending birth years.

Americans aged 50 and over represented approximately half of the U.S. population and controlled 70 percent of the nation's disposable income in 2017. Yet, according to Pew Research Millennials will surpass Baby Boomers in size, with 72 million Boomers and 73 million Millennials nationwide by 2019. And by 2025, Millennials will account for 75% of the global market.

September is Life Insurance Awareness Month, as coordinated by the nonprofit LIFE

Foundation. So this month it's time to note that people in both of these major demographics may be neglecting the need to put in place plans that address two important factors relevant to everyone. The first is that life is fickle. The second is that death is inevitable. Boomers need to protect all the things they have worked so hard to achieve. For Millennials, while planning for death may sound premature, they need to protect dreams yet realized. This is where a good life insurance policy comes into play.

September 23, 2018 – Twenty-fifth Sunday in Ordinary Time Gospel: Mark 9: 30 – 37

The scene in the Gospel is an easy one to picture. Jesus and his disciples are walking through Galilee and most likely Jesus is up front leading the way like a good shepherd leading his flock. He's telling them the harsh reality of what is going to happen; he's going to be killed and on third

day will rise. What a message! I would imagine that when the disciples heard this sobering instruction they would have had all kinds of questions: Who will hand you over? Who will kill you? Why? What do you mean by "rise on the third day?" – and on and on.

There was no discussion with Jesus about what he said; instead a quiet conversation among them was taking place. The topic was "who among them was the greatest." Or, in other words, "When Jesus dies, which one of us will take his place?" How callous could these disciples be?

It's easy for us to question and maybe even think that we would never act like that. To do so would be disingenuous and a failure on our part to realize that each of us struggles in one way or another with false pride. False pride is when we lift ourselves up at the expense of another. This is different than a healthy pride in which we acknowledge some accomplishment and achievement that we earned by claiming and using some gift or talent God has given to us. It is false pride that comes before the fall and is addressed in the first reading from Wisdom as a characteristic of the wicked.

The reading from the letter of James also addresses false pride and gives us some excellent guidance on how to live a fruitful life in the Christian Community. It is believed that the James who authored this letter was not an apostle, but rather a relative of Jesus who is mentioned several times in the Gospels. He became a leader in the early church and when Peter moved to Rome, James remained in Jerusalem as the leader of that community. He had the gift of taking the Jewish heritage of the people of Israel and connecting it clearly to the message of Jesus. This just wasn't a matter of making simple comparisons between the two, but of showing a progression of the Old Testament teachings to Jesus and how Jesus renewed them and gave a different interpretation to them through his ministry and teachings. Jesus is the Word made flesh who brings new life to the words of the Old Testament. James was familiar with the Old Testament Wisdom literature, and he knew well the teachings of Jesus and the some of the struggles of the early church. James tells us that this kind of behavior is a disorder, while God's wisdom is what leads us to proper behavior. When we live by God's way the following are present: peaceable, gentle, compliant, full of mercy and good fruits. It is in this way that we can rightfully boast, as Saint Paul did, in the works he accomplished by the grace of God.

We avoid the errors of the disciples and the early Christians if we take seriously the instruction of Jesus at the end of the Gospel; "If anyone wishes to be first, he shall be the last of all and the servant of all." This goes against the grain of the temptation to build ourselves us regardless of the cost to us or others. It is by becoming a true servant of all that we can rise to be the leader, not by our own doing but by the recognition of others of God's presence within us.

September 30, 2018 – Twenty-sixth Sunday in Ordinary Time Lectionary 137

Envy is a particularly evil sin because by means of it we wish to deprive others without gaining anything ourselves—it is the self-pitying refuge of all of us when we become embittered and petty. The YouCat, a version of the Catechism which Pope Benedict XVI directed to be developed for use among young adults, says this about envy: "Envy is sadness and annoyance at the sight of another's well-being and the desire to acquire unjustly what others have" (YouCat 466).

That is exactly what we see happening in today's first reading from the Book of Numbers. Numbers is not often read at Mass; a passage from it is proclaimed every year on New Years' Day, and every third year on the twenty-sixth Sunday of the year (today), aside from a few readings at weekday Masses. It tells the story of the people of Israel after they had left their slavery in Egypt and before they entered into the promised land of Canaan, and it is full of rich imagery and moral lessons.

In today's excerpt from Numbers, we hear how a group of seventy elders of the people were about to receive the Spirit of the Lord so that they could assist the over-worked Moses in leading and judging the people during their desert wandering. A young member of the congregation saw that two men, Eldad and Medad, had received the very same prophetic gift of the Spirit even though they were not among the chosen seventy. He and Joshua, Moses' principal assistant, became envious and complained to Moses "Moses, my lord, stop them!" asking him to forbid Eldad and Medad from exercising their God-given gift. Moses wisely reproves them: "Are you jealous for my sake? Would that all the people of the Lord were prophets!" (Num 11:28-29).

Moses understood that God will give gifts to whom he wishes to give gifts, and while it is natural to wonder how the Lord "decides" upon such outpourings of the Spirit, nonetheless we are not to be envious of others' blessings. This theme is taken up subtly but firmly in the gospel account of our Lord rebuking his disciples when they had tried to chase away someone who was driving out demons in Jesus' name, but was not of the company of the disciples. Plainly speaking, they were envious of this man who succeeded in doing something they had failed at (see Mark 9:14-29).

Jesus takes up the lesson of the reading from Numbers when he tells the disciples: "Do not prevent him...whoever is not against us is for us" (9:39-40). He then continues to teach them that there are in fact deeds that confirm their practitioners are very much "against" the Lord and "against us" who wish to be his followers. Of such a person Jesus says "it would be better for him if a great millstone were put around his neck and he were thrown into the sea." Further, he tells his disciples that they must be willing to set aside anything that gets in the way of being "for Jesus" when he says "If your hand / foot / eye causes you to sin, cut it off / tear it out" (9:43-47).

Stemming from that teaching, the reading from the Epistle of James which precedes the gospel can be seen in its proper light: riches and the seeming security they provide can put us squarely in the "against" Jesus camp. James says: "Come now, you rich, weep and wail over your impending miseries" (James 5:1). Be it temporal riches or the spiritual gifts that God bestows on others, many intrinsically good things can become stumbling blocks for us when they become ends in themselves or when envy of them takes over. Let us rejoice then in whatever gifts that come from the gracious hand of the Lord, whether they be given to us—or to another.

Acknowledging need

Recent studies show that 59% of respondents regardless of age place a priority on financial matters other than life insurance and 64% think that life insurance policies are too expensive. When Nielsen recently conducted research evaluating insurance ownership by the generations, another trend emerged. While auto insurance ownership is fairly consistent and high across generations, exceeding 80%, people are less likely to have life insurance. This is particularly true for Millennials who are delaying many traditional life experiences that 20- and 30-somethings in the past would have already achieved such as getting married, buying a house or starting a family in favor of paying off student loans or starting a business. Yet now is the very time Millennials should consider life insurance.

Insurance can help protect co-signers of private student loans who may be held accountable for the remaining balance in the event of your death. If you are starting your own business or joining a small business, the right insurance plan that covers your life or the lives of essential people running it can provide the business with funds to recover from such critical owner losses. And, in general, life insurance may be the most cost effective when you are younger and may be healthier than in the future.

For the baby boom generation, the need for life insurance may be even greater. According to a Wall Street Journal article "The Big Squeeze" almost half of adults ages 40 to 59 provide financial support to at least one grown child in the past year, with 27% providing the primary support. And 21% of this group are providing financial support for an aging parent.

If you are a Boomer providing even partial financial support for your family and are no longer here to provide it, where do your children, grandchildren or elderly parents turn to for help? The government? Social Security? Friends and other family members? Insurance can help your family replace lost income. Reviewing the basics

A review of the basics can help determine the right life insurance. There are two main types of life insurance policies: term and permanent. Term insurance expires at a certain point in time, meaning at the end of the term.

Permanent life insurance, on the other hand, is as the name implies, permanent. These

plans include different whole life policies. When you go to buy this type of policy, you will probably have to answer questions about your health and depending on the coverage amount, a simple physical may be required.

As to the amount of coverage needed, there are two common ways of calculating it: needs-based versus human-life value. The needs-based method calculates the coverage amount based on what the individual would need to cover expenses. These include funeral expenses, emergency funds, mortgage, child care, etc.

The human-life value approach is calculated based on the financial loss the family would incur. This includes factors such as person's age, occupation, salary, employment benefits and other information about a spouse and children. It's designed to replace all the income that's lost when the individual passes away. Additionally, when thinking about the right amount of coverage, if you have group insurance already through your job, please remember that you may lose this coverage if you leave that job. While some group policies may allow you to convert coverage to an individual policy, it's often the exception and not the rule.

You also should take into account specific policy features. One of our juvenile term policies, for example, can be converted to permanent insurance with a guaranteed right to purchase with no medical exam required prior to age 25.

This brief overview of life insurance is just a start. It is vitally important to assess each option with an eye to your individual needs and situation. There are many options out there so be sure to do your research, and understand that financial professionals such as our inhouse insurance agents are always available to help you answer questions about specific policies.

The Patience of God

St. Augustine once said, "Patience is the companion of wisdom." Everyone wants to have wisdom. We want to understand the complexities and nuances of life and be capable of acting accordingly; but sometimes we lose sight of the tremendous amount of patience needed to gain such wisdom. One might say that the first step towards wisdom is to understand and cultivate patience within ourselves, and the best way to do that is to consider the immense patience of God.

In The Christophers' short online video entitled "The Patience of God," Father Jonathan Morris explains that God's patience manifests itself at special times that he calls "God moments." These are moments when we sense the hand of God and realize that, no matter how difficult life has been, God has always been by our side.

Father Morris offers an example of a God moment that occurred while he was waiting for a train at Manhattan's busy Penn Station. A man came up to him asking for money to buy breakfast. Father Morris told the man he would not give him money but instead would be willing to buy him breakfast right there at the station. The man said this wouldn't work because he always bought a particular breakfast at a different place down the road. Giving in to what he perceived as the man's creativity in trying to cajole money out of him, Father Morris reached into his pocket for a bill only to find that he didn't have anything lower than a twenty.

Father Morris says, "By this time I was already committed, and I just felt an inspiration – maybe I should just give him a chance. I said, 'Here. Take this money, but bring me back the change.'" Several minutes passed and suddenly the man reappeared and approached Father Morris with the receipt for his breakfast and the entirety of the change. Father Morris said to the man, "Sir, you don't know how much you've blessed me today. I am a Catholic priest." The man asked, "What's that?" Father Morris explained, "It's kind of like a pastor." With astonishment, the man said, "You're a minister?" Then he got down on his knees, raised his hands, and declared, "I won the Jesus lottery!"

This beautiful, funny, and unexpected exchange was truly a God moment. It was a wonderful reminder for Father Morris that God will never stop surprising us with the good that exists in people. And for that man who asked for money for breakfast, it was a powerful example of the joy God has in store for those who follow the right path.

Moments like these are profound manifestations of God's patience at work in our lives, and they are proof that He knows and understands our hearts and can send the right people into our lives even for passing exchanges that can light our way. It's important to remember that it also takes patience on our part to appreciate such moments. When we exercise that patience and look for those God moments, we gain the wisdom that will allow us to accomplish amazing things in this world.

Understanding the patience of God strengthens our faith and teaches us to be patient with others and look for opportunities to bestow little gifts that lead to surprise in the goodness of humanity at the most unexpected moments. Appreciating, enjoying, and taking part in creating those moments is the surest manifestation of wisdom in our lives.

The Pontifical Oriental Institute – 100 years in service to the Christian East

The Pontificio Istituto Orientale (Pontifical Oriental Institute) or as it's commonly referred to - the Orientale - celebrated its 100th anniversary this past academic year. The Orientale was founded by Pope Benedict XV on October 15, 1917, with the main goal of helping Eastern Christians to not only rediscover the richness of their own authentic traditions, but also to share this richness with Latin-rite Christians. His successor, Pius XI, entrusted the Institute to the Jesuits in 1922, who are still in charge today. It is located in Rome, Italy, close to the Basilica of St. Mary Major in the vicinity of the ancient Basilica of St. Praxede, and is set on top of the Esquilino hill, one of the seven famous hills of ancient Rome.

Throughout its existence, the Institute has seen some 6000 students in its classrooms and corridors; and Slovaks and the Orientale have enjoyed a special connection from the very beginning. The institute is well known to Byzantine Catholics, too, and it has played a special role in the history of the Byzantine Catholic Church, both in Slovakia and North America. Among the Institute's first ministers was the Slovak Jesuit and current candidate for beatification, Fr. Vendelín Javorka SJ. The Slovak Fr. Michael Lacko, SJ, taught history at the Orientale and was always willing to share his free time with his students, or the visitors to Rome, who were coming there from the Pittsburgh Metropolia or the Slovak parishes in Canada. A great moment of history came in 2007, when Fr. (now archbishop) Cyril Vasil', SJ, was named rector of the Institute.

Nowadays, you also can find other religious, lay people and even Orthodox Christians among both the faculty and the student body. Since 1928 the Orientale has been in association with the Pontifical Biblical Institute and the Pontifical Gregorian University. Many celebrated scholars have taught there, among them: Michel d'Herbigny, SJ; Prince Volkonsky; Cyril Korolevsky; Cardinal Špidlík, SJ; and Robert Taft, SJ; along with such Eastern Canon Law experts as Ivan Žužek, SJ; Dimitrios Salachas, and others. The former Superior General of the Jesuit Order, Peter Hans Kolvenbach, was a one-time rector of the Orientale as well. The current rector is Fr. David Nazar SJ, Canadian. Several Byzantine Catholics from the USA have studied there as well. Fr. David Petras, native of Cleveland, OH, defended his Doctorate at the Institute. Bishop Kurt Burnette of Passaic, NJ, studied there and obtained a Doctorate in Canon Law, while he was still a priest of the (then) Eparchy of Van Nuys. American-Slovak, Fr. Michael Kuchera SJ, native of Pennsylvania was for a time a Dean of the Faculty of Eastern Canon Law. He still continues to teach there.

The Orientale has given many intellectuals and members of the hierarchy to the Universal Church. Bishop Milan Lach SJ, Bishop of Parma, OH, is another alumnus of the Orientale, where he defended his Doctorate. The present-day patriarch of Constantinople Bartholomew also is an alumnus, and there are many more. Martyrs of the 20th century studied there as well. Several have been proclaimed as beatified, while others are awaiting such a process, like the Slovak Ján Ivan Mastiliak CSsR, who spent many years in a communist prison, or Fr. Ján

Kellner, who was shot as a missionary in the Soviet Union, and who was a friend of another Orientale alumnus, Bishop Theodore

Romža, the beatified Bishop of the Eparchy of Mukačevo, Ukraine. The list of the martyrs will likely continue to increase as many former Orientale students are now victims of the religious persecutions and was in the Middle East.

What makes Oriental such a special place? One real treasure is the library, which contains over 180 000 volumes, many of them in English, but there are Slovak titles as well. It houses one of the most extensive collections on Eastern Christianity, including a rare collection of Old Slavonic manuscripts, and is used for research work by scholars worldwide. The true heart of the place, though, may just be a beautiful chapel designed in the Byzantine rite and therefore adorned with icons, painted by two Slovaks, Fr. Rastislav Dvorový and Mr. Rastislav Bujna.

With its relatively low number of students, those who have visited or studied there have commented that being at the Orientale is like being part of a family – a family of fellow Christians, coming from all over the world, from India through Egypt, Ethiopia or Europe all the way to USA, Canada, Brazil or other American countries, as an answer to the prayer of Jesus that All may be one.

ACCEPTANCE OF THE JUNE MEETING MINUTES:

The Executive Secretary presented the minutes of the June 2018 Executive Committee Meeting. A motion was made by Kenneth A. Arendt, and seconded by Andrew R. Harcar, Sr., to accept the minutes as presented. Motion carried.

AQS MANAGEMENT, INC.:

Larry White, representing AQS Management, Inc., presented an extensive Investment Portfolio Transaction Report by telephone and WebEx to the Executive Committee. Each member of the Committee received a copy of the presentation in advance for his review. Following the report, Mr. White answered the Committee's questions.

ECONOMIC OVERVIEW:

Annuity Rates:

The President asked Nick DePersis of ENDePersis Fraternal Consulting, LLC, Andrew P. Rajec, Director of Independent Agents, and Robert Kopco, Branch Coordinator, to join the meeting. The President presented an extensive review of our current annuity rates and asked for input on the effects of possibly raising our current annuity rates.

Nick DePersis presented information on the impact that raising annuity rates may have on our financial statements.

Andrew P. Rajec presented feedback from our agents regarding our current annuity rates and commissions.

Robert Kopco presented feedback from the branches regarding our current annuity rates.

After a lengthy discussion, the Executive Committee was unanimously in favor of raising the annuity rates effective August 1, 2018.

The 8 Year Flexible Premium Deferred Annuity/IRA will increase from 3.60% to 3.85%. The 6 Year Flexible Premium Deferred Annuity/IRA will increase from 3.20% to 3.45%. The 6 Year Fixed Rate Annuity/IRA will increase from 3.10% to 3.35%.

TREASURER'S REPORT:

The Treasurer and the Executive Secretary gave a full written report on the investment update and answered the Committee's questions.

EXECUTIVE SECRETARY'S REPORT:

Investment Updates

The Executive Secretary and Treasurer submitted a written report to the Executive Committee on the investments and transactions with the Federal Home Loan Bank (FHLB), UBS, MAI Fund, and Clutterbuck Fund. Following the report, the Executive Committee discussed the report and the Executive Secretary answered the Committee's questions.

Portfolio Review

The Executive Secretary updated the Executive Committee on the report from our portfolio custodian, Key Bank, found everything in order, and answered the Committee's questions.

Mortgages and Overdue Mortgages

The Executive Secretary presented the report for the month of June for the Committee's review and answered their questions.

Monthly Disbursements

The Executive Secretary reported that the following disbursements were incurred and paid during the month of June:

The Executive Secretary also presented the Membership and Annuity Report. The Executive Committee reviewed the remainder of the disbursements and the Executive Secretary answered all questions.

SALES AND MARKETING:

The Vice President gave a production report on our agents. He stated we are still recruiting and adding new agents, and at present have 300 agents. The Home Office is sending the independent agents monthly updates on our products. The independent agents are also in frequent contact with Andrew P. Rajec, Director of Independent Agents. Agents now produce over 70% of annuity sales. The Home Office has started an extensive Facebook ad recruiting campaign to recruit agents in the states we are licensed in.

The Vice President stated he is in the process of setting up training seminars and is encouraging branches and districts to contact him for available dates.

The Executive Secretary stated that our outside marketing firm is working on updating our presentations and reviewing all our marketing material.

The Executive Committee decided to continue the first year free on the JEP program until August 31, 2018

The Executive Committee is reviewing the current commission rates being paid to licensed agents to determine if any changes are necessary.

Andrew P. Rajec will be contacting all our independent agents either by letter, email or telephone call to inform them of the new annuity rates.

The new annuity rates will also be advertised on our website, sent in emails, and mailed to all branch officers.

CONVENTION:

The Executive Secretary stated that the Home Office has everything in place for the 51st Convention being held August 4-8, 2018 in Cleveland, Ohio. We will be utilizing electronic voting machines for the motions but still have written ballots for the election of officers. We are looking forward to an excellent Convention

REQUESTS FOR ADS AND DONATIONS:

Requests for donations and ads were reviewed and acted upon.

ADJOURN:

There being no further business to discuss, a motion was made by Kenneth A. Arendt and seconded by George F. Matta II to adjourn the meeting. Motion carried.

My 2018 Adventures in Slovakia (Part 2)

This second installment about my travels in Slovakia covers my trip to area north of Trenčianske Bohuslavice.

Trenčianske Bohuslavice Folk Songs

On May 31, I again awoke early with the dawn and the rooster. Tilka (Matilda Macháčová) and I continued our interesting conversations over breakfast about her work on the village. As I was interested in folk culture, I asked Tilka whether she knew some local songs from the village. She treated me to singing a set of folk songs from Trenčianske Bohuslavice and I recorded them on video. Subsequently, I posted these on my Facebook page and uploaded them to YouTube, so all might see and hear them and appreciate village songs: https:// youtu.be/6ZViKHRTQpw and https://youtu. be/hiPO_wpv2H4. They are well worth listening to and a rare treat.

We had a busy day ahead of us so we got an early start, as we were traveling northwest up the Bošác valley, which is about 20 km long and lies at the foothills of the White Carpathian Mountains, with the river toward Moravia. The valley abounds with historical monuments dating back to the 19th century Slovak national awakening.

Day 4 - North of Trenčianske Bohuslavice -- Bošáce and Its History

Our first stop was in Bošáce, just 4 km from Trenčianske Bohuslavice. According to written documents, the village of Bošáca originated around 1380 and was named "Bosach", then Bosacz in 1506, and Bosacza in 1773. The Hungarian spelling is Bosác.

At one time, the population grew considerably larger as kopaničiari colonized the village in the 18th century. Kopaničiari were independent people, not serfs, and lived in small groups of humble homes in the mountains, especially in this region of the White Carpathians. One Slovak emigré once described them as "Slovak hillbillies"! They gradually moved downhill and relocated mountain valleys. The population of Bošáce rose so much that by 1784, 2,146 inhabitants lived there, and by 1900, there were 3,488 inhabitants, but declined into the late 20th century. Today it is home to just 1,393 people.

In the 18th and 19th centuries, Bošáce residents worked mainly in agriculture, but benefited from a thriving trade. The area acquired a reputation for its fruit orchards, mainly plums and pears (slivky a hrušky). Merchants would load crates of dried fruits in carriages to the Vah River and then load the cargo on rafts traveling to the Hungarian lowlands, and down the Danube River as far as Budapest; trains replaced water transport after the opening of a railroad in 1878. A prized product of the village was Bošácka slivovice (plum brandy), which is still manufactured there to this day by the distillery firm Bošácka paleníca. To this day, Bošáčania (the people of Bošáce) feel proud knowing that they have a reputation for producing the best slivovice in all of Slovakia.

In the early 19th century, vineyards used to dot the hills around Bošáce, but those have disappeared since due to a devastating blight. Other trades enhanced the Bošáca economy as well, and the village boasted 11 mills at one time. It was also the

home of many sculptors, carpenters, blacksmiths and other craftsmen.

Cultural life thrived in the late 19th and early 20th centuries as amateur theater and clubs; the gymnastic Sokol (Falcon) and Orol (Eagle) built gyms and sports fields for its members. There used to be a Jewish synagogue in the center of the village, but went into ruins after the Second World War.

A Baroque Jewel

At the south end of the village stands the baroque Catholic Church of the Assumption of the Virgin Mary (kostol Nanebovzatia Panny Márie). From the 11th to the 16th century, the Benedictines occupied the site and made a fortified area during the 14th century Tartar incursions. After 1380, it came under the lordship of Miklós Bánffy, the lord of Beckov Castle. After the Benedictines left, later the barefoot Augustinians moved on the site; according to local lore, the name of village derives from the term Bosáci (barefoot monks). Tradition has it that the hermit St. Svorád resided there for a while and later lived moved to in Skalka near Trenčín. The monks constructed a wooden monastery on the site, with a small chapel, but it lay in ruins by 1691.

The current yellow church with white trim was built in a late baroque style between 1729 and 1733, and modified in a more classical style in 1789. The church contains a single isle, with three sanctuaries and a bell tower. The tower features a helmet-like roof with a skylight turret. The original bells were added in 1737, but the three largest bells no longer exist because the Austro-Hungarian War Ministry confiscated them and melted down the material for military purpose during World War I.

As with most baroque churches, the exterior appears rather plain, but the interior lifts one up to the heavens. The main altar was originally painted by the artist Pauer from

Nitra, but the current altar is made of Tyrolian wood and dates from 1928. On the two sides of the main altar stand statues of St. Augustine and St. Nicholas, who dazzle with amazement at God's glory.

The main feature that draws one's eyes upon entering the nave is the painting of the Assumption of Our Lady, the work of the renowned painter Josef Hanula. It consists of four scenes: the first depicts the most Holy Trinity; the second groups together prominent saints -- St. Svorád and St. Benedict, St. Vojtech (Adalbert), St. Augustine, and SS. Cyril and Methodius; the third scene shows Stephen, the first King of Hungary with his wife Gizella and their children -Ladislav I, Imrich, Alžbeta and Margita; the final section, the highlight, shows the Immaculate Virgin Mary with her child Jesus. Marble columns and gold trim surround the sanctuary and add accent to the artist's masterpiece.

The Bošáč Valley Museum

The village also boasts its own local museum for the region, the Bošáč Valley Museum (Múzeum Bošáckej doliny). The museum opened just in 1996. Two retired teachers, Ján Jurák a Adam Rýdzi, organized the effort and raised the funding through donations.

It is a skanzen type museum (an open-air museum) that presents visitors with an overview the folk culture of a picturesque Slovak region. It is situated in an original peasant

home next to the local distillery.

The central living room displays the original historical furniture; the kitchen is equipped with a classic masonry stove and a traditional loom (krosná), which saw much use during the winters. Another part of the house contains an exhibition of rare, traditional Bošáca folk costume (kroj), which are decorated with intricate hand-embroidery.

As is typical in many peasant houses, in the back there is a small barn with a stable (maštaľ) for cattle and, goats, and a pig-pen (chlievik) and a chicken coup (kurín). There is also a work bench area for the man of the house (gazda) and a storage place for farm equipment and tools such as a wagon, chaff cutters, and a threshing tool (vozy, sečkovica, mláťačka). The lady of the house (gazdina) would also have her space — a summer kitchen. There would be a large pot (kotol) for boiling plums to make lekvár (plum jam or preserves) and perform other cooking outside during the warm summer months.

In the past, a cellar would serve as protected place for storing fruits and vegetables during the cold winters. Finally, no respectable Slovak peasant an outhouse (záchod) and a manure pit (hnojová jama).

The museum is well worth of visit. But a note of caution. Since it a small museum, it is not regularly open. Any museum visit planned should have an advance notice of 2-3 days. One may telephone at this number: 032/7781130.



EMIL MADEA BRANCH 796 – EGYPT, PENNSYLVANIA



The following are requirements to complete in order to qualify for your branch stipend:

Bylaw Section 4.05 FINANCIAL OBLIGATIONS:

"By the end of March of each year, the Home Office shall pay each local branch \$5.00 per member, per year, not to exceed \$8,000.00, provided the local branch has fulfilled the following requirements:

- Published, announced and conducted two (2) semiannual meetings, one (1) of which shall be an annual meeting held for the election of officers. Meeting attendance (sign in) sheets or copies shall accompany the reports submitted to the Executive Secretary.
- Submitted an annual report to the Executive Secretary on a provided form, by February 15th of the following year.
- Submitted a financial report to the Executive Secretary on a provided form, by February 15th of the following year.
- Hosted, sponsored, promoted, or attended at least one (1) fraternal activity in the (d) past year.
- Produced at least one (1) new contract in the previous calendar year. Branches (e) with two hundred fifty (250) or more members must produce at least two (2) new contracts.
- Provided the Home Office, on a continuing basis, current addresses of members and completed change of beneficiary forms, death reports, and such other documents as required by the Home Office.
- Sent a branch representative to attend at least one (1) district meeting per calendar year. Those in attendance at the district meeting may vote to provide a branch with an excused absence.
- Members attending a district meeting shall sign an attendance sheet evidencing their presence at the event. No later than February 15th the District shall notify the Executive Secretary of those branches failing to meet this attendance requirement of article "g" above.
- 2. The Executive Secretary shall publish no later than May 1st in the Official Organ those branches failing to meet the requirement of section 4.05.
 - Maintained good standing within its district by paying current fiscal year dues and any dues that may be outstanding from previous years.
- The requirements of this Section must be met by the branch to receive payment of any other compensation.

Bylaw Section 14. RULES GOVERNING LOCAL BRANCHES

14.01 General Rules

Správy zo Slovenska

Bratislava - Tripartita sa vráti k rokovaniam o výške minimálnej mzdy pre budúci rok opäť v septembri. Sociálni partneri sa totiž na poslednom rokovaní na sume nedohodli. Rezort práce však trvá na svojom návrhu, aby minimálna mzda od budúceho roka stúpla o 40 eur na sumu 520 eur a túto sumu plánuje predložiť minister práce Ján Richter (Smer-SD) v prípade nedohody tripartity aj na rokovanie vlády.

Bratislava - Ministerstvo zdravotníctva (MZ) SR rokuje s Ministerstvom financií (MF) SR o dofinancovaní miezd zdravotníckych pracovníkov pre rok 2019. Uviedla to hovorkyňa MZ Zuzana Eliášová. Dofinancovanie žiada Asociácia nemocníc Slovenska (ANS), ktorá upozorňuje na rast nákladov.

Bratislava - Daňová kobra odhalila v roku 2017 podvody v celkovej sume 97.178.496,63 eura, z toho nevyplatený nadmerný odpočet dane z pridanej hodnoty (DPH) bol v sume 5.640.895,66 eura. Potvrdila to hovorkyňa Generálnej prokuratúry (GP) SR Andrea Predajňová s tým, že očakávaný nález predstavuje sumu 78,4 milióna eur a zadržiavaný nadmerný odpočet DPH sumu 4.913.427,97 eura.

Bratislava – Najsledovanejšou televíziou v prvom polroku tohto roka bola TV Markíza, ktorú sledovalo 40 percent slovenskej populácie. Vyplýva to z výsledkov národného prieskumu spotreby, médií a životného štýlu Market & Media & Lifestyle – TGI za prvý a druhý kvartál 2018, ktoré zverejnila spoločnosť Median SK. V poradí druhá TV JOJ zaznamenala v kategórii sledoval včera sledovanosť na úrovni 32 percent. Verejnoprávnu Jednotku, ktorá skončila na treťom mieste, sledovalo v prvom polroku 24 percent populácie.

Trnava - Medzinárodný vzdelávací projekt Mladí pre sociálne podnikanie pod hlavičkou programu Erasmus+, s podporou mládežníckej organizácie luventa a s účasťou zástupcov šiestich krajín Európy, sa uskutočnil v Trnave od 3. do 10. septembra. Jeho cieľom bolo prispieť k zníženiu nezamestnanosti mládeže a reagovať na sociálnu inklúziu v Európskej únii. Organizátorom je občianske združenie (OZ) Youth for Equality.

Banská Bystrica - "Rozhlasákom" z roku 1968 odhalia utorok (21.8.), v deň 50. výročia okupácie bývalého Československa vojskami Varšavskej zmluvy, pred Štúdiom RTVS v Banskej Bystrici pamätnú tabuľu. Jej zhotoviteľom je mesto. TASR o tom v pondelok informovala Dominika Mojžišová z kancelárie banskobystrického primátora.

Bratislava – Dni európskeho kultúrneho dedičstva (DEKD) ponúknu v septembri takmer 400 podujatí a aktivít po celom Slovensku. Otvorené budú i bežne neprístupné pamiatky a v inom svetle sa predstavia aj tie bežne prístupné. Počas tlačovej konferencie to informovala ministerka kultúry Ľubica Laššáková (Smer-SD). Rôznorodé vzdelávacie podujatia, semináre i prednášky doplnia aj turistické atraktivity, súťaže a hry súvisiace s historickým prostredím a jeho hodnotami.

Bratislava - Pätica slovenských stredoškolákov, ktorá v auguste v Mexiku súťažila na medzinárodnej robotickej olympiáde, získala ocenenie Judges Award – Technical. To sa udeľuje v prípade, že chce porota oceniť úsilie tímu a jeho výkon v oblasti technických schopností a zručností. Informovala o tom Simona Kocková zo spoločností Neopublic.

Bratislava - Od nového roka by sa mali spustiť národné skríningové programy pre rakovinu krčka maternice, kolorektálneho karcinómu a karcinómu prsníka. Plánuje to ministerka zdravotníctva Andrea Kalavská (nominantka Smeru-SD), ktorá vo vláde presadila Národný onkologický program (NOP).

Bratislava – Na Slovensku chýbajú stovky učiteľov. Na portáli pre učiteľov edujobs.sk bolo zverejnených viac ako 550 voľných pedagogických pozícií, teda na učiteľov materských, základných a stredných škôl, ale aj na vychovávateľov, pedagogických asistentov a na učiteľov základných umeleckých škôl.

Bratislava - Prístup detí žijúcich na národnostne zmiešaných územiach k vzdelávaniu v slovenskom jazyku by sa mal zlepšiť, a to zavedením povinnosti pre štát zriadiť v obci, v ktorej tvoria občania slovenskej národnosti menšinu, slovenskú základnú školu. Stať sa tak má v prípade, ak o jej zriadenie požiadajú zákonní zástupcovia starajúci sa spolu minimálne o päť školopovinných detí. V novele zákona o štátnej správe v školstve a školskej samospráve to navrhujú poslanci ĽSNS.

Bratislava - Rekreačné poukazy budú povinné v prvej etape pre firmy s 50 a viac zamestnancami. Informoval o tom na brifingu po rokovaní s Klubom 500 a ďalšími zamestnávateľmi Andrej Danko, predseda Národnej rady SR a SNS, ktorá príslušnú legislatívu ohľadom poukazov predkladá na rokovanie parlamentu. Rekreačné poukazy, ktoré majú podporiť cestovný ruch na Slovensku, by mali začať fungovať od januára 2019.

Bratislava – Priame náklady na zdravotnú starostlivosť o fajčiarov predstavujú pre Slovensko miliardu eur. Ročne na choroby spojené s fajčením zomrie 7900 ľudí. Národný onkologický program (NOP), ktorý vláda schválila minulý týždeň, má ambíciu tieto dôsledky zmeniť. Ministerka zdravotníctva Andrea Kalavská (nominantka Smeru-SD) chce ľudí motivovať k tomu, aby nefajčili. "

Bratislava - Žiaci stredných a vysokých škôl sa budú môcť v najbližších rokoch zúčastniť na inovačných workshopoch. Program je určený pre žiakov 3. a 4. ročníka stredných škôl a pre študentov vysokých škôl. Plán inovačných workshopov na budúci školský rok 2018/2019 aktuálne pripravuje Slovenská inovačná a energetická agentúra (SIEA). Informoval o tom vedúci oddelenia komunikácie SIEA Stanislav Jurikovič.

Budapešť/Bratislava - Po šiestich rokoch odňatia slobody za spôsobenie dopravnej nehody pod vplyvom alkoholu s následkom úmrtia štyroch ľudí sa Slovenka Eva Varholíková dostala 28. augusta podmienečne na slobodu. Uviedol to spravodajský server Blikk.hu. Odsúdená požiadala prostredníctvom svojho obhajcu budapeštiansky súd o podmienečné prepustenie pred niekoľkými týždňami. Súd jej žiadosti 17. júla vyhovel.

Košice - Financie na rekonštrukciu mostov a ciest II. a III. triedy v Košickom samosprávnom kraji (KSK) sa tento rok zvýšia o 6 miliónov eur. Vyplýva to z úpravy krajského rozpočtu, ktorý nedávno schválilo Zastupiteľstvo KSK. Nové investície budú financované zo zvýšeného úveru z Európskej investičnej banky (EIB) vo výške 5,6 milióna eur a zo zvýšených príjmov z dane z príjmov fyzických osôb vo výške zhruba 674.000 eur.

Bratislava – Pri počte učiteľov, ktorých je okolo 90.000, hľadajú školy viac ako 200 nových pedagógov. Nedostatok učiteľov je najmä fenomén Bratislavy, uviedla to v rozhovore pre TASR ministerka školstva, vedy, výskumu a športu Martina Lubyová (nominantka SNS). "Podľa našich informácií najviac chýbajú učitelia cudzích jazykov a informatiky. Súvisí to s tým, že v kraji majú ľudia možnosť zamestnať sa inde mimo školstva," poznamenala Lubyová

V gréckokatolíckej cirkvi tento sviatok slávia pod názvom Narodenie Presvätej Bohorodičky. V rímskokatolíckej cirkvi latinského obradu aj v gréckokatolíckej východného obradu sa 8. septembra konajú na Slovensku sväté omše a liturgie zasvätené narodeniu Matky Božej. Mnohí veriaci sa zúčastňujú na tradičných ma-

riánskych púťach.

Gréckokatolícka cirkev považuje sviatok 8. septembra za veľmi radostný deň, lebo Narodenie Presvätej Bohorodičky zvestovalo celému svetu radosť.

Oficiálne zavedenie tohto sviatku v Byzancii sa pripisuje cisárovi Maurikiovi (*539-+602). Maurikios bol v rokoch 582-602 cisárom Byzantskej ríše. Z východu sa sviatok Narodenia Presvätej Bohorodičky rozšíril na západ v 7. storočí, najskôr do Ríma a potom do celej západnej cirkvi. Dátum 8. september sa stal dňom sviatku preto, lebo na tento deň pripadá deväť mesiacov od počatia Panny Márie v lone jej matky sv. Anny, ktoré východné cirkvi slávia 8. decembra, a aj preto, lebo v ten deň mal byť postavený chrám zasvätený Panne Márii v Jeruzaleme.

Deň po sviatku Narodenia Presvätej Bohorodičky slávia gréckokatolíci spomienku na jej rodičov - Joachima a Annu.

Veriaci z Bratislavy, gréckokatolíci aj rímskokatolíci, sa zvyčajne zúčastňujú na výročnej púti v najstaršom pútnickom mieste na Slovensku, v Marianke pri Bratislave. V tomto roku je výročná púť pripravená na 7.-9. septembra. Podľa informácie z webovej stránky Baziliky Marianka špeciálnou akciou tohtoročnej púte bude "požehnanie novej studničky, ktorú sme postavili pre mariánsku požehnanú vodu".

Po sviatku Narodenia Panny Márie si katolíci 12. septembra pripomínajú deň mena Matky Božej - Márie. O tri dni neskôr, 15. septembra, sa slávi sviatok Sedembolestnej Panny Márie, patrónky Slovenska, na Slovensku je to deň pracovného voľna.

V ich strede sú vsadené ďalšie Ankine relikvie - a to tri zrnká z jej ruženca, ktoré sa našli v hrobe. Našli sa spojené. Je to symbolika modlitby troch Zdravasov, ktoré sa modlievajú na pútiach vo Vysokej nad Uhom - za múdrosť v povolaní, za čistotu a za živú vieru. Margarétky majú spolu 53 lupienkov - ako je zdravasov v ruženci. Relikviár je vsadený do kameňa - vápenca, ktorý bol nájdený v prírode ako súčasť vydutého morského dna. Tento kameň znázorňuje ulitu pre túto vzácnu perlu.

Relikvie novej blahoslavenej boli hneď po skončení svätej omše blahorečenia v sobotu 1. septembra vystavené pre veriacich na verejnú úctu na mieste vedľa štadióna. Slovenskú delegáciu na septembrovom VZ OSN povedie prezident A. Kiska

Slovensko bude podľa smernice pre postup delegácie aj naďalej prispievať do mierových operácií OSN na Cypre, Haiti a Blízkom východe. Bude tiež presadzovať reformu bezpečnostného sektora a boj proti terorizmu, extrémizmu a radikalizmu. V rámci migračnej politiky OSN chce zas zdôrazňovať právo štátov určiť si, koho prijmú na svoje územie.

Podľa dokumentu je pre Slovensko dôležitá aj implementácia Parížskej dohody a jej čo najširšia univerzalita. "Rok 2019 bude kľúčový pre urýchlenie opatrení na ochranu klímy a pre operatívnu realizáciu Parížskej dohody," zdôrazňuje.

Čo sa týka úlohy Slovenska v orgánoch OSN, predložilo kandidatúru do Bezpečnostnej rady OSN na obdobie 2028 – 2029. Zároveň sa Peter Tomka uchádza o znovuzvolenie za sudcu Medzinárodného súdneho dvora v Haagu (MSD) na obdobie 2021 – 2030. Slovensko tiež predložilo kandidatúru Mlynára na post predsedu 6. právneho výboru VZ OSN počas 74. zasadnutia VZ OSN.

Príhovor prezidenta Andreja Kisku z príležitosti 50 výročia okupácie Československa

Pred päťdesiatimi rokmi sa milióny obyvateľov Československa ocitli v šoku. Rozhlasoví reportéri ohlasovali neslýchanú správu: do našej krajiny vtrhli cudzie vojská. Po uliciach miest a obcí rachotili tanky, ľudia stáli pred nimi s holými rukami. Na mnohých miestach sa ozývala streľba.

Všetko to malo podobu nepredstaviteľného, príšerného filmu. Naozaj, kto by bol uveril, že raz nás budú okupovať armády takzvaných "spriatelených krajín", spojencov z Varšavskej zmluvy? Uverili by sme tomu, že vrcholných predstaviteľov nášho štátu na čele s Alexandrom Dubčekom okupanti zatknú a odvlečú do Sovietskeho zväzu?

Žiaľ, naozaj sa to stalo. Našu vlasť zaplavilo pol milióna vojakov, vyše 6 000 tankov, 800 lietadiel a 2 000 diel. Sovietske divízie nás v noci napadli z východu, zo západu, zo severu aj z juhu. Pridali sa k nim poľskí, maďarskí a bulharskí vojaci. A jednotky armády východného Nemecka stáli na hraniciach ako "rezerva."

Najväčšia operácia v dejinách Varšavskej zmluvy sa vydarila, do rána obsadili celú republiku. Nijakých kontrarevolucionárov nenašli, zato však v krajine, kde sa dovtedy šírila nádej na slobodnejší život, zabili desiatky nevinných obetí.

Po podpísaní Moskovského protokolu sa hororový film menil na krutú realitu normalizácie. Začala sa potláčať slododa tlače, prejavu či viery. Na pracoviskách sa rozbehli potupné previerky, desaťtisíce zamestnancov boli šikanované, vyhadzovali ich z práce, ich deti nesmeli študovať. Mnohí šikovní a vzdelaní ľudia emigrovali. Moc prevzali bezcharakterní jedinci opierajúci sa o sovietske bodáky.

Dnes sa vám prihováram zo Śliača. Z miesta, odkiaľ po dlhých 23 rokoch odišli poslední cudzí vojaci. Zanechali za sebou zdevastovanú krajinu, zdemolované byty, ale najmä zmarenú nádej na zmenu v roku 1968. Je povinnosťou dnešných demokratických politikov chrániť našu slobodu, možnosť rozhodovať o našej budúcnosti bez obáv z toho, že naše rozhodnutia zlomí hrubá sila. Preto potrebujeme spojencov s rovnakými hodnotami a rovnakým rešpektom k slobode, právam ľudí a demokracii. Takých spojencov a partnerov máme v Európskej únii a Severoatlantickej aliancii, dvoch pilieroch našej prosperity a bezpečnosti.

Dovoľte mi však vysloviť jednu prosbu. Okupáciu našej krajiny vojskami Varšavskej zmluvy dnes odsudzujú tri pätiny obyvateľov Slovenska. Pribúda však tých, ktorí o nej vedia málo alebo nič. Najmä medzi mladými ľuďmi.

Prosím preto rodičov, učiteľov, príbuzných, ako aj pamätníkov, aby si v tieto dni našli chvíľku času a s mladšími ľuďmi a deťmi sa podelili o svoje poznatky a skúsenosti. Aby im priblížili časy nádeje, ale aj chvíle zrady, zúfalstva a poníženia. Spomenuli si na obete okupácie i zásadnú zmenu, akú nám priniesol November 1989. Aby sme im pomohli pochopiť, že slová "nikdy viac" znamenajú nielen odhodlanie, ale vyžadujú si rozumné, zodpovedné rozhodnutia, ktoré túto túžbu naplnia obsahom.

V Bratislave rokovania o zmene sídla americkej ambasády

Hlavné mesto a Veľvyslanectvo Spojených štátov amerických v Bratislave začínajú rokovania o zmene sídla americkej ambasády. Tá si za možnú lokalitu vybrala súčasné sídlo Dopravného podniku Bratislava (DPB) na Olejkárskej ulici. Spĺňa vraj bezpečnostné štandardy. Rokovania aj s vedením DPB by sa mali v tejto súvislosti začať v najbližších týždňoch. Americká ambasáda sa medzitým odvolala voči rozhodnutiu, ktorým mestská časť Staré Mesto ako príslušný stavebný úrad nariadila odstránenie oplotenia okolo súčasného sídla veľvyslanectva. Staromestský starosta Radoslav Števčík to odôvodnil tým, že americká ambasáda stále nepreukázala vlastnícky vzťah, ani iné právo k pozemku, na ktorom je predmetné oplotenie. Toto právo časom stratilo svoju platnosť a bratislavské mestské zastupiteľstvo od roku 2016 opakovane ambasáde neschválilo nájom mestských pozemkov pod oplotením.

Ambasáda ešte v júli uviedla, že bezpečnostné oplotenie neplánuje odstrániť. Odvoláva sa pritom na bezpečnostné dohody podpísané s hlavným mestom a mestskou časťou, a taktiež na Viedenský dohovor v súvislosti so zabezpečením bezpečnosti diplomatických misií hostiteľskými krajinami. Momentálne podotkla, že sa k prebiehajúcim právnym prípadom nebude vyjadrovať. Odvolanie však potvrdila mestská časť. "Áno, odvolali sa. Rozhodovať bude okresný úrad," uviedla staromestská hovorkyňa Nora Gubková. Okresný úrad Bratislava zatiaľ danú vec neeviduje.

Ambasáda USA mala mestské pozemky na Hviezdoslavovom námestí a Paulínyho ulici prenajaté od roku 2005. Veľvyslanectvo ešte v roku 2002 prijalo bezpečnostné opatrenia v podobe oplotenia budovy aj v súvislosti s teroristickým útokmi v New Yorku z 11. septembra 2001. Diskusie o odstránení oplotenia z historického centra mesta prebiehajú od roku 2016. Podľa mnohých by bolo práve presídlenie budovy, aj vzhľadom k bezpečnostným opatreniam, najvhodnejším riešením.

"Podarilo sa nám takisto rozbehnúť niekoľko inovačných projektov v oblasti inteligentných miest. Máme veľmi nádejne sa rozbiehajúcu spoluprácu medzi univerzitami v Berkeley a Žiline v oblasti inteligentných dopravných systémov a takýchto projektov je čím ďalej, tým viac," uviedol veľvyslanec Peter Kmec a dodal, že je cítiť veľký záujem jednotlivých štátov USA o bilaterálnu spoluprácu. "Za ten čas sa mi podarilo nadviazať dosť kontaktov, tak dúfam, že ovocie sa objaví v najbližších rokoch," povedal Kmec. Veľvyslancom SR vo Washingtone sa od jesene stane súčasný štátny tajomník rezortu diplomacie Ivan Korčok.

Zánik demokracie

Československo si po 2. sv. vojne udržalo svoju demokraciu len krátko.

Zrod socializmu

Už vo februári 1948 sa dostala po politickom puči k moci Komunistická strana Československa.

Po vzore Sovietskeho zväzu

Jej ústredný tajomník, súčasne aj predseda vlády a neskôr prezident Klement Gottwald, bol neochvejným a horlivým stúpencom politiky Sovietskeho zväzu. Čoskoro sa začalo presadzovať do praxe jeho heslo: "So Sovietskym zväzom na večné časy a nikdy inak." Ten sa nám stal vzorom vo všetkých sférach spoločnosti : v poľnohospodárstve, priemysle, kultúre, vede, školstve... No najviac zasiahol katolícke cirkvi.

Kňazov, ktorí neprejavovali viditeľne a s patričnou úctou svoje sympatie k súčasnej politike štátu, sa považovali za jeho nepriateľov a odporcov a zatvárali ich.

Likvidácia reholí.

Postihnuté boli aj rehoľné rády. Tak pri akcii "Barbarská noc" z 13. na 14. apríla 1950 vnikli príslušníci štátnej bezpečnosti do kláštorov, Rehoľníkov v autobusoch poodvážali na vopred sústredené miesta a tam ich internovali a prehovárali, aby sa vzdali svojich reholí, ktoré boli zrušené.

Podobný osud stihol aj ženské rehole.. Po "Barbarskej noci" nasledovala akcia "R", pri ktorej 28. – 31. augusta 1950 násilne odvliekli 1962 sestier a dali ich dispozícii na rôzne pracoviska, kde pracovali v poľnohospodárstve v rastlinnej a živočíšnej výrobe, v závodných kuchyniach a jedálňach... Boli izolované od kostolov a znemožňovala sa im účasť na cirkevných obradoch.

Náboženstvo – brzda socialistickej výchovy Ešte väčšia neprávosť postihla náboženstvo, ktoré bolo považované za brzdu socialistickej výchovy. Začalo sa uvádzať do praxe Marxova téza: "Náboženstvo – ópium ľudstva". Vyučovanie na školách sa sťažovalo rôznymi taktikami a formami. Na prihlasovanie žiakov sa vyžadoval podpis oboch rodičov. Vyučovanie sa zaraďovalo do rozvrhu na neskoršie popoludňajšie hodiny, kedy už žiaci z okolitých obcí nemali vhodné dopravné prostriedky na cestu domov.

A nakoniec rodičia často neprihlasovali deti na náboženstvo v obave, že by sa pred nimi uzavrela cesta na strednú alebo vysokú školu, pretože v komplexnom hodnotení žiakov sa uvádzalo aj to, či navštevovali náboženstvo a či nie sú ich rodičia príliš nábožensky angažovaní.

Sledovanie kňazov

Učitelia dostali od nadriadených úradov pokyn, aby hospitovali na hodinách náboženstva a overili si či kňaz – katechéta nemarí ich socialistickú výchovu. Na školách, kde sa za pomoci "šikovného" riaditeľa a ideologicky uvedomelého kolektívu náboženstvo nevyučovalo, bola takáto škola na ONV a OV KSS vysoko hodnotená a dávaná iným za príklad.

Na ONV bola zriadená funkcia "cirkevného tajomníka", ktorého úlohou bolo sledovať činnosť, kňazov, kázne v kostoloch, ich lojalitu k socialistickému zriadeniu, a či učitelia a iní verejní funkcionári sa v kostoloch nesobášia alebo si tam nedávajú deti krstiť.

Zánik ČSSR a obrodný proces

Tento neblahý stav trval až do zániku socialistického Československa v roku 1991, no výrazné zlepšenie nastalo prechodne už aj v období Dubčekovho Obrodného procesu, ktorý výrazne presadzoval voľnejší "socializmus s ľudskou tvárou." A ten sa prejavoval v mnohom: v odstraňovaní hraničných zátarasov a ostnatých drôtov, v slobode tlače a vy-

jadrovania sa, v slobodnom cestovaní do zahraničia, v amnestii politických väzňov a účastníkov v západných štátoch, v rehabilitácii súdnych procesov s kňazmi a cirkevnými hodnostármi, v navrátení gréckokatolíckych kostolov, ktoré boli násilím včlenené do pravoslávnej cirkvi, vo výstavbe nových kostolov...

V obnovenom demokratickom Slovensku odvtedy pribúdajú nové kostolov, kláštory, otvárajú sa cirkevné školy všetkých druhov...

Už len spomienky

Nuž takéto bolo obdobie. Búrlivé, rušné, nepokojné, niekedy nepochopiteľné, obdobie neprávosti, prenasledovania, krutosti a útlaku. Ostáva už len v spomienkach staršej generácie, ktorá sa o ne občas podelí so svojimi deťmi a vnukmi.

Na rozlúčkovom podujatí na slovenskom veľvyslanectve vo Washingtone sa zúčastnili aj miestni Slováci, predstavitelia krajanských organizácií a spolkov, slovenskí honorárni konzuli v USA, veľvyslanci a zástupcovia viacerých európskych veľvyslanectiev, ako aj predstavitelia amerického ministerstva zahraničných vecí. Z toho 30 000 prišlo na hlavnú sobotnú slávnosť spojenú s obradom blahorečenia, pričom medzi nimi boli dvaja kardináli, viacero arcibiskupov a približne 30 biskupov zo Slovenska i zahraničia a viac ako 600 kňazov, vyše 650 rehoľníkov a desiatky predstaviteľov verejného a spoločenského života.



Pápeža Františka zastúpil legát kardinál Giovanni Angelo Becciu, prefekt Kongregácie pre kauzy svätých. V službe bolo počas troch dní 630 dobrovoľníkov, viac než sto policajtov, 15 supervízorov, 5 pracovníkov control roomu, 150 usporiadateľov a vyše 50 zdravotníkov a záchranárov. Pozostatky tela Anny Kolesárovej budú uložené do dvoch relikviárov – jeden bude v Katedrále sv. Alžbetty v Košiciach a druhý v kostole Sedembolestnej Panny Márie vo

Na hlavnej slávnosti blahorečenia, ktorá sa uskutočnila v sobotu 1. septembra 2018, to bol relikviár, ktorý bol vyrobený zo striebra. Jeho príprava trvala niekoľko mesiacov. Autorom je šperkár Marek Husovský. Relikviár je v tvare srdca - ako symbol obety a lásky, po ktorej túži každé ľudské srdce. Má priemer asi pol metra. Srdce má v strede perlu, cez ktorú sa dá pozrieť
