Message from the President

As we enter the year 2020 I would like to wish you all a Happy New Year, Šťastný Nový Rok in Slovak, and hope that the coming year will bring you and your families health and happiness.

I would also like to inform our Members of a very important transaction that closed on November 1, 2019, and culminated in the sale of most of our property in Middletown, PA. Let me explain.

History of the Sale of the Jednota Properties in Middletown, PA

The original purchase of the approximately 300 acres of farmland was made in 1911, but for reasons lost in history was not recorded in the public records until 1914. (Note that Fr.

Furdek, the primary founder of the FCSU, along with others, died in 1915.)

Ultimately, the FCSU built a 3-story orphanage along with other buildings in about 1914.

Ultimately, the FCSU built a 3-story orphanage along with other buildings in about 1914. There also was a printing facility constructed to print the Jednota newspaper, along with other publications and books, primarily in the Slovak language.

The Pennsylvania turnpike, which bisected the FCSU property, opened in 1940 but was proceeded by land acquisition, whether by purchase or eminent domain is unclear. The FCSU lost substantial prime acreage.

In the 1950's several pipeline and utility easements were granted or taken by eminent domain for eventual construction of several pipelines across the Jednota property. Since it was agricultural land the cost of eminent domain was minimal. However, the easements meant that they not only cut off accessible land but they rendered more land not buildable.

In 1974 the remodeled Harrisburg airport needed better road access for customers. The state of Pennsylvania built the "airport connector" road, a two-mile 4 lane highway that again dissected the Jednota property.

The taking of additional land by eminent domain by the state of Pennsylvania for highways led to a series of issues. 1) the Jednota lost a significant amount of land, @ 20 acres;


2) the new airport connecter road cut off about 15 acres of land which the Society sold off to a local developer (more about that later); 3) the old printery building and residence had to be demolished; 4) the old cemetery that was cut off was the resting place for over a dozen former Jednota orphans or nun caretakers; the graves were disinterred and the remains moved, either to their relatives' cemeteries or to the Middletown cemetery.

This issue of easements again was reared in the period after 2010 when the fracking boom made those old easements even more useful to the easement holder. After hard bargaining, the Society was able to negotiate more favorable payments for easements threatened with eminent domain. The FCSU received more than \$270,000 from Sunoco pipelines.

St. Vincent Archabbey — Homily, Father Edward Mazich, O.S.B.



64 – 2nd Sunday of Ordinary Time – January 19, 2020

Energized by the Advent and Christmas seasons, as the Church goes forth into the new year we are presented with a strong challenge and equally strong encouragement in today's readings: the challenge is the call to divine servanthood, and the encouragement comes from the prophetic words of Isaiah and John the Baptist.

The Book of Isaiah was likely written


over a span of two centuries, and as one would expect of any such lengthy period the nation of Israel saw both triumphs and tragedies in that time. One consistent theme—and challenge—that carries



Earlier in this long book Israel's role as the Lord's servant is traced over rocky ground, with the nation drifting from her fidelity to the Lord's service and being besieged by enemies all about. Later however, in the era today's reading is drawn from, we see signs of great hope. When today's passage was recorded Israel was in the process of coming home from a long exile in Babylon, and a new sense of joyful anticipation was emerging: here is where the challenge turns to encouragement; we read, "It is too little, he says, for you to be my servant, to raise up the tribes of Jacob, and restore the survivors of Israel; I will make you a light to the nations, that my salvation may reach to the ends of the earth" (Isa 49:6).

This verse, and this Sunday's entire first reading, are taken from the second of four socalled "servant songs" found in Isaiah. The "servant songs" are poetic outbursts of the prophet, marked both by hope and by a realistic understanding of the disappointment that often accompanies hope in human life. Israel came to appreciate the proper places of hope and realism in her role as the Lord's servant, and we must do the same. The Psalm at today's mass reflects a similar profound recognition of the Psalmist's vocation as a servant of the Lord, and in spite of the dual-edged nature of this calling he accepts the responsibility with zeal, saying: "Hear I am, Lord, I come to do your will" (Ps 40:8-9).

With remarkably pointed words John the Baptist takes up his servant role where Isaiah



and the Psalmist leave off, exclaiming, "A man is coming after me who ranks ahead of me

The 15-acre parcel noted above was sold in 1975 to a local developer that developed a small strip mall that deteriorated and was eventually sold to another developer (Mr. Nardo). Unfortunately, the original sale agreement signed in 1975 by former FCSU officers contained a provision that said: "if for any reason it becomes necessary for grantor to request grantee (FCSU) to relocate their pipelines, and grantor agrees to make available other lands of grantor for the installation and maintenance of grantee's pipeline, then and in such event, the First Catholic Slovak Union of the United States of America and Canada agrees at its own cost and expense to relocate its pipelines to the area designated by grantor."

All the parties to that 1975 agreement have passed, and there is no record to express their reasoning.

Unfortunately, several years later, in 2007, the current owner (grantor/Nardo) sought to enforce that clause and demanded that the Society pay \$450,000 for a new sewer that he installed. When we refused, they filed suit for that amount. Incidentally, that also was the amount the Society had originally received for the land sale.

In a prolonged legal engagement, which also involved the township and issues such as the sanitary sewer capacity, the case was settled in 2018 for \$300,000.

This settlement opened the door to later sell the property because it secured sewer availability and capacity for new development. The settlement occurred with a face to face meeting with Mr. Rajec and the plaintiff Mr. Nardo, at a scheduled deposition of Mr. Nardo. To date, the only new construction on the 15 acres has been a CVS drugstore and a low budget hotel. Most of the former mall in now vacant or torn down.

The destruction of the old printery for the new highway raised the issue of a new printery. In the 1974, a new printery was built on the grounds not far from the old orphanage, which itself was closed in 1969 for lack of orphans and other reasons. The orphanage was ultimately demolished in the mid 1990's, after the building suffered major water damage. There was an effort (Save the Orphanage Fund) to repair the orphanage. However, there was only about \$75,000 raised of the approximately \$1 million needed. The money was eventually donated to the sisters of Sts. Cyril and Methodius who had staffed the orphanage for many years.

The new printery opened in 1974 under Joseph C. Krajsa, manager, who also was the editor of Jednota. His son, Joseph J. Krajsa, subsequently became manager several years later. A new editor, Anthony Sutherland was named after Mr. Krajsa Sr.'s retirement. The new printery was a modern building built for a designated purpose, that is to print newspapers, books and other small volume publications. It branched out to attract other commercial printing business.

As we all know the printing business has seen many changes after the 1970s. We have seen the small shop printers go out of business, great consolidation in the industry, at-home office printers, use of the internet, and less demand for the printed word.

Dollar losses and increased competition caused FCSU President Tom Hricik to close the printery operation in the mid-1990s.

The building was put up for lease, but because of the specialized single use of the building it remained vacant. It remained vacant up to the sale of the property, despite efforts of listing with at least 4 real estate firms over the years.

Meanwhile the cost of repairs (HVAC, roof etc.) and the cost maintenance, utilities etc. continued - plus it was a con-conforming use with regard to current zoning.

There was a continuing effort thru the years, to lease the printery building with no results. A "for lease" sign advertising the building constantly was on the property visible from the PA turnpike.

However, the potential threat of more easements still existed and the need to maximize the value of the undeveloped property was critical before other remaining land could be reduced in value.

In 2008 a local developer expressed interest in buying the entire property. However, the near-collapse of the economy in 2008-2010 caused them to drop their interest.

In 2017, President Rajec again began receiving unsolicited phone inquiries about purchasing the entire property. A respected Pittsburgh appraisal firm was hired to appraise the various segments of the property. The entire parcel appraised in 2018 at \$11,680,000.

The primary negative was that 2/3rds of the entire parcel was zoned "agricultural" and the remaining 1/3rd was zoned "industrial limited". For any meaningful development the zoning had to be changed. The FCSU Board of Directors believed that FCSU did not have the expertise, experience and political pull and presence in the community to be successful in obtaining the necessary zoning changes.

Jednota Properties Inc., formed in the 1980's, as a FCSU wholly -owned sub and as a taxable entity, was the owner of Building #2 (50,000 sq ft 1 story office building on 4.5 acres of the property). Jednota Properties, Inc. eventually began to pay corporate income tax after years of loss-carry forwards. In addition, the Properties Inc. depreciation benefits were becoming exhausted. The President and the Board onsidered the lease situation, cost of upkeep, lack of presence in the area (the Home Office is 300+miles away) and the fact that property ownership is not the core business of the Society. It is fraternal life insurance and annuities. With these factors in mind, the FCSU Board considered sale of the property.

Outside events, such as the decline of shopping malls and the rise of online shopping that has created a demand for warehousing, often on a huge scale - e.g. Amazon, etc. — contributed to these considerations.

In late 2017 Mr. Rajec was approached unsolicited by four firms that were interested in making offers on the property. All four were invited to the Home Office to make their presentations to the Board of Directors. Two dropped out.

In January 2018, the two remaining, Trammell Crow and D&H/Kinsley made live presentations to the Board. The presentations were also attended by specialized real estate outside counsel, Atty John Feichtel, whose retention was approved by the Board.

The Board had previously, based on expert appraisal, had set a price of \$13 million for the

entire property, 300 acres, plus Building #2. Any buyer would have to pay any commission to any real estate broker.

A primary consideration was – in addition to all the other issues that had to be addressed: could the buyer get the necessary zoning changes, since any zoning changes were subject to voter challenge at the local level?

After careful deliberation, the Board voted unanimously to enter into a contract of sale with D&H/Kinsley for \$13 million, subject to various contingences regarding zoning, timing etc. Also, the buyer had to grant the Society, by permanent easement, the recently constructed FCSU Memorial. Also, FCSU would retain 21 acres of vacant land for any future uses.

The President's and the Board's concern was that with the massive growth of online shopping and the big-box warehouse building boom it fueled, warehousing could be overbuilt. FCSU could be left with 300 acres of farmland, mostly zoned agricultural, 300 miles away from the Home Office. It was time to cash-in and concentrate on our core business: fraternal insurance.

The contract of sale, with several contingencies, was signed on August 8, 2018, after Mr. Rajec disclosed the planned sale at the Convention. Closing was set for November 1st, 2019, subject to a complicated number of contingencies including rezoning.

Note, that there was a vote at a Convention in the 1980s that would have moved the Home Office to Middletown, PA. That vote was narrowly defeated and a new Home Office building was purchased in Independence, OH.

The Sale

The following is a time-line of the actual events surrounding the sale of the property. It became very fast moving, especially in the last several weeks before the close on November 1, 2019.

The timeline of communications was presented to the Board by Mr. Rajec. During September and October 2019 there were numerous calls and emails (several dozen) between President Rajec, the realtor for a tenant (Conduent), Atty Feichtel, the attorney for D&H/Kinsley (Drew Kipnis), Jim Marmol, Gary Matta regarding the Conduent lease renewal (1-1-2020), and other critical issues regarding the sale of our property.

Fortunately, since we closed on November 1, 2019 the final resolution of the Conduent lease fell to the new buyers.

There was a flurry of activity in the last two weeks before November 1, 2019. In a conference phone call with Mr. Rajec and the buyers (D&H/Kinsley) and Atty Kipnis, representing the buyers, and Atty Feichtel, representing FCSU, the buyers in exchange for an extension of the closing date, agreed to pay 20% of the purchase price or \$2.6 million immediately as a "down payment". As Mr. Rajec promised to the Board, this must be in cash, not in escrow.

However, when the amended extension agreement was sent from the Buyers' Atty Kipnis on October 3, 2019 (passed the October 1st deadline to change the November 1, 2019 closing date), it stated, \$2.6 million would be held in escrow. When Mr. Rajec received the extension agreement, he immediately called Atty Feichtel (witnessed by Mr. Arendt). Mr. Rajec said escrow was not acceptable, as he had stated in the prior conference call with the buyers. He told Atty Feichtel that FCSU would consider this a breach to the existing contract and demanded a November 1, 2019 closing as the original contract called for.

Atty Feichtel immediately relayed that message to the Buyers' attorney. Feichtel received a response on October 10 and the closing was scheduled for November 1, 2019 as originally planned.

The closing documents were to be prepared by the title company (First American Title Insurance Co.). Mr. Rajec drove to Easton, PA on October 31st on another FCSU matter. Atty Feichtel called him en-route on cell and said that he just received the closing documents from the Title Co. and there was a nasty surprise. At the Buyers' direction the Title Co. apportioned the purchase price of the property to show a \$6.2 million purchase price for

Building #2. The professional appraisal done in 2018 had put a \$4.7 value on Building #2. Mr. Rajec got to his hotel at 7:30pm and the package was faxed to him. He immediately told Atty Feichtel to call the Buyers' attorney and the Title Co. FCSU will not complete the transaction with those allocations. The cost to Jednota Properties Inc. – and ultimately the FCSU - in additional federal and state taxes could be as much as \$450,000 (the difference between \$6.2 mill and 4.7mill at a rate of approximately 30%).

Atty Feichtel called Mr. Rajec on his cell at 8:00am on Friday, November 1, 2019 and said he had just received the new closing documents showing the \$4.7mill allocation. The buyers had relented. The FCSU saved \$450,000.

The President went to Atty Feichtel's office from Easton, PA. He and James Marmol, Jednota Properties, Inc. President, signed the closing documents on November 1, 2019.

On Saturday the President went to the former editor residence on the Jednota grounds. Tony Sutherland and he went through the documents stored on the grounds. Steve Nease (FCSU property custodian) assisted. They kept any documents that appeared to have some historical value, with any questions given a nod to save the documents.

Dozens of boxes of old materials were collected. They finally finished at 5:30pm.

Mr. Rajec returned to Cleveland on Sunday, November 3, 2019.

Within two weeks Steve had loaded all the materials that had been saved into a storage pod that has been delivered to the Home Office parking lot for further examination and retention for our Museum.

The proceeds from the sale of the property will be added to the Society's surplus for investment, and for the benefit of the Members according to a plan developed by the President and the Board of Directors.

A chapter of the Society's history has been closed with the sale of the property. But a new chapter is opening for the future. How the Society meets future challenges and opportunities will depend on its leadership and Members to expand the vision of Fr. Furdek and the founders.

Guests were then welcomed by Consul General Ladislav Begeç; Prime Minister of the Slovak Republic Peter Pellegrini and Minister of Foreign and European Affairs of the Slovak Republic Miroslav Lajčák delivered remarks followed by unveiling a plaque bearing the name of the Consulate General of the Slovak Republic in New York. This will be displayed on the exterior facade of the building together with the national flag after the reconstruction. The ceremony also included the

signing of a Proclamation of the dedication. The ecumenical blessing of the building was performed by representatives of the Catholic and Evangelical Church and of the Jewish religion. The program ended with a performance by Luba Mason.

Until its completion, the Consulate General of the Slovak Republic in NYC will continue to operate in its current premises (801 Second Avenue, 12th floor).






He was an avid golfer and belonged to several leagues; he liked football and baseball and was an Ohio State and YSU fan.

LIGHT ONE CANDLE

Sarah Hart recalled that her grandfather was a lovely man with a servant's heart who always turned strangers into friends. But one day, during the last few years of his life, they were talking on the phone and she realized he sounded out of sorts. "Are you grumpy, Grandpa?" Sarah asked him. He acknowledged that he had gotten a little crotchety lately and that he'd even yelled at somebody that day. Sarah told him, "That's so not like you."

The message registered, so a few days later, Grandpa called her back to say he had found a solution to his problem. Using the old style printer paper that still had holes on the side, he made himself a banner that read, "Be Nice" and hung it over the door so it was the last thing he saw before he left the house. It proved to be a reminder that worked, and the phrase "Be nice" even became a family mantra for the Harts. So when Sarah was working on songs for her latest album, entitled "And Lovely It Is," she turned the words "Be Nice" into a song – not just because of her grandfather, though.

During a "Christopher Closeup" interview, Sarah told me, "I wrote it right before the 2016 presidential election when everybody was being so mean to each other, and I just couldn't take it. Songwriters are lovers, not fighters, but our weapons are the pen and the melody. So my weapon was to write a song about the fact that we should work on our civility, our kindness."

Though Sarah is a Grammy-nominated Christian music mainstay, "And Lovely It Is" is outwardly more secular, inspired by her love of her daughters Rose and Evelyn, husband Kevin, and other family members and friends. Implicitly, however, the light of the divine is reflected on the album's songs in various ways. Sarah notes, "I'm very much of the school that the Lord is in all things...And we as believers, if we have that in our hearts...then our hearts can't help but radiate it."

Some songs are meant to simply inspire joy in the listener, as is the case with the track "C'est La Vie." Joy doesn't always get the attention it deserves when it comes to living a fully Christian life, but Sarah hopes to change that. She said, "[Music] is a beautiful gift that God gave us, and sometimes it's intended for fun."

In order to tap into this spirit of joy, Sarah made one major change in her life: she stopped watching the news on TV or listening to it on the radio because it has "a tendency to report on nothing but the negative." To stay abreast of what's going on in the world, she will read some stories, but she refuses to go back to being a full-fledged consumer of all media.

Sarah said, "It's amazing the effect that [a news fast] has had on my spirit. I think there's something that happens in the way that you look at other human beings when you're not constantly hearing every day about how bad human beings can be...Instead, [you're] looking at people and trying to see the face of God in that person and be one-to-one communicating with people and loving people in the world. That has changed me, so I highly recommend it. Don't listen to the news. If you need to know something, read it. But listen to good things instead. Like 'Christopher Closeup.'"










My First Visit to Slovakia, 1978 (Part One)

I will never forget the first time I visited communist Czechoslovakia. That occurred in the summer of 1978, during the era of "normalization". After the 1968 Soviet-led invasion, Communist Party chief Gústav Husák had determined to crush all reforms and potential opposition. My first impressions of communism would be quite grim, but they would also stir my curiosity and my wish to pursue further studies in the country itself

I was traveling with my wife Rebecca on our European grand tour for three months during the summer of 1978. I was working on a doctorate, studying history at the University of Pittsburgh and she had just completed her Masters of Library Science degree at Kent State University in Ohio. Unlike the typical American tourists, we were not traveling "in style," but rather backpacking on a very tight and skimpy budget, camping out, and sleeping in train stations to save money. We entered Czechoslovakia on the way to our first stop in Bratislava.

The main reason I went was to see the country and the village where my mother was born and my maternal grandparents lived. My mother had immigrated to the USA in 1936 with her mother and sister. My paternal grandparents arrived in 1906 and 1907, but I knew less about where they were from at the time. My curiosity put this destination on the top of my list of places to visit. While my maternal side of the family had no close relatives in Slovakia, my mother had some childhood friends she had kept in contact with, and she visited them three years later in 1981. My wife also had relatives there, her father's first cousin.

In order to visit during the communist era,

because of government restrictions on Western visitors, before our trip, we had to apply for a visa at the Czechoslovak Embassy in Washington; we had to list the exact dates of the visit and our purpose - tourism. We determined that we would enter the country on Tuesday, August 1, 1978, and would stay for 8 days. That would provide enough time to enter at the border, see Bratislava, and then head out east for a few days to visit relatives and our families' villages, and then depart from the country after seeing the capital, Prague.

We rose early that morning at 3:45 am in order to be sure to catch the first train so we would have a full day in Bratislava, as there were few trains that ran back and forth to Czechoslovakia at that time. We were camping in the west suburbs of Vienna, and missed the first train to the city, so we had

to board the slower tram, and then go to the South Bahnhof rail station. Luckily, we caught the 6:40 morning train for Bratislava, and arrived at the border by 9 a.m. (My wife kept a daily journal on our trip, so we have an exact and accurate record of times and expenditures.)

Our first impression of communism was distressing at the border crossing by train as we left Austria. Guard towers, heavily armed soldiers, fences, and barbed wire were not something we were accustomed to seeing in Europe. The border guards and customs control stopped us for a couple hours as we presented our passports and visa. The officials were not very nice, not at all welcoming, and rather gruff. We had to change an obligatory \$10 per day per person for our 8-day stay. The money exchanged at 10 crowns

(koruny) for a dollar, but we were only given 754.40 crowns, so we were either taken, or there was a high exchange rate fee. Later, we found out that the regime set the exchange rate and overvalued the currency to earn money off of foreigners. On the black market, which reflected the real worth of currency, the dollar fetched 34 crowns per dollar!

Certainly we did not feel welcome in any way, and the customs agents were in no hurry to check credentials quickly and send the train on its way. It seemed as if they moved slowly just to irritate passengers and flex their muscles to show how powerless we were. Though Bratislava is only 70 km from Vienna, getting to the city took nearly four hours because only local trains ran in that direction, and then we had to experience the tight border security and inspections of bag-

gage on the Czechoslovak side.

Near the border, we had to change trains, and boarded the train headed to Bratislava. The seats were rather hard and seemingly had no cushion at all. Using the restroom was no delight, for both the toilet and sink were very dirty and not cleaned at all, and smelled awful; nor was there any toilet paper – bring your own! The Czechoslovak train rode rough and was not nearly as comfortable as the other European trains we had traveled on. On our trip into the country, we could see mainly run-down buildings from the railcar window. We could already tell that we were in for a cultural shock.

When we finally arrived in Bratislava at 10:30 am, the stark colorless and drab appearance of the city shocked us. The main train station appeared gray, unkempt, and depressing, hardly what one would expect from the capital of Slovakia. It was far worse than we had expected, even though we knew it would not be as developed as in the free Europe. For a large city of over 350,000 people at the time, the train station was relatively small, and it looked like it had not been remodeled since World War II! Few shops existed in the station, and everything appeared dirty and unkempt, badly in need of some Mr. Clean. There was little evidence of the hustle and bustle we had experienced at most train stations in the previous two months of our traveling across Europe. Very few travelers were making the trip there from Vienna, and most of the train cars had detached from the locomotive and remained in Austria.

The contrast seemed all the more striking because we had just spent four days in the colorful, cheerful, and tourist-friendly city of Vienna. The dinginess and dirty gray of the Slovak city stood out. It seemed like soot hung over the city, a symptom of the terrible pollution, even though there were very few automobiles. The streets were dirty, again in contrast with the very tidy Vienna. We knew we were in for an experience. So this was communism!

We could also sense a certain sense of sadness in the faces of people. Few would look at us directly in the eye, though they might have noticed our very tattered and

worn-out jeans, as we had few changes of clothing. No one wore shorts as in the USA, although wearing shorts at the time was generally much less common in Europe than in America. Most women wore dresses, and slacks were rarely seen on ladies.

To get around we did our best, and we had two months of experience traveling in free Europe, but this would be a challenge of a different sort. In addition, my Slovak was still weak, and I had little real practice at conversation in the USA. But I knew some basic words from having taken a couple classes in the language. No one spoke English, so I had to get by with broken Slovak and a little German, which some older folks knew. At the time, my German was better than my Slovak, since I had studied German in college. It was my first real taste of communism in practice, not in theory, and I realized how fortunate my mother was to have left the country before World War II and the subsequent communist takeover in 1948.

The first thing we needed to do was to deposit our sleeping bags, tent, and heavy backpacks (Mine weighed 40 pounds!) in lockers at the train station, something we had become accustomed to doing during our travels. Then we had to find something to eat, meet some friends, get our bearings on the layout of the city, and find a place to stay. Since this was before the age of the internet, we always headed for the Tourist Information Center in the city, as there was no information at the train station. To navigate any city, one needs a map. Luckily, some kind Slovak fellows directed us to the proper electrička (tram) to the center of town.

The tram was jerky, old, and people did not talk for the most part. Most people were standing, as there were not enough seats. It cost just one crown (10 cents at the official exchange rate) to ride into town. We had heard that prices were low in Bratislava, and they were, but choices of most anything were very limited. The private street vendors one saw in the rest of Europe were not around, as the government owned all the businesses. As we were hungry by this time, we bought a few groceries and some fruit at a cost of 25 and 7 crowns, and had a quick lunch on a bench. (We kept an exact budget of everything we spent on paper.)

In town we found a ČEDOK, the Czechoslovak Travel Bureau, and someone there assisted us. At lunchtime, I had prearranged to meet an American couple, Jack and Maureen Buchko, whom I knew from studying Slovak with at the University of Pittsburgh. They were both attending Studia Academica Slovaca, the Slovak language summer school at Comenius University. Thus we found them in the cafeteria at the Philosophical School, across the street from the main campus administration building.

We walked briefly around town with them, and visited a store together. They filled us in on some hints about how to get around and what to see in Bratislava. Then we said our goodbyes, as they had to go back to classes. We set out touring the town and enjoyed some zmrzlina (ice cream), one of my favorite treats. It cost only 4 crowns for the two of us, but we noticed that it was more watery than our ice cream and melted very quickly.

While in the center of Bratislava, we explored the town and passed numerous dilapidated buildings. Many were Renaissance and Baroque structures that were crumbling apart. The old town hall (radnica) which houses the city history museum was quite beautiful and better maintained, as was the adjacent Archbishop's Palace. But we decided to visit them on our next day's schedule. Instead we sauntered through the city, past the old Slovak National Theater and passed through Hviezdoslav Square, named after the early 20th century famous Slovak poet. By 3:30 pm, we had walked to the SNP Bridge (Most Slovenského národného povstania, the Bridge of the Slovak National Uprising of 1944), which spans the Danube River. People called it Nový Most ("New Bridge"), and in 1993, the city council changed its name to what people always had called it. It is the world's longest bridge to have just one pylon and one cable-stayed plane. It features a UFO-like tower restaurant that resembles a flying saucer on top of the bridge. At the time we did not know it, but apparently the communists had gutted the old Jewish quarter and its synagogue to build this bridge and the road leading to it.

We did not cross the bridge, but took some photos of the Bratislava Castle on the hill, and decided to leave the climb to visit the castle for the next day. We walked back into town, bought a few more groceries (15.5 crowns) for the evening. As my wife was not feeling well and was getting upset, we decided to go back to Čedok to find out where we might stay that night.

As graduate students getting by on a very tight budget, we were looking for inexpensive accommodation such as at a Youth Hostel. The Tourist Office recommended a student dormitory, as they were economical and rented out rooms in the summer. After buying some postcards and stamps to write home (50 crowns), we went to catch a tram

to the dorm. Nobody was answering at the dorm and we wound up waiting 45 minutes for someone to arrive! So we ate a quick meal in the park while we were waiting.

When someone finally showed up at the dormitory, we said we wanted to see the room first. It was quite inexpensive, but we always wanted to see where we would stay before paying. The room with bunks that the young man showed us was unlike anything we had ever seen. The place was absolutely filthy and there were no sheets on the beds. Mattresses were piled on the side, and in the halls. When I patted one to feel it, dust flew up, and the springs were so bad they seemed 30 years old. This stunned us, for even though we had stayed in some less than luxurious places in Europe, this was by far the dirtiest and most revolting accommodations we had seen. The place needed a complete overhaul and cleaning, and we worried about possible bedbugs. We had slept in a cleaner place on the streets of Brussels!

What really surprised us is that Slovaks would tolerate such filthy conditions. Both of us had come from Slovak-American homes that kept pristine households, and all our relatives lived similarly.

It was so dirty that there was no way we would stay there. We did tell the attendant that we had a small pup tent, and we asked

if there was somewhere that we could camp. He said to try Zlaté piesky (Golden Sands), a camp on the edge of Bratislava). It would prove to be a much better choice.

So we headed back to the rail station, picked up our knapsacks, and asked until we found a very packed tram with more standing room than seats. We stood out as foreigners. The tram took us to another stop, where we would catch a bus to take us to Zlaté Piesky, the campground at the edge of the city. The ride took nearly an hour with all the stops, and we passed by row after row of drab, gray high rises (paneláky or cinžáky), which the communists had built to satisfy the high demand for housing in the industrial city. We could see workers with shabby clothing going home from their jobs, and the stench of the city and crowded bus made the journey quite uncomfortable.

When we finally arrived at the campground, we were pleasantly surprised. There were fairly nice sites to set up our tent, and it was not as crowded as some of the other many European campgrounds we had stayed at. Camping was very inexpensive, just 12 crowns, and the place was much nicer and cleaner than that filthy dormitory. We set up our tent and settled down for a good night's rest, and retired by 10:30 pm.

Commemorating the Velvet Revolution's 30th Anniversary

This past November marked the 30th Anniversary of the fall of the Berlin Wall and the subsequent events that brought freedom from communist domination to many countries of the former "Soviet-bloc." In Czechoslovakia, public demonstrations, spearheaded by student movements, sparked the relatively peaceful downfall of the communist government and began the country's "return to the West," in what came to be known as the Velvet Revolution. A number of events took place in Washington D.C. in the fall to commemorate and assess the significance of the Velvet Revolution.

Since 2001, Friends of Slovakia (FOS) has co-sponsored the prestigious Annual Czech and Slovak Freedom Lecture at the Woodrow Wilson International Center for Scholars in Washington, D.C. Each year, the Lecture alternates between a Czech and a Slovak speaker chosen by the cosponsors, the Czech Embassy, the Slovak Embassy, the American Friends of the Czech Republic (AFoCR), FOS, and the Wilson Center's Global Europe Program. This year's Freedom Lecture on November 13 commemorated the Velvet Revolution with a special double-lecture event featuring both a Czech and a Slovak lecturer. The Czech speaker was Šimon Pánek a key leader in the 1989 student movement, who subsequently went on to found an important NGO, People in Need. The Slovak speaker was Katarína Cséfalvayová, the Chairwoman of Foreign Relations Committee of the Slovak National Council (parliament).

Ms. Cséfalvayová, who was a young child in 1989, provided a perspective as an important legislator who is in a position to look back and assess the legacy of the Velvet Revolution in the context of current challenges to democracy in Slovakia and Central and East Europe generally. Mr. Pánek then provided a first-hand perspective as a key leader in the overthrow of the communist regime in Czechoslovakia. He discussed the historical events of the period and assessed the accomplishments of the Velvet Revolution and challenges democracies have subsequently faced.

The speakers were introduced with remarks by Slovak Ambassador to the U.S., Ivan Korčok, and Czech Ambassador to the U.S., Hynek Kmoníček. After the Lecture, AFoCR President Tom Dine presented the speakers with certificates of appreciation and FOS Chairman Scott Thayer presented the speakers with the FOS Medal commemorating Milan Rastislav Štefánik and the friendship of the Czech and Slovak nations.

Those interested in a contemporary perspective on Slovakia and events in Central and Eastern Europe would do well to view Ms. Cséfalvayová's lecture. The Wilson Center has posted a video of the full lecture event at:

saw additional events in Washington commemorating the legacy of the Velvet Revolution. Members of the Friends of Slovakia Board of Directors attended and participated in these events.

Forum at Georgetown University

On Tuesday, November 12, a forum was held at Georgetown University, Velvet @ 30: A Legacy to Uphold. The forum was cosponsored by the Czech and Slovak Embassies in collaboration with the Georgetown University's Walsh School of Foreign Service. The event featured welcoming remarks by Joel Hellman, Dean of the Walsh School, as well as Slovak Ambassador Korčok and Czech Ambassador Kmoníček. Then, a discussion was held between former U.S. Secretary of State Madeline Albright and

former Ambassador of the Czech Republic to the U.S., Martin Palouš. They discussed their experiences of the events of 1989 and provided perspective on the significance of the events.

The first panel then discussed "How the Velvet Revolution Changed Our World." Simon Pánek, student leader during the Velvet Revolution, Martin Bútora former Slovak Ambassador to the U.S., and co-founder of the Slovak-based civic movement Public Against Violence, and Angela Stent, Georgetown Professor of Government and Foreign Service, discussed the 1989 period and its implications. Gregory Feifer, Executive Director of the Institute of Current World Affairs in Washington moderated the discussion. The second panel, "Fight for Freedom Never Ends: Velvet Revolution's Legacy for Today and Tomorrow," sought to view current events in light of lessons learned and point a way forward given contemporary challenges to freedom and democracy in Central and Eastern Europe and elsewhere. The panel featured Katarina Cséfalvayová, Chairwoman of the Slovak Parliament's Foreign Affairs Committee, Václav Bartuška, a former Velvet Revolution student leader and current Czech Ambassador for Energy Security and Jamie Fly, President of Radio Free Europe/Radio Liberty. The panel was moderated by František Šebej, former Chairman of the Slovak Parliament Foreign Relations Committee.

Dr. Bútorová presented results from her recent survey research on attitudes of the Slovak and Czech populations about the Velvet Revolution and related issues. The research was conducted under the auspices of the Bratislava-based Institute for Public Affairs (IVO) a think-tank founded by the Bútoras and others. The survey results were part of a study produced by IVO, 30 years after the Velvet Revolution: Profits and Losses in the Eyes of the Public, which is available on the IVO website at:

Panel Exhibit at GWU

The event was held at the Elliott School in downtown Washington. The exhibit displayed a series of panels depicting the events of the Velvet Revolution with a special focus on events in Slovakia. It is hoped that students at the Elliott School as well as the GWU student community and the general public will learn about the events of 1989 in Czechoslovakia and their significance. Slovak Foreign Minister Miroslav Lajčák opened the exhibit and was joined by the Slovak Ambassador Korčok, Acting Assistant Secretary of State, Ambassador Phillip Reeker, along with representatives of the Elliott School and Slovakia's National Memory Institute in providing remarks about the events of 1989.

It's fair to say that the attendees of these events gained a greater understanding of the events of 30 years ago. They also came away with a deeper perspective on the importance of maintaining and renewing the legacy of freedom and democracy in Slovakia and Central and Eastern Europe generally.


