
Whatever can be said about "Virtual" meetings, face to face meetings and get-togethers have a lot of value.

As you probably know, our Society has grown in assets in the past 14 1/2 years from \$197,310,824 as of 12/31/2006 to \$497,280,026 as of 9/30/2021, an increase of \$299,969,202 million dollars or over

In those 14 ½ years surplus has grown from \$11,555,544 as of 12/31/2006 to \$43,201,889 million dollars as of 9/30/2021, or an increase of \$31,646,295 or over



# Message from the National Chaplain

Ninety-year-old actor William Shatner, along with 3 others, went on a 10 minute ride in a rocket last month that took them a little over 66 miles above the earth. The travelers experienced about 3 minutes of weightlessness and got to see the curvature of the earth.

In the news conference that followed the flight, Mr. Shatner spoke on how the flight affected him personally. The mere thrill and excitement of it all caused him to say, "I hope I never recover from this. I hope I can maintain what I feel now. I don't want to lose it."

But he followed this up with this sobering comment. "To see the blue color [of the earth's atmosphere] whip by, and now you're staring into blackness, that's the thing. The covering of blue, this sheath, this blanket, this comforter of blue that we



and you're looking into blackness, into black ugliness."

Mr. Shatner's observation is revealing. It tells us how much God cares for and loves

us. The earth's atmosphere, the blue sky, is a very thin layer that separates us from the blackness of outer space. This "comforter of blue" is what provides us with the air we need to breathe, protects us from nearly 70% of solar radiation reaching the surface of the earth, and prevents the vast majority of meteoroids from striking what Pope Francis calls "our common home."

"In the beginning when God created the heavens and the earth" (Genesis 1:1), he also created the earth's atmosphere. We can never cease expressing our gratitude for this manifestation of God's protective love for us and all humanity.

# FCSU's Andrew R. Harcar Posthumously Honored by IFA

Organized in 1898, the Indiana Fraternal Alliance (IFA) is the oldest state fraternal alliance in the US. The IFA is comprised of 22 fraternal benefit societies licensed to do business in the state – including the First Catholic Slovak Union. The alliance was created to unite fraternal society members in the promotion of fraternalism.

Andrew R. Harcar, Sr., the late National Vice President of the First Catholic Slovak Union, was a longtime member of the IFA. He served as a past president of the organization, and was its director at the time of his passing this year.

On October 17, 2021, Andy was posthumously recognized by the IFA at a ceremony attended by Andy's daughter and son-in-law, Theresa and Tim Graves. Not only did the IFA name Andy their Fraternalist of the Year for 2021; but the alliance also is permanently changing the name of its prestigious award to honor him. The IFA Fraternalist of the Year Award, established in 2008, will hereafter be known as the Andrew R. Harcar, Sr. Fraternalist of the Year Award.


# Veterans Day Is in November: A Great Time to Remember our Jednota Memorial

## **History of Veterans Day**

World War I – known at the time as "The Great War" – officially ended when the Treaty of Versailles was signed on June 28, 1919, in the Palace of Versailles outside the town of Versailles, France. However, fighting ceased seven months earlier when an armistice, or temporary cessation of hostilities, between the Allied nations and Germany went into effect on the eleventh hour of the eleventh day of the eleventh month. For that reason, November 11, 1918, is generally regarded as the end of "the war to end all wars."

In November 1919, President Wilson proclaimed November 11 as the first commemoration of Armistice Day with the following words: "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations..."

An Act approved May 13, 1938, made the 11th of November in each year a legal holiday—a day to be dedicated to the



cause of world peace and to be thereafter celebrated and known as "Armistice Day." Armistice Day was primarily a day set aside to honor veterans of World War I, but in 1954, after World War II had required the greatest mobilization of soldiers, sailors, Marines and airmen in the Nation's history; after American forces had fought aggression in Korea, the 83rd Congress, at the urging of the veterans service organizations, amended the Act of 1938 by striking out the word "Armistice" and inserting in its place the word "Veterans." With the approval of this legislation (Public Law 380) on June 1, 1954, November 11th became a day to honor American veterans of all wars.

Veterans Day continues to be observed on November 11, regardless of what day of the week on which it falls. The restoration of the observance of Veterans Day to November 11 not only preserves the historical significance of the date, but helps focus attention on the important purpose of Veterans Day: A celebration to honor America's veterans for their patriotism, love of country, and willingness to serve and sacrifice for the common good.

Our Sisters who emigrated from central Europe have contributed mightily not only by their spiritual presence but also by the works they have performed in convents, parishes, schools, hospitals, homes for the elderly and by their very presence which has brought joy and comfort to all with whom they came into contact.

Mary Palek, our Sister Lidwina, was a smiling, friendly, enthusiastic person, always ready to lend a listening ear or to share a word of encouragement, or even a funny joke.

Mary was born in Humena, Slovakia, and at 9 months immigrated to the U. S. with her family and settled in Shenandoah, PA, where she belonged to St. Stephen's parish. She joined the SSCM's from Shenandoah, but she had originally applied to and was accepted by the Missionary Servants of the Sacred Heart in Reading, PA. Having learned to play the organ at an early age, she enjoyed being the organist at St. Stephen's. Before she left her post for the last time, she

carefully prepared the organist who would succeed her.

Her father's niece, Sister Philomena Yakubov, SSCM, serving as local superior in Mount Carmel, asked the pastor to sell FIALKY in the parish. Mary accompanied her. We have no record of how many copies of the Fialky, an Academy publication, were sold, but we do know that Sister Philomena had cultivated another violet that bloomed among the SSCM's for many years to come.

Because Sister Lidwina's dad was very fond of his niece, Sister Philomena, who was rec-

ognized as a kind, thoughtful, outgoing person, he recommended that his daughter follow in her footsteps. "If you want to be a Sister, go to the same community that Sister Philomena is in." At the age of 23, Mary did enter the Cyrilites. To prepare herself for her life's work Sister earned a B. A. from Marywood and studied at Villanova University and Scranton University. She specialized in music studies at the Academy of Music in Philadelphia and St. John's, Collegeville, MN.

As has already been noted, seeing a job through to the end was one of her outstanding characteristics. Besides being a gifted organist, she also played the piano, the violin and the accordion, and she enjoyed teaching others these instruments. For example, when she was missioned to Philadelphia, she served as parish sacristan and gave music lessons. In the early 1940's, she gave lessons at the Villa. Her happiness in religious life resulted from being very close to God and music. For all of her 50 active years, Sister gave piano lessons.

Sister Lidwina was able to celebrate her Golden Jubilee in Shenandoah on August 13, 1978. The Mass of Thanksgiving was celebrated at St. Stephen's Church by the Reverend Charles Sperlak, the Reverend Raymond Orloski and the Reverend Jerome Urbanski.

Sister Lidwina taught in eight different parish elementary schools, grades 2 to 7. Her last four years of teaching third and fourth grades in Lebanon, PA, were the end of her 53 years of active ministry as well as the withdrawal of the Sisters of Saints Cyril and Methodius from the parish school.

In 1981, Sister Lidwina took up residence at the Motherhouse where for four years she was engaged in general duties, especially in the dietary department. Her great joy was baking cookies. The Sisters referred to her as "the Cookie Monster" which brought a smile to her lips.

In 1986 Sister Lidwina was assigned to Maria Hall where she lent a hand wherever needed. All her days as a religious were a splendid example of a deeply spiritual life. It is not

# Slovensko je pripravené na zimnú sezónu, má dostatočné zásoby plynu

Bratislava 25. októbra (TASR) – Záťažový test nariadený ministerstvom hospodárstva ukázal, že Slovensko má dostatočné zásoby plynu na túto zimnú sezónu, informovali TASR z tlačového odboru ministerstva.

"Záťažový test, do ktorého sa zapojili všetci dodávatelia, dopadol dobre. Na zimu sme pripravení, zásoby sú dostatočné," zdôraznil podpredseda vlády a minister hospodárstva Richard Sulík (SaS).

V záťažovom teste boli hodnotené dodávky plynu za obdobie od 1. novembra do 31. marca. Test bude počas vykurovacej sezóny aktualizovaný s ohľadom na vývoj počasia. Ak je zima teplotne priemerná, tak plynu je na Slovensku dosť a krajina má rezervu už teraz, tvrdí ministerstvo. Slovensko by v prípade priemernej zimy spotrebovalo 3,2 miliardy metrov kubických plynu.

Ak by bola nadpriemerná zima, spotreba plynu na Slovensku počas vykurovacej sezóny sa odhaduje na 3,5 miliardy metrov kubických.

# Slovakia Ready for Winter Season, Has Sufficient Gas Supplies

Bratislava, October 25 (TASR) – A stress test ordered by the Economy Ministry showed that Slovakia has sufficient gas supplies for this winter season, TASR has learnt from the ministry's press department.

"The stress test, joined by all suppliers, turned out well. We are ready for the winter, supplies are sufficient," stressed Vice-premier and Economy Minister Richard Sulik (Freedom and Solidarity/SaS).

Gas supplies for the period between November 1 and March 31 were assessed in the stress test. The test will be updated during the heating season with regard to the weather developments. If the winter is average in terms of temperature, then there is enough gas in Slovakia and the country has a reserve already now, claims the ministry. Slovakia would consume 3.2 billion cubic meters of gas if there was an average winter.

If there was a colder-than-average winter, Slovakia's gas consumption during the heating season is estimated at 3.5 billion cubic meters.

# Reforma národných parkov odložená do apríla budúceho roka

Bratislava 25. októbra (TAŚR) – K prevodu štátnych pozemkov v prvých dvoch národných parkoch za účelom dokončenia reorganizácie zón na ich území dôjde až 1. apríla 2022, informoval o tom v pondelok Minister životného prostredia Ján Budaj (OĽaNO) a Minister pôdohospodárstva SR Samuel Vlčan (nominant OĽaNO) pred podpisom memoranda o vzájomných vzťahoch.

Reforma národných parkov sa mala pôvodne začať v januári budúceho roka.

Do 1. apríla budúceho roka by mali štátne pozemky v Národnom parku Slovenský raj a Pieniny prejsť pod Štátnu ochranu prírody (SOP). V ostatných národných parkoch by sa presuny mali týkať len území s najprísnejším štvrtým a piatym stupňom ochrany. Medzitým sa začne reorganizácia zón v rámci zostávajúcich siedmich národných parkov. "Verím, že reorganizácia zón bude ukončená do konca budúceho roka, kedy by mal byť tento proces ukončený a čo sa týka majetku štátu v národných parkoch, malo by to prejsť na SOP, resp. Ministerstvo životného prostredia "povedal Budaj.

Minister je presvedčený, že memorandum pomôže aj k schváleniu reformy národných parkov. "Domnievam sa, že všetky výhrady, ktoré mal predseda parlamentu Boris Kollár (Sme rodina), sme prebrali a [odpovede na ne] sú zapracované aj v memorande," uviedol Budaj.

Obe ministerstvá sa v memorande dohodli aj na polkilometrovom pásme medzi bezzásahovými územiami a hospodárskymi lesmi. "Som rád, že sme sa na tom zhodli. Do 30. júna 2022 by nám malo ministerstvo životného prostredia predložiť návrh na reorganizáciu zón ostatných národných parkov. Musíme dosiahnuť celospoločenskú dohodu o tom, akú výmeru územia chceme a môžeme si dovoliť pre národné parky. Verím, že sa férovo dohodneme," povedal Vlčan.

O návrhu reformy, ako aj o novele zákona o národných parkoch by sa malo hlasovať na aktuálnej schôdzi parlamentu.

# National Parks Reform Postponed until April of Next Year

Bratislava, October 25 (TASR) – The transfer of state land in the first two national parks to see a reorganisation of the zones within their territory completed will not take place until April 1, 2022, Environment Minister Jan Budaj (OLaNO) and Agriculture and Rural Development Minister Samuel Vlcan (an OLaNO nominee) reported on Monday prior to the signing of a memorandum on mutual relations.

The reform of national parks was originally supposed to begin in January of next year.

By April 1 next year, state land in the Slovak Paradise and Pieniny National Parks should be transferred to State Nature Protection (SOP). In other national parks, the transfers should only cover areas with the strictest fourth and fifth levels of protection. Meanwhile, the reorganization of zones within the remaining seven national parks will begin. "I believe that the reorganization of the zones will be finished by the end of next year, when this process should be completed, and as far as state property in national parks is concerned, it should be transferred to SOP, or the Environment Ministry," said Budaj.

The minister is convinced that the memorandum will also help to ensure that the reform of national parks will be approved. "I believe that we've covered all the objections that Parliamentary Chair Boris Kollar (We Are Family) had and [responses to them] are also incorporated in the memorandum," stated Budaj.

The two ministries also agreed in the memorandum on a half-kilometre zone between non-intervention areas and commercial forests. "I'm pleased that we've agreed on this. By June 30, 2022, the Environment Ministry should submit to us a proposal for reorganizing the zones of other national parks. We must reach society-wide agreement on what area of territory we want and can afford to national parks. I believe that we'll reach a fair agreement," said Vlcan.

The reform proposal as well as an amendment to the law on national parks should be voted on at the current parliamentary session.

The race was won by American Mikaela Shiffrin, who finished 0.14 seconds ahead of Switzerland's Lara Gut-Behrami and 1.30 seconds ahead of Vlhova.

The Slovak skier thus notched her 45th World Cup podium appearance in her career.

# The Impact of My Mother's Homeland: My Mother's Family (part 3)

Part 2 ended with my parents marriage in 1942, and World War II would separate them until the conflict ceased.

It was typical for many second generation Slovaks to marry other Slovaks, or at least other Slavs or Hungarians who were of the same faith. Since my paternal family also came from Spiš County, my father spoke a dialect similar to my mother and he could easily communicate with his new in-laws. Having a man in the family would be an asset to his immigrant in-laws who had three girls.

But my father's family opposed the marriage and wanted him to wait until he returned from the war to marry, for they would not receive my father's army pay or an insurance payment if he was killed in action. This attitude typified the attitude of many immigrants, who viewed even their children as contributors to the family income. Instead of going to my father's parents, his pay went to my mother, who wisely saved as much as she could. Like many other women in the war, she took a factory job as a welder of airplane parts at General Fireproofing, in Youngstown, Ohio, where my father had been employed.

After basic training, my father shipped out with the 39th Combat Engineers to Northern Africa and fought in a desert war with General Patton's army against the forces of German General Rommel. His army job involved transporting British soldiers in a truck, since he had experience driving a garbage truck before the war. He also participated in the invasion of Sicily and Italy proper at the invasion of Anzio in 1944. After getting bogged down, his unit would advance to Rome, and then end the war in Udine in northeastern Italy. His unit mainly built bridges to facilitate the movement of Allied troops. The war further ensconced second generation Slovaks in American culture, and also exposed the second generation of immigrant family young men to the wider world, for many had never ventured far beyond their local neighborhoods, unless they were in the Civil Conservation Corps or the military service.

While at war, my father retained a deep love for my mother and wrote to her every day. (Service men could write home at no cost, though letters were censored for security reasons.) In order to read my father's letters, my mother attended night school to understand better the English language.

My father's love for her continued to gel while he fought overseas. He used to sing songs about her and one of his favorite Slovak songs about her that he sang overseas was "Naša Anička". He also created his own lyrics to the tune of a song of a German exile who had fled Hitler's Germany, Marlene Dietrich; her renowned "Lili Marleen" was popular among American troops. In place of the German lyrics, he substituted words about how he was fighting over in Italy, and ending with the chorus line, "I love you Annie dear," One may hear the original German here: https://www.youtube.com/watch?v=7heX-ZPl2hik

Luckily, my father survived the war, but did suffer a back injury when his truck was

hit by German shelling. When my father returned to the USA in October 1945, he regained his former job at General Fireproofing and my mother worked cleaning house for people. They lived with my father's Slovak parents at first, but that did not work out well because of the inevitable clash of two women in the same kitchen. Thus they decided to live on their own, but they still did not have enough money to buy their own home, and there were housing shortages after the war. For a while they stayed at the home of a Jewish family closer to where he worked, where my mother served as a domestic servant and my father was a parttime chauffer. They eventually bought a trailer, and then in 1948, a house in Liberty Township just north of Youngstown. Like many Slovak-Americans who were skillful and handy, my father learned carpentry by watching others. He then started his own business on the side, building garages, which many people needed after the war. He also built a new house on Bella Vista Avenue for his in-laws. And he later built a big double garage with a huge attic for us at our own home. A short time later, he put in a cement driveway.

My parents had four children, three boys and a girl, and I was the third. At home, we spoke English, even though my mother had an accent when I was younger, and always had trouble pronouncing the article "the." We heard Slovak though, yet my parents only spoke it to each other when they did not want us children to know what they were talking about. We visited baba and dzedo on most every Sunday, and the

families of my Aunt Mary and Aunt Helen would also come. All the adults spoke Slovak, and the children of the extended family did not know the language. But my oldest cousin Rosemary learned more than any of us cousins, mainly because her family lived just a few blocks from baba and could go there more frequently.

Baba used to call me "malý Michal" and I used to think it was spelled like the name "Molly." My mother and baba used to talk on the phone with each other every day in their Spiš dialect, so my ear certainly caught something. My mother also had a very good voice, though it was never trained, and I think my daughter inherited her talent. Just once in a while, my mother would sing a Slovak Marian hymn, which was so beautiful that I recorded it after cassette tapes came on the market. On holidays, we heard Slovak music on the phonograph, so I became familiar with some Slovak tunes. And I remember my dzedo was so happy when he used to sing Ja parobek z Kapušan (I'm a young man from Kapušany), one of the most popular Slovak-American songs. He and my father also loved to sing Hej Slováci (Hey Slovaks), which was the patriotic national song of Slovak-Americans.

I never learned to speak Slovak from my parents, but was always curious about the language. My mother did teach us to make the Sign of the Cross in Slovak, when we prayed before meals and when we prayed the rosary every day. And we heard a few basic words. When I was little, I did spend a week at baba's house during several

summers. She would communicate with me mainly through hand gestures. Dzedo knew a little more English from working at the mill. They had no car like many Slovak immigrants, and they walked to church every day and to the store. Baba attended 6 am Mass daily at Holy Name of Jesus Slovak Catholic Church on Manhattan Street, in the heart of the Steelton community on the lower east side of Youngstown. On special occasions, we attended Slovak Mass there. Baba and a corps of other babas would sit on the left hand side of the church in the front and recite the rosary before each Mass.

I remember going to the store with baba. She would say "Idzeme do štoru" in her Spiš dialect Americanization of the Slovak word obchod into štor. We went to the bakery and to Roscoe's poultry shop, which smelled awful. That is because it had fresh chickens, so the soup baba made was always tastier and fresh. And it seemed like I was always eating chicken soup there (kurová polievka)! She made her own noodles and could roll dough and cut noodles faster than anyone I have ever known. She would spread the noodles all over her kitchen table to dry during the day.

In the summer, my grandparents always had plenty of fresh vegetables and fruits, for they cultivated a huge garden, as big as the yards of many people. Dzedo took care of and sprayed his many fruit trees - plum, apple, peach, cherry, pear, etc. He raised bees for home-made honey, and produced his own brandy from peaches, which was sweet and powerful. My grandparents only ate what we viewed at the time as regular food, which was not called organic at the time. Baba scrimped and saved so they could make ends meet. She canned for the winter months, and my mother did the same. Baba even used to buy day-old bread to save money, for she had become accustomed to living in poverty during her years in Europe. Even on holidays, she scaled back compared to the typical Slovak Christmas and Easter custom foods we learn about today.

Baba always had a strange smell. When I was young, I never knew why, but after learning more about Slovak culture, I figured it out. In her later years, baba suffered from chronic arthritis, and she did not go to doctors. In fact, my mother used to say she was just like a doctor and knew all sorts of folk remedies and cures from the old country. The smell obviously came from the homemade remedies which she concocted from the spices which she grew in her garden.

As I grew older as a boy, I would help baba fetch things, and I cut the grass for my grandparents. My brother Jim and I also helped paint their home exterior as well as the house of the Slovak family of Mr. and Mrs. Mitsa across the street. My father had taught us boys to be handy, and we learned how to paint and do roofing when we were as young as 10 years old.

Dzedo was rather gruff and grumpy, and very bossy, but we did share a love for baseball. The problem was that he was a Cleveland Indians fan, and I rooted for the New York Yankees. He always had the television on with the Indians game when we visited on Sunday afternoons, and I







surprising that she believed wholeheartedly in the saying, "Happiness is having Jesus in the chapel. I feel secure in His presence."

When Sister Lidwina died at Maria Hall at age 91, St. Stephen's pastor at the time, the Reverend Victor Anselmi, was celebrant and homilist. The concelebrants were the Reverend Edward Deller, Maria Hall chaplain, and the Reverend Augustin Zan, chaplain at Maria Joseph Manor. In his homily Father Anselmi extolled Sister's life. "Although Sister left Shenandoah more than 65 years ago," he said, "her spirit of sacrifice and dedication as a religious is a source of blessings for St. Stephen's, her home parish. Eucharist was the one steady center of her life amid changes of residence and ministry." Father then elaborated on the theme of the Eucharist as a foretaste of the heavenly kingdom. Indeed the funeral liturgy was a fitting tribute to a dedicated parish organist.

# Reflections for Thanksgiving

Katie got done quickly and scanned all her items in the self-checkout lane only to discover that her debit card was registering as "Not Authorized." A store employee came to help, but with a restless two-year-old and a growing line of people behind her, Katie felt more than a little "frazzled." Then, she got some unexpected good news.

The lady who had been checking out next to Katie and witnessed her struggles had paid for all her groceries but slipped out to remain anonymous. On the Today Show's Community blog, Katie wrote, "I burst into tears, incredibly touched by the generous stranger's act of kindness."

Before you sit around the Thanksgiving table this year, take account of the simple kindnesses and blessings for which you are grateful. And if you need a prayer to say before your meal, here is one that I composed: "Gracious Lord, as many of us in this country gather around the table with our loved ones on this special day, we praise and thank You for the blessings in our lives. # Reflections on Remembrance Day 2021

Ever since my family emigrated to Canada in 1951, and I started to attend school in grade two, our classes always held Remembrance Day commemorations on November 11th, primarily for Canadian soldiers who were killed during the Great War of 1914-1918. While I always gladly participated in these commemorations, I wondered why Slovaks in the Old Country did not do likewise. Certain villages or cities in Slovakia did have monuments to the fallen, including my father's village of Turzovka (now a city), which lost 500 killed in action out of a population of 8,425 in 1910 (6% of the population). Not until I did some research a few years ago did I discover the great disparity in casualties suffered by the Slovak population during World War I and that of Canada during that same conflict.

If we compare some statistics concerning the Canadian contribution of soldiers to the Great War versus that of Slovakia, we will discover a huge difference between them. Canada sent 470,000 men overseas and suffered 60,000 fatalities (12.8%). Slovakia contributed 400,000 soldiers to the Austro-Hungarian war machine and suffered 69,000 fatalities (17.2%). Furthermore, if we compare the population of Canada at that time (8,000,000) with that of Slovakia (2,000,000), we will detect an even greater disparity between them: Canada lost 0.75% of its adult male population whereas Slovakia lost 3.45% of its adult male population. In reflecting upon these numbers, I suspect that Slovakia does not commemorate Remembrance Day very much for two reasons: As a part of the Austro-Hungarian Empire, Slovakia was on the wrong side of the war and, more importantly, its loss of lives was enormously more than that of Canada. Perhaps the memory of the Great War was (is) much more painful for Slovaks than for Canadians. Perhaps the Slovaks would rather forget World Wear I, rather than commemorate it.

# Thanksgiving — A Catholic holiday?

British writer and Catholic philosopher G.K. Chesterton is quoted as saying: "The worst moment for an atheist is when he is really thankful and has no one to thank." Today, football games and dining room tables filled with food tend to overshadow the real meaning of Thanksgiving for American citizens, even Catholic ones.

Thanksgiving has been on the liturgical calendar for the United States as an optional memorial since 1970. Father Robert Garrow, pastor of St. Stanislaus Kostka in New Carlisle, IN, appreciates the reminder to be appreciative of what God has given.

"Of course, we have the Mass, which is thanksgiving. We give thanks to God for everything in our lives," Father Garrow stated. He stressed that giving thanks to God for His boundless blessings should be a frequent occurrence, "but it's an important reminder for us of a greater thanksgiving that we should do every day."

Scripture is filled with words of praise and thanksgiving to God for all He has done for His people. Even the readings for Thanksgiving Day Mass reflect this theme of showing gratitude to God, particularly the Gospel story of the 10 lepers whom Jesus cured of their disease, and the one Samaritan who returned to thank Him. So, though it may not be a liturgical feast, the Church has certainly embraced the holiday as a natural part of the faith life.

While most Americans know the history of Thanksgiving, there are some historians who claim that the first Thanksgiving was actually a Catholic celebration. More than 50 years before the Mayflower, a group of Spanish colonists celebrated Mass and had a feast with native Timucuans in what would become the oldest settlement in the U.S. — St. Augustine, Florida. Michael Gannon, former professor at the University of Florida, wrote about the event in his 1965 book "The Cross in the Sand."

Another story tells of a different group of Spaniards lead by Don Juan de Oñate, who in 1598 traversed the dangerous Chihuahuan Desert that spans northern Mexico and southern Texas, seeking to colonize the American southwest. After safely reaching the Rio Grande, Franciscan missionaries said Mass for the colonists, and a great feast with the natives followed.

The Spaniards eventually settled at Santa Fe. The Texas Almanac notes that various historians point to this event and the new settlement as milestones of Spanish influence in America – "one of hundreds of towns the Spanish had already established in the New World" prior to the arrival of the Puritans at Plymouth.

Even if these potential "first Thanksgivings" are not celebrated as such, the traditionally held event did have a Catholic attendee — Squanto, the Native American who taught the Puritan settlers survival techniques in their new land. Years prior, he had been captured by the English and freed by Franciscans who educated and catechized him. It is not known with complete certainty that he converted to Catholicism, but it is highly likely, as his Christianity is documented.

No matter where or when the first Thanksgiving took place, there is no doubt that it was a means of giving thanks to God for His boundless gifts. Catholic families have many ways to bring a sense of the sacred to the day and praise God for His goodness.

If you or someone with whom you are close has suffered from depression, you might know how isolating it can be. Depression is a mental illness that touches every part of one's life: family, work, friendships, hobbies. It can feel dark and alone. Sometimes those with depression withdraw so as not to burden others with

their darkness. At other times, they are isolated by the stigmas that surround depression. Some friends may tell them, "Just get over it," while others avoid them altogether. Jesus, however, shows us how to meet people in their suffering. He meets the blind man Bartimaeus, the woman at the well, lepers, and paralytics. They have been pushed to the margins of society, and Jesus meets them there. He gets close to them, connects with them and offers restoration. So, how can we follow Jesus' example as we encounter those suffering from depression and burnout in our world today? How do we extend an opportunity for healing and restoration? We draw close, we connect, and we offer the Light of Christ. He is the Light that gives us hope always.

To those suffering from depression or burnout: there is hope. Depression is a treatable mental illnesses. Do not be afraid to take the risk of reaching out and seeking professional help. Do not be afraid to let others accompany you in your difficult journey. If you know someone who is suffering in this way, reach out; encourage them to see a counselor. And invite Jesus close. Ask for His healing and His Light. Take consolation in His words, "I am the Light of the world; he who follows Me will not walk in the darkness, but will have the Light of life." (John 8:12)

# The Impact of My Mother's Homeland: My Mother's Family (part 3)

came to dislike the Indians because their fans like dzedo used to pick on me for backing the Yanks. I did play catch with dzedo when I got a little older, and he claimed that he played baseball before for the Toledo baseball team, but I have never been able to verify that, and he was a bit of a braggart who told tall tales. I used to climb the hill at Borts Park and play ball if I had a chance, especially when I became old enough to get selected in a pickup game, particularly after I improved playing Little League baseball.

I developed a genuine affection for my grandparents over the years, but I knew they were different than some grandparents of kids I went to school with, for we lived in a non-ethnic community on the north side. I wanted to get to know them better, and I realized that not knowing the language was a barrier. That kernel of curiosity would later drive my interest in the Slovak language and Slovak history and culture.

On my paternal side of the family, I had less personal experience which I can remember. My paternal baba died when I was only two years old, so I do not remember her at all. My dzedo was a very kind man who I remember as very loving. After his wife's passing, he moved in with my Aunt Mary Malley on the East side of Youngstown. I recall how he used to sit me on his lap and rock me a little. He always would give me a penny, which was big money to me when I was four or five years old. I really looked forward to visiting him. Unfortunately, he died on March 20, 1961, when I was just six years old. I will never forget his funeral, an overcast and rainy day. It was the first funeral I remember when someone I loved died. And I cried in the rain at Calvary Cemetery, as I am crying now thinking about him. How I wish I could have known him better. And I never knew my Aunt Nellie, who died from breast cancer in 1947, and is buried next to him and my baba. Nellie's death had devastated my father, since she was his favorite sibling.

We did visit some of my father's other siblings, especially Aunt Helen Evans. Her husband Bill was handicapped with polio and died in 1965. She always fed us well and made superb kolače (nut rolls). We also visited with Uncle Anthony and his wife Velma, especially over the Christmas holidays. They had three children of similar age, and we enjoyed playing games with them, especially Twister. But there was very little talk about Slovakia or grandparents and their family had very much assimilated into American society. We rarely saw Uncle Paul Kopanic or Aunt Anna Dechant. Marriage to a non-Slovak appears often to facilitate the assimilation process. After my paternal dzedo died, we only saw the rest of my father's family sporadically, usually on the occasion of a wedding or funeral.

On my mother's side, my Aunt Mary married a Slovak, Aloysius (Al) Sobinovsky, who was born in Slovakia in Malý Hnilcík, Slovakia, and immigrated to America at age three. So he could not remember Slovakia, but my Aunt Mary had such dour memories of her hard times in her former homeland that she never wanted to return there, and never did. I do remember that Aunt Mary had a good sense of humor, made fantastic cookies, and her husband was a great cook. We were also close with his parents,

Louis and Maria Sobinovsky, who lived in the Slovak section of Lansingville on Youngstown's south side. We most always visited them at Christmas, and Baba Sobi, as we called her, was so kind to us children and also baked super koláče.

During my childhood, I gradually acquired a love for history and this would ultimately carry over into sparking my interest in learning more about Slovak history. Early on, I was fascinated with biographies of US Cavalry officers like Custer and Sheridan and devoured biographies of soldiers from the Old West. During my college years, my interest shifted from early American history to German history, as I minored in the German language, the tongue of my paternal grandfather. Then when Professor Martin Berger made some general statements about Czechs and Slovaks forming a country after an agreement in Pittsburgh, a new interest in Slovak history emerged. I wanted to learn about my own people.

I exhausted and read every book written in English about Slovaks in the Youngstown State University Library. But the one that struck me the most was the book Racial Problems in Hungary by Scotus Viator (the pen name of R.W. Seton-Watson). Inspired by the 1907 Černová massacre, he wrote the book to awaken the world to the attempts of Magyars to deny other nationalities the right to use their own languages in multi-national Hungary. The tragedy occurred when Hungarians refused to allow a Slovak priest, Andrej Hlinka, to consecrate the village church which had been built with the donations of American Slovaks and the parishioners' own money. To disperse a peaceful protest, Hungarian gendarmes shot and killed 15 unarmed Slovaks who had gathered to prevent a blessing by a pro-Magyar bishop. The quote in the book that stood apart and stirred me was the Hungarian saying in the Magyar tongue "Tót nem ember", meaning "a Slovak is not a man!" I had to learn more about my people.

Thus my love of history and the experience of hearing the language and some stories about the Old Country aroused my desire to know more about my family's history. I realized that knowing the language was the key to unlocking the past and getting to know better my own parents and ancestors. The quest unleashed a lifelong desire to pursue Slovak studies when I was in college, and it continued when I went on scholarships to study at the University of Notre Dame for my Master's degree, and then the University of Pittsburgh, where the Slovak language was taught.

I just started to learn a smattering of Slovak words and phrases when my baba died while I was studying at Notre Dame. I so much wanted to talk to her and understand. And she was so enthusiastic when she learned of my interest in her culture and tongue. When she told me her cane was called a kul'aga in Spiš dialect, and I pronounced it correctly, she beamed with pride. Although I could no longer speak with her, my interest in Slovak studies just magnified, and continues to this day; it is my driving passion. The learning never ends, and is a connection I have with my mother, father, ancestors and the land they lived in - Slovakia.
