January Message from the National Chaplain

Apostolic Letter issued Moto Proprio (on his own initiative) by Pope Francis instituting the Sunday of the Word of God

On September 30, 2019, the 1,599th anniversary of the death of Saint Jerome, Pope Francis issued an apostolic letter directing the Third Sunday in Ordinary Time to be celebrated as the Sunday of the Word of God. The Memorial of Saint Jerome was chosen as the day to publish the letter because Saint Jerome not only translated the original biblical texts from Hebrew and Greek into Latin, but he also is the source of many commentaries or explanations of several books of Scripture. This is a brief summary of the pope's letter.

Pope Francis cites three sources for what he is to announce. The first is Saint Jerome, who wrote in his Commentary on the

Book of Isaiah: "Ignorance of Scripture is ignorance of Christ." His second source is the Dogmatic Constitution on Divine Revelation (Dei verbum) from the Second Vatican Council, where, among other things, the importance of Scripture for the life of the Church is explained. The third is The Word of the Lord (Verbum Domini), Pope Benedict XVI's Apostolic Exhortation which emphasizes the use of Scripture in the liturgy.

Francis then writes "that the Third Sunday in Ordinary Time is to be devoted to the celebration, study and dissemination of the word of God." That particular Sunday is chosen because it occurs during the annual Week of Prayer for Christian Unity.

He encourages several practices to mark the occasion. Among them are the enthronement of the Sacred Text at Mass, a homily addressing the appropriate honor due to God's holy Word, and efforts to offer training for those reading the Scriptures at Mass to be "genuine proclaimers of the word."

Clergy are reminded that Sunday Mass is the only opportunity for many of the faithful to hear the Scriptures and have it applied in their lives. Therefore, homilies are to be well prepared and based on the Word of God. They are neither to be dull, long-winded, nor roam from topic to topic. The homilist who prays and reflects on the Scriptures can speak from the heart and thus reach the hearts of those who listen.

Francis notes the Holy Spirit was instrumental centuries ago when the sacred text was written and is effective today in those who hear God's word. The inspiration of the Holy Spirit continues today whenever the Scriptures are taught by the Church; when the Magisterium, or official teaching office of the church, interprets it; and whenever a believer makes it the norm of his or her spiritual life.

The Holy Father pinpoints two challenges Scripture offers. One is from Ezekiel, where the word of God is described as both sweet and bitter. Its bitterness comes from personal experiences of both the difficulties of our daily living of the Word and its rejection as meaningless for life. Its sweetness inspires us to share it with others and to announce its certain hope. The second is from the parable of Lazarus and the Rich Man from the Gospel of Luke. The person who listens to Sacred Scripture is to be led to practice mercy.

The letter concludes with the pope's desire for the Sunday of the Word of God to be a means by which people become more familiar with Scripture for their daily living.

FOS Celebrates 20th Anniversary with Dinner at Slovak Embassy

Current and former directors of Friends of Slovakia (FOS), along with spouses and special guests, celebrated FOS' 20th anniversary on November 17, 2021, with a dinner at the Slovak Embassy in Washington, D.C. hosted by Ambassador Radovan Javorčík.

Earlier in the day, Beata Balogová, editor-in-chief of the Slovak daily SME, delivered the 2021 Czech and Slovak Freedom Lecture via live stream from Bratislava. After learning that Ms. Balogová would not be able to deliver her lecture in Washington, Ambassador Javorčík generously offered to host an event that would not only commemorate the anniversary but would feature a policy discussion of issues raised in the Freedom Lecture. In his welcome toast the Ambassador noted that while the dinner was taking place on the 32nd anniversary of the Velvet Revolution, the work of democracy building continues in Slovakia and elsewhere in Central Europe. Each generation must work to protect and expand the precious gift of freedom,

Distinguished guests included senior representatives of the International Republican Institute, National Democratic Institute, Congressional staff members, the Department of State desk officer for the Czech Republic and Slovakia, plus local arts leaders, business executives, and philanthropists. FOS special guests included founding directors Joseph T. Senko and Ambassador Theodore Russell, plus Andrew M. Rajec, president of the First Catholic Slovak Union, and his wife Idka.

Martin Bútora, Slovak Ambassador to the United States from 1999 to 2003 (and a driving force for the creation of FOS), sent a letter of congratulations that was read at the dinner by FOS Director Thomas W. Skladony. "In calling to mind these many accomplishments of the past 20 years, I do not mean to suggest that your work is done," Ambassador Bútora wrote. "History moves on, so that even as some issues are resolved, new challenges arise... I am especially pleased to know that one of the signature projects of Friends of Slovakia today is your series of international student summits focusing on key

challenges to democracy, such as disinformation, freedom of the press, and upholding the rule of law."

In responding to Amb. Javorčík's welcoming toast, FOS Vice Chairman, Kenneth J. Bombara, congratulated Slovakia on its successes in becoming a key member of NATO, the European Union, and the Transaltlantic community, while establishing a strong bond with the United States. He emphasized that the strength of the bond between Slovakia and the U.S. is rooted in the support of the Slovak American community as well as those individuals, professionals and organizations that consider themselves to be "Friends of Slovakia."

Fergus Shiel, managing editor of the International Consortium of Investigative Journalists, was the keynote speaker. He described the critical work performed by investigative journalists worldwide and the serious threats such journalists face, calling special attention to the 2018 murders of Slovak investigative reporter Jan Kuciak and his fiancé Martina Kushiro.

Mr. Shiel praised the courageous response of Slovak journalists and civil society to these

shocking crimes, which eventually led to resignation of prime minister Robert Fico and the trial and conviction of those responsible for the deaths of Kuciak and Kušnírová. FOS Director David Frankel moderated the discussion and a lively Q&A session.

"Friends of Slovakia is extremely grateful to Ambassador Javorčík for hosting us on this very special occasion," said Vice Chairman Ken Bombara, "It truly was a pleasure collaborating with the Ambassador and his hard-working team, and FOS dinner committee members Tom Skladony and Martina Hrvolova, to organize this dinner and policy discussion, and we look forward to future collaboration in 2022 and beyond."



Learning to Trust in God

The 1943 film The Song of Bernadette opens with the quote, "For those who believe in God, no explanation is necessary. For those who do not believe in God, no explanation is possible." This line is derived from the teachings of Saint Thomas Aquinas, and it expresses such an important theme within the story that it is reiterated near the end of the film when the character of Abbe Dominique Peyramale, played by Charles Bickford, speaks these words to skeptics who cannot get beyond their doubts, despite the miraculous occurrences that have taken place in their humble town of Lourdes, France.

This struggle to believe in God and in his miraculous hand at work in the world around us is an enduring challenge that has been faced by people from all walks of life, and it is a challenge that even the saints have faced. In the Gospels, we see the Apostles themselves struggling with doubt, with perhaps the most famous story of doubt taking place when Thomas declares that he will not believe in the Resurrection until he sees Christ with his eyes and feels Him with his hands.

Christ's response to grant Thomas the proof he seeks demonstrates the reality of God's miraculous interventions in the world. This type of intervention is similar to what took place at Lourdes, where Saint Bernadette experienced visions of our Blessed Mother and then healing waters poured forth from a spring in the ground, where thousands of miracles have since taken place.

But we should also remember that, after dispelling Thomas' doubts, Christ said to him, "Have you believed because you have seen Me? Blessed are those who have not seen and yet have come to believe." This is the challenge that most of us are faced with for the majority of our lifetimes. Even those who encounter the miraculous at some point in their lives must return to everyday reality where they might struggle to maintain faith in God. But we might also see this challenge as a gift because Christ is giving us the opportunity to exercise

faith in the same way we might exercise our brains or the muscles in our bodies. And when we exercise faith, we cultivate endurance that will prepare us to be tested.

The Christophers recently produced a prayer card on faith that is a beautiful meditation on the mindset that leads us to trust more fully in the providence of God. This prayer helps us to realize that, in order to cultivate our faith, we must first open ourselves to God and to realizing how He guides us through life experiences. And by exercising faith, especially in the most difficult times, we inspire others to face their own challenges and to cultivate faith within themselves.

As we start into this new year of 2022, one great resolution is to recommit ourselves to cultivating the faith within ourselves, our families, and our communities. When we do this, we will find a greater ability to see God at work in our lives and in the world around us, and we will need less explanation for those things that are inexplicable. This leads to wisdom and an understanding of how to cooperate with grace, even when we can't predict the outcome. It is this way of being that will inspire others in our families and communities to let go of doubt and move closer to the joy of knowing and believing in God.



The FCSU Celebrates Advent & Christmas Season in Slovakia with December Webinar

In the early evening of December 6, 2021 - an auspicious day in of itself! – many members throughout our Society explored the traditions, customs, and foods of the Advent and Christmas seasons in Slovakia. The live webinar was hosted by two leaders of the not-for-profit Global Slovakia - its Founder Dr. Zuzana Palovic and its Co-Director Dr. Gabriela Bereghazyova – and sponsored by the First Catholic Slovak Union. FCSU National Officers participating in the webinar included: National President Andrew M. Rajec, Executive Secretary Kenneth A. Arendt, Region 1 Director Sabina Sabados, and Region 6 Director Thomas J. Ivanec. Over 100 attendees in all joined the event to learn about and share stories about Slovak Advent and Christmas Customs.

Topics covered: how St. Nicholas Day, the day on which the webinar was held this year, is a very special pre-Christmas celebration in Slovakia. St. Nicholas (Mikuláš, in Slovak), derives from the legend of Nicholas of Myra, a bishop in 4th century Greece. He was known for selling off his own items and giving the money to the poor. Slovak customs related to the day of St Nicholas have been evolving for centuries, all relating to beliefs established by this legend -those of prosperity and the role of Mikuláš as a protector of the most vulnerable. Today in Slovakia, children look forward to the morning of December 6th when they find sweets and fruits in the boots they carefully cleaned the evening before and then placed under the window.

The webinar also examined Advent in Slovakia, how it is a season filled with traditions, age-old practices, rituals, stories, and special foods. Also discussed was how far from the hustle and bustle of commercial Christmas, Advent in the heart of Europe really has been, and remains today – in Slovakia and in many homes





In addition to a lecture, the event featured tastings of Slovak spirits, including Slovak vodka and the first-ever Slovak whiskey, samplings of artisanal klobasy, home-made "slane tycinky" (salt sticks) and other appetizers, as well as old-fashioned, in-person socializing.

The event was hosted by Wesmont Liquors G4 in Wood-Ridge, NJ, a Slovak family-owned state-of-the-art liquor store. If you live in New Jersey, please consider this distinctive liquor store your new onestop shop for traditional spirits! This month Wesmont Liquors is launching delivery and shipping just in time for the holidays! In their large portfolio they also offer unique custom-made gift baskets for any occasion. The new store management is proud to present a variety of Slovak products to the Slovak-American community here in the US. At this unique store, customers can find a variety of Slovak products such as Goral Vodka Master, Familia Vodka Premium and the first Slovak Whiskey called Nestville. These products are produced in a historical town named Stara Lubovna located near the Tatra Mountains in Slovakia.

Interestingly, the town of Stara Lubovna received the official status of "Free Royal Town" in 1343, and with it, the right for citizens to manufacture spirits, thus beginning a tradition of distilling in the region. The Impact of My Mother's Homeland: My Mother's Family (part 4)

Part 3 ended with my baba's death, and part 4 continues with my quest to learn more about Slovakia's culture, history, and the language.

Looking back, my baba's passing in 1977 represented a milestone in my life. I hoped I could still converse with my dzedo (grandfather), who was still living, but had lost his leg by this time. I was ever more motivated to learn the Slovak language all the more, and I wanted to be able to speak it fluently.

At Notre Dame, I exhausted the library in reading every book there about Slovakia and its people, and I developed an interest in immigration history while taking a Historical Methods course and wrote a paper on the historiography of Slovak immigration studies. Although I loved Notre Dame dearly, I decided to move on to the University of Toronto, where East Central European history was taught. I served as a Teaching Assistant in Western Civilization courses. Unfortunately, Toronto only taught the Czech language and I wanted to learn Slovak, so once a week, I worked with a private tutor, a recent immigrant from Slovakia. At the time, I did not realize how similar Czech and Slovak were, but I did not want to be speaking Czech to my parents or other older relatives.

Only those who never knew Slovak and then tried to learn it realize how difficult it is for an English-speaking person. The grammar is a monster to harness, unless one speaks it from childhood. Even then, it can be difficult for native Slovaks. Besides learning a different vocabulary, one has to adjust to seven different cases in which the ending of the noun, adjective, and verb all change, depending on the usage in a sentence. I know many people who tried to learn Slovak over several years and then gave up, or just knew a smattering of phrases after much effort. The one positive is that the pronunciation is the same once one learns it, and so it is easier to spell once one learns Slovak, as there are not loads of exceptional spelling exceptions as in English. Many foreigners have told me that English is much easier to learn than many other languages.

Thus when I transferred to the University of Pittsburgh in 1978, I was able to study Slovak, as the school tried continually to teach the language, even though there was no permanent position there yet. Pittsburgh relied on visiting professors such as František Galan, and later used Fulbright scholars whom I studied with, such as Verona Chorvathová to teach Slovak. A Slovak Studies Program with a regular professor was not established until Dr. Martin Votruba received an appointment in 1990, a position he held until he death in late 2018. Since then the university has filled the chair with temporary appointments of natives of Slovakia, Marcela Michálková in 2019-2021, and at present Renáta Kamenárová.


While pursuing learning Slovak, another transformation in life happened when I courted my future wife, Rebecca, who was half Slovak and half Polish in ethnicity. The Slovak side dominated in her family because her Polish grandmother had died when her mother was 12 years-old, leaving her to raise her younger sisters in the tiny coal mining town of Glen Robbins, Ohio.

My wife's father was an ethnic Slovak and was raised in Central City, PA, another mining town with a sizeable Slovak population. He had met his future wife in New York City, where many second generation children of immigrants went to look for work during the latter stages of the Great Depression. After her father returned from the Pacific theater in World War II, they married and lived with his Slovak mother, who had moved to Youngstown, Ohio, where work was more plentiful. Thus my wife's baba taught her new daughter-in-law the Slovak language

During the summer of 1978, my wife and I spent the entire summer in Europe, and the climax of the trip for me was our 8-day visit to Czechoslovakia, which I described in a previous article. The experience of seeing a communist country firsthand was an eye

and many Slovak recipes.

opener, as so many places were so dingy and dirty without private ownership. In the countryside, the world was somewhat different and many people owned their own homes rather than living in apartments as in Bratislava. The fact that my wife's relatives and had previously visited gave us someone to visit, spend time with, rest, and get acquainted with Slovak village life in the Spiš area of eastern Slovakia. Seeing my mother's village awed me and inspired me to want to learn more. The trip helped me realize that I had much more work to do, as I could not comfortably carry on a conversation in Slovak.

When we returned home, I realized that I wanted to spend rest of my life with my wife and left school, even though I had a Foreign Language and Area Fellowship. Academic jobs were hard to come by at universities.

I took some education courses and then taught high school at Culver Military Academy for a year, and my wife worked cataloging at the University of Akron library. Thus we started our life together in Akron, and I started teaching history part-time at the university, but in the winter of 1981, I would return to work on my Ph.D. at the University of Pittsburgh and continue a more intense study of history and the Slovak language.

While at the University of Akron, I was able to take a Slovak course with Rev. Bonaventure Babik. Ironically, the bishop appointed him as pastor at All Saints Church, a Polish Catholic parish in Canton, Ohio, rather than at the Slovak church. Father Babik taught the Slovak language once a week for Continuing Education. This helped keep alive my pursuit of learning Slovak and Fr. Babik offered many useful handouts.


The Akron area also offered some Slovak cultural events as well, particularly in Barberton. I befriended Margaret Kluka, a member of the Barberton Slovak Chorus, and other Slovak-Americans whom I met in Father Babik's class. The big annual event which she worked to organize was the annual Vilija supper in Barberton. There I also had the opportunity to first see Slovak-American dance groups perform, such as the Lučina Folklore Ensemble from Cleveland, directed by Tom Ivanec, whom I have a lifelong friendship with. On another occasion, the Pittsburgh Slovakians put on a superb rendition of the Bethlehem play that is typical in Slovakia, done complete with lyrics in Slovak. Rudy and Sue Ondrejco directed the group and awed the audience with their performance. Both folk groups made a lasting impression on me and only increased my desire to learn Slovak.

Living in Slovakia


After studying Slovak again at Pittsburgh, I came to realize that one had to live in a culture to become fluent in the language. Upon passing my pre-dissertation doctoral exam, I succeeded in obtaining an International Research Exchange Grant to study in Slovakia and started my studies at the summer school in late July 1982. It included a section to study the grammar in the morning and afternoon lectures. The lectures at the summer school were quite intense, and a bit boring to a student who did not know Slovak well enough yet. But I obviously learned a little more gradually and had to become used to hearing the language used at regular speed.

After summer school, I spent a week with my wife's relatives, and that served to improve my conversation skill a bit. Upon returning to Bratislava, I began my formal research. I intently worked on my research in the State Archives and the Comenius University library, but I also focused on building my vocabulary and conversation skills. A weekly class with several other foreigners was the formal extent of my language classes during my year-long stay. I wrote down every new word I came across in a small pocket notebook and asked people questions about meanings when I did not understand something. Subsequently studying them and using new words in conversation helped. Meeting a few new friends helped with the language more than research, but they were also weary of the secret police



Immigrant Sisters of SS Cyril & Methodius

It is no secret that immigrants have provided our nation with a strong and blessed support. Our Sisters who emigrated from central Europe have contributed mightily not only by their spiritual presence but also by the works they have performed in convents, parishes, schools, hospitals, homes for the elderly and by their very presence which has brought joy and comfort to all with whom they came into contact.

Mary, the third youngest, had a firm desire to become a Sister even though she had never met one. On one occasion she and some friends went to the city and tried to look into the window of a convent. At that very moment, however, a Sister left the building, forcing them to flee in terror. Never again did they attempt to catch a glimpse of a Sister. Evidently, though, the experience did not deter Mary from later pursuing a vocation to religious life.

She herself believed that her vocation came from the pages of THE FOLLOWING OF CHRIST. In the 1978 Jubilee Booklet when she celebrated her Golden Jubilee, she recommended to the young the practice of spiritual reading. "The message of the faith may not be so clear to the young today, but 'the pull of Christ' is there for listening ears and courageous hearts,

impelled by love. He's in the Gospels. He's in the Tabernacle. He's in our fellow-Sisters. He's in our own heart. God assures us in Scripture: 'If with all your heart you seek Me, you shall ever surely find Me.' Now there's a worthwhile quest to pursue!"

Mary was an independent and resourceful individual and considers her coming to the U. S. at age 14 as a journey to the Promised Land. Never, however, did she lose her sense of rootedness in Slovakia. She preferred to speak in her native tongue, and could always be counted on to offer the vinš at the Vilia Supper. One of her most cherished memories was her visit to Slovakia—"Aká si mi krasná, ty rodná zem drahá…" "How beautiful you are, my dear homeland." Sister was also able to go to Rome in the Holy Year 1950 when Pope Pius XII declared the dogma of the Assumption.

When she came to the U. S. Mary lived with relatives in New York City. "All of us were members of the Third Order of St. Francis and we were faithful in cultivating our spiritual life. Both she and Sister Claudia began their commitment to God as Third Order Franciscans. Mary had a special devotion to the Eucharist in Mass and Benediction.

She was led to the Sisters of Saints Cyril and Methodius on an auspicious occasion. Two SSCM's, Sisters Amabilis and Gabriel, went to New York City to see the newly built St. John Nepomucene Church. "When I met them, I knew that my vocation was with the SSCM's.

Since then I have not stopped thanking God for this precious grace." Meeting them provided a way for Mary and Helen Šipka (Sister Claudia) who also belonged to the Third Order, to respond to God's call. Since God has a sense of humor and provides surprises for those He has chosen to follow Him, the prelude to their entrance on July 6, 1925 was "a comedy of errors." First of all, Mary and Helen found they had to borrow money because the banks were closed. They paid Bohemian store owners for material for clothing and stayed up all night sewing. In Scranton they missed the train, but a helpful conductor stopped the train and got them a ride on the caboose of a freight car. Because they were so determined to get to Danville for their entrance date, they became separated from their trunks. (No doubt, the tale ended well although there is no record in any of our sources.)

Sister Basil accepted the fact that because of a lack of formal education she was prevented from becoming a teacher and spent all her religious life in domestic service. She was once described as "a perfectionist in paring." "It has been a joy for me to be an apostle in the kitchen, preparing meals, encouraging and helping others, faithful to prayer, promoting devotions like the message of Fatima, supporting all community projects. My community, the SSCM's, are a father and mother and friend to me."

In the tribute given when Sister Basil died, are the words, "She lived a life of simplicity and even austere poverty. She knew how to cash in coupons, get rebates and exchange proof of purchase symbols for merchandise. The gains from her legendary coupon-collecting were shared with the community and friends."

And speaking of friends, she is known for making friends in the places to which she was missioned and communicated with them even after she left the area. Sister Basil touched thousands of lives—parishioners in Shamokin and Lebanon and those in the thirteen other areas she served loved her and were reminded of God's love. The academy students, women retreatants, Middletown orphans, the Sisters in mission homes enjoyed the fruits of her labors and the meals she prepared and also benefited from the prayers and the sufferings she offered up.

Sister Basil prayed for perseverance, an increase of vocations, unity in the Church (a special intention among the SSCM's) and world peace. Sister was known to be very serious and often very intense, but she was also known for comical quips and sometimes comical actions. Interestingly enough, she did appreciate the things of this world. She kept not only her rosary in her habit pocket but also a deck of pinochle cards.

Sister Basil's death was a surprise because it came suddenly on October 30, 1988, after a party at which she had mentioned that she enjoyed the snacks so much she could have eaten more. The Mass of Christian Burial was celebrated on the Feast of All Saints, November 1, by the Maria Hall chaplain, Father Edward Deller. Father Deller opened his homily with these words, "Having Sister Basil's funeral Mass on the Feast of All Saints immediately turns our minds heavenward where we are certain Sister shares eternal life with the saints." In the closing of her tribute to Sister Basil, Sister John Vianney, then General Superior, stated "It is the hope and prayer of all the Sisters of Saints Cyril and Methodius, her family and friends, that Sister Basil is now enjoying the glories and splendor of her final pilgrimage—the pilgrimage to our God of the unexpected, our God of surprise and that she is, with Mary and all the saints, tasting the joys which our Lord's resurrection and His Mother's Assumption promise to us all."

Vlhova Wins World Cup Slalom in Lienz

Lienz, December 29 (TASR) – Slovak Alpine skier Petra Vlhova won a World Cup slalom event in Lienz, Austria on Wednesday.

Vlhova finished the race with a time of 1 minute and 42.1 seconds, edging out Austria's Katharina Liensberger by 0.51 seconds and Switzerland's Michelle Gisin by 0.68 seconds.

The Slovak skier thus notched up her 23rd victory in the World Cup and 50th podium appearance in the series.

CoFoE: Slovensko má vplyv na tvorbu európskej politiky

Bratislava 20. decembra (TASR) – Slovensko má okrem priamych výhod z členstva v EÚ aj reálny vplyv na tvorbu európskej politiky, zhodli sa na nedávnej diskusii, ktorú zorganizovala televízia TASR v súvislosti s prebiehajúcou Konferenciou o budúcnosti Európy (CoFoE), slovenskí europoslanci Vladimír Bilčík, Michal Šimečka a Michal Wiezík

Poslanci tiež odpovedali na otázky študentov politológie z Univerzity Konštantína Filozofa v Nitre. Jeden zo študentov sa ich opýtal, ako by chceli "zmeniť euroskepticizmus", ktorý v regióne panuje.

Wiezik vníma euroskepticizmus ako "veľký problém" a pripisuje ho vplyvu dezinformačnej scény. "Euroskepticizmus nie je založený na objektívnych poznatkoch alebo objektívnych faktoch. V dnešnom svete je to veľký problém, pretože existuje preťaženie informácií a ľudia nie sú dostatočne schopní tieto informácie filtrovať a pristupovať k nim kriticky," povedal.

Šimečka uviedol, že mnohé tvrdenia, ktoré sa šíria cez internet, sú číry nezmysel. Na druhej strane Únia potrebuje kritiku, zdôraznil.

Bilčík uviedol, že nemá problém s kritikou EÚ, keďže vecnú kritiku považuje za dobrú. Ľuďom sa zdá, že Únia je pomalá a ťažkopádna. Je to úplne prirodzené, keďže existujúca demokracia je mimoriadne komplikovaná.

CoFoE bude zbierať pripomienky a nápady do jari 2022. Tie môžu viesť ku konkrétnym odporúčaniam pre reformu EÚ.

CoFoE: Slovakia Has Impact on European Policy-making

Bratislava, December 20 (TASR) – In addition to drawing direct benefits from its EU membership, Slovakia also has a real impact on European policy-making, Slovak MEPs Vladimir Bilcik, Michal Simecka and Michal Wiezik concurred during a recent discussion organized

by TASR TV in connection with the ongoing Conference on the Future of Europe (CoFoE).

The MEPs were also answering questions posed by political science students from Constantine the Philosopher University in Nitra. One of the students asked them how they would like to "change the euroscepticism" that prevails in the region.

Wiezik views euroscepticism as a "big problem", ascribing it to the influence of the disinformation scene. "Euroscepticism isn't based on objective knowledge or objective facts. This is a big problem in today's world, as there is an overload of information, and people aren't sufficiently able to filter and approach this information critically," he said.

Simecka stated that many claims that are being spread via the Internet are pure non-sense. On the other hand, the Union needs criticism, he stressed.

Bilcik stated that he has no problem with criticism of the EU, as he views matter-of-fact criticism as good. It seems to people that the Union is slow and ponderous. That's absolutely natural, as the democracy in place is extremely complicated.

The CoFoE will collect comments and ideas until the spring of 2022. These may lead to concrete recommendations for reforming the EU.

Parlament schválil štátny rozpočet na rok 2022 s deficitom 4,94 % HDP

14. decembra (TASR) – Parlament v tento deň schválil štátny rozpočet na rok 2022, za návrh hlasovalo 91 zo 146 prítomných poslancov.

V budúcom roku by malo Slovensko hospodáriť s deficitom 4,94 percenta HDP. Tohtoročný deficit sa odhaduje na približne 8 percent HDP.

V nasledujúcich rokoch sa predpokladá pokles deficitu verejných financií na 2,7 percenta HDP s vyrovnaným rozpočtom v roku 2024. Podľa Ministerstva Financií na to sú však potrebné konsolidačné opatrenia v hodnote takmer 4 miliárd eur.

Štátny rozpočet podporili kluby OĽaNO, SaS a Sme rodina, proti hlasovali Smer-SD a krajne pravicová ĽSNS. Pokiaľ ide o nezávislých poslancov, podporili ich Jana Žitňanská, Alexandra Pivková, Miriam Šuteková, Ján Krošlák a Juraj Šeliga, pričom Jozef Šimko, Miroslav Kollár a Tomáš Valášek sa zdržali, ostatní hlasovali proti.

Celkové plánované príjmy verejnej správy na rok 2022 sú 44,2 miliardy eur a výdavky 49,4 miliardy eur.

Vo viacročnom rozpočte verejnej správy sa predpokladá, že hrubý dlh Slovenska bude kulminovať v rokoch 2021-22 na úrovni 61,5 percenta HDP, do roku 2024 potom klesne pod 59 percent HDP.

Podľa návrhu zákona o rozpočte sa v rámci plánu obnovy na roky 2022 – 24 očakáva vyčlenenie 4,59 miliardy EUR, pričom väčšina týchto zdrojov sa v budúcom roku vyčlení na ekologické hospodárstvo (454 miliónov EUR), vzdelávanie (323 miliónov EUR) a zdravie (218 miliónov eur).

House Okays 2022 State Budget, With Deficit of 4.94% GDP

December 14 (TASR) – Parliament approved the 2022 state budget on Tuesday, with 91 out of 146 present lawmakers voting for the bill.

In the next year, Slovakia is supposed to run a deficit of 4.94 percent of GDP. This year's deficit is forecast to equal about 8 percent of GDP.

In the following years, the public finances deficit is prognosed to decrease to 2.7 percent of GDP, with a balanced budget to be achieved in 2024. In order to make that happen, however, consolidation measures worth almost €4 billion are needed, according to the Finance Ministry.

The state budget garnered support from caucuses of OLaNO, SaS and We Are Family, with Smer-SD and far-right LSNS voting against. As for independent lawmakers, lending their support were Jana Zitnanska, Alexandra Pivkova, Miriam Sutekova, Jan Kroslak and Juraj Seliga, with Jozef Simko, Miroslav Kollar and Tomas Valasek abstaining and the rest voting against.

The public administration's total projected 2022 income stands at €44.2 billion and expenditures at €49.4 billion.

The public administration's multi-year budget expects the gross debt of Slovakia to culminate in 2021-22 at 61.5 percent of GDP, then drop under 59 percent of GDP by 2024.

According to the budget bill, the allocation of €4,59 billion is expected under the recovery plan in 2022-24, with the bulk of these resources earmarked next year for the green economy (€454 million), education (€323 million) and health (€218 million).



Most of us have become used to the fact that we carry a cell phone so that we can be reached immediately; in fact, it is expected that we do. But there is more: We have also come to understand that this device gives us access to an incredible number of audio-visual platforms that can completely take over our lives to the point of forgetting everything else: Consider the oft-published caricature of a family eating a meal where no one speaks because all are looking at or answering their cell phones Have we entered an era where our behaviour is defined and influenced by a new communications revolution?

The invention of the printing press around 1440 by Johannes Gutenberg in the German city of Mainz launched the communications revolution that we are familiar with by making information not only more accessible, but also recorded and remembered. The inventions that followed, namely the radio, television, and the internet, made this information amazingly ubiquitous and immediate and brought about a new communications revolution. What has this done to us? How have we, indeed how should we react to this new and overwhelming presence in our lives?

All living creatures communicate. Biologists tell us that even trees in the forest communicate. Humans developed the most sophisticated form of communication that has enabled them not only to pass on information, but also to express in detail and depth feelings and emotions. Social life and everything that flows from it, especially inventions, became possible because of this ability to communicate. But with this ability came the challenge of accuracy and veracity. It tested our individual reaction to information, or put another way, whether we told the truth as we understood it or whether we distorted the facts and lied. "Fake news" was not invented this century; it was always there. What accounts for this?

The answer is found in the way we process the information we receive. We all have an innate reaction to the world around us, a reaction that is fueled by experience, feelings, and emotions, but also by rationality. But rationality is a double-edged sword that can take the information and challenge it – it can offer arguments for or against – and thereby have an impact at the emotional level. This process, which is both individual and social, is the essence of politics and has been with us since time immemorial. Societies and even civilisations have risen and fallen on how information played out in the decisions leaders took. Is anything different today?

The change in the dissemination of information is what distinguishes our current reality from that of the past. We now face a test of rapidity and quantity that our ancestors and previous generations never did. Information overflow is a special challenge that they did not encounter because they usually had time to digest, even to discuss the information they received before turning to action. It seems that we no longer have this "luxury." If anything, we are now overwhelmed with information and challenged to deal with it; the question is whether we do so rationally and/or emotionally? The current pandemic brought home this dilemma very forcefully.

Our current communications allow decision makers and citizens to assess a situation in good time and to move quickly when rapid action is necessary to save property and lives. But they also allow opposing views, even misinformation and disinformation, to partake in this process, and to do so just as quickly. The challenge we face is what information to believe before we come to a decision. Since the pandemic began, we have been told that the best way to "beat" COVID is to get vaccinated. The rapidity with which vaccines were created and made available around the world is a story of incredible human ingenuity, international communication, cooperation, and good will, rarely seen in history. And yet, the merits of the science that brought these vaccines have been challenged and the information behind these challenges has been disseminated to such an extent that in many countries in Europe, Slovakia among them, there have been low vaccination rates and, as a result, the possibility of what may become a fourth wave of COVID infections. What accounts for such a mass reaction?

The incredible impact of current communications, it would seem, explains in great part the refusal to accept science-based recommendations by allowing the dissemination of a plethora of arguments to justify it. Contemporary communications have reinforced the tension between social and individual responsibility that has always existed when assessing information, resulting in new levels of confusion and uncertainty. Coercive, authoritarian, or total-itarian political systems can forcibly bend individual responsibility and enforce one officially sanctioned view, but democratic ones are reluctant, hesitant, and, in fact, generally unable to do so by law. This has resulted in an emphasis on individual rights as never before.

What aggravated this situation in democratic societies was the appearance of some sort of official sanction to the predominance of individual over social responsibility, of emotion over evaluation and reasoned judgment. On 20 January 2017, Donald Trump, the newly elected president of the United States began to use the social media to repudiate anything

he disagreed with: On the day of his inauguration, he claimed that the crowd present at his inauguration was the biggest ever in American history, despite evidence to the contrary. He gave "fake news" a level of legitimacy that it never had before. Many media reacted by contributing to this new polarisation. Will future historians not say that on this day, the communications revolution underwent a major modification? Did we enter an age not only of mass confusion, but of mass manipulation beyond anything that existed before, with as yet unforeseen consequences?

How future historians answer this question will depend on how each one of us acts and responds now and in years to come to this new communications world we live in. We now have more information available than ever before and that is a very good thing. Information is the best defence against manipulation. But we must also recognize and accept that, more so than before, we have a responsibility to evaluate this information, acknowledge the tension that exists between social and individual accountability, and, in the end, act accordingly. Perhaps, when evaluating information henceforth, we might consider the Golden Rule: "Do onto others as you would have them do onto you!" If modern communications were to disseminate this message, then this might indeed help us to come to terms with the new communications revolution that we are experiencing. "Stay tuned!"

P.S. It might also help put a quick end to the pandemic.



I am Home, but Not for Long

On November 14, 2021, I boarded a plane for my trip back to the USA. It has been over 3 years since the start of my missionary journey. In August, 2018, I began my four-month formation program in Los Angeles, CA. Shortly after completion I flew off to Ghana to begin what has been an amazing journey.

Prior to leaving Ghana I watched as 30 exceptional girls from the class of 2021 graduated from St. Anne's Girls' Senior High School. I had the privilege of organizing their graduation ceremony. Remember the Holy Spirit. He is with you, wanting to guide you. Pray to him. Ask him for his assistance, especially in times of uncertainty.



Historical documentary brings the life and work of Pavel Jozef Šafárik in closer view, particularly for students

Dr. Zuzana Pavelcová, Matica Slovenská

Pavel Jozef Šafárik University in Košice and Matica Slovenská have prepared an online educational historical documentary about Pavel Jozef Šafárik for schools and those interested in national history. The work will also serve as a representative video of the university.

"Working on a new historical documentary about Pavel Jozef Safárik is of great moral importance to Matica Slovenská, as it was Safárik who proposed its founding in 1827, even though he did not live to see it. For many students, the Internet has become a place where they obtain information for their studies, but also for increasing their intellectual potential. Freely available videos have proven to be a unique educational tool. That is why we create historical documents about Slovak personalities and events, that will help young people better master historical context and will help support the collective historical memory of the nation. One of our last topics this year is the life and work of Pavel Jozef Šafárik on the occasion of the 160th anniversary of his death, so we naturally joined forces with PJ Šafárik University to create this unique historical document, "said MS chairman Marián Gešper. The historical documentary "Silent Genius Pavol culture and its further historical development; and opens the romantic idea of Slavic reciprocity.

Jozef Šafárik" comprehensively depicts Šafárik as a Slovak poet, historian, ethnographer, Slavist, university professor, and founder of scientific Slavonic studies.

The idea of producing a new documentary about the life and work of Pavel Jozef Šafárik was born under the leadership of UPJŠ in Košice on the occasion of commemorating in 2019 the sixtieth anniversary of its founding. Its creation was planned for 2021, in which the Slovak and Czech professional public commemorated the 160th anniversary of the death of PJ Šafárik. Ján Gbúr, a professor at the Department of Slovak Studies, Slavic Philology and Communication at the UPJŠ Faculty of Arts in Košice, collaborated on the documentary on the basis of the latest results of scientific research into the work of a native of Kobeliarov, and significantly collaborated on the preparation of the film entitled Silent Genius Pavol Jozef Šafárik. The document was created together with Matica Slovenská, which builds on its previous historical documents dedicated to important Slovak personalities and events.

"The legacy of Pavel Jozef Šafárik has been proudly represented by our university since 1959. This document points way for younger generations to learn about Šafárik's genius. The love for knowledge, curiosity and the desire to overcome the unknown through knowledge are the inspiration and legacy to which the university named after the giant of scientific Slavic studies subscribes, " said Professor Pavol Sovák, Rector of UPJŠ in Košice. Together with the chairman of Matica Slovenská, Marián Gešper, they unveiled the first bronze bust of Pavel Jozef Šafárik in 2019 on the university campus.

Safarik came from an evangelical teaching family. He received a quality education at the Evangelical Lyceum in Kežmarok and at the University of Jena. He was the director of the Serbian Orthodox grammar school in Novi Sad, but he later worked more significantly in Prague. Here he developed into one of the leading figures in scientific circles. He became a pioneer of Slavic studies and an important figure in the Czech and Slovak national revival. His work significantly contributed not only to the establishment of Slavic studies, but also to the political emancipation of the Slavic nations, as it had hitherto given only a romantic basis to the

I found it took about 5-6 months before I could speak Slovak fairly well and think in Slovak. I even experienced my first dream that was wholly in Slovak by December. Once I could converse more easily, the process of learning accelerated. But it was still a challenge to understand some of the heavy dialects when I visited in the countryside, and I never became fully comfortable with Czech, even though it was broadcast on mass media. But since Czechs had such an impact on Slovakia and I had to read some documents in Czech, I gradually learned some basic Czech.

Living in communist Czechoslovakia was an eye opener as to how a totalitarian system works with a monopoly of power controlled by one party. I also saw how people coped with their lack of freedom and relied heavily on close friends and relatives in a world when true trust of someone becomes a highly prized value. Knowing the language and exchanging ideas with trusted friends enabled me to understand how people developed their own networks to get by as best they could despite the overarching control of the communist system. While I learned a great deal and became frustrated with the bureaucracy there, it would still be one of the most memorable years in my life, even though being without my wife for most of the stay would take its toll.

Back in the USA

My newfound Slovak language skills would remain an integral part of my life after I returned to the USA in July 1983. While writing my dissertation preoccupied me over the next few years, I kept up my conversation skills by talking only in Slovak with my mother and father, even though they used the Spiš dialect. This aided my learning the dialect which my own ancestors had used and speaking it helped me feel closer to them.

Life changed again when my wife gave birth to our first child, Milenka Anna, in 1984. I loved her so much that I gave her that name, and from the very beginning, I decided to speak only in Slovak to her and any other children that followed. My daughter, Erika Elizabeth, was named after relatives from Slovakia. From an early age, I read to them from Slovak children's books, and urged them to talk in Slovak with each other. Since I worked only part-time at teaching and my wife worked full-time as a librarian, I was able to spend much more time with them than most fathers, and always felt very close to my daughters to this day, as we share the most precious gift I gave them from birth - the Slovak language.

While in Akron, I continued to be actively involved with the Akron-Cleveland Slovak community and became to be one of the hosts of the Slovak Radio Program on WAUP-FM, the station at the University of Akron. Frank (Fero) Vršan and I formed one of four teams that hosted the program. I regularly presented segments on Slovak history and culture, along with some Slovaks words and their translations. My children used to listen to my program on Sunday evenings, and I remember how they used

to dance, and sing Slovak songs. We also used to read each evening some Slovak children's books which I obtained from the Matica slovenská.

To reinforce the language and the Catholic faith, we attended Slovak masses at St. Matthias in Youngstown, Ohio when we were visiting relatives. I also urged my parents to speak with them in Slovak so that the language would flow naturally. When they were teenagers, I took my children on a three week trip to Slovakia where they could experience the language in our ancestral homeland. That was one of four overseas trips with them, where they also studied at the Slovak language summer school. We would also spend at least a week with relatives, whom they developed a genuine affection for.

Pursuing genealogy also became a passion and I would question my parents and older family members about their experiences in Slovak and the Slovak-American community. The Czechoslovak Genealogical Society International offers webinars, useful literature and conferences to assist members working on family history. And sites like www.familysearch.org offer new opportunities to find materials on the internet. I have found that usually one member of an extended family takes a genuine interest in genealogy, and that is important so that the family history is not forgotten. Stories and old photos need to be found and explained. Visiting Slovakia can help reinforce interests in ancestral background and the culture.

After the fall of communism, I would travel to Slovakia every two or three years, but the Covid-19 virus has put a damper on reinforcing those personal connections. A 1997 trip with my parents and aunt to Slovakia provided me with further insights about the culture and my mother's own past. Today the internet provides ways to connect with family and friends, but nothing compares with being there in person to experience the culture. The longer there, the better.

Whether an appreciation for Slovak culture and the language continues in the family is up to the adult children. I taught my grandchildren the language and many songs, and it is up to them to carry on. We can expose them to the culture, and then they have to make their own decisions about how much they value faith, family traditions and ethnic heritage. Whom they marry can make a difference, as well as the friends they associate with. Being active with Slovak organizations and ethnic fraternal societies like the First Catholic Slovak Union can help, as well as regularly reading Jednota and other publications. The internet offers many ways to keep in touch with our ethnic heritage, including some great Slovak recipes. Sunday Slovak Masses can be viewed online anytime on Facebook on the site of TV Lux in New York City (https://www.facebook.com/watch/ live/?ref=notif&v=4421946924575796¬if_id=1641136565165649¬if_t=live_video_explicit).

All we can do is try to nurture a love of Slovak culture through exposure and hope it takes hold into adulthood and continues in the family. The future of what we call a Slovak-American community depends up that, but its nature is surely changing over time.

Gala Evening in NYC celebrates UNs 76th, Papánek, and Dubček

On November 15, 2021 the Slovak Permanent Mission to the United Nations hosted a special Gala Evening at the Residence of the Permanent Representative of Slovakia. The Gala evening was a celebration of the 76th anniversary of the United Nations and commemorated the 125th anniversary of the birth and 30th anniversary of the death of Dr. Ján Papánek, the first Permanent Representative of Czechoslovakia to the UN, and one of the fourteen co-authors of the UN Charter. Also in attendance was Archbishop Gabriele Giordano Caccia, Permanent Observer Of The Holy See To The United Nations as well as Fr. Stefan Chanas of St. John Nepomucene Slovak Church, and Pastor Michal Misina of Holy Trinity Slovak Lutheran Church who offered an invocation.

MINUTES OF THE QUARTERLY MEETING OF THE BOARD OF DIRECTORS OF THE FIRST CATHOLIC SLOVAK UNION OF THE USA AND CANADA SEPTEMBER 17-18, 2021 COLLEGE PARK MARRIOTT HYATTSVILLE, MD

FIRST SESSION:

Friday, September 17, 2021

OPEN MEETING:

The Board of Directors Meeting is being held at the College Park Marriott in Hyattsville, Maryland in conjunction with the 56th Anniversary of the Dedication of the Shrine honoring Our Mother of Sorrows, Patroness of Slovakia, at the Chapel at the National Shrine on Saturday, September 18.

Reverend Thomas Nasta opened the meeting at 8:30 a.m. by celebrating a Memorial Mass for our deceased officers and members who passed away in 2021.

President Andrew Rajec called the meeting to order at 9:00 a.m. and asked Reverend Thomas Nasta, National Chaplain, to offer the opening prayer. The President asked Regional Director Sabina Sabados to lead the Board in singing the Anthems of the United States, Canada, Slovakia, and the recitation of the Pledge of Allegiance.

ROLL CALL:

Kenneth Arendt, Executive Secretary, read the roll call with the following members present:

Timothy Graves, Regional Director, Region 7 – present;

READING OF THE CALL:

The Executive Secretary then read the Call to the Quarterly Meeting of the Board of Directors of the First Catholic Slovak Union.

ACCEPTANCE OF THE MINUTES OF THE QUARTERLY BOARD MEETING JUNE 19, 2021:

A motion was made by Damian Nasta and seconded by Gregory Maurer to accept the minutes of the Quarterly Board of Directors Meeting held June 19, 2021, as presented. Motion carried.

AQS REPORT:

Larry White, representing AQS Asset Management, Inc., joined the meeting by teleconference. Mr. White presented an extensive Investment Portfolio Transaction Report to the Board of Directors. Each member of the Board of Directors received a copy of the presentation in advance for his or her review. During and after the presentation, Larry White answered questions from the Board.

Mr. White also led a review of the current Investment Policy. Mr. White stated that due to current economic conditions, it is necessary to modify the Investment Policy and raise the limit for corporate investments from 75% to 80% and raise the limit for corporate investing for Rule 44A from 30% to 35%. A motion was made by Damian Nasta and seconded by Kenneth Arendt to accept Mr. White's changes to the Investment Policy. Motion carried.

Mr. White provided an explanation of the new investment opportunities that FCSU will be entering into and answered the Board's questions.

Mr. White stated that he will work with General Counsel Gary Matta to review investment contracts.

TREASURER'S REPORT:

Acting Treasurer James Marmol gave a full written report on the investment update and answered the Board's questions.

PRESENTATION OF THE AGENDA:

President Rajec presented the agenda for the Quarterly Meeting and asked for its acceptance. A motion was made by Timothy Graves and seconded by Andrew P. Rajec to accept the agenda and to allow the President to change the order of the agenda, if necessary, as he presents each item on the agenda with appropriate comments or recommendations. Motion carried.

The President stated that the vote for the Vice President and Treasurer positions will be held on Saturday, September 18, 2021. Regional Director Thomas Ivanec stated that since both candidates for Vice President are currently present that the Board should consider voting for the Vice President position on Friday, September 17, 2021. A motion was made by Kenneth A. Arendt and seconded by Michael Lako to vote for the Vice President position on Friday and hold the vote for the Treasurer position on Saturday. Motion carried.

The President stated that each candidate will be given 5 minutes to speak on their behalf before the vote.

SECOND SESSION:

Friday afternoon, September 17, 2021

OPEN MEETING:

President Andrew Rajec called the meeting to order and asked Reverend Thomas Nasta to offer the afternoon prayer. The Executive Secretary stated that all members were present.

VICE PRESIDENT'S REPORT:

Acting Vice President Andrew P. Rajec gave a production report on our agents to the Board of Directors. He stated we are still recruiting and adding new agents, and at present have 429 agents. The Home Office is sending the independent agents monthly updates on our products. The independent agents are also in frequent contact with Andrew P. Rajec, Director of Independent Agents.

The President stated that he is considering a membership meet to be held in 2022 for our agents and recommenders.

The President led a review of the current annuity interest rates. The rates will remain the same and be reviewed at the next Executive Committee meeting.

FINANCIAL REPORT:

Executive Secretary's Report

The Executive Secretary presented a detailed summary of the Financial Report for the second quarter of 2021. After the Executive Secretary's report, he answered the Board's questions. The Executive Secretary stated that the 2021 second quarter Financial Report will be published in the Jednota newspaper.

Federal Home Loan Bank of Cincinnati

The Executive Secretary submitted a written report to the Board of Directors giving a complete update of the investments and all current transactions with the Federal Home Loan Bank of Cincinnati.

Portfolio Custodian

The Executive Secretary updated the Board of Directors on the report from our portfolio custodian, Key Bank. Everything was found to be in order, and he answered the Board's questions.

Investment Updates

The President and Executive Secretary led a review on the investments and transactions with the UBS Fund, MAI Fund, and the Clutterbuck Fund. Following the report, they answered the Board's questions.

PRESENTATION OF THE EXECUTIVE COMMITTEE REPORTS:

Executive Committee

The Executive Secretary gave a report on the Executive Committee Meetings. He stated that in accordance with the Bylaws of the First Catholic Slovak Union, the Executive Committee meets monthly and whenever else it is necessary to take care of the business of the Society.

<u>Investments</u>

All investments were made in accordance with the laws of the State of Ohio and with the investment policy adopted by the Board of Directors. The Executive Committee members work very closely with AQS Asset Management Company, and all investments are approved by a vote of at least three members of the Executive Committee.

Scholarship Committee

The Executive Secretary gave a report on the Scholarship Committee, which is comprised of three independent professional educators. Applications for the Jednota Benevolent Foundation scholarships are being received and they will be sent to the Scholarship Committee.

NEW LIFE INSURANCE PROGRAM:

The President and the Executive Secretary stated that a new life insurance program is being developed for all members who are under the age of 80. Each member will be mailed a life insurance offer with a reduced premium and liberal underwriting. This offer is only available until 12/31/2021. It will be advertized in the Jednota newspaper, in our monthly newsletter and on our website. The President encourages all members to take advantage of this offer.

The Executive Secretary stated that all our new insurance and annuity applications that have been approved by the states we are licensed in are available on our website. Please discard any old applications and use the new applications on our website. Anyone having any questions on the application is asked to please call the Home Office.

CONVENTION UPDATE:

The Executive Secretary stated that the estimated delegate count letter will be mailed out to the Branches that qualify to attend the Convention. The estimated delegate count will be based on the number of members as of 10/1/2021. The final delegate count will be based on the number of members as of February 1st of the Convention year.

The Executive Secretary stated that we will use electronic voting again for the motions and the election of officers.

Director of Fraternal Activities Kevin Collins updated the Board on the International Golf Tournament that was held August 6 – 8, 2021 at Treasure Lake Golf Resort in DuBois, PA with the Greek Catholic Union and the Slovak Catholic Sokol. Mr. Collins hopes to hold multiple golf tournaments in different regions in 2022. Other upcoming activities include the FCSU NFL's Losers Pool, a hunting contest, ugly sweater contest, Christmas decorating contest, coloring contest and March Madness.

Mr. Collins stated that the coloring contest winner will work with Regional Director Sabina Sabados in creating a Christmas card.

Mr. Collins stated that a Pen Pal program with people in Slovakia may be held.

Mr. Collins also stated he is working on activities for the 52nd Quadrennial Convention and will provide more details at the next meeting.

The President stated that the museum is currently on hold due to the coronavirus pandemic. The President has been in touch with the builder of the building and more information will follow.

The President stated he stopped and visited the Jednota Memorial in Middletown, PA. He met with the landscaper who maintains the grounds.
