### Message from President

Andrew M. Rajec

As I look at my office window with the blowing snow and the temperature at 23°F I think of the Society's past and look into the future.

I see a small group of Slovak men (at that time there were no women members) with Fr. Furdek in Cleveland Ohio getting together to form a fraternal Society for the purpose of providing death benefits to members and their families.

Their "mission statement" was

"ZA BOHA A NÁROD" – "For God and Nation". The First Catholic Slovak Union has tried to fulfill that goal for over 130 years.

The original "Jednota" newspaper was entirely in Slovak. Today, we still have several pages in Slovak. The Society was founded as a fraternal under the IRS code with a branch system. As with most fraternals the branch system has showed signs of age with branches combining and more fraternals merging.

Over the years, there were more than 200 Catholic and Byzantine Slovak parishes in the United States and Canada that were founded with assistance and support of the First Catholic Slovak Union and its Members. Unfortunately, many have been closed or merged. The Slovak clergy and religious staffed many of these churches and schools. We thank them all for their service and dedication.

These churches and schools not only were places of worship and learning but also places where our Members and Branches could meet and socialize.

I am well aware that things have changed; in our Churches and in our Branches. Fewer young people are attending Mass, even before the COVID issue. All we can do is try to encourage our young people and set an example.

Our Branches are impacted, along with all other fraternals, with changes in state laws that impact our Recommenders and require licensing. These changes have required most fraternals to do business with independent insurance agents. In 2021 independent agents generated \$88 million in FCSU annuity sales, over 80% of our

2021 premium income. We thank our annuity staff and Andrew P. Rajec, Director of Independent Agents for their efforts.

The Society had assets of \$192.31 million at 12/31/2006. Today we have assets of over \$500 million.

To give some help to Catholic parishes and hopefully provide an incentive to our Branches to be more active we are implementing a "Matching funds" program in 2022.

I will be presenting to our Board of Directors proposals for a 5-year plan to address the future of the Society in a challenging fraternal environment.

I believe that we have an obligation to our Members and our Catholic Faith to stay true to the vision that Furdek and our founders had when they established the Society.

I intend that we continue to honor our Slovak heritage by continuing our Slovak section in the Jednota, continuing our excellent relationship with the Slovak Embassy in Washington DC, and finding ways that we can promote relations with the people in Slovakia and our Members of Slovak descent in the US and Canada.

I am Slovak and proud of it and I hope you feel the same.

In closing, I would like to announce that we have hired a new Editor to continue the high quality of our Jednota newspaper. He is Michael Kopanic whose bio follows. In addition to his excellent scholarship credentials, he reads and speaks Slovak. He will be responsible for the February 2022 issue.

### St. Cyril, Monk and St Methodius, Bishop Memorial: February 14 -

Cyril and Methodius were Greek Byzantine Church brothers, born in Salonika about 825 and educated in Constantinople. They translated the Bible, and liturgical texts, into the Slavonic language. Cyril died in Rome on 14 February 869. Methodius was made a bishop and spent many years preaching the Gospel in Great Moravia, despite resistance and hostility. He died in 885, in what became Czechoslovakia 1918.

Father, you brought the light of the gospel to the Slavic nations through Saint Cyril and his brother Saint Methodius. Open our hearts to understand your teaching and help us to become one in faith and praise. Through our Lord Jesus Christ, your Son, who lives and reigns with you in the unity of the Holy Spirit, one God, for ever and ever. Amen.

### Saints Cyril & Methodius Appeal Continues in February

A direct mailing for the 2022 Appeal has been sent to local district and branch leaders from the four Catholic Slovak Fraternal Organizations, members of the Slovak Catholic Federation, and previous donors. As of January 30, 2022, 17 donors have given \$3,450 to the 44th Annual Appeal. ### St. Michael Church a 100-year support to Slovak, Korean communities EmmaLee Italia, Contributing Editor, TrentonMonitor.com

The church motto "No one comes to St. Michael's as a stranger and leaves us that way" was abundantly evident Dec. 12 when Bishop David M. O'Connell, C.M., celebrated a Mass and blessed a St. Michael mosaic to commemorate the 100th anniversary of St. Michael Church in Trenton. Coined by Father Louis W. Kralowich, St. Michael's administrator in the late 1970s to early 1980s, the phrase emphasizes the sense of community and common purpose that has married the historically Slovak Catholic community of St. Michael Church with the Korean Catholics and English-speaking Catholics who also now share the worship site affiliated with St. Ann Parish, Lawrenceville.

"Anniversaries are a time for 'going home,' for reaching back through the years and remembering the good things and the good times that were part of our lives," said Bishop O'Connell in his homily. "Today we celebrate a homecoming of 100 years here when St. Michael Church was built and consecrated by my predecessor Bishop Thomas Walsh a century ago yesterday.

"As we celebrate a homecoming of 100 years today, we also recognize that Advent, in a sense, is a homecoming," the Bishop continued, "a return to the Church and all that it offers: a family; things familiar; the opportunity to be 'at home' with God and one another – all things to celebrate with joy."

From Roots to Branches

Erected in 1921 to serve the Slovak community of North Trenton, St. Michael Church sits at 1130 Brunswick Avenue. Slovak and Polish priests from the surrounding area served the parish until a permanent pastor was found in Father Michael J. Kallok, installed in 1926. Under his direction a social hall was added under the church in 1927 and a rectory was constructed in 1929.

Plans were made for a more majestic church in the current parking lot, with the smaller original building rebuilt into a school – but financial income in the hard-strapped 1930s wouldn't allow for the expansion. A long-celebrated tradition of the St. Michael community is the St. Jude Novena, a fixture among the Slovak faithful of the church since 1939. Father Ladislav J. Rakvica – who became administrator in 1936 and served for 36 years – initiated the first Solemn Novena to St. Jude Oct 20, 1939, as a thank you to the saint for his miraculous recovery from a near fatal illness. The novena tradition continued weekly on Thursdays, gaining in popularity, and devotion to St. Jude continues today.

When Father Rakvica, after 10 years of assisting at St. Michael's following his retirement, died in 1982, the Slovak language Mass was not regularly celebrated again in the church until 20 years later. In the meantime, the community was administrated by Father William Capik (1972-1974); Father Kralovich (1974-1982), and then-Father (now Msgr.) James G. Innocenzi, who was appointed administrator in 1982 and pastor in 1986. Through his guidance and assistance, Msgr. Innocenzi welcomed weekly Masses in the Slovak language and the Slovak community back to St. Michael's in 2002, with the approval of then-Bishop John M. Smith.

Father Vladimir Chripko, a native Slovak priest, began celebrating the Slovak Mass there, ushering in a return of St. Michael's as a center of spiritual and cultural life for Slovaks of the wider area. Msgr. Innocenzi remained until 2005 when St. Michael's merged with St. Ann Parish. The Korean Catholic community was welcomed to St. Michael Church in 2006.

Currently under the ministry of Father Peter Bujdos, who replaced Father Chripko in 2015, many repairs and updates were made to the church and rectory structures, including

12. decembra 2021 oslávil Kostol svätého Michala v Trentone 100. výročie svojho vysvätenia.

Bol postavený slovenskými imigrantmi v severnej časti mesta, kde sa slovenská komunita v tom čase rýchlo rozrastala.

11. decembra 1921 sa v ňom konala prvá svätá omša, počas ktorej ho posvätil vtedajší trentonský biskup Thomas Walsh.

V začiatkoch kostol nemal stáleho kňaza. Sväté omše tu slúžili slovenskí a poľskí kňazi z blízkeho okolia. Prvým stálym kňazom vo farnosti svätého Michala bol Michael J. Kallok (1926-1931).

Za jeho pôsobenia sa v roku 1927 postavila spoločenská hala pod budovou kostola a o dva roky neskôr aj fara.

Plány rozrastajúcej sa slovenskej komunity boli dokonca oveľa odvážnejšie. Na mieste dnešného parkoviska mal stáť väčší, majestátnejší kostol a pôvodná budova kostola mala byť prerobená na katolícku školu. Veľká hospodárska kríza, ktorá prišla v roku 1929, všetky tieto plány zastavila.

Významnú rolu v histórii kostola zohral duchovný otec Ladislav Rakvica (1936-1972).

Vo farnosti pôsobil ako farár 36 rokov a aj po odchode do dôchodku prichádzal ďalších 10 rokov do Kostola sv. Michala každú nedeľu, aby tu odslúžil slovenskú svätú omšu.

20. októbra 1939 začal v Kostole svätého Michala s novénami a pobožnosťami k svätému Júdovi ako poďakovanie za jeho zázračné uzdravenie z veľmi vážnej choroby. Prosby mnohých veriacich boli vypočuté na orodovanie svätého Júdu Tadeáša, ktorý je patrónom ľudí v beznádejných a zúfalých situáciách. Pobožnosť k sv. Júdovi v Kostole sv. Michala si počas rokov získala v širokom okolí Trentonu veľkú popularitu a aj dnes sa tu koná pobožnosť k sv. Júdovi každý štvrtok o 7:30 PM ako aj slávnostná 9-dňová novéna každý rok od 20. do 28. októbra.

S odchodom duchovného otca Ladislava Rakvicu sa z kostola vytratil aj slovenský jazyk na dlhých 20 rokov.

Ďalšími kňazmi, ktorí tu pôsobili boli Father William Capik (1972-1974), Father Louis Kralowich (1974-1982) a Msgr. James Innocenzi (1982-2005).

V roku 2002 pani Mária Kolcunová iniciovala obnovenie slovenských bohoslužieb v Kostole sv. Michala. Vtedajší trentonský biskup John Smith jej žiadosti vyhovel.

Msgr. Innocenzi, farár vo farnosti sv. Michala, prijal slovenskú komunitu s otvorenou náručou.

Duchovným otcom pre Slovákov žijúcich v okolí Trentonu sa stal Father Vladimír Chripko, ktorý tu prichádzal v nedele a vo sviatky vysluhovať slovenské sväté omše a sviatosti v slovenčine. Svojím obetavým prístupom k ľuďom stmeľoval slovenskú komunitu, ktorá pod jeho vedením rástla na duchovnom poli aj v počte svojich členov. Začalo sa s vyučovaním náboženstva v slovenskom jazyku. V rámci komunity sa konalo a stále koná množstvo krásnych kultúrno-spoločenských podujatí.

V roku 2005 zanikla farnosť sv. Michala a kostol sa stal súčasťou susednej farnosti sv. Anny v Lawrenceville, NJ. Father Vladimír začal vysluhovať aj anglické sv. omše pre americkú komunitu, ktorá zostala v Kostole sv. Michala.

Kórejská katolícka komunita pribudla do kostola v roku 2006.

the addition of a camera system and internet access to allow for livestreaming of Masses. A Century to Remember

"I would like to thank God we are here ... can we imagine how many sacraments, graces and blessings people have received here these 100 years?" Father Bujdos reflected at the end of the anniversary Mass. "The church is not big – however it is cozy, and we are thankful to those who have built this church. ... We should be joyful people because we are people of light ...for all three communities – American Slovak and Korean – St. Michael is not only a building, but as Bishop David said, it is home."

A St. Michael parishioner for 18 years, Maria Krutkova helped plan the celebratory Mass and music selection as a member of the liturgical committee, and also worked on the committee creating a commemorative St. Michael booklet, due to be distributed in a few weeks.

"This centennial celebration means so much to me," said Krutkova, who came to the U.S. from Slovakia at a young age. "What made it so much easier for me is that the Slovak community at St. Michael's was already established; I have found [my] home away from home. ... I'm so proud and grateful that our Slovak predecessors, with great dedication, built a

place where people of many origins found their spiritual home." In addition to the anniversary Mass, the committees have been organizing events and commemorations throughout the year that celebrate St. Michael's legacy in the community: the writing and recitation of an anniversary prayer and logo; slideshows and photo collections; archival material in Slovak language curated and updated; clothing drive, bake sale and anniversary souvenir sales held as fundraisers; the installation of a St. Michael the Archangel mosaic above the church entrance, and much more.

Dagmar Sabova, chair of the 100th Anniversary Committee and parish religious education teacher, has been a member of St. Michael's since 2002, along with her husband, Jozef Sabo; son, Michal Sabo, and daughter, Emma Sabova. Father Kralovich's motto "is how I felt on our special day," she said. "It was so nice to see the church full of people; everyone was smiling and enjoying the beautiful ceremony."

"Our ancestors... found time, energy and, most importantly, funds to build a new church," she continued. "They brought from their homeland a hard-working mentality, but also a deeply rooted faith in God. This led to the conviction that, with His grace, they would be able to fulfill their dreams of a better life."

Sabova's second grade class contributed to the anniversary Mass with a song sung in the Slovak language following Communion. Their group name is Pramienok, meaning small fountain or small river flow.

"Commemorating 100 years is even more meaningful given that we are even now able to exalt our Heavenly Father [at St. Michael] in our language," Sabova noted. Krutkova agreed. "It was a pure joy and blessing," she said. "In these uncertain times, we

### EC sa zaviazalo spracovať výsledky CoFoE počas tohto obdobia

Brusel 24. januára (TASR-spravodajca) – Plenárne zasadnutie Konferencie o budúcnosti Európy (CoFoE) v sobotu (22.1.) v Štrasburgu zúžilo okruh odporúčaní občanov, ktoré vzišli z dvoch už uzavretých občianskych panelov. Podpredseda Európskej komisie (EK) Maroš Šefčovič, ktorý je poverený riadením pracovnej skupiny CoFoE pre zdravie, pre TASR uviedol, že jeho pracovná skupina zúžila odporúčania občanov v tejto oblasti na štyri tematjické okruhy.

Šefčovič upozornil, že ďalším krokom jeho pracovnej skupiny bude vo februári štruktúrovaná debata na vybrané témy. Zhrnutie záverov skupiny následne zašle – ako v prípade ostatných pracovných skupín – vedúcim troch hlavných inštitúcií EÚ: Rade EÚ, Európskej komisii a Európskemu parlamentu.

"Ich úlohou bude prijať tieto závery počas francúzskeho predsedníctva a navrhnúť ich ďalšie rozpracovanie. V mene Európskej komisie sme sa politicky zaviazali, že hneď ako sa konferencia skončí konkrétnymi výstupmi, urobíme všetko pre to, aby sme v tomto volebnom období prišli s konkrétnou implementáciou," povedal Šefčovič. Súčasný mandát Európskej komisie vyprší v polovici roku 2024.

Európska komisia musí byť podľa neho pripravená, že po konferencii bude musieť v niektorých ohľadoch vytvárať nové politiky či právne predpisy.

### EC Committed to Process CoFoE Outcomes During This Term

Brussels, January 24 (TASR-correspondent) – The plenary of the Conference on the Future of Europe (CoFoE) in Strasbourg on Saturday (January 22) narrowed down the range of citizens' recommendations that emerged from the two already closed citizens' panels, European Commission (EC) Vice-President Maros Sefcovic, who is in charge of managing the CoFoE working group on health, told TASR that his working group had narrowed the citizens' recommendations in this area to four thematic ranges.

Sefcovic pointed out that the next step of his working group will be a structured debate on selected topics in February. It will then send a summary of the group's conclusions – as in the case of the other working groups – to the heads of the three main EU institutions: the EU Council, the European Commission and the European Parliament.

"Their task will be to adopt these conclusions during the French Presidency and to propose their further elaboration. On behalf of the European Commission, we've made a political commitment that as soon as the conference concludes with specific outcomes, we'll do everything we can to come up with specific implementation in this electoral term," said Sefcovic. The current mandate of the European Commission expires in mid-2024.

According to him, the European Commission must be prepared that following the conference it will have to create new policies or legal regulations in some respects.

### Štatistiky: Inflácia narástla na 3,2 percenta v roku 2021, najvyššia hodnota za deväť rokov

Bratislava 14. januára (TASR) – Celoročná inflácia v roku 2021 vzrástla na 3,2 percenta, čo je najvyššia hodnota za posledných deväť rokov, a to v dôsledku prudkého rastu cien v druhej polovici roka, informoval Štatistický úrad SR k tomuto dátumu.

Štatistici poznamenali, že vlani ceny rástli rýchlejšie, ako odborná verejnosť očakávala. V roku 2020 dosiahla inflácia pod vplyvom pandémie len 1,9 percenta.

"Vývoj počas roka 2021 bol turbulentný, pričom v prvých dvoch mesiacoch vzrástli spotrebiteľské ceny o menej ako jedno percento, ich tempo rastu sa postupne zvyšovalo. Od júla rástol celoročný rast cien nad tri percentá a v poslednom mesiaci roka sa priblížil k šiestim percentám," poznamenal vedúci odboru cenovej štatistiky Štefan Adamec.

Ceny v minulom roku vzrástli vo všetkých 12 hlavných zložkách spotrebného koša. Výrazný vplyv mali vyššie ceny v doprave, najmä rast cien pohonných hmôt – v medziročnom priemere o 17,3 percenta. Tento rast je podľa štatistikov aj dôsledkom bázického efektu, keďže ceny pohonných hmôt klesli v rokoch 2020 a 2019. Výrazný vplyv malo aj zvyšovanie cien tabakových výrobkov po úpravách daní v marci 2021, ktoré celoročne vzrástli o 13,7 percenta.

# Stats: Inflation Swelled to 3.2 percent in 2021, the Highest Rate in Nine Years

Bratislava, January 14 (TASR) – Yearly inflation in 2021 increased to 3.2 percent, the highest value in the past nine years, as a result of rapid growth in prices in the second half of the year, the Statistics Office reported on this date.

The statisticians noted that last year prices rose faster than the professional public expected. In 2020, under the influence of the pandemic, inflation reached only 1.9 percent.

"Developments during 2021 were turbulent, while in the first two months consumer prices rose by less than one percent, their growth rate gradually increased. From July, year-onyear price growth grew above three percent and in the last month of the year approached six percent," noted head of the price statistics department Stefan Adamec.

Last year, prices rose in all 12 main components of the consumer basket. Higher prices in transport had a significant effect, especially the growth of fuel prices – with an annual average by 17.3 percent. According to statisticians, this growth is also a consequence of the base effect, as fuel prices fell in 2020 and 2019. Rising prices of tobacco products after tax adjustments in March 2021 also had a significant impact, rising by 13.7 percent year-on-year.

víťazstvo a 52. pódiové umiestnenie v prestížnej sérii. V slovinskom lyžiarskom stredisku predstihla Švajčiarku Wendy Holdenerovú o 0,23 s, tretia skončila Švédka Anna Swenn Larssonová s výrazným odstupom 1,06 s. Američanka Mikaela Shiffrinová nedokončila druhé kolo.

Dvadsaťšesťročná Vlhová v tejto sezóne dominuje slalomu. Vyhrala už piatu zo šiestich súťaží, postupne sa dvakrát radovala vo fínskom Levi, raz v rakúskom Lienzi a v chorvátskom Záhrebe. Až v americkom Killingtone ju Shiffrinová zdolala. Vlhová oslavuje 17. slalomové víťazstvo v kariére. Z možných 600 bodov má 580 a suverénne vedie poradie v disciplíne, pred druhou Shiffrinovou má obrovský náskok 240 bodov.

### Vlhova after Winning Slalom in Kranjska Gora: Not So Easy to Win All the Time

Kranjska Gora, January 9 (TASR) – Slovak skier Petra Vlhova triumphed in another World Cup slalom race in Kranjska Gora on Sunday, notching up her 25th victory and 52nd podium appearance in the prestigious series.

In the Slovenian ski centre, she edged out Swiss Wendy Holdener by 0.23 seconds, the third place was taken by Sweden's Anna Swenn Larsson with a significant gap of 1.06 seconds. American Mikaela Shiffrin didn't finish the second round.

Twenty-six-year-old Vlhova is dominating slalom this season. She has already won the fifth of six competitions, gradually rejoicing twice in Levi, Finland, once in Lienz, Austria and in Zagreb, Croatia. Only in Killington, USA did Shiffrin defeat her. Vlhova is celebrating 17th slalom victory in her career. Out of a possible 600 points, she's scored 580 and is sovereignly leading the ranking in the discipline, she has a huge lead of 240 points over second Shiffrin.

"It's not so easy to win all the time and the conditions were tough today. [In the] second run I did everything perfect and at the end, it's another victory," VIhova told Eurosport.

### In a Slovak-made plane, 19 year-old Belgian-British pilot Zara Rutherford lands in the Guiness World Book of Records,

On January 20, 2022, Zara Rutherford entered the Guinness Book of World Records as the youngest female pilot flew solo around the world, and she did so in a challenging manner, in a very light aircraft. Her sponsors included her former school in Hampshire, and Shark - the Slovak manufacturer of her Shark UL aircraft.

She started out her journey on August 18, 2021, two months later than originally planned due to inclement weather. Her trip included over 60 stops across five continents. During her trip, she was stuck a month in Nome, Alaska, and 41 days in Russia.

Upon completing her journey, she wrapped herself in British and Belgian flags and told reporters: "It's just really crazy, I haven't quite processed it."

Her parents are both pilots, and she aspired to inspire other girls to pursue careers in science, technology, engineering and math.

The Cleveland Slovak program on WERE 1490 AM airs on Sunday mornings at 11 am EST, and airs live. Organized by the Cleveland Slovak Radio Club, it is the longest running Slovak radio program that has been continually broadcasting in the USA since 1939. Milan Kobulsky, a native of eastern Slovakia, serves as the principle announcer. The radio website is https://newstalkcleveland.com/listen-live/ and the Club also hosts a Facebook website: https://www. facebook.com/ClevelandSlovakRadioClub.

Another Slovak program airs on WPIT 730 am in Pittsburgh and is hosted by the well known Jednota couple from the Pittsburgh area, Rudy and Sue Ondrejco; it may be heard at 3-4 pm EST on Sundays and must be listened to when broadcast. Sue does a fantastic job explaining various Slovak customs, and Rudy supplements her with his excellent Slovak. To listen on the web, search WPIT on the web, or go to: http://player.listenlive.co/57381.

The WPIT Rusyn program hosted by Dean Poloka now airs live from 3:30-4 pm. The Carpatho-Rusyn Society offers an archived list of the programs, so it is easy to listen even if a computer or mobile device is not handy at the time of the broadcast. For info, go to: https://c-rs.org/Rusyn-Her-

itage-Radio-Program. One may listen to Rusyn Radio any time on Rusyn FM. Don't forget that 3:30 pm in Pittsburgh is 9:30 pm in Prešov and 10:30 pm in Uzhorod. Listen at the website below: tinyurl.com/2prsye7z. In the Youngstown, Ohio area, Dennis

Spisak hosts a live Slovak Radio Program from 9-11 pm EST on Saturdays. Broadcast from WKTL FM 90.7 as a public service from Struthers, Ohio, the show plays many traditional Slovak polkas and čardašes as well as current news about the local Slovak community of the Mahoning and Shenango valleys. Dennis is always willing to dedicate songs to listeners and has experience hosting a polka program for many years, and is known as "the Polka Rabbit". While one must listen live, the show now offers a listening site on the internet, and it can be heard on live radio as far away as the outer suburbs of Akron and Pittsburgh. The station may have just changed its website in 2022 to the following link: https://thewideworldofmusic.com/listen-live.

Another Slovak program, CJAM, 99.1 FM, broadcasts for the Detroit/Windsor area from the University of Windsor, Canada. Co-hosted by Mary Boldizar Jacko and Anna Bagin, the program presents Slovak music as well as information on Slovak culture and local happenings. If one lives outside the broadcast area, the shows are recorded and the 5 most recent are posted on the internet at the website: tinyurl. com/3uswued2.

The Chicago area offers Krajanské Rádio/Centrum Chicago (Countryman Radio / Downtown Chicago) and also hosts a website with mainly modern Slovak and Czech music: https://www.radiokrajan.com/. Recent younger immigrants host the program and it appeals to the taste of youth with some knowledge of Slovak and Czech. It also hosts a Facebook website: https:// www.facebook.com/krajanskecentrum/.

Finally, I discovered a Slovak program in Brisbane, Australia which broadcasts over the internet and keeps an archive of recent programs. It announces mainly in Slovak and is staffed by emigrés who are native Slovaks. It is broadcast at 6 pm on Fridays, Australian time, but has podcasts at: tinyurl.com/2p92amxs.

To hear Slovak radio programming in English directly from Slovakia, visit the RTVS radio site: http://enrsi.rtvs.sk. The show features news of the day and special features about Slovakia and its culture. RTVS stands for Radio TV Slovakia, and it also has an archive in case you missed a program you wished to hear.

There are many other Slovak radio programs which one may find with an internet search. One of my favorites is Rádio Regina, which plays mainly folk music, and one may choose variants from western central and eastern Slovakia. I prefer Radio Regina Východ, which features music from the east where my family origins are. It offers an extensive archive in case you missed a show. Listen at https://reginavychod.rtvs. sk/.

For Catholic religious radio in Slovak, Rádio Lumen (Radio Light) has a website with live and archived broadcasts. It offers religious music, talks, airings of pilgrimages, etc., and offers daily mass in Slovak (svätá omša) at 6pm European time, which is 12 noon EST. The website is: https://www.lumen.sk/ and to listen live, one must click on Spustiť naživo (Listen Live).

Another option for Slovak language religious programming is on TV Lux or Televízia Lux from Slovakia. It features Masses as well as many podcasts and an archive to choose from. See: https://www.tvlux.sk/.

Live Mass in Slovak is also available on Sundays at 10:15 EST and on holy days from St John Nepomucene Church in New York City at Lux New York. Masses are visible and celebrated by either visiting priests or Rev. Martin Kertys, C.O., the Parochial Vicar, who speaks a clear literary Slovak and offers some very insightful sermons. The site also stores Masses on the Facebook website: https://www.facebook.com/ luxnewyork.net.

#### Conclusion

All of these Slovak programs are well worth listening to, and can help one learn and reinforce Slovak language skills while learning something and enjoying the music. I recommend that listeners send a donation to their favorite program, so they can continue in the future as we try to preserve our Slovak heritage.



1. The Tournament shall be conducted in compliance with the rules and regulations of the United States Bowling Congress (USBC).

2. This event is being sponsored by the First Catholic Sovak Union, Slovak Catholic Sokol, NSS and GCU. The goal of the tournament is to promote fraternalism and good sportsmanship and to generate nationwide interest in the Slovak fraternal organizations. The National Officers of the First Catholic Slovak Union, Slovak Catholic Sokol, NSS and GCU wish to extend to all members a cordial invitation to attend the tournament.

3. ELIGIBILITY: This Tournament is open to all First Catholic Slovak Union male and female bonafide MEMBERS IN GOOD STANDING. All winners will be checked before any prize money is awarded.

4. CONSENT RULES: Any grade or high school student who has not at- tained the age of eighteen (18) must have written consent of his/her parents or guardian in order to participate in USBC Certified Tournament where cash or merchandise prizes are offered. Said written consent must be on a form approved by USBC and must be on file with Tournament Committee at least one week before the bowler is eligible for tournament competition unless the student is accompanied by his/her parents, in which case the parental consent form may be filed up to the time the student starts to bowl. USBC Rule No. 13.

5. The total cost per person for each event shall be:

Only bowlers paying the \$5.00 for the All-Events will be eligible for the cash awards. PRIZE FEE WILL BE RETURNED 100 PERCENT IN EACH EVENT At least 1 of 10 of participants in each event will win prizes.

Note: Contestant may win only one cash prize event (gross or net), whichever cash prize is higher. Excluding special prizes. Awards will be presented to the Contestants who roll the highest gross and highest actual net scores in each event.

6. SUBSTITUTES. Bowlers may compete only once in each event. However, the tournament manager may allow a bowler who has previously bowled to substitute on a four bowler team when one of its original entrants is absent. The score of such bowler in the team event rolled with his entering team must count for all events. No one may bowl in this tournament except those originally entered before the tournament opens or such substitutes who may be authorized by the captain of a team or his appointee provided the individual whose name appears on the entry blank is unable for sufficient reason to at- tend the tournament at the time scheduled. The National Fraternal Director shall have power as to the substitutes that are offered by the captain or his legalized representative, and if accepted, each substitute must bowl each event under his full name and only at scheduled time in each event. The substitutes score and handicap from the said event will be used.

7. Any contestant whose current average as of March 15, 2022 of at least 21 games is ten pins or more above his highest average from the previous season must use his current average.

HANDICAP - Handicap (Men) allowed will be 85% of the difference between 240 and last season's 2020-2021 highest sanctioned league average of at least 21 games. Bowlers who have no established average will use their highest sanctioned league average of at least 21 games as of March 15, 2022. Male bowlers who have no established average for this year or last year will be listed as 175 average and will be handicapped accordingly. If the bowler does not have a sanctioned average over the last two years, but has competed in the Joint Fraternal Tournament, the most recent 5 year history from the Joint Fraternal Tournaments will be used. Male bowlers with an average over 240 will receive no handicap and will bowl scratch in the tournament.

Handicap (Women) allowed will be 85% of the difference between 200 and last season's 2020-2021 highest sanctioned league average of at least 21 games. Bowlers who have no established average will

use their highest sanctioned league average of at least 21 games as of March 15, 2022. Female bowlers who have no established aver- age for this year or last year will be listed as 150 average and will be handicapped accordingly. If the bowler does not have a sanctioned average over the last two years, but has competed in the Joint Frater- nal Tournament, the most recent 5 year history from the Joint Fraternal Tournaments will be used. Female bowlers with an average over 200 will receive no handicap and will bowl scratch in the tournament.

Under no circumstances will handicaps be increased after participant has bowled.

Contestants in this tournament are not required to report any tournament prize winnings for the previous 12-month period.

8. FALSIFYING AVERAGES - PENALTY - The team captain is responsible for reporting all averages of the individual team members, and they are responsible to him. Should the Tournament Committee find at any time that the averages have been falsified, the team shall forfeit all claims for prize money as well as their entry fee and will be subject to disqualification and suspension from organized bowling.

All prize winners are subject upon request to submit an affidavit of correct

league averages. 9. Rerating of Bowlers - According to USBC Rule No. 319 A-E, bowlers may be rerated by the Tournament Committee.

10. All entry applications and bowling fees are to be sent directly to: Kevin Collins, 628 Heather Brite Cr., Apopka, Fl. 32712; not later than April 11, 2022. Rule 310-A2 is in effect.

11. Bowlers who participate in tournament games must be dressed in a presentable manner to appear before public and when possible to use an emblem attached to shirt or dress so that participant can be identified.

12. Both USBC and eligible non-USBC members may participate in moral support tournaments with high score protection automatically extended to USBC members. Eligible non-USBC members can qualify for high score protection at their option by paying a \$21.00 fee for which the Congress will issue an unattached membership card.

13. NO MONEY WILL BE REFUNDED. All prize fee money will be paid in prizes.

14. In the Doubles contest the names of both members of the team must be given, because entries with the word "Partner" will not be accepted. Entry blanks so compiled will be returned and the entry money retained until proper blank is received. If both entrants in the Doubles event appear when scheduled, it is understood that they must bowl as they have been entered on the original entry blank and no change in position will be allowed at any time after entry blank has been filed.

 Assignment of Alleys - The Tournament Committee will make up the alley assignments for all entrants in the Doubles, Singles and Team Events. Entrants in the Doubles and Singles Events are required to report fully 30 minutes prior to the time they are scheduled to bowl.

Captains of teams must report their line-up at least 30 minutes before scheduled to bowl.

16. In the Doubles & Singles Events bowling entrants will bowl all six of their games on the same pair of lanes. Bowlers entered in the Singles Event only will be assigned to alleys by the Committee. 17. A team may use a name other than its league name for tournament entry without the payment of additional membership dues as formerly required.

18. Failure to use the correct average shall disqualify score if submitted average is lower than correct average thereby resulting in a lower classification or more handicap. Prize winnings shall be based on the submitted average if it is higher than the correct average. However, corrections in averages may be permitted up to the completion of the first game of a series.

### **IN MEMORIAM**

### The Life of ElNora Metroka Rusnak (1935-2022), by Anthony Rusnak

ElNora Metroka Rusnak, a lifelong Jednota member, was born in 1935 in Scranton, PA. Her great-grandparents counted among the first wave of Slovak immigrants escaping cultural suppression from the Austro-Hungarian Empire around 1880. Her parents, Anthony Metroka, and Helen Kozub, were both born in Wilkes-Barre, Pennsylvania in 1906. The children of coal miners, they later moved to Scranton for a new job.

A life centered around music came early to ElNora. Around 1943, her mother took eight year old ElNora to a singing teacher for lessons, for she was a natural talent and determined to learn. ElNora's singing voice was so beautiful. Even answering the phone "hello" was a

little song. Her "Ave Maria" was spot on.

St. Mary's Byzantine Catholic Church in Wilkes-Barre benefited from her trained voice and natural talent. In the choir, she mastered the liturgy - Chrysostom and Basil, the matins, the vespers, and even the Holy Week and Easter services. She was confident and capable, but rarely was offered the lead cantor role in the male dominated choir. This strong willed teen was not happy being limited by her gender.

In her late teens, she and her girlfriends formed the choral group, "The Chansonnettes," which performed throughout eastern Pennsylvania. Her brother Dan loved to play the drums, and introduced her to the club scene, and she occasionally performed as his band's lead singer.

ElNora was smart and had a determination not just to finish high school. With her parents' support and despite questions about her going to college, she earned a degree in accounting from Wilkes College in 1957. ElNora did not see the option of getting a college degree and having a family as mutually exclusive, and she confided to a friend, "I want to have a dozen kids."

When her Aunt Verna from the Chicago area invited her to come live with her, ElNora left Wilkes-Barre. The real love of ElNora's life, however, was Nicholas Richard Rusnak. His parents were part of the final wave of immigrants to come from Slovakia in the early 1920s. His father, Andrej, was a steel worker, and his mother, Maria, was ... unhappy with life in the United States. A determined and headstrong woman, Maria did what many immigrants at that time dreamt of doing: she took her five children she birthed in the United States and moved them back to Slovakia in the early 1930s. Her husband, Andrej, and her oldest son, Andrew, stayed in the United States, sending money back to Slovakia. Initially, life in Slovakia was good for the separated family.

For the family, the Greek Catholic Church was now central to their life. World War II, however, brought great hardship, and tragically left 14 year old Nick orphaned in Slovakia. Eventually, he and his siblings found their way back to the United States.

While visiting her brother and attending liturgy at the small mission church in San Diego, Holy Angels Byzantine Catholic Church, ElNora met her future husband Nick when singing in church and he was smitten by her voice. They shared the same ideals: a devotion to their Byzantine Rite Church, a love of music, a love of Slovak culture, and a commitment to education. Nick was also a great dancer and an excellent cook and he found his life partner. In time, ElNora sewed her own wedding dress, and she and Nick were married in Chicago. In the 1960's, they lived in Southern California and raised a family of 11 children. Holy Angels parishioners were the source of many of ElNora's friendships, as were the cloistered nuns across the street.

They sent their children to parochial schools, a great expense to the family, but education was worth the cost. To defray the cost, in the late 1970s, ElNora obtained teaching credentials, and began substitute teaching fourth grade at St. Didacus Elementary School. Her husband Nick worked overtime to pay the mounting food bills. When their asthmatic child passed away in 1982, at age 11, ElNora, Nick and the family were shaken to the core.

Nick's brother, Bishop Mike, suggested that ElNora and Nick form a Slovak Heritage organization in San Diego. These organizations were common in Canada and the eastern United States, but non-existent in Southern California. With Nick's culinary skill for Slovak fare, ElNora's organizational skills, and enough of an interest among their children to form a dance group, ElNora had suddenly found an outlet for her boundless energy.

The Slovak Heritage Association quickly expanded outside of the congregation. With the other Slovak Heritage members, ElNora organized Slovak picnics, Christmas dinners, and cultural events. A hundred in attendance was not unusual. A number of the Association's events occurred at the newly built Holy Angels Byzantine Catholic Church. The church's congregation also grew as a result of this influx of new visitors. Even though ElNora did not speak Slovak, she could phonetically sing the traditional Slovak songs as well as a native born Slovak. She was the cantor on Holy Days, but on Sundays she shared cantoring with her male counterparts. Old traditional stereotypes were hard to break, but ElNora was undeterred. With the approval of the priest, she became the first female to sing the epistle on a Sunday morning liturgy at Holy Angels - with a few parishioners walking out in protest. She ultimately became the first female cantor at Holy Angels as well.

In 1987, ElNora posed an idea to Nick about going to law school. Nick agreed, and ElNora was accepted into the first class of law students with National University. Upon graduation in 1990, she flawlessly sang the National Anthem.

In the years that followed, she enjoyed weddings, grandchildren, Nick's eventual retirement, the Holy Angels choir, some travel, Slovak cultural events, and occasional part time work. In February 2003, she lost her lifetime partner. ElNora still had much to give, especially to her grandchildren. She genuinely enjoyed the company of the children, taking them on outings or just picking them up from school and quizzing on times tables.

In 2017, ElNora no longer felt comfortable driving, and she progressively became homebound. She suffered a series of health setbacks. ElNora passed away to the Lord on January 12, 2022.

The epitaph on her headstone will be in Slovak, translated to English, "OUR DEAR MAMA." This epitaph hardly begins to describe her energy, her dogged determination, her accomplishments, her strength of character, her love of family, her love of Slovak culture, and her truest passion, singing. It truly was beautiful.

It is difficult to say "goodbye,"

we long to hear you sing "hello,"

just one more time, a little song,

a chansonnette.




### United Slovak Societies offer scholarship grants in Lorain Ohio

Elizabeth Slezak was born on July 6, 1903, in Sabinov, Slovakia, the daughter of Louis and Mary (Hrapchak) Slezak. When she was six years old, she emigrated to the U. S. to join her father Louis who had been working in Pittston, PA, as a shoemaker. Three years after arriving, she transferred to St. John's School, particularly to prepare for First Holy Communion. Classes were held under the church and her teachers were two novices in the Sisters of Saints Cyril and Methodius, Sister Pius who later became General Superior, and Sister Annunciata who taught Kindergarten and first grade. Sister Helena never forgot their gentle expressions and kind words.

As a child Elizabeth was attracted to the long rosaries the Sisters had. They were worn at their sides and were attached to their cinctures (belts around their waists.) Elizabeth wanted to purchase one for herself from the Sisters at St. John's Convent in Pittston. Evidently they told her they had none to sell, but with the determina-

tion of a youngster, she crossed the street to the convent of the Sisters of the Immaculate Heart of Mary and obtained one from the "Sisters in blue."

When Elizabeth's mother was reluctant to let her enter the SSCM's, (It seems that mothers who have all boys and only one girl feel reluctant about letting her become a Sister), Elizabeth reminded her that Sister Joachim who had lived on their street in Exeter had been accepted the year before. She told her mother, "If they accepted her, who is so small, surely the Sisters will accept me." When Elizabeth was accepted, she met Mother Monica, director of novices, whom she remembers for her gentleness. In her second year as a novice Sister Helena went to Vandergrift where she was a substitute teacher for two months.

Sister Helena has many memories of her days with the SSCM's. Two stand out—the retreats in which she participated over six decades and the plays she directed every December and June and whenever an assembly was required. A special joy was preparing the boys to be servers at Mass. Later when some of them became priests, she was especially delighted to participate in their Masses. An outstanding quality she possessed was her willingness to meet every situation as it occurred, being pliable and accommodating. No doubt one source of her ability to meet any demand was the peace she found in prayer.

Sister Helena died on August 17 and her funeral was celebrated on August 18, the traditional feast of St. Helena, mother of the Emperor Constantine who was instrumental in Christianizing the Roman Empire. According to historians St. Helena persisted in the search for the True Cross. She was also a builder of Basilicas. Our Sister Helena prepared a dwelling place for God in her own heart and soul and in the souls of thousands of young people. She carried with her a sense of the Holy of Holies. (from the tribute to Sister Helena.)

Father Edward Deller, Maria Hall chaplain, celebrated Sister's funeral with concelebrants Father Waters and Father Suknaic.

### A Mother's Enduring Faith

In Chapter VIII of his Confessions, Saint Augustine writes, "For Thou, O our God, shalt lighten our darkness: from Thee riseth our garment of light; and then shall our darkness be as the noon day." This sentiment reveals Augustine's journey from spiritual desolation to his discovery that fulfillment is only found in pursuit of a relationship with God.

In his Confessions, Saint Augustine describes losing his way many times and for long periods throughout his life, but his story also demonstrates how God pursued a relationship with him and continually invited him to walk in the light of Christ. One of the greatest gifts God placed in Augustine's life was Saint Monica, his mother, a devout Christian who became a saint through the practice of an abiding faith.

While Augustine strayed from the faith often in his youth and well into adulthood, Monica remained steadfast in her loyalty to God and continually invited her son and her husband, who was a pagan, to discover the joy of sacrificial love. Saint Monica epitomized The Christophers' motto, "It's better to light one candle than to curse the darkness," because she never gave up hope and always chose to believe her loved ones could find their way.

Monica's influence on Augustine, who became one of the greatest saints in Church history, and on her husband, who converted to Christianity on his deathbed, demonstrates the power of faith to transform the lives of those around us. The Christophers' recent prayer card captures this profound sentiment that faith can guide us to God and help us lead others along their own path to Christ. Our Faith Prayer Card articulates the language of the heart reaching out to God, and this was the type of faith Monica practiced as she continually spoke to God, in fervent prayer for the spiritual well-being of those she loved.

In the opening of his Confessions, Augustine writes, "Thou hast made us for Thyself, O Lord, and our heart is restless until it finds its rest in Thee." These are the words of a man who had searched the world for happiness and found that only God could lead us to true and lasting joy. Imagine what a sense of reward his mother must have felt to know her son had come home to the faith. She lived to see him baptized by none other than Saint Ambrose, who had adopted Augustine as a spiritual son after the death of his father.

Monica died in the same year Augustine was baptized, living to see the conversion of the two men she loved most in the world. What a triumph this was for her life of prayer and her patience in waiting on God to mold the hearts of those for whom she prayed.

The story of Monica and Augustine demonstrates that faith and patience go hand in hand, because it is only in patience that we demonstrate our faith. We must have the courage to believe in God even when things don't work out exactly as we want. Faith is about knowing that God is at work in the world and is constantly guiding events to bring about the greater good. Only when we have that kind of faith can we focus on all we are called to do to play our part in God's plan of love for humanity. And when we exercise that kind of faith, we exercise the virtues that animated Saint Monica and her beloved son Saint Augustine
