## Message from the President


Over the weekend I was surfing the TV channels as most of us do. I came across a program on PBS (Public Broadcasting Service) that I had seen several times before. It is called "History Detectives".

Previously, I had watched them researching the backgrounds of various well-known celebrities; researching their ancestors (their roots, so to speak). They had researched

ancestors who had served in the military going back to the Civil War and beyond. Many of the stories were fascinating and many uncovered the lives of ancestors of the guest celebrities that they never knew and facts that were very surprising and many times uplifting. The last week's program was about a person who came across a recipe book that he found in the estate items of a deceased uncle. The recipe book was from about the 1860's and was about a method to cut or extend the volume of alcohol spirits. but not how to distill alcohol.

What's my point? History is important. What if no one had kept a copy of the Magna Carta? Or the Declaration of Independence? Or the Bible? What if the Wright Brothers airplane had not been preserved in the Smithsonian in Washington DC along with the Mercury Space Capsule and the shoes Judy Garland wore in the Wizard of Oz?

This is true for all of the exhibits in museums across the world, from well-known, very valuable items to items that were more common, such as an old hat worn by coal

miners in Pennsylvania.

You have heard the saying that "If you don't learn from history you are doomed to repeat it" (George Santayana, 1905).

Many of you have items in your attic, garage, or items that you have that have been passed down from parents, relatives etc. I am referring to items that are related to Slovak culture and/or history such as Slovak kroj (folk costumes)

and items related to the old Slovak churches such as paintings, etc., or the First Catholic Slovak Union, for example, the Lodge banners used to parade into Church, or badges or pins or pictures.

If we do not preserve our Slovak heritage who will?

Several times a month I receive a call or a letter from one of our Members who wants to donate items for our Museum. We have to be selective, but will consider everything. A problem is that our exhibit space is limited to the hall and the Board Room. Most of the items are displayed in our hall.

Others have expressed an intention to donate a large number of items to the Society. However, we need to expand our space in our building to do this. That would mean that we would have less space for tenants and less income. The Board has previously approved \$50,000 for a study and proposals to not only expand our existing museum, but also re-do our office space since it is original since 1988.

A few people are opposed to expanding our museum space because we would lose tenant income. That may be true but our Catholic Faith and our Slovak heritage must be honored and preserved for future generations. You may have heard the saving. "You cannot know who you are if you don't know where you came from." We can hear future generations asking, "Where did great grandpa come from? What is a Slovak? Where is Slovakia?"

I repeat, if we do not preserve our Slovak and Society heritage, who will? It is our duty to do so. I hope you agree. Please give me your comments.

# Message from the National Chaplain The week between the second and third Saturdays in May is Armed Forces Week in the United States. The third Saturday in May

is Armed Forces Day.

Prior to the creation of the Department of Defense during the administration of President Harry S. Truman, the Army and the Navy had their own days of celebration. Louis Johnson, Truman's Secretary of Defense, is credited with establishing Armed Forces Day on August 31, 1949 to unite the separate celebrations.

Armed Forces Week and Armed Forces Day honors active members of all branches of the military: Army, Marine Corps, Navy, Air Force, Space Force, Coast Guard, Army National Guard and Air National Guard. The Week and the Day are intended for us to show support for those who risk their lives to keep us safe and reserve and



protect the freedoms we cherish.

The Archdiocese for Military Services, USA was established as a separate and distinct archdiocese by Saint John Paul II in 1985. Archbishop Timothy Broglio is currently assisted by 4 auxiliary bishops, each with a specific responsibility assisted by 4 auxiliary bishops. bility in caring for the pastoral needs of military personnel. Catholics on active duty in all branches of the armed forces, including the National Guard when on active duty under a federal mandate, along with family members living them while away of active duty, and military priest-chaplains are all part of this archdiocese.

Countless videos are available showing members of the military catching their loved ones off guard when they come home unexpectedly. Some haven't seen each other for months and it is very heartwarming to see the hugs and kisses exchanged.

Armed Forces Day and Armed Forces Week reminds us think of those who are now serving their country, thank them for their service, and pray that they receive the graces of courage and perseverance to protect and defend the nation, and for them to rely upon the help of God in the performance of their duty.

## Ukrainian Refugees

President Andrew M. Rajec presenting a gift to Bishop Milan Lach of the Byzantine Catholic Eparchy of Parma.

The First Catholic Slovak Union at its March 2022 annual Board of Directors meeting made a donation of \$50,000 for the refugees of the war in Ukraine.

It is estimated that the Russian invasion in Ukraine has caused millions of Ukrainians to seek safety in neighboring countries. Slovakia shares a 60-mile common border with Ukraine with three official border crossings. Many FCSU members had and still have ancestors that came from Eastern Slovakia.

About 200,000 Ukrainians have sought refuge in Slovakia, with potentially more coming. The FCSU wired \$25,000 directly (the check was symbolic) to the Slovak Catholic Byzantine Eparchy in Košice, Slovakia, which directly adjoins Ukraine, was one of the first Catholic agencies in Slovakia to help refugees.

Bishop Lach is a member of the FCSU. He is also a Jesuit priest.

Another \$25,000 was sent to the US Bishop's fund for refugees in Ukraine to assist Catholic relief for refugees from the conflict in Ukraine.

We offer our prayers, in addition to monetary help, for the refugees and pray that the conflict will end and Peace can return to Ukraine as soon as possible.

We believe that we as a Catholic Society have an obligation to help our fellow man/woman in their time of need.

#### LIGHT ONE CANDLE

Ten Commandments Lead to Happiness
(Desať prikázaní vedie k šťastiu))

Christ said, "Whatever you wish that men would do to you, do so to them; for this is the law and the prophets" (Matthew 7:12). This idea that God's law pertains to how we treat others was later reiterated by St. Paul in his letter to the Galatians, when he wrote: "For the whole law is fulfilled in one word, 'You shall love your neighbor as yourself'" (Galatians 5:14).

We know these statements aren't telling us to ignore all other laws because Christ also said, "Think not that I have come to abolish the law and the prophets; I have come not to abolish them but to fulfill them" (Matthew 5:17). Therefore, we must see Christ's words as a lens through which to interpret the law. When we do this, it opens our eyes to God's beautiful plan of love for humanity.

The Ten Commandments provide an excellent opportunity to apply Christ's wisdom to our interpretation of God's law. Many in today's society look upon the Commandments as a set of strict rules utilized to condemn people for wrongdoing. But when seen through the lens presented to us by Christ, they become a trustworthy and benevolent guide through life's trials.

For instance, we are commanded not to do certain things, like steal, kill, covet, commit adultery, or bear false witness. These commandments are all about loving our neighbor and treating them as we would want to be treated. So, we can see why love of neighbor sums up the law, and we can see the wisdom in the law being all about our relationship to others. It is also evident that the law guides us towards a fruitful life because no one who wrongs others could possibly be happy.

The other set of rules in the Ten Commandments relates to respect for God (Note that God put these first!). We are told not to take His name in vain, to keep holy the Lord's Day, and not to worship false gods. We are also told to honor our parents. This relates to our respect for God because respect for one's parents is the first way we learn to respect the order God intends for the world. We are given these commandments because God wants us to avoid the misery that results from bad decision-making. He wants to be our guide and commands us to keep Him as our beacon and lodestar, lest we be led astray.

It's also important to consider what Christ means in saying He came to fulfill the law, because sometimes we need a path back to communion with God and neighbor. Christ fulfills the law by showing us the way of mercy (milosrdenstvo). In the Beatitudes, Christ says, "Blessed are the merciful, for they shall obtain mercy" (Matthew 5:7). Here is another aspect of God's law relating to the command to treat others as we would want to be treated. For who among us would not want to be forgiven when we seek mercy for our faults?

Christ's command to show mercy reveals the heart of God because we're made in His image and are constantly being called to renew God's likeness within ourselves. Therefore, when we are told to be merciful, we can take consolation in knowing that God is merciful. So, Christ has provided us with a lens through which to see the law as being like a treasure map, drawn for us by a loving God, who desires nothing other than to lead us to true and lasting happiness

## Annual Report of the National Vice President

Dear Reverend Nasta, President Rajec, Executive Officers, and Fellow Board of Directors,

This is my annual report for the year 2021. It is divided into two parts. In the first almost nine months of the year, I served as National Fraternal Activities Director, a position to which I was elected at the FCSU's 51st Quadrennial Convention in Cleveland, Ohio, August 4-8, 2018. Then, at our Board of Directors Meeting held September 17 - 18, 2021, in College Park, Maryland, I had the honor of being elected by the Board to serve as National Vice President until the next FCSU Convention in 2022. The last three and a half months of 2021, I served the Society as National Vice President. I am only receiving a salary for the National Vice President position.

Report as National Fraternal Activities Director: January 1, 2021 – September 16, 2021

As Fraternal Activity Director, I immediately began managing & increasing the number and types of programs we sponsor from 3 or 4 a year to 10 plus. I have continued to regularly talk to my fellow board members and all members throughout the FCSU to ask about and respond to requests for new activities and get new, fresh ideas. In 2021, I promoted & managed the following:

- Jan: announced & opened extremely popular March Madness Contest 2021 in Jednota.
- Feb: Introduced new April Online Talent Contest for members in Jednota; announced 2020 NFL Loser Pool winners, with increased participation to 105 members Society-wide from this contest I initiated in 2019.
- Mar: announced & opened Kentucky Derby Hat 2021 in Jednota after receiving member requests to continue this contest; coordinated & announced winners for 2020 Christmas contests: kids & young-at-heart coloring; ugly sweater; and Christmas tree decorating. Three contests which were new since I took this office in 2019, with participation for all increasing to all-time high of 500 plus contestants overall.
- Apr: announced & opened registration for Aug National Golf Tournament in Jednota; also highlighted FCSU Traveling Challenge Cup in this issue, a highly successful competition I instituted in 2019. Recapped member names by Region that to date had been placed on the cup; also began to advertise 2022 National Bowling Tournament with Save the Dates for May 13 & 14, 2022.
- May: announced winners in Jednota of 2021 March Madness, noting participation increased to 186 members; announced winners of first-ever online talent show in Jednota.
- Jun: Announced winners of 2021 Kentucky Derby Contest, which more than doubled participation since previous year.
- Jul: announced final schedule of events for National Golf Tournament to be held the next month; opened new contest possibility to members for consideration Pen Pal Program with interested parties in Slovakia.
- Aug: announced & opened popular Loser's Pool Contest 2021; announced and introduced new contest based on member requests big game hunting contest; hosted & coordinated onsite member participation & events for National Golf Tournament held at Treasure Lake, Dubois, PA, Aug 6 8, 2021.
- Sep: announced winners of National Golf Tournament in Jednota, including highlights of all sponsors, contest winners, & golfers.

#### Report as National Vice President: September 17, 2021 - December 31, 2021

While my official title changed in September 2021, in some ways my duties remained the same. This is for several reasons. First, President Rajec asked me to continue performing the duties of the National Fraternal Activities Director under my duties as National Vice President. He did not appoint a new candidate to replace this vacancy on the Board. To date, the position has not been filled. Second, continuing to work at fraternal activities for our members is near and dear to my heart. My motivation for running for National VP was a lot of the same reasons that I ran for Fraternal Activities Director at our last convention. Namely, to help promote and strengthen fraternalism in our Society.

#### **Continuing Fraternal Activities**

So I continued to coordinate, announce, and manage fraternal activities throughout the remainder of the year. These included: new details for National Bowling Tournament to be held May 13 – 14, 2022 in Nov Jednota; announcing & opening four Christmas Contests for 2022 starting in Nov Jednota; beginning prep for contests to continue in 2022.

#### **Coordinating Quadrennial Convention**

Our bylaws dictate that FCSU Conventions should be overseen by a convention committee which includes the National Vice President. I was most pleased to introduce fresh new ideas to the convention program – including a fun "casino themed" evening before the official start of convention & a concluding evening at an extremely popular venue Top Golf which is located right next to our hotel.

#### Sales Input

The bylaws also say the VP oversees sales. Our sales more & more are coming through licensed agents and less & less through the old recommender model. As I have a strong background in sales and account management, I was very much looking forward to contributing to & working with the Executive Committee & the FCSU Director of Independent Agents in this area. However, I have had 2 meetings with the FCSU Director of Independent

Agents and requested monthly updates. This included rate comparisons and monthly sales figures and to be copied into the monthly flyer that is sent to the agents via the Director. As of the date of this report, I have only received 1 rate comparison for the 1st three months. The sales figures documents I received, were sent from the Executive Secretary.

#### **Meeting Members**

After reviewing the bylaws for the National Vice President position, I requested more direction from the National President.

Despite repeated requests to the National President, I have never received any additional direction for my duties as National Vice President. As my election to this office was never formally announced to the membership, I used my first three months as National Vice President to travel to as many member events and meetings as possible throughout our Society, as well as attending Home Office Executive Meetings in person so I could also get to know the Home Office staff. As I had no official guidance, all travel costs such as airfare, car rentals, & hotel reservations have been at my own expense.

What I've learned in my time spent among our dedicated members is that there is a strong need for opportunities to interact with one another, and a desire for better reasons to want to be active members once they've purchased a product from us.

I remain hopeful that working together as a Board and as a Society, we can ensure a strong future for the First Catholic Slovak Union.

# Annual Report of the National Treasurer

Fr. Nasta, President Rajec, Members of the Executive Committee and the Board of Directors,

I am pleased to present my report on the FCSU's finances and treasury operations for the year ended December 31, 2021.

I was elected to serve as National Treasurer in September 2021 to succeed Mr. George F. Matta II, who passed into Eternal Life earlier in the year and Mr. James Marmol, Director for Region 4 who was asked to act as Temporary Treasurer until a replacement could be voted upon by the Board. I can only hope to maintain their high standards. As such, my report and comments will reflect only on year end balances and on treasury activities since my appointment.

- Total assets increased by 16% to \$530,939,088 (2020 \$457,648,477)
- Insurance and annuities sold almost doubled to \$92,488,251 (2020 \$46,423,786), up
  - Surplus increased by 6.6% to \$46,657,607 (2020 \$43,771,595)
  - Net investment income decreased by 8% to \$18,621,567 (2020 \$20,225,043)
  - Net income for the year was \$2,880,203 (2020 \$3,552,357), down 19%

- Average investment quality was 6.99 (2020 6.42) on the NAIC 20 scale and approximately 1.49 on the NAIC 6 scale (both meaning investment grades between A2 and A3, the higher the better).

The FCSU had another strong year, marking the first time we ended up with over \$500,000,000 in assets, due mostly to large increases in policy and annuity sales, made possible by offering outstanding competitive products and retaining outside agents to sell them. This has led to sales to persons who would not normally be introduced to the FCSU's products.

Understandably, that has resulted in an increase in sales commissions paid, but worth it as it is part of the process of growth. Also, changes in some state regulations have dictated that larger policies and annuities must be sold by licenced insurance agents and brokers, also a reason for that increase.

IMR and AMR which are liability reserves to provide for changes due to changes in interest rates or asset valuations. These reserves are required by state regulators and are non-cash items caused by changes in amortization.

Surplus was at 8.8% of assets, comparing favorably to other insurance companies and in some cases, much better.

As we all know, interest rates have been rather low for the past few years. The FCSU's investment policy is to invest mainly in interest and income bearing investments (meaning bonds, notes, asset and mortgage backed securities, loans and SEC Rule 144a securities) as opposed to common and preferred stock. All of the FCSU's investments are in 100% compliance with the policy. Because of that, net

2 investment income decreased because of investments earning relatively high rates matured or were redeemed and had to be reinvested at current lower rates of return. As well, all of the incoming funds from the sales of new policies and annuities had to be reinvested at the best rates available to us.

The FCSU achieved a portfolio earning rate of approximately 4.6% at the end of 2021 (2020 - 4.39%). The FCSU achieved a 2021 average gross product margin of 1.16% (2020 - 1.27%), however, that rate is steadily increasing (was 1.34% at January 2022), which allows the FCSU to maintain its current rates it pays on its annuities. Average gross product margin

is the portfolio earning rate less the rates it pays out on its annuities and other products.

With rising interest rates, that would tend to increase the rates we earn on our new investments; however, most of the FCSU's investments are currently tied up for longer terms. New investments tend to have shorter times to maturity. The FCSU's investment philosophy is to hold investments until maturity as opposed to active daily buying and selling. This allows us to lock in rates of return, irrespective of what the markets do. However, interest rate changes can cause unrealized gains and losses (another non-cash accounting number), because of changes in market values due to changes in yields, which does not matter so much as again, the FCSU tends to hold to maturity. Over time, unrealized gains or losses disappear at the time of maturity.

The 2021 year saw challenges for most of us, both in the investment markets and also the way we live. The COVID 19 pandemic continued to wreak havoc and government administrations changed leading to effects in regulations and fiscal and monetary policies. Throughout all of this, interest rates stayed low, stock markets reached new highs, unemployment decreased as employers opened up again, energy costs and inflation stayed low for most of the year but started to trend sharply upward toward the end of the year.

With interest rates expected to rise a fair amount during 2022, we would love to be able to hold onto our cash until rates are higher and then invest, however, circumstances dictate that we keep reinvesting. Most of the FCSU's investments are in the \$1-3 million range with maturities ranging from 2 to 40 years. We generally look for investments with grades in the low A's to mid B's, anything lower is generally out of the question. This policy allows for a respectable comparative yield with lower risk.

The FCSU's Executive Board and its Board of Directors are faced with constant reinvestment activity and having to make the decisions that move the FCSU forward and in the right direction. To assist with this, the FCSU engages professional asset managers (currently AQS Asset Management) to assist in locating new investment vehicles and sales and redemptions in its portfolio. AQS Asset Management specializes in managing portfolios for other small or fraternal insurance companies. I greatly appreciate their assistance and wise counsel in assisting us to make informed investment decisions.

In addition to these activities, I have also made inquiries as to the FCSU's financial systems, controls, record keeping, compliance, risk management, strategic planning and cash management. I have found all of those to be more than satisfactory. I have also enquired as to adequate insurances and records being kept for the FCSU's fixed assets, which I also found to be satisfactory.

2021 was a challenging year in that decisions were made to position the FCSU for constant strong future growth as opposed to a view with a shorter time horizon. Because of those underlying structural changes, investment income and net income did decrease, however, both the Board and I firmly believe 3 that 2022 and onward will be better and will exceed our expectations, because of increased assets and rising interest rates.

With the restrictions on the COVID-19 pandemic being slowly lifted, I will be able to and look forward to getting out and about and meeting many of you. Any questions on our treasury activities or my report can be directed to me through the Home Office.

To introduce myself, I have over 37 years of financial experience with public and private companies. I continue to be active in my home Branch 785 and District 19 activities, acting as the District's Fraternal Activities Director, Financial Secretary and Treasurer. I am a member of the Branch's local bowling league and have participated in the International Bowling and Golf Tournaments for many years.

Thank you for allowing me to be of service to your Society and wishing everyone the best in the year to come.

and evaluation, risk assessments were an integral part of my work. #### TREASURER'S REPORT:

Treasurer John Tokarsky gave a detailed update on the investments and answered the Board's questions.

#### FINANCIAL REPORT:

#### **Executive Secretary's Report**

The President and the Executive Secretary presented a detailed summary of the Financial Report for the third quarter of 2021. After the Executive Secretary's report, he answered the Board's questions. He also stated we are in the process of completing the fourth quarter financial report and once completed, it will be sent to all Directors.

#### Federal Home Loan Bank of Cincinnati

The Executive Secretary submitted a written report to the Board of Directors giving a complete update of the investments and all current transactions with the Federal Home Loan Bank of Cincinnati.

#### Portfolio Custodian

The Executive Secretary updated the Board of Directors on the report from our portfolio custodian, Key Bank, found everything in order, and answered the Board's questions.

#### Investment Updates

The President, Executive Secretary, and Treasurer led a review on the investments and transactions with the UBS Fund, MAI Fund, and the Clutterbuck Fund. Following the report, they answered the Board's questions.

#### PRESENTATION OF THE EXECUTIVE COMMITTEE REPORTS:

#### Executive Committee

The Executive Secretary gave a report on the Executive Committee Meetings. He stated that in accordance with the Bylaws of the First Catholic Slovak Union, the Executive Committee meets monthly and whenever else it is necessary to take care of the business of the Society.

The Executive Secretary stated all investments were made in accordance with the laws of the State of Ohio and with the investment policy adopted by the Board of Directors. The Executive Committee members work very closely with AQS Asset Management Company, and all investments are approved by a vote of at least three members of the Executive Committee.

#### Scholarship Committee

The Executive Secretary gave a report on the Scholarship Committee, which is comprised of three independent professional educators. Applications for the Jednota Benevolent scholarships are being received and they will be sent to the Scholarship Committee. The Executive Secretary also gave a report on the Jednota Benevolent Foundation and answered the Board's questions.

#### **VICE PRESIDENT'S REPORT:**

The Vice President gave a production report on our agents to the Board of Directors. He stated we are still recruiting and adding new agents, and at present have over 450 agents. This represents fewer than 17 agents for each of the states we are licensed in. The Home Office is sending monthly updates on our products to our independent agents. The Home Office continues an extensive recruiting campaign to recruit agents in the states we are licensed in. The Home Office is currently targeting agents in the 27 states we are licensed in. Annuity sales are well ahead of plan.

The Vice President is working with the Home Office and the outside marketing firm to develop new recruiting campaigns to recruit agents we are currently licensed in.

#### **PROPOSED BUDGET 2022:**

The Executive Secretary presented the proposed budget for 2022 to the Board for approval and answered any questions. A motion was made by Michael Lako and seconded by Martha Zavada to approve the proposed budget for 2022. Motion carried.

#### **DISASTER RECOVERY PLAN:**

The Executive Secretary presented the updated Disaster Recovery Plan which included the Information Security Program (Cybersecurity). A copy of the plans were available for the Boards review. A motion was made by Michael Lako and seconded by James Marmol to accept the plans. Motion carried.

#### LIFE INSURANCE PROGRAM:

The Executive Secretary updated the Board on the current life insurance program being offered to all members under the age of 80. 350 members took advantage of this offer. The Executive Committee will review the program and discuss if they should re-run the program or develop a new life insurance program.

#### **CONVENTION:**

The Executive Secretary said that the estimated delegate count letters have been mailed out to the Branches who qualify to attend the Convention. He stated that the estimated number of delegates is based on the number of members as of October 1, 2021. The final delegate count will be based on the number of members as of February 1, 2022.

The Executive Secretary stated that electronic voting machines will be used again at the convention for all motions and the election. The voting process will be explained to the delegates.

The Executive Secretary stated that the Home Office is working on a Plan B for the convention due to the pandemic. The Home Office is looking at options for a virtual convention to be held, if necessary. This is not anticipated, but the Home Office is preparing just in case.

#### LONG TERM PLANNING:

The President stated that he received long term planning strategy proposals from two different consulting firms. He will present them at the Board of Directors meeting in March for review.

#### **DIRECTOR OF FRATERNAL ACTIVITIES REPORT:**

Director of Fraternal Activities Kevin Collins gave an overview of the NFL Losers Pool, Hunting Contest, Ugly Sweater Contest, Tree Decorating Contest, and Coloring Contests. He is looking into expanding the coloring contest to more age groups.

The Director of Fraternal Activities is looking forward to holding the Kentucky Derby Hat Contest and a virtual Faster Basket Blessing

The Director of Fraternal Activities stated that a regional picnic is planned for June 12, 2022 in Novelty, Ohio and is looking into holding a picnic at Frogbridge in New Jersey and at Knoebles Amusement Resort in Pennsylvania. More details will follow.

The Director of Fraternal Activities stated that he is looking into activities to be held during the Convention. The possibilities include a casino night on Saturday night and either a boat trip or a party at Top Golf on Monday night. More details are to follow.

#### MATCHING FUNDS:

The President is developing a matching funds program and will present it to the Board at the Annual Meeting for review.

The March webinar explored one of the world's biggest challenges: ocean pollution. Slovak architect Lenka Petráková, winner of the 2020 Grand Prix Award for Architecture and Innovation of Sea from the Jacques Rougerie Foundation - Institut de France, presented her design concept, "The 8th Continent," which offers a solution to a crucial part of this problem. Adding to the discussion was Bonnie Monteleone, founder of Plastic Ocean Project, a non-profit whose mission is to educate the public through field research and implement outreach initiatives addressing the global plastics pollution problem, and Nick Adamo, technology executive and founder of Making a Mark, a charitable foundation dedicated to empowering change through awareness, knowledge and inclusive opportunities targeting the environment and education. The webinar offered excellent ways each of us can reduce ocean waste.

In late March, a webinar on Slovak Easter traditions and delicious dishes was appropriate for the season. The webinar was presented by Global Slovakia founders Dr. Gabriela Bereghazyova and Dr. Zuzana Palovic. In April these two accomplished women virtually launched their new book Super Slovaks / Super Slováci with an interactive discussion and presentation of their 270-page vividly illustrated bilingual book that tells the story of Slovakia through 50 personalities that shaped the country. It was exciting to see so many Jednota members engage in the question-and-answer session.

In May, there was a virtual launch of the children's book Ja som Milan, the fascinating biography of a great Slovak statesman, soldier and scientist, designed to entertain audiences both young and old. The authors, Róbert Čemerička and Stanislava Čemeričková, took the audience behind the scenes of the creation of this unique, beautifully illustrated book which depicts the life journey of General Milan Rastislav Štefánik, one of the greatest heroes of Slovak history. The young authors based in Slovakia are working on a series of books depicting the true life stories of Slovakia's heroes – in summer of 2021 they released Ja Som L'udovít a book about L'udovít Štúr and are working on Ja Som Hana about Hana Gregorova whose most famous book is called Ženy (Women) released in 1912.

To conclude the webinar series, in June, a panel of Slovak-American medical doctors discussed how the pandemic, as a chronic stressor, impacts our brains, emotional regulation, decision making, impulses and daily interactions. The panel included renowned scientists and clinicians.

Thank you to the Jednota members that participated, if you did not have a chance to watch live, I encourage you to view the recordings.

Region 1 Picnic: In 2021, I was excited to once again organize the Region 1 Summer Picnic which has become a fun annual summer tradition. The picnic was an initiative on my part as Region 1 Director to have a joint event when I first became Regional Director. Branch 746 had hosted a summer picnic but with my branches financial support, we were able to extend the invitation to all the branches of the region!

After a long hiatus from in-person events, members gathered on a beautiful sunny Sunday under the shade of the Linden trees to spend some quality time together and enjoy delicious Slovak food including holupky, halusky, BBQ ribs, chicken cutlets, sausage and kraut, the obligatory picnic hot dogs, Slovak cucumber salad, watermelon and more!! After enjoying some delicious home-made desserts and refreshing fruit, courtesy of the ladies of Branch 45, 290, and 746, the mood was set for singing of some traditional Slovak folk songs. The young (and young at heart) enjoyed the playground at the park and some special games while others indulged in some wine from Indian Trail Winery courtesy of Slovak winemakers and Jednota members, Mr. and Mrs. Stefan Cuchran. United Nations: On September 14th leaders and professionals from the Slovak community were invited to the residence Permanent Representative of the Slovak Republic to the United Nations, H.E. Michal Mlynar who hosted a reception on the occasion of the official visit of Slovakia's Minister of Foreign and European Affairs, H.E. Ivan Korčok. The event marked the

start of the 76th session of the United Nations General Assembly. I was honored to be attend and represent the FCSU.

Gala Evening in NYC: On November 15th the Slovak Permanent Mission to the United Nations hosted a special Gala Evening in celebration of the 76th anniversary of the United Nations and commemorated the 125th anniversary of the birth and 30th anniversary of the death of Dr. Ján Papánek, the first Permanent Representative of Czechoslovakia to the UN, and one of the fourteen co-authors of the UN Charter. On the occasion of the 100th anniversary of his birth, another important Slovak was remembered, Slovak, Alexander Dubček. Both leaders dedicated their lives to the fight for freedom and democracy, but also to humanism, human dignity and service to the people. By invitation of Permanent Representative of Slovakia to the United Nations, Ambassador Michal Mlynár and his wife Andrea I was honored to moderate the event. Amongst those in attendance was the President of the 76th session of the United Nations General Assembly and Archbishop Gabriele Giordano Caccia, Permanent Observer Of The Holy See To The United Nations. Notes of congratulations were also shared by Secretary General of the United Nations and Former Secretary of State Madeline Albright. The program featured Slovak-American performers including Broadway star Luba Mason of Branch 45.

## OSN: Z Ukrajiny už utiekli 4 milióny ľudí, z nich 281.172 na Slovensko

Ženeva 30. marca 2022 (TASR) - Ukrajinu od začiatku ruskej invázie 24. februára opustili už viac ako štyri milióny obyvateľov. V stredu to v najnovšej správe uviedla Organizácia Spojených národov (OSN), podľa ktorej na Slovensko zatiaľ prišlo 281.172 utečencov z Ukrajiny. TASR prevzala správu od agentúry AFP.

Úrad vysokého komisára OSN pre utečencov (UNHCR) informoval, že z Ukrajiny utieklo celkovo 4.019.287 ľudí, z nich viac ako 2,3 milióna prešlo cez ukrajinsko-poľské hranice. Zhruba 600.000 ľudí utieklo pred vojnou do Rumunska, viac ako 387.000 do Moldavska a 364.804 ľudí prekročilo ukrajinsko-maďarské hranice.

OSN uviedla, že svoje domovy od začiatku ruskej vojenskej invázie opustilo viac ako desať miliónov Ukrajincov a takmer 6,5 milióna z nich sú vnútorne vysídlené osoby.

## UN: 4 million people have already fled Ukraine, 281,172 of them to Slovakia

Geneva, March 30, 2022 (TASR) - More than four million people have fled Ukraine since the start of the Russian invasion on February 24. The United Nations (UN) said this in its latest report on Wednesday, according to which 281,172 refugees from Ukraine have arrived so far. TASR picked up the report from the AFP agency.

The Office of the United Nations High Commissioner for Refugees (UNHCR) reported that a total of 4,019,287 people have fled Ukraine, of whom more than 2.3 million have crossed the Ukrainian-Polish border. Roughly 600,000 people fled the war to Romania, more than 387,000 to Moldova, and 364,804 people crossed the Ukrainian-Hungarian border.

The UN has said that more than ten million Ukrainians have fled their homes since the start of the Russian military invasion, and nearly 6.5 million of them are internally displaced

## Ukrainian President V. Zelenskyy receives the State Prize A. Dubček Award

This follows from the resolution approved by the government on Wednesday.

Bratislava, March 9, 2022 (TASR) - The government of the Slovak Republic will award Ukrainian President Volodymyr Zelenskyy with the Alexander Dubček State Prize on the occasion of the 100th anniversary of his birth. This follows a resolution approved by the government on Wednesday, March 9.

The awarding of the Alexander Dubček State Prize involves a financial reward of 25 times the average monthly nominal wage of an employee in the economy of the Slovak Republic published by the Statistical Office of the Slovak Republic for the previous calendar year in which the submission is made, rounded up to the nearest euro.

Bratislava 31. marca (TASR) - Minulý rok na Slovensku zomrelo viac ako 73.000 ľudí, čo je najvyšší absolútny počet od roku 1919. Celková nadúmrtnosť bola vlani na úrovni 37 percent. Najčastejšou príčinou smrti boli choroby obehovej sústavy, druhou bol COVID-19. Najviac ľudí zomrelo v januári. TASR o tom informoval Štatistický úrad (ŠÚ) SR.

"Pandémia ochorenia COVID-19 Illustration (photo by TASR) spôsobila výrazné zvýšenie mier úmrtnosti na Slovensku, už v roku 2020 prekročil

počet zomretých hodnotu 1000 úmrtí na 100.000 obyvateľov a v roku 2021 sa zvýšil až na 1350. Ide naozaj o najvyššiu hrubú mieru úmrtnosti v povojnovej histórii Slovenska," spresnila riaditeľka odboru štatistiky obyvateľstva ŠÚ SR Zuzana Podmanická.

Najviac ľudí zomieralo v prvom a poslednom štvrťroku minulého roka, keď Slovensko zasiahli druhá a tretia vlna pandémie. Počet zomretých v týchto mesiacoch dosiahol takmer dvojtretinový podiel na celoročnom počte zomretých.

Oproti obdobiu pred pandémiou počet zomretých najvýraznejšie narástol v Košickom kraji (o 43 percent) a Prešovskom kraji (o 42 percent). Naopak, najmenšia nadúmrtnosť bola v Bratislavskom kraji (o 32 percent) a Žilinskom kraji (o 34 percent).

"Spomedzi ôsmich regiónov Slovenska v roku 2021 nadpriemernú hodnotu hrubej miery úmrtnosti vykázali štyri kraje. Rekordné úrovne dosiahol Nitriansky kraj a Banskobystrický kraj s viac ako 1500 zomretými na 100.000 obyvateľov. Horšia situácia ako v SR bola aj v Trenčianskom a Trnavskom kraji," doplnil úrad.

Piatimi najčastejšími príčinami úmrtí boli choroby obehového systému (38,6 percenta), COVID-19 (20 percent), nádory (18 percent), choroby dýchacej sústavy (deväť percent) a choroby tráviacej sústavy (štyri percentá).

Nadúmrtnosť sa vlani prejavila v dvoch vekových skupinách obyvateľstva, a to v produktívnom a poproduktívnom veku. U osôb v produktívnom veku (15 - 64 rokov) presiahla 23 percent, u osôb v poproduktívnom veku (65+) dosiahla 42 percent.

## Over 73,000 People Died in Slovakia Last Year, Highest Figure Since 1919

Bratislava, March 31 (TASR) - Over 73,000 people died in Slovakia last year, which is the highest absolute figure to be reported since 1919, the Statistics Office reported on Thursday. Excess mortality, i.e. the number of extra deaths when compared to the five-year average before the pandemic, amounted to 37 percent last year. The highest number of people died in January 2021.

"The coronavirus pandemic of Covid-19 caused a significant increase in the mortality rate in Slovakia. The number of deaths exceeded 1,000 deaths per 100,000 people in 2020, and it even increased to 1,350 in 2021. This is the highest gross mortality rate in the postwar history of Slovakia," said Zuzana Podmanická, head of the office's population statistics department.

The highest number of people died in the first and final quarters of last year, when Slovakia was hit by the second and third waves of the coronavirus pandemic. The number of deaths in these months accounted for almost two thirds of the deaths reported for the of last year.

Kosice region reported the highest excess mortality among all regions of Slovakia, at 43 percent, followed by Prešov region (42 percent). Conversely, Bratislava region recorded the lowest excess mortality (32 percent) and Zilina region the second lowest (34 percent).

The five most common causes of death last year were diseases of the circulatory system (38.6 percent), COVID-19 (20 percent), cancer (18 percent), respiratory diseases (9 percent), and gastro-intestinal diseases (4 percent).

Last year, excess mortality appeared in two age groups of the population, namely in productive and post-productive age. For people of working age (15-64 years), it exceeded 23 percent, and for people in their post-productive age (65+) it reached 42 percent.

## Student Conference in the Slovak Studies Program at the University of Pittsburgh

The Slovak Studies Program at the University of Pittsburgh held a two-day Student Conference on April 20-April 21, 2022. The Slovak Studies Program at Pitt is the only program in the United States that allows students to gain an undergraduate minor in Slovak Studies. The curriculum consists of many courses, including some on Slovak film, communism, and of course Slovak language study. The student conference was a moment for these accomplished students to demonstrate to the Pitt community and the Slovak-American community at large how much they have accomplished under the adroit tutelage of Dr. Renáta Kamenárová, the current Director of Slovak Studies. Also, the students took advantage of weekly tutoring sessions and a weekly conversation table hosted by Ben Sorensen to hone their work. Their hard work paid off, and this conference also had an audience that reached all the way to Slovakia thanks to this being hosted online over Zoom.

There were ten presenters in this student conference:

Alexandra Glova, a sophomore studying on the Pre-Physician Assistant Track, focused on the development of Covid-19 in Slovakia and in the USA, comparing each nation's rules, regulations, hospital crises, and vaccination rates and hesitancy. Her presentation gave both the American and the Slovak audience insights about the differences of the responses between the two countries and was completely done in Slovak.

Emily Molitoris is a graduating senior at the University of Pittsburgh majoring in Bioengineering. She has been studying Slovak at Pitt for two years and has found the experience very rewarding. She has been honored to have received the Thomas Kukucka Memorial Fund grant twice from the Department of Slavic Languages and Literatures. Because of her interest in biotechnology, Emily wanted to explore Slovakia's response to the Covid-19 pandemic as well as individual experiences of several contacts she has in Slovakia. She first discusses accomplished Slovak scientists before going into Covid-19 statistics on vaccination and infection rates of Slovakia and their latest policies and restrictions, and then lastly, individual attitudes toward the pandemic.

Andrea Janak, a junior psychology major at the University of Pittsburgh, is pursuing a a minor in Slovak Studies and is in Pitt's Occupational Therapy Guarantee Program. She took us on a trip through modern Slovak music in "Popular Slovak Music." Focusing on Slovakia's culture new and old, Andrea's presentation introduces a handful of Slovak musical artists under a variety of genres. For each artist introduced, she plays a sample of his/her work and included translations of the lyrics side by side. Learning a language through the art of music is a great way to familiarize oneself with speech patterns and common phrases.

Alexis Waksmunski, a very energetic student and employee at the University of Pittsburgh, gave us a deep dive in her talk "Famous Fairy Tales and Their Slovak Counterparts." She explained the meanings, similarities, and differences of Slovak fairytales and their American counterparts (such as Cinderella/Popoluška).

Dave Drager, a Chief Technology Officer from Philadelphia, presented "A Short Tour of Slovak Castles." He took the audience on a virtual tour of the most iconic castles and ruins in Slovakia. This was an amazing virtual experience; for those in the audience who had not been able to travel for the last two years, and his presentation allowed them to

vicariously visit many places that are now on Slovak and American bucket-lists alike.

Jeffrey Micher, an OSHER student at Pitt, a linguist, and a computer scientist, presented "Slovenská tlač v USA." This presentation introduced the Slovak audience to the immense reach of Slovak newspapers published and read in the United States. His presentation was completely in Slovak.

Karen Melis, an OSHER student at Pitt, presented "Kto som a odkial som," a presentation on genealogy and how to find materials to research one's own family history. Her presentation was also completely in Slovak, and the Slovak participants found her insights extraordinarily interesting.

Timotej Kožuško, an OSHER student at Pitt and a former social studies teacher and guidance counselor, spent an entire school year teaching in Bratislava in 2001-02. He documented his studies in "Moji slovenskí starí rodičia a ich cesta za oceán," his own family's journey from Slovakia to America in great detail. Everyone learned about the hardships of travel at the turn of the Twentieth Century, and also the process of assimilation into American society. Again, this presentation was also completely in Slovak!

Tom Uhring is an OSHER student at Pitt and a former equipment operator, who is dedicated to learning Slovak so that he can return to Slovakia to communicate better with his family; he offered his talk in English, "My Family's Journey Before and After World War II." It was a very interesting look at immigration during a very tumultuous time the world over. He also told us about his first trip back to Slovakia, along with many hilarious moments he experienced there.

Also, Jim Švagerko, an OSHER student at Pitt and a professor and business owner, told us about "The Emigration of Slovaks to the Mahoning Valley." Here the entire audience learned wonderful information about how Slovak communities were set up in the greater Youngstown area, known as the Mahoning Valley of Ohio and Pennsylvania: he discussed the reasons for migration, his own family's struggles, and how Slovaks coped with their integration into the new culture.

While this short article cannot do their presentations justice, each of them did an excellent job. There are certainly no words to adequately express how proud both Dr. Kamenárova and Mr. Sorensen are of them. These students are proof that anyone can learn about Slovak culture and pick up some Slovak language. In fact, if any of Jednota's readers are interested, they should too look into the Slovak Studies Program at Pitt!

#### **FCSU Matching Funds Guidelines for Branches and Districts**

- 1. The **Eligibility Form** should be completely filled out and submitted at  $\underline{\text{least 30 days prior}}$  to the event.
- 2. The activity must be <u>sponsored and planned</u> by the branch/district (Br/D) submitting the activity. If more than one Br/D is involved only one Br/D may submit for the matching funds. Every Br/D is permitted to apply twice in a calendar year.
- 3. The Br/D officers/members are responsible for recruiting as many Br/D members to be involved in the activity. The Br/D officers may also invite other branches or districts, church members, a community or other organizations to participate in the activity.
- 4. After your Br/D has received approval for your activity, it should be publicized on our website, in our newspaper/magazine, direct mail to Br/D members, church bulletin, diocesan newspaper or local newspaper. The FCSU name should be prominently displayed at the site of the activity. Posters are available upon request from the Home Office.
- 5. The maximum amount matched by the FCSU is **\$600.00 per event**. The cause must be charitable or benevolent in nature. Phone or email the Home Office if you are not sure your charitable or benevolent cause qualifies.
- 6. Br/D that consider helping an established project at their church or in their community may submit the activity as a matching funds project, providing the Br/D sponsors the entire activity or in conjunction with the event a Br/D sponsors a raffle, bake sale, etc. and has a separate table or booth.
- 7. The Br/D officers are responsible for taking pictures and keeping receipts that should be submitted with the "Matching Funds Request for Payment Form".
- 8. **Matching Funds Request for Payment Form** <u>must be submitted for payment no later than 30 days</u> after the completion of the activity to the Home Office. Forms are available on <u>www.fcsu.com/forms</u>.




