The First Catholic Slovak Union (FCSU - Prvá Katolícka Slovenská Jednota) convened its 52nd Quadrennial Convention from July 30-August 2, 2022, at the Holiday Inn in Independence, Ohio.

Upon entering the hotel, attendees were greeted to an outstanding exhibition of Slovak kroj (Slovak folk costume), which George Terbrack tastefully organized from the FCSU and his own collection.

Saturday's program featured an evening buffet with an Elvis Presley impersonator, followed by a night of socializing and casino play with fake dollars. Some big money rollers dressed up for the occasion, including Tom Ivanec and his wife Terri, the former editor of Jednota! Many concluded the evening with trips to rooms of various districts, and I was with a group which sang Slovak and Rusyn songs and enjoyed homemade klobasa (sausage).

Appropriately, Sunday began with a con-celebration of Holy Mass, led by FCSU Protector, Bishop Larry J. Kulick from the Diocese Greensburg, PA. Mass concluded with a short welcome from Bishop Edward Malesic of the Cleveland and the Slovak

Cardinal Emeritus Jozef Tomko Dies in Rome

Bratislava, August 8 (TASR) – Cardinal emeritus Jozef Tomko died at the age of 98 in Rome on Monday morning, TASR was told by the Slovak Episcopal Conference's (KBS) press office.

"With pain in our hearts and with hope for the resurrection, we announce that His Eminence Cardinal Jozef Tomko passed his noble soul to the Lord in the early morning hours today, August 8, 2022, surrounded by his closest colleagues," said the office.

Vatican, August 9 (TASR) – Pope Francis will attend Slovak Cardinal Jozef Tomko's final farewell in person and will lead the final farewell ceremony, the Slovak Bishops Conference (KBS)'s press office told TASR.

A requiem mass, which will take place at 11 a.m. on Thursday (August 11) in St. Peter's Basilica in the

Vatican, will be celebrated by Tomko's long-term friend, Cardinal Giovanni Battista Re. After the mass, Pope Francis will lead the final farewell ceremony.

Slovak bishops will take part in the ceremony as well. Head of the Slovak diplomatic mission at the Vatican Marek Lisánsky said that Slovak bishops will travel to Rome by the government plane, which will later transport Cardinal Tomko's remains to Slovakia.

In line with the schedule published by the KBS press office, the several-day farewell to Cardinal Tomko in Slovakia will begin on Friday (August 12) and Saturday (August 13) in St. Martin's Cathedral in Bratislava. It will continue in St. Elizabeth's Cathedral in Košíce on Sunday (August 14) and Monday (August 15), culminating in a holy mass including

Message from the National Chaplain

The Solemnity of the Assumption of the Blessed Virgin Mary is celebrated by the Church each year on August 15. Few today realize that for over nineteen centuries, the Assumption was not officially taught by the Church as a divinely revealed truth, but rather a long-held common understanding or belief among Catholics. It was Pope Pius XII (1939-1958) who infallibly proclaimed the Assumption to be Church dogma in his apostolic constitution The Most Bountiful God (Munificentissimus Deus).

Prior to the promulgation of "The Most Bountiful God" on November 1, 1950, Pius sent an extremely brief encyclical to the world's bishops on May 1, 1946. This encyclical, Mary, Virgin Mother of God (Deipare Virginis Mariae), was written for the purpose of seeking the input of the world's bishops on "whether it would be lawful, convenient, and useful" to have the Assumption of the Blessed Virgin Mary defined as a dogma of the Catholic faith.

Pius XII states in "Mary, Virgin Mother of God" that for nearly 100 years the Holy See had been receiving petitions from clergy, consecrated religious, and laity asking for the commonly held belief that Mary at the end of her life on earth was taken body and soul into heaven to be declared a dogma of the Church. He notes that the bishops who participated in the First Vatican Council (1869-1870) were in favor of such an announcement.

By means of this encyclical, Pius consulted with the world's bishops to report on the devotion to the Assumption of Mary among of the clergy and people under their pastoral care as well as their own desire for it to become official church dogma.

Saints Cyril and Methodius Appeal Continues in August

The Saints Cyril and Methodius Appeal is in its 44th year raising money to assist the Pontifical Slovak College of Saints Cyril and Methodius in Rome with its day-to-day operations. The Appeal relies upon the generosity of individual donors in addition to collections taken up in personal parishes of Slovak ancestry. A direct mailing asking for donations was sent in January to local district and branch leaders from the four Catholic Slovak Fraternal Organizations, members of the Slovak Catholic Federation, clergy with Slovak ancestry, and previous donors.

As of July 27, the 2022 Appeal has received \$26,447.87 from 188 donors. Among the 57 donations received from Catholic Slovak Fraternal Branches and Districts, Branch 3, Branch 19, Branch 35, Branch 45, Branch 85, Branch 112, Branch 162, Branch 173, Branch 213, Branch 320, Branch 382, Branch 450, Branch 746, Branch 853, District 17, and the Home Office of the First Catholic Slovak Union have donated a combined total of \$2,325. Donations to date have also been received from 6 parishes, 32 clergy and religious, and 93 individuals. On behalf of the Pontifical College, thank you for your continued generosity and support.

Insights and Viewpoints

August 15, 2022 Assumption of the BVM (Mass of the Day)

Today the Church marks the feast of the Assumption of the Blessed Virgin Mary, when we recall a solemn article of our Catholic faith; namely, that Mary, "having completed the course of her earthly life, was assumed body and soul into heavenly glory." In some ancient western Christian traditions and in many eastern Christian traditions this event is referred to as the "Dormition" of Mary—literally, her "falling asleep."

The term Dormition is useful in speaking of the end of Mary's earthly life since it is ambiguous: it can figuratively refer to death, and it can serve more plainly to describe the act of falling asleep. In his declaration setting forth the dogmatic teaching on this subject—the 1950 Apostolic Constitution Munificentissimus Deus—Pope Pius XII did make references to Mary's death but did not include belief in her death in the clearly worded binding section of that declaration; rather, he simply stated that Mary "completed the course of her earthly life." In any case, the point is that by virtue of the unique place of Mary in the story of our salvation as the Mother of God, Mary's body was preserved from the physical corruption of death as surely as her soul was preserved from the spiritual corruption of sin.

To guide us in celebrating this feast day the Church's Liturgy of the Word begins with a famous passage from the Book of Revelation in which the travails of a female figure are described in dramatic terms. This woman has long been perceived by Catholic commentators as symbolizing both the Blessed Virgin Mary and the Church. This dual identification is helpful in reflecting on today's readings since they speak both about Mary and about our own future glory—those believers who constitute the Church on earth in every generation.

The woman of Revelation can be understood to represent Mary in that "she gave birth to a son, a male child, destined to rule all the nations with an iron rod" (Rev 12:5)—whom we call the Christ child. The woman can also be interpreted as symbolic of the Church insofar as, like the nation of Israel itself, she gave rise to the messiah and anointed one (12:10) who would redeem all nations, and she and her offspring, "those who keep God's commandments and bear witness to Jesus," then endure the persecution of evil forces (12:17), much as the Church has throughout its history.

Taking this a step further, in his First Letter to the Corinthians Saint Paul connects the mystery of Christ's resurrection, which has already taken place, to the mystery of our future resurrection: "Christ has been raised from the dead, the first fruits of those who have fallen asleep....For just as in Adam all die, so too in Christ shall all be brought to life" (1 Cor 15:20, 22). Although he makes no direct reference to Mary here, Paul's words nonetheless anticipate (even if unknowingly) Mary's Assumption into glory as part of Christ's plan for the glorification of all humanity.

On the feast of the Assumption we celebrate the moment when Mary began to share fully in the risen presence of the Lord; today's feast also reminds us of our hope that one day we all might experience the same heavenly glory that Mary knows, abiding forever in union with the Father, Son, and Holy Spirit. With gratitude in our hearts let us rejoice this day, saying to Mary with her kinswoman Elizabeth, "Blessed are you who

During The Slavic, East European, and Near Eastern Summer Language Institute's thirty-second year, the Slovak Studies Program at The University of Pittsburgh hosted firstthrough fourth-year Slovak from June 6 to July 15, 2022. This was the first time in years that fourth-year Slovak was offered, and the course was a resounding success, with students eager to return next year to continue their learning.

The Slavic, East European, and Near Eastern Summer Language Institute (SLI) allows students to gain an academic year's worth of Slovak language courses in just six weeks. What's more, the instructors at SLI, Dr. Renáta Kamenárová, Director of the Slovak Studies Program, Dr. Vlasta Štofová, and Dr. Helena L'os Ivoríková have decades of teaching experience and are among the authors of the textbook series used at SLI: Krížom-krážom, which is available from levels A1 through B2 of the Common European Framework of Reference for Languages

What is beautiful about SLI at Pitt, and the Slovak program specifically, is that students come to this program from all around the world with vastly different reasons for studying Slovak. Some are students who want to use Slovak in their professional lives. Others are descendants of Slovak immigrants who wish to obtain their Slovak Living Abroad Certificates or Slovak Citizenship by Descent. The process for obtaining Slovak Citizenship by Descent is relatively new – it only became available in April 2022. Still, students from this year's first- through fourth-year Slovak courses are at varying stages of applying for Slovak Citizenship by Descent.



All in-person Summer Language Institute students enjoyed the Slovak picnic where they tasted Slovak cuisine (holúbky, halušky and koláče) and practiced Slovak folk dances.

Slovak at Pitt had twelve students at SLI this year. Many are applying for Slovak Citizenship by Descent, and all shared their talents with SLI to create a music video for the song, "Desať krokov (k slovenskému občianstvu)" – Ten steps (toward Slovak Citizenship), written by SLI student Stephen Baluch. From retirees living all over the U.S. to undergraduate students exploring their heritage, graduate students studying Slovak politics and linguistics, a pharmacist living in California, a professor (and farmer) in Ohio, and a ballet dancer, Slovak at Pitt truly has students from all walks of life.

Whoever you are and whatever your reason for studying Slovak, SLI is the place for you! Do you love the Slovak language and Slovak culture – specifically Slovak national clothing, folk songs, folk dances, and traditional food, wine, beer, Vinea, and Kofola? Do you want to visit Slovakia? Do you enjoy Slovak castles, chateaus, mountains, rivers, and beautiful, clear lakes? Do you like art museums, history museums, and open-air museums like Čičmany? Do you enjoy and want to understand more of the music of Katarina Knechtová, Zuzana Smatanová, Katarzia, Rytmus, Tina, Hana Hegerová, and music from groups like Peha, Desmod, and IMT Smile?

Would you like to learn how to make traditional Slovak foods like bryndzové halušky, palacinky, bryndzová pomazanka, or parené buchty? Do you want to live in Slovakia and be able to communicate well with Slovaks? Do you hope to become a Slovak citizen? All these and other unmentioned reasons show why it is useful to study Slovak at SLI. And, of course, you will make wonderful new friends, learn more about Slovak culture, and want to return to SLI every year. So, come to SLI! We are excited to meet you at SLI next year.



Slovak Canadian Academic Retires after Distinguished Career



On 30 June 2022, Professor Stanislav J. Kirschbaum has retired after 53 years in academia. He began his career at Queen's University, Kingston, Ontario, in 1969, moving to York University in Toronto in 1970 where he was professor of International Studies at York University's bilingual Glendon College, teaching in both English and French. He was also a visiting professor at Université Laval in Quebec City, Université de Montréal in Montreal, and at Trnavská univerzita in Trnava, Slovakia.

Professor Kirschbaum is especially known for his research and publications on Slovak politics and Slovak history. He is the author of the first English-language history of Slovakia, A History of Slovakia. The Struggle for Survival, which saw a second edition (available in bookstores and through the internet as is another first, his A to Z of Slovakia). He published many books, made numerous contribu-

tions to academic journals, appeared multiple times on radio and television, and the quality and scope of his work was given recognition in 2002 when he was elected a Fellow of the Royal Society of Canada, the highest academic accolade given in Canada. He was also made a Chevalier dans l'Ordre des Palmes académiques de France in 1994 and promoted to the rank of Officier in 2015 for his contribution to international scholarship.

He has been a regular contributor of articles on Slovakia and the Slovaks to Jednota and is a member of Branch 785. Colleagues in his department wished him a happy retirement with the gift of a drawing of him and a e-card signed by faculty and staff.





FCSU Matching Funds Guidelines for Branches and Districts

- 1. The **Eligibility Form** should be completely filled out and submitted at <u>least 30 days prior</u> to the event.
- 2. The activity must be <u>sponsored and planned</u> by the branch/district (Br/D) submitting the activity. If more than one Br/D is involved only one Br/D may submit for the matching funds. Every Br/D is permitted to apply twice in a calendar year.
- 3. The Br/D officers/members are responsible for recruiting as many Br/D members to be involved in the activity. The Br/D officers may also invite other branches or districts, church members, a community or other organizations to participate in the activity.
- 4. After your Br/D has received approval for your activity, it should be publicized on our website, in our newspaper/magazine, direct mail to Br/D members, church bulletin, diocesan newspaper or local newspaper. The FCSU name should be prominently displayed at the site of the activity. Posters are available upon request from the Home Office.
- 5. The maximum amount matched by the FCSU is \$600.00 per event. The cause must be charitable or benevolent in nature. Phone or email the Home Office if you are not sure your charitable or benevolent cause qualifies.
- 6. Br/D that consider helping an established project at their church or in their community may submit the activity as a matching funds project, providing the Br/D sponsors the entire activity or in conjunction with the event a Br/D sponsors a raffle, bake sale, etc. and has a separate table or booth.
- 7. The Br/D officers are responsible for taking pictures and keeping receipts that should be submitted with the "Matching Funds Request for Payment Form".
- 8. **Matching Funds Request for Payment Form** <u>must be submitted for payment no later than 30 days</u> after the completion of the activity to the Home Office. Forms are available on <u>www.fcsu.com/forms</u>.

Social Partners Agree for First Time Ever on Minimum Wage – at €700 a Month

Bratislava 14. júla (TASR) – Zamestnávatelia, odbory a zástupcovia samospráv sa historicky po prvý raz dohodli na zvýšení minimálnej mzdy, a to zo súčasných 646 eur na 700 eur v budúcom roku. Sociálni partneri o tom vo štvrtok informovali na spoločnej tlačovej konferencii.

To znamená, že sa neuplatní zákon na zvyšovanie minimálnej mzdy. "Všetci sociálni partneri sa zhodli, že v súčasnej situácii musí výška minimálnej mzdy zohľadňovať možné negatívne dopady na zamestnancov a domácnosti, no zároveň zohľadňovať nepriaznivé podnikateľské prostredie a rešpektovať reálne príležitosti slovenských zamestnancov," píše sa v spoločnom vyhlásení zástupcov Republikovej únie zamestnávateľov (RÚZ), Asociácie zamestnávateľských zväzov (AZZZ), Zväzu priemyselných zväzov a dopravy (APZD), Združenia miest a obcí Slovenska (ZMOS) a zástupcov zamestnancov združených s Konfederáciou odborových zväzov (KOZ) a Slovenskými spoločnými odborovými zväzmi. Čle-



novia tripartity zdôraznili, že spoločný návrh na zvýšenie minimálnej mzdy na 700 eur je jasným dôkazom toho, že zodpovedný sociálny dialóg má zmysel. "Veríme, že aj týmto spôsobom vysielame politikom a verejnosti jasný signál, že vecná diskusia, schopnosť počúvať a byť otvorený kompromisom sú to, čo naša krajina dnes azda najviac potrebuje," dodávajú sociálni partneri.

Social Partners Agree for First Time Ever on Minimum Wage – at €700 a Month

Bratislava, July 14 (TASR) – Employers, trade unions and local government representatives have agreed for the first time ever to increase the minimum wage at a single rate – from the current \leq 646 to \leq 700 per month next year, the social partners announced at a joint press conference on Thursday.

This will mean that the automaton for increasing the minimum wage stipulated by the law won't apply.

"All the social partners agreed that in the current situation the level of the minimum wage must take into account possible negative impacts on employees and households but at the same time take into consideration the unfavorable business environment and respect the real opportunities of Slovak employees," reads a joint statement of representatives of the Republican Union of Employers (RUZ), the Association of Employers Unions (AZZZ), the Association of Industrial Unions and Transport (APZD), the Slovak Towns and Villages Association (ZMOS) and representatives of employees associated with the Trade Union Confederation (KOZ) and the Slovak Joint Trade Unions.

The tripartite members stressed that the joint proposal to increase the minimum wage to €700 is clear evidence that responsible social dialogue makes sense. "We believe that in this way we're also sending a clear signal to politicians and the public that a factual discussion, the ability to listen and be open to compromise are what our country needs perhaps most today," added the social partners.

Volvo Cars postaví nový výrobný závod pri Košiciach

Bratislava 1. júla (TASR) - Švédska automobilka Volvo Cars postaví pri Košiciach nový závod na výrobu elektromobilov za 1,2 miliardy eur, informovalo v piatok ministerstvo hospodárstva.

Začiatok výstavby závodu je naplánovaný na rok 2023, inštalácia zariadení a výrobných liniek na rok 2024. Sériová výroba novej generácie čisto elektrických automobilov Volvo Cars by sa mala začať v roku 2026.

V súlade s cieľom automobilky využívať do roku 2025 klimaticky neutrálne výrobné procesy bude závod využívať len klimaticky neutrálnu energiu. Okrem toho bude závod navrhnutý tak, aby dosahoval najvyššie svetové štandardy energetickej a environmentálnej účinnosti.

Závod by mal vyrábať až 250 000 vozidiel ročne a očakáva sa, že v regióne vytvorí niekoľko tisíc pracovných miest. Jeho umiestnenie umožní aj ďalšie rozširovanie v budúcnosti.

Volvo Cars Set to Build New Production Plant near Košice

Bratislava, July 1 (TASR) – Swedish car maker Volvo Cars is set to build a new plant for the production of electric cars for €1.2 billion near Košice, the Economy Ministry reported on Friday.

The construction of the plant is scheduled to start in 2023, with installations of equipment and production lines slated for 2024. Series production of Volvo Cars' next generation of pure electric cars is expected to be launched in 2026.

In line with the car maker's aim to use climate-neutral production processes by 2025, the plant will deploy only climate-neutral energy. In addition, the facility will be designed to achieve the highest global standards of energy and environmental efficiency.

The plant should produce up to 250,000 vehicles per year and is expected to create several thousand jobs in the region. Its location will also allow for further expansion in the future.

V centre strávila asi hodinu a potom navštívila základnú školu na Tomášikovej ulici, kde boli nedávno zriadené dve triedy pre ukrajinských žiakov.

"Táto škola je veľmi nápomocná, v súčasnosti sa stará o 60 detí. Pani riaditeľka zároveň spustila hodiny slovenčiny pre ukrajinských rodičov, ktorí sú v Košiciach, a tak im pomáha, aby sa tu adaptovali," povedal primátor Košíc Jaroslav Polaček.

V súvislosti s návštevou prvej dámy USA platili v Košickom kraji prísne bezpečnostné opatrenia. Bidenová by svoj nedeľný program na východe Slovenska ukončila návštevou hraničného priechodu Vyšné Nemecké s Ukrajinou.

The wife of the American president, Jill Biden, Expresses Support to Volunteers Helping Ukrainians in the Košice Crisis Center

Košice, May 8 (TASR) – First Lady of the United States Jill Biden expressed her support and respect to volunteers and representatives of the refugee crisis center in Košice, whom she met during her visit to Slovakia on Sunday morning.

In addition to volunteers, Biden also talked to several Ukrainian refugees who were in the center. She was interested in where they came from, what happened to their homes, or what they experience after coming to Slovakia. She spent about an hour in the center and then she visited the primary school on Tomášiková Street, where two classes for Ukrainian students were recently established.

"This school is very helpful, it currently takes care of 60 children. At the same time Mrs. headteacher launched lessons in Slovak for Ukrainian parents who are in Kosice, helping them to adapt here in this way," said Košice mayor Jaroslav Polaček.

Strict security measures were in place in Kosice region in connection with the visit of the First Lady of the United States. Biden would end her Sunday agenda in eastern Slovakia by visiting the Vyšné Nemecké border crossing with Ukraine.





Sister M. Anita



At a time when there is so much evidence of hatred and animosity among people in general, it is heartening to read about an individual whose life was marked by exceptional kindness and the thoughtfulness of others.

Mary Mikula, who later became Sister M. Anita, SS.C.M., is a stellar example of virtues disregarded by a vast majority of individuals in our world. Selfishness and lack of consideration for others very often reign supreme.

When Mary and her family came to the U. S. from their home in Dubina, Slovakia, they settled in Hazleton, PA, and became parishioners of Holy Trinity Church whose pastor at the time was the Rev. Andrew Pavčo. Mary first read about the Sisters of Saints Cyril and Methodius in the JEDNOTA, but did not think she could imitate them. However, it would not take the Lord long to prove to her that He was calling her to religious life.

One day she and her mother went to visit cousins in Ashley. (It happened that Mary's mother was a cousin to Susan Kotalik who was planning to become a Sister.) Susan later entered and became known as Sister Scholastica. Mary, too, began thinking as St. Augustine once had, "If these and those can, (serve God), why not you, Augustine?" Mary, recalling what she had read in the Jednota, asked herself, "If she can go, I can go, too!"

Susan told Mother Emmanuel her cousin was also interested in becoming a Sister, but Mother replied, "You come now; we'll take care of your cousin later." And so they did. When Susan was received as a novice, Mary went to Middletown to see what it was like and learned that her application had been accepted. Middletown was the place where the SSCM Sisters established their first Novitiate in 1913 and temporary Motherhouse in the Diocese of Harrisburg in 1917. They were able to do this with the permission of the Bishop and at the invitation of the First Catholic Slovak Union (Jednota) to work with the orphans and the elderly who were the surviving family members of their constituents who worked in the hazardous conditions of the coal mines and mills.

Castle Grove, a property in Danville, PA, was put up for sale in 1918, and on St. Patrick's Day, the owner agreed to sell it to the Sisters. Its sale to the Sisters of Saints Cyril and Methodius was finalized on June 7, 1919. Thus, Castle Grove became Villa Sacred Heart.

Sister Anita fondly remembers Mother Monica, I.H.M., and all she did for the Sisters of Saints Cyril and Methodius at the congregation's early beginnings. She also has memories of being one of the first arrivals at Villa Sacred Heart. She once said, "It was hard," she recalls, "but we made the best of it.

Sister Anita went into the field of education and taught in Indiana, Connecticut, Pennsylvania, and New York, teaching in Grades 1-7, and also served as principal. Known for her generosity and good humor, she found special joy in helping the underprivileged children because she herself had experienced poverty.

Her deep prayerfulness was evident in her kindness and love for her Sisters. Her sense of humor and light-heartedness made her a most welcome companion. She delighted in working for a common cause, and "just being in the company of my Sisters." Her philosophy of life was evident in the day-to-day activities of life: "Be kind, be patient, develop a spirit of forgiveness. Live in peace and love with each other. What you do to others will return to you."

Sister Anita died on September 27, 1981, and her funeral was celebrated on Wednesday, September 30.

LIGHT ONE CANDLE

Fr. Ed Dougherty, M.M., The Christophers' Board of Directors Invoking Mary's Intercession

We honor Mary throughout this month of August. For starters, we celebrate two important feast days that are linked together by an octave. The Feast of the Assumption of the Blessed Virgin Mary is held on Aug. 15, which marks the first day of the octave, and the Feast of the Queenship of Mary is held on August 22, which concludes the octave. In addition to these beautiful celebrations, we have a tradition dating back to World War II in which the entire month of August is dedicated to the Immaculate Heart of Mary. This is not decreed in an official way by the Church, but it remains a beautiful tradition, and it's worthy to recall the reason for its observance.

In May of 1944, as the war raged on in Europe, Pope Pius XII named August 22 the Feast of the Immaculate Heart of Mary, invoking Mary's intercession in a prayer for "peace among nations, freedom for the Church, the conversion of sinners, the love of purity, and the practice of virtue."

The establishment of this feast day inspired many Catholics to dedicate the entire month of August to the Immaculate Heart of Mary. Decades later, Pope Paul VI saw good reason to move the Feast of the Immaculate Heart of Mary to the Saturday following the Feast of the Sacred Heart of Jesus. It created an entire week in June linked together by the theme of the Miraculous Hearts of Mother and Son. August 22 subsequently became the Feast of the Queenship of Mary, and this also makes sense because we now follow our celebration of Mary's Assumption by honoring her Queenship over heaven and earth.

But tradition holds that we can still declare August dedicated to the Immaculate Heart of Mary due to the extenuating circumstances under which this dedication came about. It is hard to even imagine the terror that gripped the entire world at that time. Pope Pius XII had been inspired by the message of Fatima to turn to Mary's intercession on behalf of humanity, and as Mary promised, that intercession came and relative peace was restored to the world. It was an imperfect peace, but it was a dramatic shift from the brink of destruction to which the world had been brought.

The war in Europe came to an end on May 7, 1945, almost exactly one year after Pius XII established the Feast of the Immaculate Heart of Mary; and World War II ended on August 14, one day before the octave that began with Mary's Assumption and ended with the newly declared Feast of the Immaculate Heart of Mary.

That octave now concludes with the celebration of Mary's Queenship, and we should indeed celebrate the status she holds and the intercession she has extended to all of us. It is a time to recognize the miraculous hand of God at work in Mary's life, beginning with her Assumption, when the hand of death was stayed, and she was assumed body and soul into heaven; it's a time to honor her Queenship over heaven and earth; and it's a time to grow in admiration for her purity of heart.

So, let's join our current prayers for peace with all those who prayed for soldiers on the front lines of the war during that tumultuous year between 1944 and 1945, imploring the pure heart of Mary to intercede on our behalf so that Christ will bring peace to the world.

Deň Slovákov v Maďarsku opäť po sarvašsky

Viac ako sedemnásťtisícové mesto Veľkej dunajskej kotliny rozprestierajúce sa na ľavom brehu mŕtveho ramena Trojitého Kereša – Sarvaš – Slováci mohutne osídlili pre 300. rokmi. V pri sčítaní obyvateľstva v roku 2011 sa k slovenskej národnosti v meste prihlásilo už iba 10,7% krajanov. Sarvašu sa prisúdil prímer intelektuálneho centra Békéšskej župy (nachádzalo sa tu viacero významných vedeckých a vzdelávacích inštitúcií, napr.: Vysoká škola Samuela Tešedíka, Výskumný ústav zavlažovania, Výskumný ústav šľachtenia rýb). Toto mesto však poznáme najmä v spojitosti s menom evanjelického kňaza Samuela Tešedíka, ktorý sa do miestnych dejín trvale zapísal zlatým písmom. K jeho dielu pripisujeme založenie prvej poľnohospodárskej školy v Európe i zveľadenie mesta výstavbou ulíc do šachovnice. Dal vybudovať prvú školskú budovu, ktorá dodnes na Sarvaši stojí a podpísal sa i pod vznik starého evanjelického kostola. Sarvaš preslávil aj Milan Rastislav Štefánik. Na tamojšom gymnázium v roku 1898 zmaturoval.

Celoštátna slovenská samospráva v Maďarsku každoročne pripravuje Deň Slovákov v Maďarsku, ktorý sa práve v tomto roku konal (opäť, po 22. rokoch) na Sarvaši pri príležitosti 300. výročia jeho osídlenia Slovákmi. Za Maticu slovenskú podujatie navštívili I. podpredseda Matice slovenskej, Marek Hanuska a riaditeľka Krajanského múzea Matice slovenskej, Zuzana Pavelcová.

Za účasti významných hostí z domova i zo zahraničia celodenný program uviedla výstava v Slovenskom pamiatkovom dome postaveného z roku 1885. Výstavu prác sarvašských slovenských tkáčov z dielne Ústavu kultúry Slovákov v Maďarsku a mesta Sarvaš uviedla citarová skupina z miestnej Slovenskej základnej školy.

V starej školskej budove, kde sa dnes nachádza Tešedíkovo múzeum, porota udelila vyznamenania ProCultura Slovaca za významné počiny krajanov v oblasti kultúry. Cenu ProCultura Slovaca získali harmonikár Ondrej Maglovský zo Srbska a Folklórny súbor Furmička z Maďarska, plaketu ProCultura Slovaca získali hudobná pedagogička Mariena Stankovićová Kriváková zo Srbska a učiteľ a krajanský pracovník Vlatko Miksád z chorvátskeho lloku.

Sarvaš [Szarvas in Hungarian, ed.] is a town of over 17,000 inhabitants in the Great Danube Basin, situated on the left bank of a former branch of the Kereš (Körös) River. Three hundred years ago, a great number of Slovaks settled in the town, but in the 2011 census, only 10.7% of the town's inhabitants claimed Slovak nationality.

[It was originally an ethnic Magyar town in 1495, the Ottoman wars ravaged the town and the native population fled. It remained uninhabited until 1720, when an Austrian Baron, Johann Georg Freiherr von Harrucker, invited Slovak settlers from Upper Hungary to re-populate area. The Slovaks reconstructed new town under the leadership of Rev. Sámuel Tessedik. He invited engineers to lay out a new town plan (Editor).]

Sarvaš became an intellectual center of Békéš County (several important scientific and educational institutions were located here, for exampe, the Samuel Tešedík College, the Irrigation Research Institute, and the Research Institute of Fish Breeding). However, we know this town mainly in connection with the name of the Lutheran priest Samuel Tešedík, who has permanently inscribed his name in golden letters in local history. He founded the first agricultural school in Europe and the improved the town by the construction of streets in a checkerboard pattern. He built the first school building, which still stands, and he also contributed to the establishment of the old Evangelical church. Sarvaš was also made famous by Milan Rastislav Štefánik, who graduated from the local gymnazium in 1898.

Every year, the national Slovak self-government in Hungary prepares for the Day of Slovaks in Hungary, which was held this year (again, after 22 years) in Sarvaš on the occasion of the 300th anniversary of its settlement by Slovaks. On behalf of the Matica Slovenská Matica, the event was attended by the First Vice-Chairman of the Matica Slovenská Matica, Marek Hanuska and the Director of the Regional Museum of the Matica Slovenská Matica, Zuzana Pavelcová.

Distinguished guests from home and abroad attended a the day-long program, which featured an exhibition in the Slovak House of Remembrance built in 1885. The exhibition of works of Sarvaš Slovak weavers from the workshop of the Institute of Culture of Slovaks in Hungary and the town of Sarvaš was presented by a zither musical group from the local Slovak primary school.

In the old school building, which now houses the Tešedík Museum, a jury awarded Pro-Cultura Slovaca prizes for significant cultural achievements of the compatriots. An award went to the accordionist Ondrej Maglovský from Serbia and the Folklore Ensemble Furmička from Hungary, while the ProCultura Slovaca plaque was awarded to the music teacher Mariena Stanković Kriváková from Serbia and the teacher and compatriot Vlatko Miksád from Ilok, Croatia.

An ecumenical devotion took place in the Old Church, providing a venue for the awarding of other prizes of the National Slovak Self-Government in Hungary $\ \ \ \$ For Our Nationality. The awards were presented to compatriots Rozália Izingová Pružinová, Anna Franková, Ruženka Komjáthiová and Zuzana Szabová. This year the Štefan Lami Prize was awarded to the director of the Institute of Culture of Slovaks in Hungary, Katarina Királyová.

Accompanying programs included music, dance and the smell of Slovak delicacies, which attacted many visitors. The beauty and color of the home-made products offered by the Slovak fair from various Slovak villages were spread out in front of the main stage. Folklore and singing groups hailing from various regions inhabited by Slovaks performed on stage.


