As we are enjoying our summer fraternal activities, such as the National Picnics at Knoebels, Wiegand Lake Park, or Slovak day at Kennywood, I wanted to touch on another yearly celebration approaching in the fall.

Coming up in September, the FCSU will

be celebrating the 58th anniversary dedication of the Our Mother of Sorrows Chapel within the Basilica of the National Shrine of the Immaculate Conception in Washington, D.C. The Board of Directors and I will be attending the yearly Mass on Saturday, September 23rd. I invite all members to come and join us in celebrating this special anniversary

For those who aren't familiar with how our Chapel came to be, here is a little history on Our Mother of Sorrows.

Devotion to Our Mother of Sorrows has its origins from 1564 in the small town of Šaštín in western Slovakia when the Virgin Mary appeared as Our Mother of Sorrows to Angelika Bakičová who was praying for help to deal with personal trials in her life. In thanks-

giving for hearing her prayers, Pani Bakičová commissioned an unknown artist to sculpt a wooden statue at the place of the apparition. Word soon spread of her vision, and the faithful from nearby towns and villages began to visit the site as a place of pilgrimage.

The Šaštín Pieta became the focus of devotion for pilgrims who credited Our Lady of Sorrows for spiritual and

physical miracles of healing. Then in 1667, the Vatican approved the feast of Our Sorrowful Mother to be recognized and celebrated.

Empress Maria Theresa took notice of the large numbers of pilgrims visiting the

a small white host.

The feast of Corpus Christi (Body of Christ) has lately acquired a special status of importance. Since the feast on June 11th this year, I have seen several reminders that we in the United States are now in the second year of a "Eucharistic Revival that Renews the Church." This "revival" began on Corpus Christi, June 19th, 2022, when the U.S. Bishops united in an endeavor to return Catholics to a deeper respect for and belief in the Real Presence of Christ in the Eucharist. During the first year the diocesan focus was on encouraging processions and Eucharistic adoration. Now parishes are promoting Eucharistic holy hours and ado-The greatest story of love is hidden in ration. In 2023 there will be many diocesan Eucharistic Congresses, leading up to a national one in Indianapolis in July 2024. The 3rd year

will climax on Pentecost 2025. The focus will be on how the Holy Eucharist inspires and enkindles in us "missionary fire." The Slovak hymn chosen for this month, BUD VZDY POZDRAVENÁ (ALWAYS BE PRAISED) is in keeping with this US Eucharistic Revival that Renews the Church.

Message from the National Chaplain

The word "Pride" has seemingly taken on a life of its own in today's world. Its popular usage now may be causing some to trigger in their minds with what the word has been traditionally associated.

The Catechism of the Catholic Church (no. 1866) lists pride as the first of the seven capital sins. They are called so because they lead or cause other sins to be committed.

For a review of what many of us learned as children in Catholic school or in religious education classes, here are the seven capital sins listed in the order found in the Catechism with a brief description of each:

- Pride making oneself the center of attention; an exorbitant bragging of one's accomplishments;
- Avarice an excessive or disproportionate desire to possess what another has; greediness;
- Envy a resentment towards the possessions or successes of another;
- Wrath a desire to seek revenge for an evil to be committed against another;
- Lust a consuming desire for that pleasure which is only proper between a husband and a wife;
- Gluttony an overindulgence in the partaking of food and drink;
- Acadia or Sloth -- a refusal to pray or to recognize the presence of God in one's life; an aversion to work.

If we are to find any of the above-mentioned to be a character trait in our lives, our faith tells us it is never too late to seek out and practice its opposite virtue so that we can live a life pleasing to God:

- Humility to recognize one's limitations; a spirit of deference; a modesty in spirit or manner;
- Charity to possess a genuine love for others;
- Generosity or Kindness to give to others with a warm heart;
- Patience to forbear under provocation or strain; to endure pains or trials calmly;
- Chastity to exercise self-control over thoughts and desires one may have for
- Temperance to have a healthy discretion over satisfying basic human instincts for food and drink;
- Diligence to put forth a steady, conscientious effort.

SS. Cyril and Methodius Appeal

The Saints Cyril and Methodius Appeal is in its 45th year raising money to assist the Pontifical Slovak College of Saints Cyril and Methodius in Rome with its day-to-day operations. The Appeal relies upon the generosity of individual donors in addition to collections taken up in personal parishes of Slovak ancestry. A direct mailing asking for donations was sent in January to local district and branch leaders from the four Catholic Slovak Fraternal Organizations, members of the Slovak Catholic Federation, clergy with Slovak ancestry, and previous donors.

As of June 26, the 2023 Appeal has received \$22,428.51 from 174 donors. Among the 55 donations received from Catholic Slovak Fraternal Branches and Districts, Branch 1, Branch 3, Branch 19, Branch 35, Branch 85, Branch 96, Branch 112, Branch 153, Branch 213, Branch 290, Branch 320, Branch 382, Branch 450, Branch 484, Branch 743, Branch 746, Branch 855, Branch 856, District 16, and the Home Office of the First Catholic Slovak Union have donated a combined total of \$3,975. Donations to date have also been received from 6 parishes, 27 clergy and religious, and 86 individuals. On behalf of

The Gift of Mercy

On July 6, we celebrate the Feast of St. Maria Goretti, who died on that date in 1902 at age 11 after suffering a brutal attack by 20-year-old Alessandro Serenelli. On her deathbed, Maria forgave Alessandro, an act that inspired him to convert while he was in prison for his crime, setting him on a course of penance and service to God for the rest of his life.

The Gorettis and Serenellis were sharecroppers living in the same house in the Italian country-side outside of Rome. Alessandro betrayed the trust that existed between their families by trying to rape Maria. When she resisted, he stabbed her multiple times in a fit of rage. Their parents returned home to find the horrible crime that had occurred, and Maria was rushed to the nearest hospital in the town of Nettuno. She died a day later after having declared her forgiveness for Alessandro and her desire for him to be with her in heaven.

Alessandro was sentenced to 30 years in prison. He spent the first three years of his sentence unrepentant, but then he began to correspond with Monsignor Giovanni Blandini, a local priest who visited him in jail. Alessandro informed Monsignor Blandini that Maria had appeared to him in a dream in which she gave him lilies that burned to ash in his hands.

Upon being released from prison, Alessandro went to Maria's still-living mother and begged her forgiveness, which she granted, saying that if Maria could forgive him, she could do no less. The next day, they attended Mass together and received Holy Communion side by side. Alessandro went on to become a lay Capuchin Brother of the Order of Friars Minor. He lived in a monastery and worked as a receptionist and gardener until his death in 1970 at the age of 87.

It seems clear that Alessandro's path to God was only made possible by Maria's forgiveness, which revealed to him the immense mercy of God. His dream of her giving him lilies seems to represent his realization of the profound gift of her mercy. And when they turned to ash, it seems he was realizing the state of his own soul and his need for repentance.

Maria's gift of mercy reveals the mercy that we must all continually seek to reveal to the world. Christ demonstrated this mercy for us in His prayer from the cross, "Father, forgive them; for they do not know what they are doing." It is not about ignoring the reality of evil, but rather about mercy for those caught up in evil. Christ shows us that mercy is sometimes the only way to rescue those who have gone astray.

And we know what Christ says about those who have gone astray. He says, "Which one of you, having a hundred sheep and losing one of them, does not leave the ninety-nine in the wilderness and go after the one that is lost until he finds it?"

In forgiving Alessandro from her deathbed, Maria followed in the footsteps of Christ on the cross and helped Alessandro find his way to God. By showing him mercy, she was being like Christ, the good shepherd, who goes after the sheep that has been lost. This is the kind of love we must have for all people despite the wrong they may do. We must be constantly looking for ways to show them Christ's mercy to inspire a change of heart and call them home to God.

shrine and requested a larger church be built to house the Pieta. By 1764, with Maria Theresa in attendance, a cathedral was consecrated to Our Mother of Šorrows in Šaštín.

Pope Pius VII in 1813 declared the third Sunday in September to be the feast day of Our Mother of Sorrows and added the observance to the Roman Catholic calendar of Saints. Nearly 100 years later in 1913, Saint Pius X moved the observance of the feast to September 15th. Today, September 15th is recognized as a non-working, national Catholic holiday. Slovaks refer to it as the Sviatok Sedembolestnej Panny Márie, the Feast of the Seven Sorrows of the Virgin Mary.

In 1927, Pope Pius XI first proclaimed Our Mother of Sorrows as Patroness of all Slovakia and Saint Paul VI strengthened this proclamation in 1964 by designating the Šaštín cathedral to be a minor Basilica, the first Basilica in Slovakia.

Within the Basilica of the National Shrine of the Immaculate Conception in Washington, D.C., is a Chapel honoring Our Mother of Sorrows, the Patroness of Slovakia. FCSU donated nearly \$140,000 towards the construction of the Chapel.

In conjunction with the 75th Jubilee of the founding of FCSU in 1965, the Chapel was completed in time for its Consecration on September 4th by Most Rev. Andrew G. Grutka, Bishop of Gary, Indiana, and Episcopal Moderator of the Slovak Catholic Federation. Abbot Theodore Kojis, O.S.B., of St. Andrew's Abbey, Cleveland Ohio, gave the homily.

The following day, September 5th, the shrine was dedicated to Our Mother of Sorrows as a true and lasting tribute to the deep faith and devotion of the Slovak people in Slovakia and America. In attendance were Most Rev. Egidio Vagnozzi, Apostolic Delegate to the United States; Most Rev. Patrick A. O'Boyle, Archbishop of Washington, DC; and Msgr. Thomas J. Grady, Rector of the National Shrine.

The Mass was celebrated by Most Rev. Andrew G. Grutka. Most Rev. Paul Hnilica, S.J. from Rome, Italy gave the homily in Slovak and Most Rev. Joseph A. Durick, Bishop of Nashville, Tennessee presented the homily in English.

An estimated 15,000 people were in attendance for Mass and, due to the large crowd, two other Masses were celebrated at the same time, one in the Crypt Church and the other on the West Terrace of the National Shrine.

FCSU members even set a Washington D.C. record when 5,000 people attended a luncheon at the Sheraton Park Hotel and an overflow crowd of about 5,000 used the facilities of the adjoining Shoreham Hotel. It was reported as the largest luncheon crowd in Washington, D.C. hotel history in 1965.

Not even a year later, the Rt. Rev. Msgr. Thomas J. Grady announced the American Sculpture Company wanted to honor the Our Mother of Sorrows Chapel with the Henry Hering Memorial Medal in March of 1966. This award was dedicated to those who worked on the shrine: Eugene F. Kennedy, Jr. F.A.I.A, architect; Ernest Morenon, sculptor; and Cardinal Spellman, Chairman of the Board of Trustees of the National Shrine. Although this award was already given out to the National Shrine in 1961 for the exterior design, this was the first Chapel to receive the award.

As the years progressed, the Chapel continues to gain visitors from people far and wide who want to honor Our Mother of Sorrows. Each year the FCSU organizes trips within our Branches for members to come to an annual Mass and experience the shrine in all its glory.

Over time, the Chapel became in need of some renovation and cleaning. Approval was given at the 47th convention of the FCSU for a donation of \$75,000 to refurbish the Chapel and for the erection of a memorial plaque.

On September 6th, 2003, the Slovak Catholic Federation sponsored a "Pilgrimage of Faith" to mark the rededication of the Chapel once the refurbishing was completed. The over 800 people attending the rededication Mass were welcomed by Rev. Philip A. Altavilla, V.F., National President of the Slovak Catholic Federation (SCF). Those in attendance for the 38th anniversary were inspired by the liturgy and magnificent music along with a homily from Most Rev. Joseph Adamec, Bishop of Altoona-Johnstown and Episcopal Moderator of the SCF, on the significance of the day.

Over 600 people came on September 12th, 2015, to celebrate the 50th anniversary of the chapel's dedication. Rosaries were blessed and distributed as commemorative gifts to all those in attendance. The rosary was then recited with the decades alternating between Slovak and English. Cardinal Donald Wuerl, Archbishop of Washington, was the principal celebrant and homilist with the Most Reverend Joseph Adamec, Bishop Emeritus of Altoona-Johnstown and Episcopal Moderator of the SCF, and Right Reverend Gary Hoover, O.S.B., Abbot of Saint Andrew Svorad Abbey, Cleveland, and Abbot Protector of the SCF, concelebrating.

Today, our members continue the annual tradition of visiting this staple monument. The

Basilica, known as "America's Catholic Church," is the largest Roman Catholic Church in the Western Hemisphere and the eighth largest Church in the world. The Basilica, dedicated to Mary, the Mother of God, is the home to over 35 individual chapels and oratories dedicated to Mary that express the ethnic diversity of the United States. One of the most admired and visited of these chapels is the Our Mother of Sorrows Chapel. The Chapel is located in the upper level of the basilica, on the right side, about halfway towards the altar. It features a life-sized Pieta of the Seven Sorrows of the Blessed Virgin with a Slovak language inscription which reads in English translation: "Our Mother of Sorrows, Patroness of Slovakia, pray for us." It is widely considered the most beautiful Chapel in the Shrine.

I encourage anyone who has not been to the Basilica and seen the historical Shrine to celebrate the 58th anniversary this September 23rd, 2023. Join us and your fellow members in the pilgrimage at the Chapel of Our Mother of Sorrows.

A rosary will be said at 1:00pm followed by Mass at 1:30pm. Please keep a lookout at the Branch Announcements to see if your Branch is planning transportation.

I look forward to seeing and meeting all of you and wish you all safe travels to D.C.

Chartering a Bus to the Immaculate Conception Basilica in Washington, D.C.

Saturday, Sept. 23, 2023.

Attention to anyone considering reserving a bus for the mass in the crypt at the Immaculate Conception Basilica in Washington, D.C. A local bus provider stated that their company commits to transporting college teams to their destinations, therefore, anyone interested in chartering a bus should book their bus reservations as early as possible so that transportation will be available.

St Wendelin Branch 162 of the FCSU at St. Mary's Nativity Church in Uniontown, PA will be providing a charter bus to the Immaculate Conception Basilica in Washington, D.C. on Saturday, Sept. 23, 2023. A bus seat will cost \$50 per person and is non-refundable Reservations will be confirmed when payment is made and will be on a first come first serve basis. The bus holds a maximum of 54 occupants. 

Professor Martin Javor Visited the FCSU and Other Slovak and Rusyn-American Sites

In June 2023, Professor Martin Javor visited some key Slovak and Rusyn sites in the USA. Dr. Javor is the director of Kasigarda, the Museum of Emigration from Slovakia to North America (Múzea vysťahovalectva z územia Slovenska do Severnej Ameriky) in the eastern Slovak village of Ťahyňa. He traveled to the USA, accompanied by his daughter Anna, to visrials for the museum.





Amboy, New Jersey, which 60 years ago was center of Slovak immigrants on the east coast. His visit there included the home of his ancestors, St. Nicholas Byzantine Church, the site of Holy Trinity Church (built in 1902 and demolished in the 1990s), and St. Nicholas cemeteries.

While in New Jersey, he collected 1400 kg of books and other materials on a pallet, which he sent to Slovakia for the museum. His cousin Milan Javor and his cousin's husband assisted in packing the materials, as he is striving to save the cultural heritage of Slovaks in America.

Next, he traveled to Wilkes-Barre, PA where he visited the Memorial room of Jozef Murgaš, the site of his Sacred Heart (closed), Slovak Lutheran church of St. Matthew Slovak Lutheran Church (closed), and the grave of Jozef Murgaš in the former Slovak Botanical Garden in Dallas, PA. Audrey Wagner Cunfer and Melinda Smith served as guides for his visits here.

Heading west, the Javors then stopped to visit the Sisters in Danville, PA, the former Slovak girls' school, St. Cyril Academy. Sister Loretta Marie, the Director of Jankola Library, accompanied them on a guided tour. Professor Javor was struck by the beauty of the Basilica of St. Cyril and Methodius. The colorful stained-glass windows are decorated with details and subjects from the history of immigration. They concluded their stop with a visit of the Jankola library with its rich collection of books from Slovakia.

The last stop of the Javors was in the Cleveland area where they visited the Slovak Institute at St. Andrew's Benedictine Abbey. Milan Kobulský, the director of the Slovak Institute, served as their guide. They then all went to the FCSU headquarters in Independence, OH for a working meeting with President Kenneth A. Arendt, Executive Secretary Kevin J. Collins, Beáta Begeniová - Fedoriouk, and Regional Director Tom Ivanec, and Terri Ivanec, the former Jednota editor. They all agreed to cooperate in saving the cultural heritage of Slovaks in America.

Branch 796 of District 8 in Egypt/Whitehall, PA Celebrated the 100th Anniversary of the Assumption of the Blessed Virgin Mary Parish in Northampton on Saturday, June 17, 2023

Parish History, 1922-2023

From 1880, Slovak immigrants settled in the Northampton area of northeastern Pennsylvania. They came to America mainly from the village of Slovenská Ves in northern Spiš county to work in the local Cement Mills. Their home parish in Slovakia was the Purification of the Blessed Virgin Mary, now the parish of The Sacrifice of the Lord. Previous anniversary books list several of these families by name. They faced many hardships, including trudging to the church of SS Cyril and Methodius in Bethlehem to hear God's word in their native tongue.

But in 1902 their journey was somewhat shortened when St. Andrew's Church was erected in North Catasauqua, PA. As the number of Catholic Slovaks grew in the Northampton/Whitehall area, so did the desire to have their own church. Their first Catholic Mass was celebrated in Northampton in Laubach's Hall by Father Gaza, then pastor of St. Andrew's Church in an area near the current Cementon Bridge.

The desire to have their own church in Northampton motivated the growing number of Slovak Catholics to search for a suitable location and solicit funds to buy land with the intent of building. This was the foundation of establishing a parish under the patronage of the Assumption of the Blessed Virgin Mary. Soon after Cardinal Dennis Dougherty granted permission to establish a parish, land at 22nd Street and Washington Avenue was purchased for \$2000.00.


The first pastor, Reverend Andrew Fekety, came to Northampton from SS. Cyril and Methodius Church in Bethlehem on June 19, 1922. This date marks the birth of the parish. Parish activities commenced immediately including sacramental preparations for the children of the first Holy Communion class. The laying and blessing of the cornerstone took place in 1923. The church basement was the setting for the first parish Confirmation.

After building a rectory in 1924, and purchasing land for a cemetery in 1926, the parish focused on funding to raise the upper church. In 1929 this was completed. Bishop Gerald O'Hara blessed the church, which was 100 feet long by 50 feet wide with a capacity of 350. The church cost just under \$56,000.00. A Major Celebration and Blessing was held in 1932 for three new bells in the Bell Tower.

Adorning the church as a house of God worthy of giving Him glory and honor was an arduous, expensive task for the parishioners. Pastoral leadership was passed onto Rev. Michael Begany in 1929. With his guidance and strong support from various societies within the parish, the church continued to grow. In 1939 the Parish built a new rectory and converted the existing rectory into a convent for the School Sisters of St. Francis of Bethlehem who taught our children in the newly opened Parish School.

Rev. Michael F. Messaros became our third pastor in 1962. For the 50th anniversary of the parish in 1972, he directed the renovation of the interior of the church and the installation of our Baut Studio Stained Glass Windows, installed Central Air Conditioning, and rebuilt the exterior front and rear steps.

When Monsignor Messaros retired to become pastor Emeritus in June of 1980, the Rev. Michael J. Stone, "the third pastor named Michael in a row," assumed his duties as the fourth pastor of Assumption BVM Church. Although the parish school consolidated with Our Lady of Hungary Regional School soon after, Father



Stained Glass Window of The Assumption of the Blessed Virgin Mary. The most admired and commented reaction of visitors to the parish are the stained-glass windows. They were designed, fabricated, and installed in 1971 by Baut Studios of Swoyersville, PA. They were commissioned by the Third pastor the Reverend Michael Messaros. Monsignor Mesaros was emphatic that the design not be contemporary/abstract, but traditional. The left side windows of the church depict The Joyful Mysteries of the Rosary, and the right side of the Church depicts the Mary and her various titles and the saints

Stone continued to upgrade the classrooms in order to accommodate a burgeoning religious education program for the children. A Mausoleum, capable of holding 460 caskets, was built on the parish cemetery grounds. It was completed in 1990 and blessed by Bishop Thomas Welsh. As our Shepherd, Fr. Stone was an integral part in the parish, growing from 300 to 700 families. Fr. Stone purchased land from the Northampton Lumber Company and constructed a new parking lot for 75 cars. In 1987, Fr. Stone hired our current Director of Music Karen Glose and Adult Choir Director Mary LaBianca. Fr. Stone's time attending to the spiritual needs of the parish became increasingly challenging when Father Stone was also appointed pastor of St. Andrew's parish in Catasauqua. A spiritual connection begun eighty years before was now resumed between the two parishes.

Rev. Stephen J. Radocha became our fifth pastor in March of 1992. He continued the duties of serving the two parishes. Renovations to Assumption B.V.M. completed for our 75th Anniversary included an elevator, a cry room, an expanded choir loft, a renovation of the church social hall and the installation of the new Stained Glass front doors that depict the Founders of the Parish, their parish church in Slovakia, their new home in America, and BVM Parish.

Rev. Monsignor John S. Mraz served as the sixth pastor from 1997 until 2008, and Rev. Francis P. Straka became the seventh pastor in 2008 until his untimely passing in 2017.

In February 2017, the Rev. Monsignor Thomas Koons was named the eighth pastor of the Parish. Monsignor Koons led the parish through the Covid Pandemic with Facebook Live Streaming of the Daily Rosary and all the Masses. The parish takes great pride in the fact that Monsignor Koons has been so successful in the Diocesan Cooks for Collars Competition every year. In the 6 years Monsignor Koons has been pastor, many capital improvements have been made

In the center is the three-story Assumption of the Blessed Virgin Mary Parish designed by Ruhe & Lange Architects. On either side or the people of God.



because of the exceptional generosity of BVM parishioners: a new church roof; a new church sound system; painting of the church stairwells, exteriors of the church and rectory, the Religious Education hallway and classrooms; new flooring in the Religious Education hall; security doors for Religious Education; security cameras for the church, rectory and cemetery; a new social hall refrigerator and freezer; renovation of the convent 1st floor apartment; moving of church office from the basement to the 1st floor of the

rectory. To mark the 100th Anniversary of the founding of the Parish, Monsignor Koons has retained Bahret Studios to update the interior of the church with new lighting, new painting, an updated Ambo, Crucifix, and flooring.

On June 27, 2023, the Parish will welcome our ninth Pastor, the Rev. Patrick Lamb, who will also remain pastor of Queenship of Mary Parish also located in the Borough of Northampton. The Twinning of the two parishes will continue to maintain their separate Parish Identities and finances. Both Parishes have parishioners living in the Borough of Northampton, Whitehall, North Whitehall Townships in Lehigh County, Allen, East Allen, Hanover, Lehigh, and Moore Townships in Northampton County.



Zuzana Čaputová nebude opätovne kandidovať za prezidentku

Bratislava 20. júna (TASR) - Prezidentka Zuzana Čaputová nebude opätovne kandidovať v budúcoročných voľbách na post hlavy štátu. Informovala o tom v utorok v Prezidentskom paláci.

"Neberte, prosím, moje rozhodnutie nekandidovať ako dôkaz toho, že so slušnosťou sa nedá uspieť. Dajú sa s ňou vyhrať voľby, vykonávať mandát a ostať pritom najdôveryhodnejším politikom," povedala Čaputová.

Vysvetlila, že síl na ďalší mandát by nebolo dosť. Svoje rozhodnutie podľa vlastných slov poctivo zvažovala a dôvody preň sú silné. Svojím rozhodnutím nekandidovať sa nevzdáva ideálov ani dôvery v hodnoty, ktorým podriaďovala svoj doterajší profesijný aj osobný život. "Demokracii a spravodlivosti na Slovensku som sa snažila pomáhať pred prezidentským mandátom, počas neho a budem aj po ňom," poznamenala hlava štátu.

Tvrdí, že to, čo pred štyrmi rokmi sľúbila, to pred dokončením svojho mandátu splní. Bude sa snažiť byť pilierom pokoja, slušnosti, vecnosti a ústavnosti. Osud Slovenska podľa Čaputovej nezávisí od jedného človeka. Múdri a empatickí ľudia s energiou kandidovali v komunálnych voľbách, kandidujú v parlamentných voľbách a nie je dôvod, aby tak nebolo aj v tých prezidentských.

"Slušnú a hodnotovú politiku porazí len to, keď jej prestaneme veriť. Ja v ňu stále verím. Moje rozhodnutie je rozhodnutím osobným, keďže dostatok síl je to, čo významne určuje kvalitu verejnej služby," poukázala.

Prezidentka bude svoju prácu naďalej robiť s ľudskosťou a empatiou, pretože je to práca pre ľudí. Počas uplynulých štyroch rokov sa podľa Čaputovej podarilo veľa dobrého.

Väčšina politických strán sa podľa vyjadrenia pre TASR kandidátom na prezidenta zatiaľ nezaoberá. Aktuálnou prioritou sú pre ne septembrové predčasné parlamentné voľby. Niektoré strany čakali aj na rozhodnutie súčasnej hlavy štátu. Podporu Čaputovej deklarovala napríklad SaS, ktorá si však vie ako jej dôstojného nástupcu predstaviť exministra zahraničných vecí Ivana Korčoka.

Mandát prezidentky uplynie v roku 2024. Hlavu štátu volia občania Slovenskej republiky v priamych voľbách tajným hlasovaním na päť rokov. Kandidátov na prezidenta môže navrhnúť najmenej 15 poslancov Národnej rady SR alebo občania na základe petície najmenej s 15.000 podpismi oprávnených voličov.

Zuzana Čaputová Will Not Run for President Again

Bratislava, June 20 (TASR) - President Zuzana Čaputová will not run again in next year's elections for the post of head of state. She informed about it on Tuesday in the Presidential Palace.

"Please don't take my decision not to run as proof that you can't succeed with decency. You can win elections with it, carry out your mandate and remain the most trustworthy politician," said Čaputová.

She explained that there would not be enough power for another mandate. According to her own words, she considered her decision honestly and the reasons for it are strong. By deciding not to run, she is not giving up the ideals or trust in the values to which she has subordinated her professional and personal life up to now. "I tried to help democracy and justice in Slovakia before, during and after the presidential mandate," the head of state noted

She claims that she will fulfill what she promised four years ago before the end of her mandate. She will try to be a pillar of peace, decency, matter-of-factness, and constitutionality. According to Čaputová, the fate of Slovakia does not depend on one person. Wise and empathetic people with energy ran in municipal elections, are running in parliamentary elections, and there is no reason why it should not be the same in presidential elections.

"A decent and valuable policy will only be defeated when we stop believing in it. I still believe in it. My decision is a personal decision, as sufficient forces is what significantly determines the quality of public service," she pointed out.

The President will continue to do her job with humanity and empathy, because it is a job for the people. According to Čaputová, a lot of good things have been achieved during the past four years.

According to TASR, the majority of political parties are not yet considering a presidential candidate. The current priority for them is the early parliamentary elections in September. Some parties were also waiting for the decision of the current head of state. SaS, for example, declared its support for Čaputová, but can imagine ex-minister of foreign affairs Ivan Korčok as her worthy successor.

The mandate of the president will expire in 2024. The head of state is elected by the citizens of the Slovak Republic in direct elections by secret ballot for five years. Candidates for the presidency can be proposed by at least 15 members of the National Council of the Slovak Republic or citizens based on a petition with at least 15,000 signatures of eligible voters.

Dočasná vláda nedokázala získať dôveru parlamentu

Bratislava 15. júna (TASR) - Dočasná vláda Ľudovíta Ódora nezískala dôveru parlamentu, keďže poslanci vo štvrtok odmietli jej programové vyhlásenie.

Zo 136 prítomných poslancov podporilo programové vyhlásenie len 34, 43 hlasovalo proti, 54 sa zdržalo hlasovania a piati sa na hlasovaní nezúčastnili.

V radoch tých, ktorí za program hlasovali, boli poslanci za SaS, nezávislí okolo expremiéra Eduarda Hegera a nezávislý poslanec Tomáš Valášek. Hlasovania sa medzitým zdržali Sme rodina, OĽaNO a nezávislí okolo Petra Pellegriniho. Proti hlasovali len poslanci Smeru-SD a viacerí nezávislí.

Počas rozpravy o programovom vyhlásení v parlamente Ódor požiadal poslancov o dôveru a predstavil hlavné priority programu. Vyhlásil, že jeho kabinet sa snaží upokojiť situáciu v krajine a priniesť kultivovaný politický diskurz. V súčasnosti je podľa neho potrebné zabezpečiť riadne riadenie štátu, pripraviť a realizovať opatrenia na pomoc verejnosti s infláciou a riešiť štátne financie.

Viacerí poslanci vyčítali, že programové vyhlásenie obsahuje len hŕstku konkrétnych riešení, pričom poslanci Smeru-SD nie sú spokojní ani s tým, že v programe nebolo zhodnotenie aktuálnej situácie v krajine.

Caretaker Government Fails to Win Parliament's Confidence

Bratislava, June 15 (TASR) - Ludovit Ódor's caretaker government has failed to win Parliament's confidence, as MPs turned down its manifesto in a vote on Thursday.

Of the 136 MPs present, only 34 supported the manifesto, while 43 voted against it, 54 abstained and five didn't take part in the vote.

The ranks of those who voted in favor of the manifesto included MPs from Freedom and Solidarity (SaS), the Independents centered around ex-premier Eduard Heger and Independent MP Tomáš Valášek. Meanwhile, We Are Family, OLa-NO, and the Independents centered around Peter Pellegrini abstained from voting. Only Smer-SD MPs and several Independents voted against it.

During the debate on the manifesto in Parliament, Odor asked MPs for confidence and presented the main priorities of the program. He declared that his cabinet seeks to calm the situation in the country and bring a cultivated political discourse. Currently, he said, there is a need to ensure a proper governance of the state, prepare and implement measures to help the public with

inflation and address the state's finances.

Several MPs accused the manifesto of containing only a handful of specific solutions, with Smer-SD MPs discontent with the fact that the program didn't include an assessment of the current situation in the country, either.



Insights and Viewpoints

Fourteenth Sunday in Ordinary Time Matthew 11, 25-30 - Gospel Summary

This Sunday's gospel is brief but exceedingly rich in meaning. It has two distinct, though related, parts. In the first, Jesus expresses profound gratitude to the Father, source of all being and goodness, because he has freely chosen to take note of the little ones. He has done so by giving them a share in his divine wisdom, while withholding it from the "wise and learned." This certainly does not mean that God despises learning but rather that the learned are too often tempted to pride, and thus closed to God's gift.

When Jesus says that "these things" are revealed only to the humble and unassuming, he is referring to the revelation that he received from the Father and now offers to all of us. This revelation is nothing less than a message about the real meaning and purpose of our lives. And since it concerns how we love and serve and forgive, it is hidden from those who want to control life by means of their human knowledge, rather than to subordinate that knowledge to the higher wisdom of love and generosity. It is only in this way that one can come to know Jesus as the one who reveals the wisdom and the gift of the Father.

In the second segment, Jesus reminds us that accepting his wisdom of loving service will indeed mean submitting to the yoke of discipline and sacrifice. But it will be a sweet yoke, first of all because we bear it with Jesus, and then because it is a burden that has meaning since it is carried with love.

Life Implications

Those who devote their lives to scholarship have often taken a dim view of religion and in many cases have rejected faith altogether. They see religion as an enemy of real learning and useful only for those who have not yet been "liberated" by knowledge. Too often the children of deeply religious parents, when sent to secular universities, end up with no faith at all. Today's gospel speaks directly to this issue. Jesus is not condemning human learning, even at the highest level, but he is saying that human wisdom will always be trumped in the long run by divine wisdom. This is not a defeat for human wisdom because it was never meant to have the last word.

Jesus heard this "last word" from his Father, creator of all the things that scholars study. He has passed it on to us, by word and by deed, and it tells us that we are called to freedom and then to loving service. Human learning can co-exist quite easily with this wisdom; in fact, it will be greatly enhanced by discovering how much is beyond its comprehension, for this too is an important part of learning. For that reason, all colleges and universities should include a strong religious element in their curriculum. And it is for that reason also that Catholic institutions of higher learning should be supported because it is there that the claims of divine wisdom can be discussed at the graduate level and without prejudice.

And so the "little ones" in today's gospel are not those who are ignorant, much less anti-intellectual. Rather, they are those who are learned enough to know that human beings are not divine and therefore need to be open to the gift of God's wisdom. This liberation from a false ideal of knowledge without limits will help all of us to lighten our yoke when life turns mysterious, and the gift of God is all that really matters.


The Executive Secretary also presented the Membership and Annuity Report.
