October Reflection

October is uniquely Mary's month as we honor her as "Queen of the Rosary." One of our favorite Slovak hymns is "O Mária Ružencová," (Oh, Mary of the Rosary), the hymn for this month's prayerful reflection. This hymn to Mary may bring fond memories to Jednota readers or elderly family members from earlier Slovak-based parishes. I like to recall my own acceptance, as a First Holy Communicant, into the Rosary Society of Holy Trinity Parish in Gary, Indiana.

In the opening verse we call on Mary as Mother of Jesus and our Mother to hear and grant us the gifts of God's love and mercy. We go on to recall how through Saint Dominic we received this gift of the rosary, like a fragrant garland of roses. 45th Slovak Heritage Festival in New Jersey




















Nomination Ceremony in California for the Košice Marathon on October 1, 2023

Professor Stanislav Kirschbaum Awarded Daniel Rapant Prize

On 20 September 2023, on a Zoom link with Slovakia, Emeritus Professor Stanislav Kirschbaum

of the Department of International Studies at Glendon College was awarded the Daniel Rapant Prize at the conclusion of an academic conference organized in Bratislava by Matica Slovenská. Matica Slovenská is an historic Slovak cultural institution founded in 1863, which, since 1995, awards this medal to persons recognised for their contributions to the development of the historical sciences and their efforts to make Slovak history and the life of Slovaks known at home and abroad. It is named after Daniel Rapant, a professor at Slovak (now Comenius) University in Bratislava who was the most outstanding Slovak historian of the twentieth century; he is considered generally to be the father of Slovak history.

Professor Kirschaum, who taught at Glendon College from 1970 to 2022, is recognised internationally as a leading expert on Slovak politics and history. His History of Slovakia. The Struggle for Survival (2nd edition, 2005) is the first comprehensive history of the Slovak people not just in English but in any non-Slovak language, as is his Historical Dictionary of Slovakia (3d edition, 2014). In addition, he has published 60 scholarly articles in English, French, German, and Slovak on various aspects of Slovak history and politics. For his overall scholarship in international studies, Professor Kirschaum was made a Chevalier dans l'Ordre des Palmes académiques de France in 1994, promoted to the rank of Officier in 2015, and elected Fellow of Royal Society of Canada in 2002. The Daniel Rapant Prize is considered one of the most prestigious awards in Slovakia.





Slovak News and Book Reviews By Fr. Gerard Gonda, OSB

• This summer marked the 100th anniversary of "Slovak Day" at Kennywood amusement park near Pittsburgh.

• Slovak Heritage Tours in Deerfield, Massachusetts has seen an increase in Polish-Americans interested in visiting Slovakia because the language and culture are so similar to their Polish experiences.

• Bishop Larry Kulick of Greensburg, Pennsylvania visited Slovakia in July and celebrated Mass in honor of his ancestors in the towns of Nova Bystrica and Stara Bystrica.

• U.S. actress Ema Horvath, 29, was born and raised in the United States by her parents who were Slovak immigrants. Since 2022, she has played Earlen, in the Amazon Prime fantasy television series, "The Lord of the Rings: The Rings of Power."

• Catholic actor Jim Caviezel, who had the starring role in movies: The Passion of the Christ and, more recently, The Sound of Freedom – has Slovak blood through his paternal grandmother.

• The United States Embassy in Slovakia created a traveling exhibit of 30 Notable Slovak-Americans that was displayed first in Bratislava in April, 2023 and then traveled to other cities in Slovakia. Some of figures included U.S. Air Force Colonel Eva Strelka Jenkins, a native of Bratislava, who commands thousands of troops in the U.S. military and Steve Ditko, a comic book artist who helped to create the character of Spiderman.

• You can find a very interesting 10-minute video called "10 Things That Shock Tourists When Visiting Slovakia" produced by Wolter's World, a You Tube video travel series. The narrator gives Slovakia higher points in several categories over neighboring countries.

Book Review: Arcadia Publishing

You may be familiar with one or another of the interesting, compact, paperback books of the "Images of America" series of Arcadia Publishing which operates out of Charleston, South Carolina; Chicago, Illinois; Portsmouth, New Hampshire; and San Francisco, California. This series allows you to learn the history of your hometown written by local authors. You can often find them in your local drugstore.

However, if you go on the website - https://www.arcadiapublishing.com/collections/images-of-america, you will be surprised to find a number of books related to Slovak-Americans in different locations of the United States (search "Slovak"). Some of these volumes are written by local Slovak fraternalists like John T. Sabol (Cleveland, Ohio) and Loretta Ekoniak (Youngstown, Ohio). Each book covers about 127 pages of mostly historical photographs with informative captions. As such, they are very effective in bringing memories to surface that have been forgotten with the passage of time.

The website lists the following Slovak-related volumes, each selling for \$21.99. I came across the following:

• "Slovaks of Chicagoland" - by Robert Fasiang and Robert Magruder

• "Slovaks of the Greater Mahoning Valley" – by Loretta Ekoniak

"Slovak Pittsburgh" – by Lisa Alto

• "A Race to Freedom – the Mira Slovak Story" – by David Williams (about a young airline pilot, born in Cifer, Slovakia, who escaped communism in 1953 by hijacking his own commercial flight and later became a hydroplane racing champion and a stunt flyer and who died in 2014.)

• "The Anthracite Coal Region's Slavic Community" by Brian Ardan

• "Cleveland Slovaks" by John T. Sabol and Lisa Alzo

• "Cleveland's Buckeye Neighborhood" by John T. Sabol.

Also, if you search under "Catholic" you will find volumes about the historic Catholic churches in cities like Cleveland, Pittsburgh, Chicago, and Detroit, as well as histories of some religious orders like the Chardon and Covington Provinces of the Sisters of Notre Dame.

The Eldred WW2 Museum

On June 30, 2023, Charles Boone of Dormont, the originator of the one and only exhibit to honor the Slovak immigrant who served in World War II, officially dedicated, and opened the exhibit at the Eldred WW2 Museum in Eldred, Pennsylvania.

Father Thomas Brown, from St Raphael's Parish in Eldred, blessed the Slovak American Exhibit and all of the Slovak American veterans who were called to serve to keep our Nation free.

Rod Beihler of Eldred worked with the museum in making the plaque and donated his services honoring our Slovak American veterans.

The Eldred Museum designed the exhibit from a life story submitted to the museum about the late WW2 veteran Private Henry Harchar previously from Bentleyville, PA. Private Harchar's family immigrated through Ellis Island from Zdoba, Czechoslovakia over 100 years ago. Private Henry, like other teenage immigrants, dropped out of school and worked to help their family during the Depression. Many of the life stories included situations of how the immigrants overcame the language barrier. Harchar was then drafted and served his Country overseas. While fighting in Germany, Private Harchar's feet were frozen fighting from a foxhole. Several life stories detailed that during the war the serviceman would send money home to help their families. Like many others, after the War, Private Harchar came back to resume his normal life. This 'Greatest Generation' of soldiers rarely shared their war stories at that time.

The Eldred WW2 Museum's emphasis is on the individual's experience in the war. They have thousands of stories of what the WW2 veterans experienced. We are proud that our new Slovak American Exhibit is near the library of these stories.

If you have a WW2 life experience story of your Veteran, you can still send it to the Eldred WW2 Museum. The documents you will send to the museum will not be returned so please send copies. In sending the documents, ask them to put the information with the Slovak American Exhibit. Any questions about the exhibit can be directed to Charles at SlovakAmericanWW2exhibit@gmail.com.

Our exhibit depicts a typical Slovak immigrant who was drafted to serve their new country and was a Private in the Army Infantry. It preserves the memory of the brave immigrants serving their new nation.

For the display, the soldier is a sentinel.

He passes the names and heroic acts of bravery to all so the visitors will remember

LIGHT ONE CANDLE Be a Blessing from the Lord Fr. Ed Dougherty, M.M., The Christophers' Board of Directors

Jesus told us that the two greatest commandments are to love God and love our neighbor. In today's world, we often seem to fall short on both counts. It's almost as if we need daily reminders to get in touch with the "better angels of our nature," to use Abraham Lincoln's term. While there are various ways to do this, I'd like to add one more to the mix: Volume 58 of The Christophers' annual "Three Minutes a Day" book, which features stories, Scripture verses, and short prayers for each day of the year.

What kinds of stories are featured in the book? Here is one example: In 2021, Gean Le-Var of Glendale, Arizona, lost her husband of 58 years when he passed away in their home. To make matters worse, the police—after entering the house and seeing how unlivable the conditions were—had no choice but to condemn it. Gean lost her husband and home all in the same day, and she had no family members to help her.

That's when her neighbor, Carmen Silva—who barely knew Gean at the time—stepped in. As reported by CBS News, Carmen told Gean, "Don't worry...We're going to fix it." Carmen invited Gean to live in her home. Although Carmen's small, three-bedroom house with eight children was already full, the family eagerly made room for one more, treating Gean like an "adopted grandmother." Carmen explained, "I've always taught my kids to take care of their elders."

In another expression of neighborly kindness, the nonprofit group Operation Enduring Gratitude, which helps Arizona veterans and their families, heard Gean's story and rebuilt her house, making it livable once more. Gean now plans to share her new home with her adopted family. The Scripture verse that goes along with this story is the obvious choice: "You shall love your neighbor as yourself."

The actions of Carmen toward Gean reflect a divine selflessness that each of us can choose as well. Or, we can emulate the generosity of someone like the subject of this other "Three Minutes a Day" story: For approximately 10 years, on the first of every month, Alabama farmer Hody Childress secretly performed a good deed. He would walk into Geraldine Drugs, a pharmacy in his DeKalb County community, and give a folded up \$100 bill to owner Brooke Walker. His instructions? Use the money to help people who couldn't afford their prescriptions. And if anyone asked where the money came from, he told her to say, "It's a blessing from the Lord."

When Childress began experiencing medical problems, he sent a relative to deliver the money to Walker, never telling the relative what exactly it was meant for. His acts of kindness were only revealed after Childress passed away at age 80 in 2023. Walker told AL.com that she used the money "to help children needing Epi-Pens for allergic reactions, families in between insurance coverages, and people just leaving the hospital." Childress's family and friends are working to establish a fund in his name to continue the practice.

Each of us can be "a blessing from the Lord" for others. Of course, sometimes we need blessings ourselves, and "Three Minutes a Day" also contains numerous stories about people dealing with the challenges and tragedies of life with help from their faith. REQUESTS FOR ADS AND DONATIONS:


Requests for donations and ads were reviewed and acted upon.


AQS REPORT:
