## Message from the National Chaplain

Happy New Year. May the Lord bless you and your loved ones with everything that is good.

We just finished celebrating the birth of our Savior at Christmas. Like every year, there are several people who wait until the very last minute to get themselves ready for the holiday. There are the last-minute shoppers, the last-minute greeting card senders, the last-minute decorators. There are even those who go to Confession at the last minute.

A similar approach is taken for Lent. A good number wait until the last minute to decide what they want to do as a spiritual exercise for Lent.

With Ash Wednesday shortly approaching (it is February 14 this year), here are some suggestions, some spiritual, some temporal, to help you get an early start in choosing what act or acts of penance you may wish to carry out this Lent.

Spiritual Exercises include:

· Attend daily Mass.

- Pray the Rosary.
- Pray the Divine Mercy Chaplet.
- · Make a Holy Hour in the presence of the Blessed Sacrament.
- Pray the Stations of the Cross.
- Make a pilgrimage to a religious shrine.
- Pray for peace and the conversion of sinners.
- Go to Confession.

 Choose a saint, read his/her biography, and put into practice one aspect of that saint's life. Temporal Exercises include:

- Reduce the time you spend on social media.
- · Perform a corporal work of mercy.
- Reduce the size of your meal portions.
- Make a donation to the Pontifical Mission Society.
- Make a donation to church-based organizations that help people in recovery.

Please remember that Catholic adults between the ages of 18 and 59 are seriously bound to fast on Ash Wednesday and Good Friday, and that Catholics 14 years of age and older are seriously bound to refrain from eating meat on Ash Wednesday and all Fridays of Lent.

## The Baptism of the Lord

#### Gospel, Mark 1:7-11

The Baptism of the Lord marks the end of the Christmas Season. In a few short weeks we have gone from the baby in the manger to the thirty-year-old Jesus preparing to begin his ministry. At the time of Jesus there was what was known as the "baptism of repentance." This was an act in which the Israelites would take on God's judgment as a sign and act of their own desire for them individually and the people of Israel to repent of their offenses against the covenant. The Covenant of Moses took place in the Sinai dessert, so it's no wonder that John the Baptist would be performing his ministry in the wilderness of Judea. Jesus comes to take part in this ritual as a sign that he would ultimately be the one who takes away the sins of the world. The Baptism that Jesus gives to us is not merely a sign, but it is the actual forgiveness of sin and adoption into God's family.

There are two important elements of the passage we hear today, the message of John the Baptist, and the manifestation of the Trinity at Jesus' Baptism by John. John's message is not only a call to repent; it is a call to get ready for the Messiah. He is preparing the way for the Lord and in humility announces that one mightier than he is coming. John had disciples as well as other followers. Human nature would tempt him to maintain his ministry and enjoy the attention and fame, but John did not give into this temptation, without hesitation he pointed his disciples and followers to Jesus. We are told elsewhere in Scripture that some did leave John in order to follow Jesus. John is for us a model of humility. The second element is that of the manifestation of the Trinity at Jesus' Baptism. We have Jesus, the Father's son and second person of the Trinity, standing in the Jordan while John Baptizes. As Jesus emerges from the water, we are told that, "the Spirit, (the third person of the Trinity) like a dove, descended upon him." Finally, there is the beautiful manifestation and revelation by the Father, the First person of the Trinity. The voice of the Father is heard speaking directly to Jesus and saying, "You are my beloved Son; with whom I am well pleased."

I imagine that our Heavenly Father says the same thing about everyone who is Baptized, for at the moment of our Baptism we become children of God. How could the Father not be pleased? Our challenge is to maintain that relationship so that as the Father continues to be pleased. How can we be pleasing to the Father? We can begin by following the example of John the Baptist and living lives of true humility. That is in acknowledging that we are not the Messiah or Lord, only Jesus is, and it is he who should be first in our lives. It is a humility in which we acknowledge the gifts and talents we have, and the particular vocation or call God has given us. John in his humility did not shy away from his call to be the prophet who announced the coming of the Messiah, and he did not hold back in using his preaching gift to proclaim this. The same should be true with us. If we begin to live truly humble lives, we will surely be beloved sons and daughters of the Father in whom he is well pleased.

#### Stephen C. Matula Scholarship

## IMPORTANT NOTICE PRIVACY – PERSONAL FINANCIAL AND MEDICAL INFORMATION

We do not disclose any personal, non-public information about you to anyone, except as permitted or required by law. We will not disclose personal medical information about you, except as permitted by law or as you may authorize.

We restrict access to your personal, insurance and medical information to those of our employees who need to know that information in order to provide insurance or service to you. We are, and will continue to be, vigilant in the safeguarding of your personal, financial, and medical information. We maintain physical, electronic and procedural safeguards to comply with Federal and State regulations regarding the safeguarding of Non-Public Information.





## Carrie Borah - "God gave us the answers we were looking for"

Carrie Borah, Member of the FCSU Branch 24 and owner of Making Memories at Wiegand Lake Park in Novelty, OH, said there are three things she would use to describe herself.

"I'm a person that's blessed to be an American, I am Catholic, first and foremost, above all, and my Slovak heritage, being 100%, Slovak," Carrie said. "And it all comes from my family."

Carrie, the youngest of four, was taught how important her heritage, faith and family values were ever since she could remember.

Carrie's great grandparents and grandparents came by boat to America from Slovakia in the 1910's. Her great grandparents and grandmother came to the states and opened a boarding house. There her great grandmother and grandmother cooked their Slovak recipes for guests, interacted with visitors and served many different people coming to America. Carrie's grandmother met her grandfather at the boarding house and married. Together they instilled their traditions and values to Carrie's mother and 6 siblings.

Growing up Carrie's family kept their Slovak traditions close to their hearts and loved to share their heritage with others. Any event they were able to teach others of their Slovak heritage, or provide a home-cooked Slovak meal, they would.

"Through school, anytime we had to do a speech or any kind of presentation, my sibling and I would present on our Slovak heritage," Carrie said. "And we would bring


foods like haluski or kolache." Her family was even featured in a 1978 article for the Parma Sun Post about ethnic Christmases. They had the opportunity to share their family, Slovak traditions and the significance of the Christmas dinner.

Along with being Slovak, being Catholic has always been a strong part of Carrie's life. She remembers always dedicating Sundays to family and church. They would never miss a Sunday service and after Mass they would go over her Aunt's and Uncle's home to be together as a family, and listen to polka.

Carrie always knew she wanted to pass on those traditions and values to her children. She wanted to be a stay-at-home mom to teach her children about their heritage, faith and provide home-cooked meals every day, as her mother did. And in 1999, she married her husband Ken, who wanted the same things she did.

Carrie and Ken have three children together, Annie, Kyle and Joslyn, who were all taught at a young age those core values. Her family would practice the same oldschool Slovak traditions and recipes that her grandmothers passed down, as well as to look to prayer for answers and know God will provide.

Blessed to be a stay-at-home mother, Carrie was very active when it came to school events, sports, church and the community. She was that hands on mom who always would cook for activities and organize or help out at events. She especially loved being part of a community or an event that shared her heritage and faith, such as the FCSU.

As her kids were growing older, and her youngest was about to enter high school, Carrie knew she wanted to enter back in the work force. Around the same time, she discovered Wiegand Lake Park in Ohio was for sale and became upset of losing the special place. It wasn't till a few months later that her husband brought up the idea of purchasing the park.

Carrie said this was a life changing decision, that she couldn't answer at the time. The whole family took the question to prayer, knowing God will give them the answer they are looking for.

At the time her and her youngest daughter, Joslyn, would go to the Chapel after school to pray and started a Novena. On the ninth day of the Novena, she said her daughter knew the answer to their prayers.

They all love helping people come together to create life-long memories, no matter what event, and hold special memories at each celebration.

*"It's one of my greatest joys of being able"* to be at the park, is being able to meet people," Carrie said, "and be a part of whatever celebration is going on and help them find joy."

One event she said she loves doing is the FCSU National Picnic at Wiegand Lake Park as it is a time to celebrate her heritage and Catholic faith. She said her youngest daughter, Joslyn, loves to cook and makes all the traditional recipes for picnic guests. Her entire family looks forward to the music, people and the celebration.

Looking back on it, Carrie said all the work she had done being a stay-at-home mom has led her to this new career.

"I like to look at it as God was preparing me to be this event planner, to be able to plan these amazing parties and events for people," Carrie said.

Carrie believes she has been truly blessed with the life she's been given and that's the only way she can describe it. She is able to share her faith and heritage with all the people she meets and has her family with her every step of the way. She doesn't take credit for being fortunate but owes everything to what she was taught and believes at her core.

"I could say I made these decisions, but I didn't," Carrie said. "It's because of what my family has instilled in me, being able to be born here in America, and everything that my parents taught me about my Catholic faith and our heritage."

## Sister M. Susan Polchin, SS.C.M.

"The Lord has done great things for me, and holy is God's name." Luke 1:49

We thought a Sister who is one hundred years old could have some good advice for any young girl willing to listen. Sister M. Susan, SS.C.M. says, "If you feel God is calling you, DARE TO LISTEN AND FOLLOW. It is a decision you will never regret."

Sister Susan has graciously told us about her life. It is long and full of wisdom which she has shared willingly because she wants to make sure we know God is good and loves us, his children, a great deal.

Sister Susan has told us she came from a large and loving family, the second youngest of nine children whose mom and dad were Susan and George Polchin. "I had five brothers, George, Joseph, Andrew, John, and Edward; three sisters, Margaret, Catherine and Emily. I was baptized Mary Margaret

in Holy Trinity Slovak, our parish church in Hazleton, PA.'

"Our family's strong faith enabled us to deal with the hardships we endured over the years. When I was only eleven, my dad was killed in the mines. Later my mom at the age of 62 had a stroke and required constant care.'

As a member of the Sodality at Holy Trinity, I got the idea it would be good to reward the sodalists who had perfect attendance at meetings with certificates. The information I needed was in the hands of the Sisters of Saints Cyril and Methodius who taught at St. Joseph School. Certainly, it was God's Providence that led me to the convent on Laurel Street where I met the superior, Sister Philip. Without any hesitation, Sister asked me if I had given any thought to becoming a Sister myself. She had no hesitation either in encouraging me to think about religious life. Later when I did apply and was accepted, Sister Festina was the Cyrilite who accompanied me to Geisinger in Danville for my physical examination. I still remember Sister Festina who was the "house Sister" at St. Joseph's Convent, who made delicious cookies, she was willing to share with a young prospective Sister.

I attended the local public schools for my elementary and secondary education. When I was a sophomore in 1939, I attended a Reception and Profession ceremony at Villa Sacred Heart, the Motherhouse of the Sisters of Saints Cyril and Methodius. This ceremony marked a turning point in my life. I began to think seriously about becoming a Sister. After I had graduated from high school in 1941, I worked in a factory to help the family. Though at one time I had considered remaining at home and holding a job, my mother made it clear she was delighted with my choice of religious life and gave me her blessing.

In 1946, I became a postulant. When I made my first profession, my mother was there, but five months before my final profession, God called her to Himself. After I had professed the vows of poverty, chastity and obedience, I was assigned to teach at St. Cyril Academy where I taught physical education and also gave violin lessons. My next assignment was at St. Mary's in Shamokin, PA. After three years the school closed and I went to St. Ann's in Binghamton, NY as teacher and principal. In 1974 while there I celebrated my Silver Jubilee. I remained in Binghamton but taught for four years at St. Cyril's. I experienced quite a change when I went to St. Andrew's in Waynesboro, PA where I spent six years as principal. In Binghamton there were many churches, seventeen elementary schools and two high schools. I did ultimately get accustomed to living in a small town with only one church and one Catholic school.

In 2008 I was delighted to return to Waynesboro to celebrate the centennial of St. Andrew's Church. I stayed in Pennsylvania at St. Catherine Laboure School in Harrisburg for three years before moving on to Holy Trinity School in Perth Amboy, New Jersey where I taught four years before the school closed.

When I returned to Broome County in New York, I became a computer teacher for grades K-3 at St. Joseph School in Endicott. I also took on the role of parish minister at St. Ann's in Binghamton and visited the homebound and parishioners in nursing homes and hospitals. A few volunteers from the Altar Rosary Society and I started a bereavement group to help parishioners plan their loved ones' funeral liturgies. In June 2004, the three churches in Binghamton, St. Stanislaus, St. Ann, and St. Joseph, merged. Two Sisters visited nursing homes and I visited shut-ins and hospital patients. We also had a Sister who devoted herself to liturgical and youth ministry as well as Adult Education/RCIA. Besides my other parish activities, I took care of the altars, changed the vigil and votive lights, and cleaned the sanctuary. During my active ministry I was always edified by the parishioners' faith in God and their patience in illness. I was sustained in my ministry by my participation in the Eucharist.

When I went to live at Maria Hall, I took my turn as receptionist. Through phone ministry I was able to keep in touch with the people I had once ministered to in Binghamton.

We have all heard the expression "The family that prays together stays together." We as a congregation can take that saying to heart. Praying together as a religious congregation gives us hope for the future of religious life.

For relaxation I enjoy watching a good game of football, basketball, or baseball on the sports channel. At one time it was also a pleasure to have a pinochle game with the Sisters. When I had the opportunity to visit home, I played pinochle with my sisters, Margaret, Emily, and Catherine. When the Dominican Sisters took up residence at Maria Hall, I asked Sister Anne Renee and her sister to teach me how to play canasta. While the Dominicans lived at Maria Hall, I gave up watching TV and joined them for a game of canasta.

Since I have a talent for music, I can still recall the many times I spent playing the violin for liturgies, prayer services, socials, and Sisters' jubilee celebrations. I also joined other Sisters who went caroling to the homes of parishioners and to the local hospital. When I needed a break from more serious duties, I played the harmonica.

Let me close by sharing with you my two favorite quotations: "You have not chosen me, I have chosen you," and "Do not let your hearts be troubled. Have faith in God and faith in Me." These quotations are a mainstay in my endeavor to lead a holy life, one that directs all my thoughts and actions to following the good Lord.

### LIGHT ONE CANDLE The Seed Planted in St. Paul's Heart Fr. Ed Dougherty, M.M., The Christophers' Board of Directors

January 25th is the Feast of the Conversion of Saint Paul, when we commemorate a monumental event in the life of the early Christian Church. Occurring in the years immediately following Christ's death and resurrection, Paul's conversion happened abruptly, but its effects have remained with us ever since, resounding throughout the centuries and speaking to humanity of the astounding power of God to intervene in our lives.

It happened on the Road to Damascus, where Paul was on his way to capture Christians and bring them to Jerusalem for punishment. Just before entering the city to terrorize the followers of Christ, Paul was met with a flash of light and fell from his horse. Jesus then spoke to him, saying, "I am Jesus, whom you are persecuting; but rise and enter the city, and you will be told what you are to do."

Paul was blind for three days after that miraculous encounter, until Jesus appeared in a dream to one of the Christians of Damascus telling him to go to Paul. The man went and laid his hands on Paul, who was healed in the name of Jesus. He was baptized, became part of the Christian community, and went on to become the greatest evangelist of his time.

It's interesting to note that Saint Stephen's martyrdom laid the groundwork for Paul's conversion because something happened at that event to plant a seed in Paul's heart, a seed just waiting to grow once he discovered Christ. Paul was present at the stoning of Saint Stephen, when the great apostle gave witness to the depths of his faith by forgiving his attackers even as they put him to death. As a figure in authority, Paul may have ordered the execution or was overseeing it in some manner, and one can only imagine the lingering effect Stephen's act of forgiveness would have had on Paul and others involved.

Looking at these key points in time bracketing the conversion of Saint Paul-from the seed of forgiveness planted in his heart at Saint Stephen's stoning, and culminating with the healing intervention of a follower of Christ-we see a dynamic that has played out repeatedly ever since the Holy Spirit was given to the Church after the Resurrection. This dynamic that comes to life so vividly in the story of Paul's conversion is rooted in the reality that God desires to work through each one of us. This is why Christ came into the world, to enter the struggle of humanity in the most intimate and sacrificial way.

In working through us, Christ calls us to witness to each other, like Saint Stephen's witness of forgiveness. And He calls us to go to each other on healing missions in the way His follower from Damascus went to Paul. These witnesses were joined to the miraculous intervention of Christ on the Road to Damascus to help inspire Paul to spend the rest of his life providing witness to others through preaching so exquisite, it is handed down to us as part of Sacred Scripture itself.

Paul witnessed to us in the way he lived after his conversion and right up to the way he died, following in the footsteps of Saint Stephen as a holy martyr of the Church, giving up his life to join with the other martyrs and Christ Himself in becoming the seed that produces good and lasting fruits. May Saint Paul intercede for us and inspire us daily to take up our cross and follow Christ.

## Nová publikácia Matice slovenskej venovaná životu a dielu Mons. Františka Jozefa Fugu

V roku 2023 sa v jubileách krajanského kalendára skvelo najmä meno Františka Jozefa Fugu (pôvodným menom Figu). Významný rodák z Vinného (okr. Michalovce) je časti slovenskej verejnosti známy najmä ako kňaz, neúnavný vydavateľ, editor, redaktor, tlačiar a agitátor slovenského života na severoamerickom kontinente, autor návrhu jednej z

podôb slovenskej zástavy a tretí predseda Zahraničnej Matice slovenskej. I napriek obrovským pronárodným zásluhám, Slováci tohto exulanta takmer nepoznajú.

Matica slovenská si ho cielene pripomína už takmer tri desaťročia, od čias keď nadviazala prvé kontakty so Zahraničnou Maticou slovenskou. Pri príležitosti stého výročia jeho narodenia, 7. júna 2023, si Matica slovenská sprítomnila jeho život a dielo vedeckým podujatím vo svojom ústredí v Martine. V týchto dňoch zo seminára vydala zborníkové dielo.

Úvodným príspevkom je príhovor jeho zostavovateľky, Zuzany Pavelcovej, ktorá približuje dôvody konania pripomienky života a diela Fugu a vzniku zborníka. Zaoberá sa priebehom vedeckého seminára, z ktorého toto dielo vzniklo a sumarizuje aktivity Matice slovenskej venované tejto osobnosti. Prvý príhovor patrí predsedovi Matice slovenskej, Mariánovi Gešperovi, ktorý čitateľa upriamuje na cyrilo-metodské súvislosti v paralelách života a diela Františka J. Fugu, historicky tretieho a v jeho hodnotení najúspešnejšieho predsedu Zahraničnej Matice slovenskej.

Osobná spomienka Jozefa Rydlu je memoárom zachytávajúcim súkromné prepojenia autora príspevku a osobnosťou Fugu. Autor spomína na počiatočné kontakty s Fugovým dielom, ktoré viedli až k prvým spoločným stretnutiam. Príspevok synovca Františka Jozefa Fugu, Františka Cupáka, prináša Fugov podrobný životopis vystavaný nielen na archívnych a knižných dokumentoch, ale i na osobných spomienkach, ktoré získal pri svojej návšteve kanadského Hamiltonu. Zaoberá sa jeho rodinnou genézou, obdobím detstva, štúdiami, odchodom do emigrácie, kňazským a pracovným poslaním i životnými osudmi. Osobitne sa venuje jeho návrhu slovenskej zástavy. Zuzana Pavelcová vo svojom príspevku prináša ďalšie doplnenie životných osudov F. J. Fugu. Zame<text>

riava sa na jeho vydavateľskú činnosť, históriu a aktivity Zahraničnej Matice slovenskej pod jeho vedením súvisiace. Približuje aktivity Matice slovenskej a občanov obce Vinné v oblasti zachovania Fugovej trvalej pamiatky. Štúdia Beáty Katrebovej Blehovej sa orientuje na dva rozmery vzťahov Františka Jozefa Fugu s vtedajšou najvýznamnejšou exilovou organizáciou – Svetovým kongresom Slovákov (SKS). V prvej línii sa zaoberá sa jeho individuálnym vkladom a jeho osobnými funkciami v orgánoch SKS. V ďalšej časti hodnotí zmysel členstva Zahraničnej Matice slovenskej pod vedením F. J. Fugu.

Pôsobenie F. J. Fugu medzi gréckokatolíkmi v Kanade mapuje príspevok Daniela Černého. Autor sa venuje najmä jeho činnosti po kňazskej vysviacke a jeho náboženským aktivitám. Nazerá na jeho činnosť komplexne s dôrazom na duchovnú a vydavateľskú činnosť. Časť príspevku je venovaná i chrámu v Hamiltone.

Dielo recenzovali ThLic. Viliam Komora, PhD. a Mgr. Jaroslav Durec, PhD. Vzniklo v spolupráci s PhDr. Evou Čulenovou, PhD. z Vydavateľstva SIGNIS, ktorá zabezpečila jazykovú korektúru a grafický dizajn publikácie. O preklad resumé sa postaral Mgr. Peter Schvantner. ## New Publication of Matica Slovenská Dedicated to the Life and Work of Mons. Franz Joseph Fuga

In 2023, the name of Frantisek Jozef Fuga (original name Figu) especially became known in the jubilees of the compatriot calendar. A prominent native of Vinné (district of Michalovce), he is known to the Slovak public mainly as a priest, tireless publisher, edi-

tor and agitator of Slovak life on the North American continent, author of the design of one of the forms of the Slovak flag and third chairman of Foreign Matica slovenská. Despite his enormous pro-national merits, Slovaks hardly know this exiles.

Matica slovenská has been purposefully commemorating him for almost three decades, since the time when it established its first contacts with Foreign Matica slovenska. On the occasion of the centenary of his birth, on June 7, 2023, Matica slovenská presented his life and work with a scientific event at its headquarters in Martin. These days she published a collection of proceedings from the seminary.

The introductory speech is a speech by its composer, Zuzana Pavelcová, who explains the reasons for holding a reminder of the life and work of Fuga and the creation of the proceedings. It deals with the course of the scientific seminar from which this work originated and summarizes the activities of Matica slovenská dedicated to this personality. The first speech belongs to the chairman of Matica slovenská, Marián Gešper, who draws the reader's attention to the Cyrillo-Methodian context in parallels between the life and work of František J. Fuga, historically the third and in his evaluation of the most successful chairman of Foreign Matica slovenská.

The personal memoir of Jozef Rydla is a memoir capturing the private connections of the author of the paper and the personality of Fuga. The author recalls the initial contacts with Fuga's work, which led to the first joint meetings. The contribution of Frantisek Jozef Fuga's nephew, František Cupák, brings Fuga's detailed biography based not only on archival and book documents, but also on personal memories he gained during his visit to Hamilton, Canada. It deals with his family genesis, the period of child-

hood, studies, emigration, priestly and professional missions and life destinies. He is particularly concerned with his design of the Slovak flag. In her contribution, Zuzana Pavelcová brings further addition to the life fates of F. J. Fuga. It focuses on his publishing activities, history and related activities of Foreign Matica slovenská under his leadership. Explains the activities of the Matica slovenska and citizens of the village of Vinné in the area of preservation of Fuga's permanent monument. Beáta Katrebová Blehová's study focuses on two dimensions of František Jozef Fuga's relations with the then most important organization in exile – the World Congress of Slovaks (SKS). On the front line, it deals with his individual input and his personal functions in the bodies of the JCG. In the next part, he evaluates the meaning of membership of Foreign Matica slovenská under the leadership of F. J. Fuga.

The activity of F. J. Fuga among Greek Catholics in Canada is mapped by the contribution of Daniel Černý. The author focuses mainly on his activities after his ordination to the priest-hood and his religious activities. It views its activities comprehensively with an emphasis on spiritual and publishing activities. Part of the paper is also devoted to the Hamilton Temple.

The work was reviewed by ThLic. Viliam Komora, PhD. and Mgr. Jaroslav Durec, PhD. It was created in cooperation with PhDr. Eva Čulenová, PhD. from the SIGNIS Publishing House, who provided the language proofreading and graphic design of the publication. The summary was translated by Mgr. Peter Schvantner. From the testimonial of J. Durec we select: "The collection of contributions on the life and work of Franz Jozef Fuga is currently a sought-after work, as today he is a relatively unknown figure in national history. After reading the proceedings, readers will gain valuable information about the personality of František Jozef Fuga and, in connection with his life and work, also about the socio-political context in which he lived and worked. For this reason, we recommend the proceedings to all those who focus on the issue of Slovaks living abroad and want to learn as much as possible about it."

### Prezidentka vymenovala za rektora Akadémie ozbrojených síl A. Sabóa

Bratislava 18. decembra (TASR) - Prezidentka Zuzana Čaputová vymenovala v pondelok za nového rektora Akadémie ozbrojených síl generála M. R. Štefánika v Liptovskom Mikuláši Aurela Sabóa. Novému rektorovi zaželala úspešné pôsobenie na čele elitnej školy.

# The President appointed A. Sabó as Rector of the Academy of the Armed Forces

Bratislava, December 18 (TASR) - President Zuzana Čaputová on Monday appointed Aurel Sabó as the new rector of the Academy of the Armed Forces in Liptovský Mikuláš. She wished the new rector a successful tenure at the head of the elite school.

"The reality east of our borders confirms that peace and security are not a given. These are values that must be protected. Among other things, training, sufficient financial and personnel resources and, last but not least, the efforts of individuals and institutions. The Armed Forces Academy plays a vital role in this, and this places great demands and responsibility on you personally," the president said in her address.

According to the president, in the 50 years of its existence, the academy has profiled itself as a top higher educational institution that educates future security defenders. "Therefore, it is extremely important that your listeners not only acquire new knowledge, but also shape their character, commitment to democratic values and patriotism," the head of state declared.

As stated by the president, the rare interplay of professional and human qualities is also confirmed by the personal story of the new rector, who, according to her, was able to combine military training with scientific work. She emphasized that she is dedicated to communication and information systems. It speaks of a key area for the defense capabilities of the armed forces in the 21st century.

### Hasiči majú 7 nových zásahových vozidiel do ťažko dostupného terénu

Bratislava/Malacky 4. decembra (TASR) - Hasiči majú sedem nových zásahových vozidiel. Určené sú na zdolávanie a likvidáciu lesných požiarov v ťažko dostupnom teréne naprieč celým Slovenskom. Novú hasičskú techniku odovzdala v pondelok v Malackách prvá štátna tajomníčka Ministerstva vnútra (MV) SR Lucia Kurilovská a prezident Hasičského a záchranného zboru (HaZZ) Pavol Mikulášek.

"Je to náhradná generácia obdobných vozidiel, ktoré dnes už majú viac ako dvadsať rokov, a preto v najvyššom čase a najvyššej potrebe ich dostávame do výkonu služby," skonštatoval Mikulášek.

Novú hasičskú techniku si prevzali zástupcovia z Krajského riaditeľstva HaZZ v Trnave, ďalšie boli prerozdelené medzi skupiny západ, stred a východ modulu GFFF-V (Modul pozemného hasenia lesných požiarov).

Tým budú vozidlá strategicky rozmiestnené po celom Slovensku. Cisternová automo-

bilová striekačka je výnimočná vysokým podvozkom a priechodnosťou v teréne, čím je predurčená najmä na zásahy v ťažkom teréne. Typ vozidla sa osvedčil aj pri poskytovaní medzinárodnej pomoci krajinám zasiahnutých rozsiahlymi lesnými požiarmi.

Projekt Posilnenie intervenčných kapacít HaZZ sa realizuje vďaka podpore z Európskeho fondu regionálneho rozvoja v rámci Operačného programu Kvalita životného prostredia. Cena jedného vozidla je 407.160 eur s DPH.

## Firefighters have 7 new emergency vehicles for hard-to-reach terrain

Bratislava/Malacky, December 4 (TASR) - Firefighters have seven new emergency vehicles. They are designed to fight and extinguish forest fires in hard-to-reach terrain across Slovakia. The new firefighting equipment was handed over on Monday in Malacky by the First State Secretary of the Ministry of Interior (MV) of the Slovak Republic Lucia Kurilovská and the President of the Fire and Rescue Corps (HaZZ) Pavol Mikulášek.

"It is a replacement generation of similar vehicles, which are now more than twenty years old, and therefore at the highest time and the highest need we get them into service," said Mikulášek.

The new firefighting equipment was taken over by representatives from the Regional Directorate of HaZZ in Trnava, others were redistributed among the west, central and east groups of the GFFF-V module (Module of Ground Forest Firefighting).

This will place the vehicles strategically throughout Slovakia. The tanker car syringe is exceptional for its high chassis and off-road capability, which makes it ideal especially for interventions in difficult terrain. The type of vehicle has also proven itself in providing international assistance to countries affected by large-scale forest fires.

The project Strengthening the intervention capacities of the HaZZ is implemented thanks to the support from the European Regional Development Fund under the Operational Program Quality of the Environment. The price of one vehicle is 407,160 euros including VAT.

#### ADJOURN:


