Finally, as we enter February we are now in the heart of tax season and approaching Tax Day. The deadline to file your taxes is right around the corner - April 15th, 2024 to be exact. All of your tax required documents should have been sent to you by January 31st, making now the perfect time to schedule an appointment with your tax advisor to get a head start.

We understand this can be stressful, that's why this year the FCSU wants to make this tax season easier when it comes accessing your documents. We have implemented a new feature for our Members who have an Annuity or IRA product. As of January 31st, a 1099 form is available to view and print on FCSU's website www.fcsu.com in the Member Portal. This is only for those who have taken a withdrawal from an Annuity or IRA in 2023 of \$10 or more. A hard copy has been mailed to you also as required by IRS regulations. If you have not made a withdrawal in 2023, you will not receive a 1099 from the FCSU.

Please keep in mind the FCSU does not provide any tax or financial advice. Please consult your tax advisor regarding your personal circumstances. For more information regarding filing your taxes or answers to any questions you may have, please visit the IRS website at www.irs.gov.

February Reflection



Message from the National Chaplain

Last October 15, Pope Francis issued his apostolic exhortation It Is Confidence (C'est la confiance) to mark the 150th anniversary of the birth of St. Thérèse of the Child Jesus and the Holy Face. This is a summary of the pope's letter.

Its theme is taken from words written by Thérèse herself: "It is confidence and nothing but confidence that must lead us to love." This citation, and virtually all other quotes in the Letter, are taken from Story of a Soul, Thérèse's spiritual autobiography published after her death at the age of 24 in 1897.

1. Jesus for others

Thérèse Martin took the religious name Thérèse of the Child Jesus and the Holy Face. "Child," Francis explains, refers to the Incarnation and "Holy Face" to the Lord's self-surrendering Passion on the Cross.

Pope Pius XI declared her Patroness of the Missions and the model of evangelization because she had a continuous, burning desire to love Jesus and to have others love him, too. Francis points out that in Story of a Soul, Thérèse writes the work of evangelization is best carried out by making the faith attractive, not by coercion or persuasion.

2. The little way of trust and love

Thérèse's "little way," the way of spiritual childhood, the way of total trust and love, is for everyone, no matter one's age or state of life. This "little way" to heaven a way that is very straight and short and ever new. We are to have the same confidence and unending trust in God's mercy as Thérèse.

Thérèse offers us this insight regarding the Eucharist. Too often we think of receiving the Holy Communion in the terms of becoming one with Jesus. Thérèse makes us think of the opposite. Jesus comes to us in the Eucharist because of his desire to be one with us and dwell within us.

Thérèse underwent a period of spiritual darkness due to a philosophical atheism that was making inroads into society during the last decade of the 19th century. However, this spiritual darkness led her to offer a tremendous contribution to Catholic spirituality: "In an extraordinary way, she probed the depths of divine mercy, and drew from them the light of her limitless hope." God's endless mercy is that which helps us understand everything else about God.

3. I will be love.

Thérèse believed Jesus knew and loved her personally while he endured his passion. Francis goes on to say her prayerful reflection on this image was extended to all humanity. Our Lord, during his Passion, knew and loved each person "as if he or she were the only one in the world."

When Thérèse came to the realization one day God was calling her "to put fire into the heart of the church," the ardent desire she had for herself to experience eternal joy and love of Jesus in heaven then became a passion to make Jesus known and loved by everyone on earth.

4. At the heart of the gospel.

Charity, the centerpiece of Christian morality, is the response we are to make to God's unconditioned love for us.

The following are three of seven examples Francis offers showing where the world points us in one direction, Thérèse point us in the opposite direction.

- While the world emphasizes individualism and self-interest, Thérèse points the way to making ourselves as gift to others.
 - While humans are obsessed with power, Thérèse offers the little way.
- In an era of indifference and selfishness, Thérèse draws us to become missionary disciples.

SS. Cyril and Methodius February Appeal

The Saints Cyril and Methodius Appeal is in its 46th year raising money to assist the Pontifical Slovak College of Saints Cyril and Methodius in Rome with its day-to-day operations. Today, the Appeal relies upon the generosity of individual donors in addition to collections taken up in personal parishes of Slovak ancestry. A direct mailing asking for donations was sent in January to local district and branch leaders from the four Catholic Slovak Fraternal Organizations, members of the Slovak Catholic Federation, and previous donors.

As of January 29, 12 donors have given \$2,225.00 for the 2024 Appeal. Among the 7 donations received from Catholic Slovak Fraternal Branches and Districts, Branch 3, Branch 743, and Branch 746 of the FCSU have donated a combined total of \$250. A donation has been received from the clergy and religious and 4 individuals have also made a donation. On behalf of the Pontifical College, thank you for your continued generosity and support.

Anyone who wishes to contribute to the 2024 Appeal but did not receive a letter asking for a donation is asked to fill out the information in the box at the bottom of this article and mailing it along with your check payable to the Slovak Catholic Federation to the address provided. Donations in any amount are deeply appreciated and are acknowledged. Gifts received after November 30, 2024 will be credited toward the 2025 Appeal. Thank you again for your goodness and generosity.

The Slovak Catholic Federation was founded in 1911 by Rev. Joseph Murgas, founding Pastor of Sacred Heart of Jesus Slovak Church, Wilkes-Barre, PA. The Federation brings together under one banner both individuals of Slovak heritage as well as Catholic Slovak Fraternal Organizations for cultural, religious and educational needs. Serving as Moderator is the Right Reverend Gary Hoover, O.S.B., Abbot of St. Andrew Svorad Abbey, Cleveland, OH. National President is Reverend Andrew S. Hvozdovic, V.F., Supreme Chaplain of the Slovak Catholic Sokol and Pastor of Our Lady of Victory Parish, Harvey's Lake, PA and Gate of Heaven Parish, Dallas, PA. Reverend Thomas A. Nasta, National Chaplain of the First Catholic Slovak Union and Parochial Vicar with Senior Priest status at Our Lady of Grace Church, Penndel, PA, serves as First Vice President of the Federation and is the Appeal Coordinator.



General March Madness Rules

The NCAA Division I men's basketball tournament is a single-elimination tournament comprised of 68 teams that compete in seven rounds for the national championship. The final round is known as the Final Four, when only four teams are left.

The NCAA Men's Division I Basketball Committee selects seeds and brackets the field for the NCAA Tournament. Then on Selection Sunday, a Selection Committee reveals the full NCAA tournament bracket, including all teams and all seeds. In 2024, Selection Sunday is March 17th.

FCSU March Madness Rules

- Each entrant must be 16 years old, have an active policy and be a Member in good standing.
- 2. One (1) Entry per person ONLY
- 3. Each Player must HAVE AND USE THEIR OWN EMAIL ADDRESS.



Applicants are eligible to win once in each of the 5 categories.

All scholarship winners must maintain an active policy during their school years.

FCSU Untold Stories

Jim Bench – "Jim, you must always help a Slovak."

ames Bench, (Jim), Branch 181 and FCSU Supreme Court Member, has had his share of helping fellow Slovaks. Now recently resigned from his position as President of the Youngstown/ Spišská Nová Ves Sister Cities Program, he shared stories of some programs in which he and his wife Kay were involved. One in particular was securing and shipping donated formal dresses to Slovakia. Jim discussed the process of receiving the dresses and how young girls in Slovakia would come to get them.

Q: How did you get involved?

I have been associated with the Youngstown/Spisska Nova Ves Sister Cities Program for over 20 years despite being from Derry, Pennsylvania.

I became involved because of the insistence of the late Judge John Leskovyansky and the late Steve Bacon who started the program. It was and still is a very effective program designed to assist Spisska Nova Ves as well as surrounding areas of Slovakia. We have had numerous programs far too many to address at this time. The gown program has existed for the past eight years and is certainly worthwhile.


Q: Where do the gowns come from?

The gowns are generously donated by the owners Reed and Mia Pederson of MB Bride and Special Occasion in Greensburg, Pennsylvania. Reed had been a speaker at Westmoreland Community College and in an informal conversation with Professor Michael Hricik, indicated a willingness to donate gowns to a worthy cause. Michael, a friend for many years and son of past President FCSU Thomas Hricik immediately contacted me.

Following a phone conversation with Reed, my wife and I visited the establishment. Thinking we were going to a traditional bridal shop, we were greatly surprised and impressed with the premises. It was large, occupying a two-story building with almost 50 employees busily engaged with business procedures. We were just amazed and delighted. The Pedersons were receptive as well as gracious, and about three hours were spent establishing a potential program. Within a few days Kay and I picked up 300 new, beautiful gowns.

As our friendship continued to grow, so did their interest in our tours. They accompanied us on tour and visited all the places where the gowns were sent. That experience added to their interest and then over the years the gowns have kept coming. Our latest shipment consisting of over 700 gowns went out in September 2023.

Yes, the Slovak women have really benefitted from the Pedersons generosity, but my wife and I have been fortunate and privileged to have acquired a lasting and meaningful friendship with Reed and Mia.

Q: What kind of dresses were sent?

Evening gowns. They have a lot of balls in Slovakia and the young girls couldn't afford evening gowns, but thanks to the generosity of Reed and Mia they were now able to attend.

Q: Do the gowns need any work done?

They are all brand new but would need altered to fit the individual. My wife is the one who is particular. She examines every single gown, puts them in individual plastic bags and puts tags marking the size. And she knows Slovakia that well that she will say these are going to Pezinok. Or we're going to send these to Trenčín because there are a lot of girls and dance

schools there, and they are smaller so we'll send the smaller gowns.

Q: How long did it take to prepare them to send over?

I used to go to Lowe's and buy the boxes. After the gowns were in the boxes, we completely wrapped them with transparent tape. Greg Maurer Chairman of Auditors for the FCSU was always readily available to assist. They were going by ship, so we didn't want any water to get in and used this as a double precaution. The procedure required many hours from start to finish.

Q: Did you have any contacts in Slovakia/Did you know where to send the dresses?

Oh, absolutely. My wife and daughter Sharon Bench Zacur, Branch 181, had previously acquired 20 wedding gowns which were worn once and had been commercially cleaned and preserved. That preceded the acquisition of the evening gowns.

Viera a very, very good friend of ours, in fact she's the guide on our tours, is one of the people in charge of distribution. When we sent the first shipment to Viera, she went to her Parish priest and told him about the gowns. Following the mass, the priest announced that Viera had the gowns and should be contacted directly to see the gowns.

Q: What is the reaction of the people receiving the dresses?

In the early beginnings, Viera called us to tell us one girl's mother was a seamstress and when they came in to look at the gowns, they became very suspicious because the mother kept saying these gowns are so expensive, why would anyone want to give them away and there has to be a trick. She did a good job of telling them, no, this is perfectly legitimate. I can give you the names of Jim and Kay Bench from Pennsylvania who shipped these gowns.

The city of Spišská Nová Ves has initiated various programs for the distribution of the gowns. The programs are generally warmly received and the response gratifying. There are many stories associated with the gown distribution, however the many stories would be better suited for an individual article.

Sometimes we get pictures of the girls when they came to look at the gowns. They said the girls were happy and delighted. The girls got to go to the ball and got a bargain gown so they were happy.

Q: What is your motivation for being involved?

My Grandmother's voice. We were poor but she used to tell me, "Jim you must always help a Slovak." I used to think in my mind, who can I help? I always remembered that, and I think that may have something to do with it. I don't know.

Although Jim has resigned, the program will continue each year with the donation of dresses. The Youngstown Spišská Nová Ves Sister Cities is always looking for new ways to help and lend a hand to Slovakia. At the end of the conversation, Jim expressed he could not do what he's done without his wife and that she has been with him every step of the way.

"Everything I'm telling you; my wife has been right there and I could never have done it without her," Jim said. "We have been married 60 years, 61 in June. Everything I do, my wife does 50% and maybe even more."

RULES and REGULATIONS FCSU International Bowling Tournament

- 1. The Tournament shall be conducted in compliance with the rules and regulations of the United States Bowling Congress (USBC).
- 2. This event is being sponsored by the First Catholic Slovak Union for the exclusive enjoyment of its members and their guests. The goal of the tournament is to promote fraternalism and good sportsmanship and generate interest in our Slovak fraternal organization. The National Officers of the First Catholic Slovak Union wish to extend a cordial invitation to all members and their guests.
- 3. ELIGIBILITY: This Tournament is open to all First Catholic Slovak Union Members (age 18+) in good standing at the time of entry. Those with lapsed memberships/policies may not participate in the tournament or its related social functions.
- **4.** a. The total cost per **FCSU MEMBER** for each event shall be:

Prize Fee.....\$10.00 Hospitality Fee.....\$ 2.00 **TOTAL COST (per event) \$25.00** Saturday DinnerNo Cost *All Events Fee \$ 5.00 (Optional)

*Only bowlers paying the \$5.00 All-Events fee are eligible for the cash awards.

4.. b. The total cost per NON-MEMBER for each event shall be:

Prize Fee.....\$15.00 Bowling Fee.....\$13.00 Hospitality Fee..... \$ 2.00 TOTAL COST (per event)\$30.00 Saturday Dinner\$35.00 (Optional)

*All Events Fee \$ 5.00 (Optional) *Only bowlers paying the \$5.00 All-Events fee will be eligible for the cash awards.

The Prize Fees will be awarded 100% in each specific event. At least 1 in 10 participants in each event will win prizes.

Note: Contestant may win only one cash prize per event (scratch or handicap), whichever cash prize is higher. Excluding special prizes. Awards will be presented to the Contestants who roll the highest scratch and handicap scores in each event.

- **5. SUBSTITUTES.** Bowlers may compete only once in each event. However, the Tournament Director may allow a bowler who has previously bowled to substitute on a four bowler team when one of its original entrants is absent. The score of such bowler in the team event rolled with his entering team must count for all events. No one may bowl in this tournament except those originally entered before the tournament opens or such substitutes who may be authorized by the captain of a team or his appointee, provided the individual whose name appears on the entry blank is unable for sufficient reason to attend the tournament at the time scheduled. The Tournament Director shall have power to approve the substitutes that are offered by the captain or his legalized representative, and if accepted, each substitute must bowl each event under his full name and only at scheduled time in each event. The substitute's score and handicap from the said event will be used.
- **6.** As of March 15, 2024, if any contestant's current average, of at least 21 games, is ten pins or more above their highest average from the previous season, they must use their current average.
- 7. HANDICAP Men's Division Handicap will be calculated at 90% of the difference between 240 and their last season's 2022-2023 highest sanctioned league average of at least 21 games. Bowlers who have no established average will use their highest sanctioned league average of at least 21 games as of March 15, 2024.

Male bowlers who have no established average for this year or last year will be listed as having a 175 average and will be handicapped accordingly. If the bowler does not have a sanctioned average over the last two years, but has competed in the Joint Fraternal Bowling Tournament, the average of most recent 2 year history from Tournaments will be used.

Male bowlers with an average over 240 will receive no handicap and will bowl scratch throughout the tournament.

8. HANDICAP: Women's Division handicap will be calculated at 90% of the difference between 200 and last season's 2022-2023 highest sanctioned league average of at least 21 games. Bowlers who have no established average will use their highest sanctioned league average of at least 21 games as of March 15, 2024.

Female bowlers who have no established average for this year or last year will be listed as having a 150 average and will be handicapped accordingly. If the bowler does not have a sanctioned average over the last two years, but has competed in

the Joint Fraternal Bowling Tournament, the most recent 2 year history from the Joint Fraternal Tournaments will be used. Female bowlers with an average over 200 will receive no handicap and will bowl scratch in the tournament. *Under no circumstances will handicaps be increased after participant has bowled.*

- 9 FALSIFYING AVERAGES PENALTY The team captain is responsible for reporting all averages of the individual team members, and they are responsible to him. Should the Tournament Committee find at any time that the averages have been falsified, the team shall forfeit all claims for prize money as well as their entry fee and will be subject to disqualification and suspension from organized bowling. All prize winners are subject upon request to submit an affidavit of correct league averages.
- 10. RE-RATING OF BOWLERS According to USBC Rule No. 319 A-E, bowlers maybe re-rated by the Tournament Committee.
- 11. All entry applications and bowling fees are to be mailed to: Joanne Fibbi, Fraternal Activities Director, 1741 Hempstead Lane, Pittsburgh, PA 15241; and must be received before March 18, 2024. Rule 310-A2 is in effect.
- 12. Bowlers who participate in tournament games must be dressed in a presentable manner to appear before public and when possible to use an emblem attached to shirt or dress so that participant can be identified.
- **13.** Both USBC and eligible non-USBC members may participate in moral support tournaments with high score protection automatically extended to USBC members. Eligible non-USBC members can qualify for high score protection at their option by paying a \$21.00 fee for which the Congress will issue an unattached membership card.
- **14. FEE WILL NOT BE REFUNDED.** All prize fees will be paid in prizes.
- **15.** Bowlers may choose to bowl in their respective gender team and doubles event or on a mixed team or mixed doubles team, but cannot participate in both divisions. Singles and All Events are gender specific. Mixed team and mixed doubles scores will be used to calculate All Events specific to the gender of the bowler. Must have 6 teams and 10 doubles teams to hold the mixed events.
- **16.** In the Doubles Event, the names of both bowlers must be listed on the entry. Incomplete forms will be returned for information. If both entrants in the Doubles event appear when scheduled, it is understood that they must bowl as entered and no change in position will be allowed at any time after entry has been filed.
- **17. LANE ASSIGNMENTS** The Tournament Committee will assign lanes. For all events. Bowlers in the Doubles and Singles Events must report 30 minutes prior to the time they are scheduled to bowl. Captains of teams must report their line-up at least 30 minutes before scheduled start time.
- **18.** In the Doubles & Singles Events bowling entrants will bowl all six of their games on the same pair of lanes. Bowlers entered in only the Singles Event will be assigned to alleys by the Committee.
- **19.** A team may use a name other than its league name for tournament entry without the payment of additional membership dues as formerly required.
- **20** Contestants in this tournament are not required to report any tournament prize winnings for the previous 12-month period.
- 21. Failure to use the correct average shall disqualify score, if the submitted average results in a lower classification or greater handicap. Prize winnings shall be based on the submitted average if it is higher than the correct average. However, corrections in averages may be permitted up to the completion of the first game of





Prezidentka sa rozlúčila s generálmajorom M. Kocianom, slúžil 42 rokov

Bratislava 23. januára (TASR) - Prezidentka Zuzana Čaputová sa v utorok rozlúčila s generálmajorom Miroslavom Kocianom, ktorý odchádza do výslužby po vyše 42 rokoch pôsobenia v Ozbrojených silách (OS) SR.

Hlava štátu, którá je zároveň hlavnou veliteľkou Ozbrojených síl SR, poďakovala Kocianovi za oddanú službu vlasti.

The president said goodbye to Major General M. Kocian, he served for 42 years

Bratislava, January 23 (TASR) - President Zuzana Čaputová on Tuesday bid farewell to Major General Miroslav Kocian, who is retiring after more than 42 years in the Slovak Armed Forces.

The head of state, who is also the Commander-in-Chief of the Slovak Armed Forces, thanked Kocian for his devoted service to the fatherland.

Kocian was educated at military academies in Liptovský Mikuláš, Brno, Hamburg and Rome. He served in both the Air Force and the Training and Support Forces Command. As a national military representative, he served on the NATO-EU Military Committee. In the past, he was Deputy Chief of the General Staff of the Armed Forces of the Slovak Republic.

Slovenskí a českí výskumníci našli jedno z najstarších mayských miest

Praha 9. januára (TASR) - Česko-slovenská archeologická výprava objavila v Guatemale doteraz neznáme mesto mayskej civilizácie, ktoré vzniklo pred zhruba 3000 rokmi. Ich významný nález pomôže odkryť neobjasnené a rozhodujúce fázy mayských dejín. V utorok to uviedla Nadácia Neuron, ktorá výpravu finančne podporila, informuje spravodajkyňa TASR v Prahe.

Expedíciu viedol český výskumník Ladislav Šilhán a Milan Kováč z Univerzity Komenského. Archeológovia identifikovali dosiaľ neznáme mayské osídlenie a podľa vykopávok zistili, že ide zrejme o najstaršie mestské centrum v regióne. Nazvali ho Yax Balam (Prvý Jaguár).

Archeologické vykopávky odhalili paláce, sochy, pozostatky rituálov, astronomické observatóriá a ďalšie objekty. "Podľa vykopávok mesto patrí k najstarším mayským aglomeráciám vôbec. Postupom času dochádzalo k jeho úpadku aj opätovnému rozvoju - od samotného počiatku mayských dejín, vzniku kráľovstva a prvých mestských štátov až po takzvaný mayský kolaps, ktorý spôsobil zánik (mayskej) civilizácie," vysvetlil Kováč.

Zasadíť nálezy do príslušného časového a kultúrneho rámca pomohli expedícii technológie umelej inteligencie. Používali ju pri overovaní digitálnych dát z leteckého snímkovania LiDAR. Podľa vedcov dokáže vykresliť zemský povrch ukrytý v džungli a tak odhaliť stavby či mestské celky. Vykopávky na mieste potom nález potvrdia.

"Technológie síce vopred umožnili identifikovať mesto a vydať sa na presne zacielené miesto v guatemalskej džungli, na mieste sa ale doteraz žiaden prieskum nerobil," zdôraznil Šilhán. Podľa neho tak nebolo jasné, či rôzne zhluky budov hlboko v džungli reálne tvoria kompaktnú aglomeráciu a aký je ich historický význam. Vedci teraz novoobjavené mesto vizualizujú do 3D modelu.

"Sme radi, že stávka na moderné technológie sa vyplatila a že sa potvrdilo, že majú svoje miesto aj v tak tradičnom odbore, akým sú terénne výkopové práce," povedala spoluzakladateľka Nadácie Neuron Monika Vondráková. Podľa jej slov môže táto česko-slovenská stopa zanechať medzinárodný odkaz

Okrem mesta Yax Balam, kde vedci zdokumentovali sedem štvrtí mestského celku, skúmali aj širší pralesný región. V ňom objavili a zmapovali ďalšie dve menšie mayské mestá.

Slovak and Czech researchers have found one of the oldest Mayan cities

Prague, Jan 9 (Reuters) - A Czechoslovak archaeological expedition has discovered a previously unknown city of the Mayan civilization in Guatemala that originated about 3,000 years ago. Their significant find will help uncover unexplained and decisive phases of Mayan history. This was stated on Tuesday by the Neuron Foundation, which financially supported the expedition, reports TASR



correspondent in Prague.

The expedition was led by Czech researchers Ladislav Šilhán and Milan Kováč from Comenius University. Archaeologists have identified a hitherto unknown Mayan settlement and, according to excavations, have determined that it may be the oldest urban center in the region. They called it Yax Balam (First Jaguar).

Archaeological excavations revealed palaces, statues, remains of rituals, astronomical observatories and other objects. "According to excavations, the city is one of the oldest Mayan agglomerations ever. Over time, its decline and redevelopment occurred - from the very beginning of Mayan history, the creation of the kingdom and the first city-states to the so-called Mayan collapse, which caused the demise of the (Mayan) civilization," explained Kováč.

To set the findings in the appropriate temporal and cultural framework, they helped the expedition of artificial intelligence technology. They used it to verify digital data from LiDAR aerial photography. According to scientists, it can depict the Earth's surface hidden in the jungle and thus reveal structures or urban units. Excavations at the site will then confirm the find.

"Although technology has made it possible to identify the city in advance and go to a precisely targeted location in the Guatemalan jungle, no survey has been carried out on the site so far," Shilhan said. According to him, it was not clear whether the various clusters of buildings deep in the jungle actually formed a compact agglomeration and what their historical significance was. Scientists are now visualizing the newly discovered city into a 3D model.

"We are glad that the bet on modern technologies has paid off and that it has been confirmed that they have their place in such a traditional field as field excavation," said Monika Vondráková, co-founder of the Neuron Foundation. According to her, this Czech-Slovak footprint can leave an international legacy.

In addition to Yax Balam, where the researchers documented seven neighborhoods of the city, they also examined the wider primeval forest region. In it, they discovered and mapped two other smaller Mayan cities.

Bratislava, January 1 (TASR) - Soldiers of the Slovak Armed Forces (OS) fired 21 artillery halls from the Danube embankment on the day of the national holiday. They commemorated the 31st anniversary of the establishment of the Slovak Republic.

Artillery of the 54th Rocket Launcher Detachment from Rožňava took care of the execution of the act. The ceremonial salvos were fired from towed 122-millimeter howitzers HD-30.

The burning of ceremonial halls takes place traditionally on the occasion of important protocol activities and public holidays, such as the Day of Establishment of the Slovak Republic.

Jankola Library and Museum to Merge with National Czech and Slovak Museum and Library

The Sisters of Saints Cyril and Methodius, and the National Czech and Slovak Museum and Library have entered into an agreement to share the resources of the Father Matthew Jankola Library in Danville, PA, with the National Czech and Slovak Museum and Library in Cedar Rapids, IA. The two groups share a commitment to honoring those who immigrated to America and contributed their hard work, skill and vision to the growth of our Nation. The mission of both groups is to engage the global community with unique Slovak, Czech, and American stories to inspire individuals with universal themes of culture, freedom, democracy, and immigration. Their shared vision is to be an innovative leader in lifelong learning, community building, and cultural connections. They encourage self-discovery for all ages so that the stories of freedom, identity, family, and community will live on for future generations.

The Father Matthew Jankola Library and Museum, in Danville, PA, has been, for its 55 years, one of the most important depositories of Slovak literature, culture and the arts in the United States. Reverend Matthew Jankola, after whom the Library is named, was the founder of the Sisters of Saints Cyril and Methodius in 1909, and he inspired the Sisters to value all that relates to scholarship and multiculturalism. The directors of the Library, including Sister Martina Tybor, SS.C.M., Sister Mercedes Voytko, SS.C.M., Sister John Vianney Vranak, SS.C.M., Sister Catherine Laboure Bresnock, SS.C.M. and Sister Loretta Marie Hrubec, SS.C.M. organized donated materials that related to Slovak and Slavic history, language, literature, fine arts, spirituality and learning. The Museum now houses over 20,000 books and offers additional educational resources including Slovak periodicals, newspapers and maps. The library contains rare books, Bibles and children's literature, as well as Slovak music and plays, and the private collections of some of the outstanding Americans of Slovak ancestry including those of the Slovak Museum from Jednota Estates in Middletown, PA, the late Bishop Andrew G. Grutka, Dr. Peter P. Hletko, and Dr. Stephanie Husek among others.

Sister Barbara Sable, SS.C.M., President of the Sisters of Saints Cyril and Methodius said, "The guiding principles of The National Czech and Slovak Museum and Library are ideals very similar to those which led the Sisters of Saints Cyril and Methodius to begin and maintain the Father Matthew Jankola Library and Museum. We believe that this collaboration will be of benefit to both our organizations, and will honor the intentions of our donors that the materials donated to us be respectfully kept, widely used and would honor the history of the Slovak peoples, their contributions, and their stories of immigration to the United States. These materials from the Father Jankola Library and Museum will not only enhance the current collection of The Czech and Slovak Museum and Library but be valued and prized additions."

The Czech and Slovak Museum and Library in Cedar Rapids IA, is led by President and CEO Dr. Cecilia Rokusek. Dr. Rokusek is fluent in the Czech and Slovak languages and has held top academic and administrative positions at several colleges and universities since 1976. For the past 15 years she has been the Slovak Honorary Consul for Florida, and during her career she has established many academic affiliations with institutions in the Czech and Slovak Republics, in several other European countries and in South Korea.
