# The Waiting Line for 2082 Starts Here

### Attention Slovak Americans – Make Sure We Are Counted

For those Slovak Americans who have not vet filled out the 2010 CENSUS Form. I urge them to indicate their Slovak Heritage on the Form.

The opportunity to do so is in question 9 on Race. The U.S. Census Bureau confirms that U.S. citizens can indicate their HERITAGE on the last row of boxes in question 9.

In filling out my own form, I PRINTED clearly:

Heritage – Slovak

Such information is important for both Legislative and Executive branches of government nationally and locally, and will definitely be included in the final repor

the United States (and Puerto Rico) has been asked to participate in the official 2010 Census, a process designed to count each individual by providing basic information about the persons living in every house and apartment throughout the land.

The census forms were initially mailed to households in mid-March, with a targeted return of no later than April 1st- the official enumeration date. And for those failing to respond, "foot soldiers" (census takers) are now replicating decades of old by visiting those missing addresses for a personal response to the 10 questions that comprise the 2010 U.S. Census.

Speaking strictly as a genealogist, what a wealth of information! However, there is a slight catch in gaining access to the treasure trove of data. . . one must wait until the year 2082—72 years hence as protected by Title 44 of the United States Code, which stipulates that the information may then be used for family and other types of historical research. Considering my present age, I strongly suspect I will not be waiting in line when they signal the unveiling of the 2010 Census data.

Currently, our research efforts with census data are limited to the same 72-year restriction, with the 1930 Census the most recent available under the Freedom of Information Act. The initial census for the United States was taken in 1790 and has been duplicated every 10 years since.

The 1790-1840 census formats simply listed the names of the head of each household. However, few Slovaks would have need for these tallies as the majority of our ancestors immigrated to the United States during the enumeration years of 1890 through 1930.

The 1900 Census is significant in that it gives the exact month and year of birth as well as the year of immigration to the United States— each excellent directional maps of where to search next; the 1910 version, and one of the most widely used for Slovak re-


### **Second Sunday of Easter** John 20:19-31

### **Gospel Summary**

It is surely an understatement to say that the disciples were filled with joy as Jesus appeared to them, alive and well, on that first Easter day. It will take years for them to draw out all the wonderful implications of this dramatic moment in their lives but

for now it is sheer joy. Jesus then gives them a mandate to bring peace to the world by translating their happiness into the difficult but rewarding gift of forgiveness.

The story of "doubting Thomas" is presented as a warning to those of us who have trouble trusting the spiritual side of life. Thom-



Finally, the author of the gospel reminds us that everything he has written is intended, not primarily to give us information about Jesus, but rather to bring us to faith in him and thereby to lead us to real "life in his name."

### Life Implications

The last verses of this gospel passage are among the most challenging passages in the entire gospel. In the first place, we are told that the whole gospel of John is intended to bring us to "believe that Jesus is the Messiah, the Son of God." This does not mean simply that we accept the fact that Jesus is the fulfillment of Israel's hopes and, much more than that, the very Son of God, equal to the Father and the Holy Spirit. To believe in Jesus means also that we accept the message, found in his words and in his example, of total self-giving for the sake of others. When we truly accept this message, we pledge ourselves to live and love as much as possible Jesus did.

What is the consequence of such a radical way of living? It enables us to participate in the very life of Jesus. As the gospel puts it, the whole purpose of believing is that "you may have life in his name." This statement is far more daring and revolutionary than we may think. For it means that, through love of others, we begin to participate in the love and life of God. To love unselfishly is to love as God loves, and that means sharing in God's life, insofar as mere creatures can do so.

In other words, we are invited to share in a life that is far superior to the fragile, uncertain life of our mortal existence. This new life is given in baptism but it must be nourished by our commitment to loving service and by our participation in the Eucharist, the ultimate sacrament of love and concern for others.

St. Paul expresses the same conviction when he writes those wonderfully consoling words: "Therefore, we are not discouraged; although our outer self is wasting away, our inner self is being renewed day by day" (2 Cor 4:16). This inner renewal is nothing less than the growth of God's life within us.









### **Gospel Summary**

Simon Peter and his companions after fishing all night catch nothing. At dawn as they approach shore, someone on the shore whom they do not recognize directs them to cast out their net. When the net is filled with a large catch, the beloved disciple recognizes Jesus, now risen from death, and says to Peter, "It is the Lord." When they reach shore, they see a charcoal fire with fish on it and bread. Jesus invites them to eat with him. He takes bread and gives it to them and in like manner the fish. Jesus then asks Peter three times if he loves him, and says to him in turn, "Feed my lambs...Tend my sheep...Feed my sheep." Jesus then speaks of the kind of death Simon Peter will undergo, and says to him, "Follow me."

### Life Implications

Friendship with Jesus is the one essential thing of life, regardless of any other circumstance--sickness or health, poverty or wealth, low or high position in society or church. That is the supreme truth John wants to tell us in his gospel. The good news is that Jesus desires our friendship, and offers it to all who welcome him in faith. We can identify with many of the persons Jesus encounters in the gospel—the Samaritan woman, Martha and Mary, Lazarus (at whose death Jesus wept), Peter, Mary Magdalene, the beloved disciple. The gospel also warns us not to identify with those who reject friendship, and even betray friendship with Jesus. Jesus can also call us his friends because he has told us everything he has heard from his Father (Jn 15:15). The titles that we use to address Jesus (Messiah, Lord, Son of God), however orthodox and exalted they may be, are inadequate to express the full meaning of Jesus for us unless they include "Beloved Friend."

A personal, loving relationship with the Risen Lord clearly was a distinguishing characteristic of John's community. Sad experience, however, soon revealed that individual relationships with Jesus were not sufficient to hold the community together. We can see from the First Letter of John that various individuals, claiming to speak with the Spirit of Jesus, began to teach false doctrines. Eventually they formed splinter groups that separated people from the community. In our gospel passage today, John shows us that individual friendships with Jesus must be complemented by authority within the community. The Risen Lord commissions Peter to serve that function.

That authority that Jesus gives, however, must be exercised out of deep friendship with him. "Do you love me?" Jesus asks Peter the crucial question three times as he commissions him to tend and to feed his sheep. The principle, of course, applies not only to the successor of Peter, but to everyone who exercises authority in the church, from the family to the chancery. Only in this way does human authority becomes an expression of the authority of Jesus, the Good Shepherd who lays down his life for his sheep.

In today's gospel passage, John also links friendship with Jesus with his real presence at our Eucharistic meal. The meal Jesus shares with his disciples together with the feeding of the large crowd (John 6) and the Last Supper Discourse reveal the meaning of the Eucharist for us. Jesus, the Risen Lord, truly is with us at our sacred meal— speaks to us, prays with us, leads us in self-giving to the Father, gives himself to us as our bread and wine. He calls us his disciples and his friends: the life implications remain the same. Jesus also says to us: "If I, therefore, the master and teacher, have washed your feet, you ought to wash one another's feet" (John 13:14). The way we will fulfill his request to follow him as disciples in service of others is unique and particular for each of us. We can count on the Spirit of Jesus to guide us in discerning what that service will be.



### Marketing

This past year the Membership and Marketing Committee did the following...

\* In January of 2009 – hired an in-house agent to help with agent recruitment as well as servicing our inactive branches.

- \* Applications for licensing have been submitted to thirteen additional states.
- \* After further review of the scholarship requirements, the committee voted that all members purchasing a single premium JEP policy are now eligible for the FCSU scholarship if they meet all requirements
- \* Implemented the new "Park Free Plus" Annuity. The "Park Free Plus" offers a first year interest rate of 3.5. This initial interest rate is guaranteed for the entire first year of the annuity policy. At the first anniversary date of the policy, the annuitant has 15 calendar days to elect this option: Withdraw the full value of the accumulated annuity funds (Principal plus interest) without incurring a surrender change! If this option is not taken, the annuity will continue for an additional 5 years. The interest rate at that time will be based on the interest rate established by the society on its flexible premium deferred annuity.

# Report of the National Treasurer GEORGE F. MATTA

# REVEREND FATHER, PRESIDENT RAJEC, AND BROTHER AND SISTER OFFICERS

I am pleased to report that all the financials and other reports as required by the various states where the First Catholic Slovak Union is licensed to do business have all been properly filed by March 1, 2010.

In 2009, this time last year, we heard how the practice of subprime mortgages was having a devastating effect on not only the U.S. economy, but also the economies throughout the world. Financial institutions, formerly highly rated banks were in trouble. Banks were being closed or were being taken over by larger and stronger banks. Numerous governments have initiated steps to stabilize monetary areas.

Our Society was not immune to the widespread drop in the stock market as well as the bond market. On December 26, 2008, The Securities Valuation Office established the rating and market value on the big three automakers, Lehman Brothers and others at bankruptcy status 6, which meant instead of carrying the value of those bonds at book value, now must be carried at market value. As a result the Society suffered a reduction in its surplus in 1998 of slightly over \$4,000,000.000 from \$13,112,264 to \$9,059,592.

Surplus - 12-31-06 = \$11,555,594

Surplus – 12-31-07 = \$13,112,264 an increase of \$1,557,670

Surplus -12-31-08 = \$9,059,592 a loss of \$4,071,572

Surplus – 12-31-09 = \$13,169,012 an increase of \$4,109,420

Against this backdrop, the Society made decisions and changes that strengthened its investment procedures and promoted increased sales resulting in a favorable growth year for the FCSU. A very positive \$ 4,109,420 increase in Surplus.

Net investment income was strengthened by a diversified investment program which produced an increase in 2009 by (20.2%) in spite of economic concerns in the world. Further complicating the situation, a large number of Government Agency bonds, with attractive rates, and the limited availability of quality bonds with higher yields has affected income as

The Internal Audit Team conducted audits of different processes of the First Catholic Slovak Union for the period January 1, 2009 through December 31, 2009. The audits were performed in accordance with the bylaws of the First Catholic Slovak Union of the United States and Canada, effective January 1, 2007.

# THE AUDIT PURPOSE/OBJECTIVES INCLUDED, BUT WERE NOT LIMITED TO THE FOLLOWING:

- Review expense vouchers submitted.

### **METHODOLOGY**

Audit procedure programs, written by the audit team, were used throughout the year to evaluate the key operations of the specific areas audited. Discussion with management and staff, observations, and analytical testing was performed.

### **OVERALL EVALUATION:**

No indications of irregularities or abuse were discovered during the audits performed for the period January 1, 2009 through December 31, 2009. The audit team finds that the Home Office operates effectively and with high standards. Controls are adequate and have been properly maintained thus keeping errors to a minimum.

### **AREA FOR IMPROVEMENT #1**

Subject: Credit Card Payments

Receipts for expenditures are not always supported by documentation. If a receipt is to be sent "after the fact" such should be noted on the statement and every effort made to attach the receipt before the statement is filed

### **AREA FOR IMPROVEMENT #2**

Subject: Travel Expense Vouchers

Inadequate information is given, generally no "to and from" street addresses shown to verify reasonable mileage. Home office continues to make changes to expense vouchers when necessary. Closer attention should be paid by those individuals submitting expenses for reimbursement.

- \* Implemented an 8 year flexible premium deferred annuity with a bonus interest rate for the first year. This new annuity program started on January 1, 2010. For more information call your branch officer or the home offic
- \* Started a Presidential Campaign with insurance and annuity incentives. For the 2010 convention we will have a year long Presidential Campaign. It will run from August 1, 2009 to the Presidential Banquet in 2010. There will be special convention prizes drawings totaling 4,450.00 for those who signed at least 2 new insurance members. Drawings totaling 4,450.00 will also be awarded for every 10,000 in annuities brought in. Go the FCSU's web site and click on announcements for more information.
- \* On May 16, 2009 held a district presidents meeting and seminar for those districts in the Eastern United States.
- \* On June 14, 2009 held a sales seminar at the Hilton, 10 Drury Lane in Oak Brook Terrace, Illinois. Members from the Rev. John J. Spitkovsky District and Michigan District were invited to attend.
- \* On July 16, 2009 set up an informational booth at the annual Slovak Day in Kennywood Park near Pittsburgh. Copies of the Jednota newspapers and information on FCSU products were distributed. The annual event draws large crowds each year from Western Pennsylvania, Eastern Ohio and West Virginia.
- \* On August 2, 2009 held a sales seminar at the Holiday Inn in Bentleyville, Pennsylvania. Members of the Rev. Andrew Hlinka District were invited to attend.

many of the called securities had more favorable yields. To offset the reduction in income, a decision was made to utilize low interest funds available from the Federal Home Loan Bank and use those low interest rates to Arbitrage for investment in securities that pay a higher interest rate. The services of an investment subsidiary of Key Bank was engaged.

A Federal Home Loan Bank, located in Cincinnati, provides the FCSU with Available rates during the months for different maturities and at different rates. In order to participate in acquiring low interest rate funds from the FHLB one must be a member; this can be accomplished by purchasing shares of FHLB Common stock. The amount of stock required is in relation to the amount borrowed from the Fed Home Loan Bank.

As reported earlier, funds are borrowed from FHLB at very low rates of interest, and invested and managed by Victory Capital Management, a subsidiary of Key Bank. Victory Capital manages fund known as Absolute Return Credit (ARC). The FCSU first engaged Victory Capital in April 2009 with significant results of 19% return. The net investment rate of return for our entire portfolio is a very respectable 7.1%. The FCSU rate of return will rank near the top among fraternals and commercial insurers. The Society's average investment return for the past five years is 6.47%

### INVESTMENT INCOME

INVESTMENT income continues to provide the strength for the Society. Following is the investment income enjoyed during the past five years

Bonds make up 83%, an increase of 3.3% of the investment portfolio. Investment grade bonds are 89.7%, an increase of 1.6%. Preferred stocks dropped to 2.8%, 1.6% lower of the portfolio. All preferred stocks owned by the Society, but two, are in the top NAIC rating grades. The Society had a \$33,758,387 increase in assets, an increase of 16.8%.

The Unrealized capital gains resulted from the increase in valuation of the Annual Statement value of Ford Motor, General Motors, GMAC and Lehman Brothers bonds. A GMAC Preferred Stock resulted in an almost \$56,160 gain. Surplus not bonds which are carried at market value had an unrealized capital gain of over \$506,279. The improvement of the Common Stock Market gained the Society \$142,905 of unrealized gain, as a result of change in market value.

The total unrealized capital gains were almost \$2,200.000. The Society may continue to experience unrealized gains as market values improve and the economy recovers.

Capital losses in 2008, both realized and unrealized, were offset by the release of the Asset Valuation Reserve (AVR) totaling \$2,202,503. While this benefited the Society in 2008, substantial contributions were required in 2009 to rebuild its balance which is determined by a formula based on the quality of securities owned.

The 2009 AVR requirement for 2009 is \$2,278,782. The balance is now \$2,514,121.

In 2009, \$54,446 or prior years' bonds/preferred stocks profits were included as a part of income. This amount was released from the Interest Maintenance Reserve. The IMR requires that most profits or losses realized when bonds or preferred stocks are matured, called, or sold, must be placed in this reserve and amortized to the original maturity date of the security. The Society holds bonds for income and does not actively trade, although the FCSU has on occasions accepted profitable tender offers that we felt would improve the Society's portfolio. The total IMR is now \$1,399,399, a portion of which will provide average annual income to the Society of approximately \$150,000 for the next 10 years.

The Society purchased over \$92,400,000 of securities in the year 2009, while almost \$58,500,000 of securities were matured, called or sold. These transactions do not include the FHLB funds obtained and invested primarily with the Victory fund. The large volume of activity was necessitated by the continuing large number of calls, especially government sponsored entities such as FNMA, FHLMC. The difficulties are to find replacement bonds of equal value and the best interest rate available.

search, includes birthplace of parents, year of immigration, citizenship status, language spoken, occupation, and if the home is rented or owned; the 1920 Census is the only form to request the exact year in which a person was naturalized, and the first census to ask the "mother tongue" of each household member and their parents. The later is a great insight if one's language is listed as "Slovak" and underscores its worth as the country of birth often created confusion when listed as Austria-Hungary.

The 1930 Federal Census provides the home address, the name of each person living in that house on 1 April 1930, the date the census commenced. Thus, any baby born after this date in the same 1930 year would have to wait to be counted – and identified – in the next census 10 years later!

The 1930 Census also names the head of the house and the relationship to him/her of all others living there. You'll learn if the house was owned or rented, if the family had a "radio set," and if they lived on a farm. You'll learn the "marital condition" of each resident and their age when they married. You will see if they attended "school or college" since 1 September 1929 and whether those being counted could read and write.

Compared to previous enumeration years, the 2010 Census version appears to be lacking in both scope and depth— at least from through the lens of one conducting Slovak research. After all, 10 questions are just 10 questions and they didn't even ask me if I owned a "radio set."

# **Book Corner**



## **Igor Grossmann-A Unique Slovak**

Igor Grossmann is an important Slovak who, through his artistry with a camera, has preserved our Slovak history. The photographs of Igor Grossmann transport the viewer back into a time where life was simpler for Slovaks. The pictures are full of joy, passion, and wistfulness. Celebrations, work, weddings, funerals all tell a tale of a way of life that is now lost. Dr. Grossmann has captured this time for us to savor. The images of a beautiful Slovak mountain village and its people are forever held in time. The traditional ways of farming, buildings blended into scenery, ordinary family,

and festive times are beautifully presented for our enjoyment.

Originally from Zilina in northwestern Slovakia, Igor Grossmann worked as a pharmacist in the mountain villages and was able to indulge his inclination to view the world through a camera lens. In 1966, he quit his work as a pharmacist, put his passion for photography first and began his quest to document a cultural identity.

Igor Grossmann's starkly beautiful black-and-white photographs capture the essence of Slovak village life in a mountainous region of Central Europe at the moment of encounter between the old ways and the new day of European development, when centuries of tradition were about to give way to the modern age. This is a striking survey, a powerful visual tool documenting what was about to be altered forever by the technologies of the second half of the twentieth century ... a yesteryear culture that will never come again.

"Images Gone with Time is a photographic record about the struggle of a people for their daily bread, about love and joy in a culture redeemed with difficult, paid for with great effort— where the sense of obligation and duty was the primary virtue — and also about the tasteful, artistic imagination of the farming society, which spins beauty from wood, colors, cloth, and reverie. But at the same time it is also a Grossmann event— a happening of extraordinary empathy, respect and affection



# Treasure Tours Now Forming For Summer 2010







# Msgr. Edward V. Rosack

The Rt. Rev. Msgr. Edward V. Rosack, Apostolic Administrator of the then Byzantine Catholic Diocese of Pittsburgh, died Tuesday, March 2, 2010, at Jefferson Hospital. He was born on December 23, 1925.

After 50 years in the priesthood, he retired in June of 2004, having served on the staffs of Bishops Daniel Ivancho, Nicholas T. Elk Elko, Stephen J. Kocisko and Thomas V. Dolinay successively in various capacities: Vicar General, Consultor, Chancellor, Defender of the Bond of Marriage in Informal Cases, Director of Vocations, Chairman of the youth commission and ad hoc committees. In addition to writing for the bishops, he composed the "Pastor's Index to the Code of Canons of the Eastern (European) Churches.

He served as editor, "Currents Events" columnist, and editorial writer for the diocesan/archdiocesan newspaper, "The Byzantine Catholic World." He also wrote the "Reflections On Our Christianity" column for the Jednota.

For 24 years, he served on the Board of Directors of the GCU and regularly wrote an article in its publication as well as its "Marriage Prep" booklet and "Scriptural Guidance for Daily Living" in celebration of the 100th anniversary.

From 1960 to 1962, he was administrator of St. Mary's Church in Bradenville, PA, and from 1973 to 2004, he served as pastor of St. Mary's Church in Ambridge, PA, where he was an active participant with the church's "Project Pirohy."

For Beaver County, PA, he founded the Logstown Associates Historical Society on October 21, 1987, and incorporated it on October 29, 1991. At the Byzantine Catholic Seminary he was a commuting faculty member, then resident prefect and faculty member. He was associated with the organization of the ecumenical group, Christian Associates of Western Pennsylvania. He conducted the organizational work and served as Director of the Diocesan Council of Catholic Women.

He has chosen to be laid to rest in the National Cemetery of the Alleghenies in recognition of his service in the Signal Corps of the United States Army during World War II.

His family coat of arms states, "To serve is to live." He did both.

# Foreign Ministry Notes Anniversary of Slovak-Hungarian Treaty

Bratislava, March 19 (TASR) - It is 15 years on Friday since the signing of the Treaty on Good Neighborly Relations and Friendly Co-operation between Slovakia and Hungary, Slovakia's Foreign Ministry noted on the same day.

"The signing of the treaty in Paris on March 19, 1995 wasn't only a significant two-sided act, but without any doubts it also had a broad international effect in the context of the re-uniting Europe," said ministry spokesman Peter Stano.

The Slovak ministry views the treaty as the fundamental document for developing bilateral co-operation between Slovakia and Hungary.

"The treaty has been an expression of our countries' resolution to be part of the European Union built on the principles of freedom, democracy, justice, equality and guaranteeing human rights. The fifteen years of the existence of this treaty have proven it justified and viable. Similarly as at the time of the signing, it also shows today that Slovakia cares about constructive dialogue with all its neighbors and partners so that our relations will be a contribution rather than a burden for European politics," added Stano.

# Lajcak Visits Tserovani Internally Displaced Persons Camp in Georgia

Tbilisi, March 17 (TASR) - Slovak Foreign Affairs Minister Miroslav Lajcak in Georgia on Wednesday visited the Tserovani Internally Displaced Persons Camp, which is being funded from Slovakia's development aid program, ministry spokesman Peter Stano told TASR on the same day.

Slovakia funds courses of English and computer skills at the camp. "I wanted to check how effective our development aid is at first hand," said Lajcak, who was accompanied at the camp by Georgian Minister for Refugees Koba Subeliani.

"It's our moral duty to help people in need, and as development aid contributors we want to continue in this," said Lajcak, who was given an appraisement by his Georgian partners.

Lajcak noted that Slovakia helps people who lost their homes in the military conflict between Georgia and Russia in the summer of 2008. As early as in August 2008, Slovakia responded to the crisis in Georgia with humanitarian and material aid for local people worth more than €85.000.

Georgia is among the group of the priority countries within the 2009-13 Slovak Aid program.

# Lajcak Sets Forth Slovakia's Goals in Formation of EU's Diplomatic Corps

Brussels, March 22 (TASR) - When vying for posts within the EU's European External Action Service (EEAS), Slovakia will take a shot at positions where the country has a comparative edge vis-a-vis fellow EU member countries and thus stands a good chance of eventually occupying the posts, Slovak Foreign Affairs Minister Miroslav Lajcak said following a meeting of foreign affairs ministers of EU-member countries in Brussels on Monday.

Discussion devoted to the EU's new institution, which is being established following the entry into force of the Treaty of Lisbon on 1 December 2009, was led by the bloc's High Representative for Foreign Affairs and Security Policy Catherine Ashton. EEAS is projected to serve as a foreign ministry and diplomatic corps for the Union.

"The debate has moved on and is now being held at a political level. The member states insist that a geographical balance and equality in representation by member states, the Commission and the Council of Europe be maintained. I believe that this isn't being questioned by anybody. However, opinions vary on what kind of tasks EEAS should perform at the consular level," said Lajcak.

In Slovakia's bid to occupy particular positions, Lajcak said that "we have people who have linguistic skills to work in the former Yugoslavia or the former Soviet Union."

# President Content with Cabinet's Work Bar Handful of Minor Missteps

Bratislava, March 17 (TASR) - President Ivan Gasparovic on Wednesday expressed his satisfaction with the work of the Government, which, bar a few minor problems, has managed to stay true to its Manifesto, TASR learnt on the same day.

Speaking at a review of the Government's term in office (scheduled to end in June in preparation for a general election on the 12th) that was also attended by Prime Minister Robert Fico, Parliamentary Chairman Pavol Paska and Government members, Gasparovic touched on what he views as missteps.

"You've replaced many ministers; there's been trouble at some ministries. Citizens and the Opposition see this, and foreign countries are aware of it, too," he said. At the same time, however, he said that ministerial changes are commonplace in other countries, too.

In turn, Gasparovic praised cooperation between the country's top three constitutional officials – namely himself, the premier and the parliamentary chairman. "Our relations were at the base of resolving some problems. Continuity between the three constitutional officials is a precondition for a strong social government, and I believe that this will be the case in the future as well," he said, adding that there's still scope for further improvement.

"I have reservations regarding the Parliament and perhaps some ministries, as well as when it comes to the process of submitting legislative drafts. I want to seek solutions in this area in the future," added the president. He also predicted that he will look for the solutions alongside a government that will be led by Smer-SD party chairman Fico again, but pledged that his endeavors in seeking solutions won't be disrupted even if it's not Smer that will form the next Government.

Gasparovic also highlighted the way in which the Cabinet has tackled the economic crisis. "I'm sure that measures that the Government has taken in order to stop this massive global crisis from spreading were justified and yielded results," he added

# Unemployment Still Slightly Below 13 percent

Bratislava, March 18 (TASR) - Slovakia's unemployment rate rose slightly again in February 2010, going up by 0.08 percentage points month-on-month to reach 12.97 percent, the Labor, Social Affairs and the Family Center (UPSVaR) announced on Thursday.

According to Peter Zeman from the UPSVaR Director's Office, the situation on the Slovak labor market is beginning to stabilize. "What is positive as well is a drop in unemployment rates at the regional level, which has been recorded in as many as 27 districts," said Zeman.

The highest rate in February was observed in the district of Rimavska Sobota (Banska Bystrica region), where 33.93 percent were out of work. The lowest rate was recorded in Bratislava I District (2.78 percent).

Zeman also welcomed the fact that the number of people registering themselves as jobless at job centers is diminishing compared to the recent past. A total of 26,340 people joined the lists of the unemployed in February, down by 9,376 month-on-month and by 10,038 year-on-year.

Conversely, the number of those leaving the lists went up by 5,399 y-o-y.

# Kia to Begin Building New Engine-Producing Facility in April

Bratislava, March 18 (TASR) - Kia Motors Slovakia is slated to build a new plant for producing car engines near the company's existing engine plant in Teplicka nad Vahom (Zilina region), company spokesman Dusan Dvorak told TASR on Thursday.

The investment costs are expected to amount to over €100 million, with 270 new jobs created. The construction work on the new hall is to be launched on April, with serial production of new engines at the new facility to begin in late 2011.

"The annual capacity of the new facility will be 150,000 engines. They will be earmarked for exports to the Czech Republic, where the sister car-maker Hyundai will put them in the Kia Venga, the Hyundai i30 and in another projected car model," said Dvorak.

"I'm glad we've attracted the €100-million investment for Kia Motors Slovakia in the construction of a new engine-making plant, which will increase our annual output to 450,000 car engines," said Kia Motors Slovakia president and CEO In-Kyu Bae. "We thereby reaffirm our intention to develop Kia's activities in Slovakia on a long-term basis," he asserted.

Kia Motors Slovakia has produced a total of 540,000 cars since December 2006. The Kia cee'd model made up around 80 percent of the overall number, with the Kia Sportage accounting for the remaining 20 percent. The company kicked off serial production of the Hyundai ix35 in January 2010.

The company produced a total of 243,000 engines in 2009, an annual increase of 37 percent.

# Slovak Companies to Take Part in Gas Projects in Serbia

Bratislava, March 19 (TASR) - Slovak companies will take part in the construction of the Aleksandrovac–Novi Pazar regional gas pipeline and underground gas reservoirs in Serbia, according to an agreement signed on Friday by representatives of Serbian gas company SRBIJAGAS, Novi Sad and Slovak company NSG Technology, Gbely, which was brokered by the Slovak Investment and Trade Development Agency (SARIO).

The two projects will cost more than €300 million. The construction work on the 175-kilometre long gas pipeline should begin next year, with the volume of the investment expected to reach €46 million. The rest of the aforementioned total sum, €254 million, will be invested in the construction of gas reservoirs with a total capacity of 1 billion cubic meters. This project is a long-term one, however, and the companies involved don't know yet when construction will be launched.

Serbia was the most severely hit country during the gas crisis in early 2009, which was caused by a dispute between Russia and Ukraine and also affected Slovakia. "There's only one gas reservoir in Serbia, which, moreover, is under the majority ownership of (Russian gas giant) Gazprom. This is inadequate when it comes to energy security. These projects are therefore very important for our country," said Serbia's Mining and Energy Ministry State Secretary Dusan Mrakic.

Slovakia's Economy Ministry and Serbia's Mining and Energy Ministry in December signed a protocol on co-operation in the sphere of energy.



# Spomienková oslava slovenskej štátnosti v New Yorku

23. januára 1946 PKSJ v Amerike uverejnila text memoranda, ktoré bolo predložené generálnemu zhromaždeniu Organizácie spojených národov: "... aby Organizácia spojených národov priznala Slovákom právo na zriadenie samostatného slovenského štátu".

29. marca 1946 Pán Churchil vo svojom prejave vo Fultone nazval Československo: "... je vlastne koncentračným táborom, v ktorom trpia 3 milióny Slovákov, ktorých spojenci zapredali Benešovi. Jedinou záchranou slovenského národa, dnes mohol byť už len kontrolovaný plebiscit, v ktorom Slováci by mohli slobodne rozhodnúť, či chú žiť v spoločnom štáte s Čechmi, alebo chcú slobodu a samostatnosť v rámci európskej konfederácie".

31. júla 1946 Český národný súd vyniesol rozsudok nad členmi protektorálnej česko-moravskej vlády. Na doživotie odsúdil A. Hrubého, J. Kejči 25 rokov, J. Kamenický 5 rokov a R. Bienert 3 roky väzenia, J. Kalfus bol oslobodený. Toto uvádzam ako kontrast k rozsudkom nad zákonnou slovenskou vládou Slovenského štátu, kde sa mnohokrát siahlo na rozsudky trestov smrti

14. augusta 1946, ako prvý bol na smrť odsúdený bývalý predseda vlády SR profesor Vojtech Tuka a bol popravený obesením dňa 28. augusta 1946 /rozhodla o tom vláda ČSR ešte pred vynesením rozsudku !!!/ napriek tomu, že po štvornásobnej mozgovej porážke bol neschopný akéhokoľ vek pohybu a museli ho na vozíku priviesť pod šibenicu a priamo z vozíka popraviť.

V januári 1947 Beneš vyhlásil: "Samostatné Slovensko v budúcnosti v žiadnom prípade Češi nemôžu prijať. To je životný problém pre existenciu Čechov, ako národa".

V marci 1947 Slovenská liga v Amerike organizovala veľkú akciu na záchranu života a cti prezidenta Slovenského štátu. Vydala brožúrku v Angličtine: Pravda o Slovensku a jeho dejinách, najmä o Slovenskom štáte 1939 – 1945 a o osobe Dr. Jozefa Tisu, lebo podľa nej: "... žiaden Tisov čin neznamená zradu na slovenskom národe".

15. apríla 1947 Národný súd v Bratislave vyniesol rozsudok trestu smrti povrazom nad prvým prezidentom Slovenského štátu Dr. Jozefom Tisom. Do Prahy prišlo 315 žiadosti o milosť z toho 29 zo zahraničia. Veľvyslanec Veľkej Británie v Prahe Philipp Nichols bol prvý, ktorý intervenoval u ministra spravodlivosti P. Drtinu, aby sa zasadil o omilostenie Dr. J. Tisu. Drtina navrhol aby sa Slovenská národná rada vyjadrila k milosti, ale komunistickí ministri presadili , aby tento návrh bol zamietnutý, z 23 prítomných členov vlády bolo 17 za zamietnutie a iba 6 za milosť. Prezident Beneš mal ústavné právo konať nezávisle od vlády, ale on milosť Dr. J. Tisovi odmietol a tak bol prvý slovenský prezident na dvore Justičného paláca v Bratislave popravený obesením dňa 18. apríla 1947 a na druhý deň o 1:00 polícia dala pochovať telo Dr. Jozefa Tisu v jednom z troch vopred pripravených hrobov na Martinskom cintoríne.

Osud prezidenta Dr. Tisu bol spečatený takmer 4 roky predtým, keď Beneš žiadal v decembri 1943 ministra zahraničných vecí Molotova o pomoc ZSSR proti politikom Slovenského štátu. Molotov sa ho opýtal, že koho chce zlikvidovať a on odpovedal: "Tuka, Šaňo Mach, Tiso, též Gašpar, Medrický, Čatloš, ten také musí viset a jiní."

S obavou pred masovou reakciou slovenského národa, tento zločin českých centralistov Benešového tábora, ako i predákov komunistickej strany československa s ich slovenskými kolaborantami, všetké ozbrojené sily boli v najvyžšej pohotovosti. Na Morave boli koncentrované celé divízie a na železničných staniciach Slovenska boli pripravené súpravy vlakov pre prípadné deportovanie vzbúrencov.

Švajčiarský časopis Vaterland v úvodnom článku takto komentoval Tisovu popravu: "Prvý a hlavný v uvodzovkách zločin Tisov bol, že nechcel padnúť do záhuby s celým českým národom, ale chcel zachrániť Slovensko v terajších politických okolnostiach. Tisova hrdinská smrť je ako záloha pre budúcu Slovenskú republiku".

Keď prišla správa o poprave Dr. Tisu do Ameriky, značná časť amerických novín a aj niektorí politici verejne odsudzovali postup Československej vlády. Poslanec Alvin Ó Konski v americkom parlamente prehlásil: "... najväčšou tragédiou je mlčanie nášho amerického prezidenta a nášho amerického štátneho departmentu vo chvíli, keď sa vraždilo ... to čo Washington spravil pre Ameriku, to Tiso spravil pre Slovákov". Rakúsky týždenník Die Furche komentoval Tisovu popravu: "V týchto dňoch dokončili na dvore bratislavskej väznice jednu zo smutných tragédií, ktoré tak často postihujú bojovníkov za slobodu".

Od 14. septembra 1947 sa započalo "odhalovanie" protištátnych sprisahaní proti republike s obvinením, že chceli obnoviť Slovenský štát a začali sa vynášať tresty smrti, doživotné a vysoké tresty odňatia slobody – za túžbu Slovákov po sebaurčení svojho národa a svojej štátnosti.

Vo Viedni založili niekoľkí členovia Slovenskej tajnej ochrany, hnutie nenásilnej spoločenskej ochrany proti bolševizmu a proti šíriacemu sa strachu z teroru a obnovenie slovenskej štátnosti tzv. Biele légie, kde niektorí členovia boli koncom decembra 1948 zatknutí a súdení

v Bratislave kde odsúdili A. Púčika, A. Tunegu, E. Tesára na doživotné väzenie a 48 ich bolo odsúdených od 6 mesiacov do 30 rokov. JUDr. Rašla sa odvolal proti ich trestom. Najvýšším súdom v Prahe boli zvýšené tresty: Albert Púčik, Anton Tunega a Eduard Tesár na trest smrti. " Ľudovít Galik na doživotné väzenie a pre zvyšok tresty odňatia slobody v súhrne 442 rokov a 6 mesiacov. Takmer všetci skončili v jachymovských baniach.

Ďalších zatkli a odsúdili, v Bratislave 22. mája 1949. Augustin Lednický bol ako vedúci skupiny odsúdený na trest smrti a popravený, dvaja 21 roční Milan M. Biščo a Štefan Erlach na doživotné väzenie, Anton Petrek 25 rokov väzenia a Ján Ganišin 15 rokov väzenia. Po obnovenom súde 6. septembra 1990 boli všetky rozsudky zrušené – všetkých uznali za nevinných, čo však nevrátilo naspäť životy, a utrpenie pri mučeniach a väznení.

4. marca 1951 americký denník New York Times písal: Slovensko nikdy nebolo príliš šťastné v spojení s Čechmi a Moravou v umelom štáte Československo. Vláda Masaryka a Beneša odsúdila Dr. Vojtecha Tuku v roku 1922 na 15 rokov pre separatizmus. Benešová a Gottwaldová vláda pre tú istú príčinu v 1947 monsiňora Tisu a za to isté teraz idú súdiť Clementisa. (osúdený na trest smrti).

2. októbra 1952 v Košiciach boli odsúdení ďalší príslušníci Bielej legie na trest smrti: Ján Rešetka, Michal Mihok, Bohumil Grúber a Dr. Bodnár. Stanislav Hadač na doživotné väzenie, Ján Minárik na 25 rokov, Jozef Ležák na 18 rokov a M. Matej na 15 rokov väzenia.

Koncom roku 1948 Komisia Spojených národov pre vyšetrovanie vojnových zločinov uzavrela publikovanie mien osôb, ktoré boli menované ako vojnoví zločinci, kde sa nenachádza ani jedno meno občana Slovenského štátu!!!

14. marca všetky slovenské organizácie v Amerike vydali ohlas na 25. výročie vyhlásenia Slovenského štátu.

Slovenská liga vyhlásila: 14. marec zostáva mimoriadne dôležitou zastávkou v slovenských dejinách... po dlhých storočiach poroby slovenský národ znovu bol pánom svojich osudov, ale i preto, že od 14. marca 1939 niet tej sily, ktorá by vedela vymazať z duše povedomých Slovákov túžbu po samostatnosti a po vlastnom demokraticky spravovanom štáte.

Prvá katolícka Jednota: "Každý národ je hrdý na svoju minulosť. Každý národ má právo na svoj samostatný štát. Každý národ má svojich mučeníkov. Aj Slováci majú byť pyšní na svoje zápasy v minulosti, nevynímajúc amerických Slovákov. A nik nevymaže z mapy Európy Slovensko, ktoré sa hlási o svoj samostatný štát a iste ho raz zase bude mať".

20. februára 1982 vláda ČSSR splatila dlhy, ktoré spôsobil Beneš na financovani svojej zahraničnej činnosti od 1938 do 1945 v prepočítanej slovenskej mene po 1.1.1993 v hodnote 6. miliard SK, načo vláda USA vrátila časť českého a slovenského pokladu – 18.4 tony zlata v hodnote 247 miliónov US dolárov. Zlato si privlastnila Praha.

V 1990 prezident v šľapajach Masaryka a Beneša v slovenskej otázke (kde bolo Slovensko dobré len na hospodárske vykorisťovanie) presadil takzvanú "konverziu" zbrojárskeho priemyslu na SLOVENSKU, ale nie v ČECHÁCH. Výroba poklesla z 13.3 miliard Kčs na 1.8 miliard Kčs t.j. o 90.6%. Desať tisíce pracovníkov na Slovensku stratilo zamestnanie. Naviac Havel dal odmontovať špeciálne stroje na výrobu tankov a diel, ktoré premiestnil do Čiech, kde chcel vyrábať tieto zbrane v tajnej dohode s iným štátom, ktorý po prezradení od toho odstúpil.

Z uvedeného stručného prehľadu je zrejme, že Slováci nedosiahli slobodnú a demokratickú Slovenskú republiku 1.1.1993 len rokovaním medzi Klausom a Mečiarom. To bolo už len zavrcholenie dlhého boja Slovákov za sebaurčenie, ktoré trvalo niekoľko storočí a mnohí pre to obetovali svoje životy. Na to by sme nemali zabúdať!!!

Česť a sláva tým čo zasvätili a obetovali svoje životy a slobodu pri boji na ceste k sebeurčeniu slovenského národa a slovenskej štátnosti!

V ďalšom programe odzneli básne: "Slávnostne" od Ľuda Bešeňovského a : "Reč krásna, svätá" od Štefana Dubiela. Recitovala Henrieta H. Daitová. Program spestril slovenský spevák Rado Lesay s prekrásnou slovenskou piesňou: "Keby som bol vtáčkom, letel by som za les pozrieť sa čo robí mamička moja dnes ..."

Na záver tajomníčka Slovenskej ligy v Amerike Nina Holá vyhodnotila podujatie na ktorej bola účasť Slovákov z New Yorku, New Jersey, Connecticut a Pennsylvánie.

Na začiatku boli oficiáln štátne hymny USA a Slovenskej republiky a na záver: "God Bless America" a "Hej Slováci" ktoré zaspieval Rado Lesay za doprovodu Jozefa Jurášiho.

Nakoniec chcem v mene všetkých poriadajúcich a prítomných účastníkov Osláv poďakovať všetkým účastníkom, slávnostnému rečníkovi Milanovi R. Daitovi, Nine Holej za vyhodnotenie podujatia, pánu farárovi Rev. Martinovi Svitanovi, Štefanovi Chanasovi ako i za pomoc pri poriadaní podujatia manželom Bilikovým, Marienke Božekovej, našim spevákom Radovi Lesayovi a Jozefovi Jurášimu ako aj Jankovi Škrkoňovi, ktorý pripravil dobré jedlá, ktoré boli podávané pri oslave.

# Slovensko stojí na križovatke ako chrániť svoje kultúrne dedičstvo

Najsilnejšia opozičná strana SDKÚ-DS je proti vývozu slovenského kultúrneho písomného dedičstva do Nemecka s cieľom jeho ošetrenia tak, ako to plánuje ministerstvo kultúry (MK). Na tlačovej konferencii to v marci uviedol predseda poslaneckého klubu SDKÚ-DS Stanislav Janiš.

Slovensko podľa jeho slov stojí na križovatke ako chrániť kultúrne dedičstvo, ktoré je dnes v archívoch či knižniciach. "Ide o milióny kníh a archívnych materiálov. Sú dve cesty, ako Slovensko naloží so svojím písomným dedičstvom," tvrdí opozičný poslanec. Prvou je riešenie MK, ktoré ho chce naložiť na kamióny, odviesť do Nemecka a tam ho ošetriť za desiatky miliónov eur a na tieto služby použiť eurofondy.

Druhá cesta, ktorú preferuje SDKÚ-DS, je postaviť na Slovensku funkčnú technológiu a zriadiť komplexnú fabriku na konzervovanie písomného dedičstva a následne ho digitalizovať. "Teda eurofondy nepoužívať v Nemecku a tvoriť tam pracovné miesta, ale využiť ich na Slovensku," povedal. Strana preto preferuje vybudovanie Integrovaného konzervačného centra (IKC) vo Vrútkach. "Chceme centrum, ktoré sme schopní postaviť z peňazí z Operačného programu Informatizácia spoločnosti do dvoch rokov. Kultúrne dedičstvo predsa bude potrebné chrániť aj po tom, ako sa minú eurofondy," vysvetlil Janiš. Navyše vybudovanie IKC má priniesť 80 nových pracovných miest a ďalšie desiatky majú vzniknúť po celom Slovensku v rámci obslužných činností.

Lokalitu Vrútok Janiš odôvodnil tým, že Slovenská národná knižnica dostala v minulom volebnom období po armáde zadarmo priestory v tomto meste. V nich s pomocou nórskych fondov vybudovala časť digitalizačného centra, ktoré už v súčasnosti funguje. "Je to v centre Slovenska aj národného kultúrneho dedičstva. Kompletne vypracovaný projekt IKC dostal aj minister, uprednostnil však obrovský tender a vývoz kníh za hranice SR. Chráňme si svoje dedičstvo doma, veď toto je vlastenectvo v praxi," dodal.

# Krátke správy zo Slovenska


- Slovenská ekonomika v tomto roku podľa Národnej banky Slovenska (NBS) vzrastie o 3.2 %. Vyplýva to z aktuálnej strednodobej predikcie centrálnej banky, ktorú predstavil jej guvernér Jozef Makúch. Ešte v decembri NBS očakávala, že po výraznom vlaňajšom prepade hospodárstva o takmer 5 % produkcia SR v tomto roku vzrastie o 3.1 %. Centrálna banka je tak naďalej optimistickejšia ako ministerstvo financií ktoré predpovedá tohtoročné oživenie na úrovni 2.8 %. Výkon slovenského hospodárstva vlani výrazne ovplyvnil prepad zahraničného dopytu pod vplyvom globálnej hospodárskej krízy. Súvisiace výpadky príjmov štátu sa podpísali aj pod prehĺbenie deficit verejných financií ktorý medziročne vzrástol trojnásobne na 6.3 % hrubého domáceho produktu (HDP). Pre tento rok sa vláda zaviazala znížiť schodok na 5.5 % a do roku 2012 ho chce dostať opäť pod hranicu 3 % povolenú európskymi rozpočtovými pravidlami.
- Kde a ako budeme bývať je názov programu, ktorý podporuje spoločnosť U. S. Steel Košice celkovou sumou 6,700 eur. V rámci tohto programu koncom marca viceprezident spoločnosti Miroslav Kiraľvarga odovzdal diplomy siedmim vybraným školským environmentálnym projektom. Dlhodobým cieľom grantového programu Kde a ako budeme bývať je zvyšovať povedomie žiakov základných škôl v oblasti starostlivosti o životné prostredie a rozdeľovať finančn prostriedky školám Košického samosprávneho kraja (KSK) na projekty, ktoré podporia deti a mládež v aktívnej činnosti v prospech životného prostredia v mieste, kde žijú. Program je určený pre základné školy Košického kraja a v tomto 7. ročníku sa o podporu uchádzalo 17 základných
- Tradičné Veľkonočné trhy sa konali aj toho roku na Hlavnom námestí v Bratislave. Predajcovia v 20 stánkoch ponúkali široký sortiment výrobkov a suvenírov súvisiacich s oslavou veľkonočných sviatkov a symbolov jari. Boli tam remeselníci a ľudoví umelci z rôznych regiónov Slovenska a po prvý raz aj predaj kraslíc spojený s ukážkou ich zdobenia. Návštevníkom boli k dispozícii veľkonočné vajíčka zdobené rôznou technikou, veľkonočné ozdoby a dekorácie z prútia, šúpolia, keramiky, skla, dreva, korbáče, rapkáče, píšťalky. Nechýbali figúrk z keramiky, textilu, dreva, slovenská ľudová majolika, vyšívané a tkané obrusy, paličkované a račianske vystrihované dečky, medovníky, zdobené perníky, sladké oblátky plnené karamelom v tvare vajíčok, zajačikov, sviečky z včelieho vosku s motívmi Veľkej noci, darčekové balenia sviečok, medu i medoviny.
- Až 98.7 % z vlaňajšej produkcie spoločnosti Volkswagen Slovakia smerovalo na export. Hodnota vývozu predstavovala 2.93 miliardy eur. Najväčším exportným trhom sú krajiny Európskej únie (EÚ), pričom len Nemecko sa na objednávkach vozidiel podieľalo 39.5 %. Nasledujú Čína s podielom 13.2 %, USA 6.4 % a Rusko s 5.4-% podielom. Podľa slov predsedu predstavenstva a. s. Volkswagen Slovakia (VW SK) Andreasa Tostmanna na výročnej tlačovej konferencii práve čínsky trh je veľmi perspektívny. Medziročný nárast vývozu do tejto krajiny dosiahol 7.3 %. Výrobné portfólio VW SK v súčasnosti tvoria vozidlá Volkswagen Touareg, Audi Q7 a Octavia. V súvislosti s prípravou na produkciu vozidiel radu New Small Family sa výroba Octavií v bratislavskom závode v máji skončí. Ešte v tomto roku sa začne v Bratislave vyrábať novinka Volkswagen Touareg Hybrid, vyznačujúca sa úspornosťou a ďalšími technologickými vylepšeniami
- Vojenský kaplán Ordinariátu Ozbrojených síl (OS) a Ozbrojených zborov (OZ) SR kpt. Jozef Paluba pôsobiaci pri slovenskom kontingente vojenskej mierovej misie UNFICYP na Cypre pripravil vo vojenskom tábore vo Famaguste pôsobivé slávenie Kvetnej nedele. Do vojenskej kaplnky sv. Cyrila a Metoda vstupovali so skutočnými palmovými ratolesťami nielen slovenskí vojaci, ale aj africkí študenti väčšinou z Nigérie študujúci na medzinárodnej univerzite vo Famaguste, informoval o tom kancelár a hovorca Ordinariátu OS a OZ SR Tibor Ujlacký. Súčasťou anglicko-slovenskej omše boli aj černošské spirituály a temperamentný liturgický tanec. Slovenskí vojaci spolu s africkými študentmi tak zaujímavo oslávili Deň mládeže (28. marca) a zároveň dôstojne vstúpili do Veľkého týždňa. Popri duchovnej službe našim vojakom sa slovenskí vojenskí kapláni už niekoľko rokov venujú aj africkým študentom. Na univerzite v moslimskej časti Cypru tvorí 80 študentov z Afriky malú skupinu, nemajú tam žiadnu možnosť katolíckych sv. omší, takže sú veľmi vďační za tie naše a umožňujú tak slovenským vojenským kaplánom pôsobiť ako skutoční misionári. Účasť afrických kresťanov na omšiach vojenského kaplána Palubu vo Famaguste je nielen duchovným a liturgickým zážitkom ich spontánnej radosti z oslavy Boha, ale aj príkladom života viery pre našich vojakov takisto odlúčených od vlastného prostredia, uviedol Ujlacký.
- Gréckokatolícka farnosť v obci Nacina Ves a Spolok svätého Cyrila a Metoda z Michaloviec sa od roku2009 podieľajú na projekte, ktorého hlavným cieľom je sprístupniť širokej verejnosti historické nástenné maľby z prvej polovice 15. storočia, ktoré boli v roku 2004 znovuobjavené počas rekonštrukcie strechy gréckokatolíckeho chrámu v obci Lesné, okres Michalovce. Ich spoločné úsilie bolo podporené prostriedkami nadácie a Košickým samosprávnym krajom spolu v hodnote viac ako 12,000 eur. Vzácne maľby podrobili výskumu ešte v 80. rokoch minulého storočia. Potvrdilo sa, že pochádzajú z 15. storočia, no na dlhý čas sa im nevenovala väčšia pozornosť. Opätovne sa o fresky začali zaujímať pamiatkari v roku 2004, kedy boli podrobené reštaurovaniu a nadobudnuté poznatky o ich histórii boli zároveň poopravené a spresnené. Základný a neukončený výskum z čias komunizmu sa tak dočkal svojho pokračovania. Pri románskom chráme v Lesnom sa pred niekoľkými desaťročiami našli aj základy stredovekej sakristie a ostiária kostnice.
- Na železničnej stanici v Spišskej Novej Vsi sa 1. apríla predpoludním zrazili dva vlaky. Informovali o tom z dispečingu Hasičského a záchranného zboru (HaZZ) v Spišskej Novej Vsi. Podľa aktuálnych informácií dispečera HaZZ si tragédia vyžiadali minimálne tri ľudské životy. Vo vagóne bolo desať ľudí zranených, z toho jeden ťažko. K nehode došlo krátko po 11.30 h, kedy do stojaceho osobného vlaku narazil zozadu elektrický rušeň Železničnej spoločnosti CARGO Slovakia. Pri náraze sa jednou osou vykoľajil jeden vagón osobného vlaku. Prebiehajú záchranné práce a príčiny nešťastia za vyšetrujú. Informovala o tom hovorkyňa Železníc SR Martina Pavlíková.
- **Pedagógom** Trnavskej univerzity "udreli" do očí podozrivo vyspelé myšlienky v seminárnych prácach študentov. Po skopírovaní textu a preverení cez internetový vyhľadávač zistili, že ide o podvod. Potvrdilo sa, že z internetu kopírovali do svojich prác celé pasáže bez uvedenia zdroja. Šesť študentov univerzity v Trnave skončilo pred disciplinárnym senátom a všetci sa ku kopírovaniu priznali. Študentov univerzita potrestala podmienečným vylúčením ak by to zopakovali, budú musieť školu opustiť. Ministerstvo školstva SR spustí centrálny register záverečných prác tento rok. Niektoré univerzity už uviedli do činnosti "vlastný" antiplagiátorský softvér.

Pod týmto názvom je ukryté ďalšie bohatstvo talentu hry Stanislava Štepku a zároveň hlavného predstaviteľa v úlohe Jozefa Murgaša, ktorú uvádza Radošinské naivné divadlo v Bratislave.

Pred návštevou divadelného predstavenia sme vyhľadali pána Štepku, aby som mu predstavila manžela, ktorý pochádza z Wilkes-Barre. Pochválila som sa, že manžela pokrstil Rev. Jozef Murgaš ako aj sa zúčastnil spolu s rodičmi a starším bratom na jeho pohrebe. Zároveň sme mu ukázali originál listu Rev. Jozefa Murgaša s jeho vlastnoručným podpisom, adresovaný manželovmu otcovi, Štefanovi Birošovi. Stanislav Štepka si so záujmom pozrel i niekoľko fotografi kostola, ktorý postavil Rev. Jozef Murgaš so svojími farníkmi, školu a cintorín, kde je aj Jozef Murgaš pochovaný.

Počas rozhovoru sme mu predstavili činnosť Spolku slovenského dedičstva vo Wilkes-Barre, ktorého sme aj my členmi. Hlavnou úlohou Spolku je šíriť bohatstvo talentu nášho slávneho rodáka z Tajova, Jozefa Murgaša. V Bratislave pripomína túto významnú osobnosť pamätná tabuľa na budove hlavnej pošty, o ktorú sa zaslúžili svojou zbierkou naši Slováci z USA.

Pán Štepka nás pred predstavením upozornil, že hra nie je životopisom Jozefa Murgaša. Touto hrou chcel docieliť, aby si slovenská verejnosť, aj formou muzikálu uvedomila, akou veľkou osobnosťou bol Jozef Murgaš, ktorého význam na Slovensku nie je dodnes docenený. Bolo veľmi vtipné, keď pán Štepka vyzval manžela, aby ako rodák z Wilkes-Barre vyslovil názov mesta, lebo jemu, hlavnému predstaviteľovi hry, to robilo problémy.

Samotná hra je úžasná so všetkým, čo k tomu patrí. A pretože Wilkes-Barre mi je veľmi blízke, najmä kostol Božského Srdca Ježišovho, kde sme boli aj sobášení Mons. Františkom Beedom, predstavovala som si počas sledovania hry slávnu faru pri kostole, kde sa rodili myšlienky nášho génia. Viaceré z nich, spolu 12, boli patentované. Najvýznamnejší Murgašov vynález bol v oblasti bezdrôtovej telegrafie kde získal prvenstvo pred Talianom Marconim. Áno, v tejto časti hry mi priam naskakovali zimomriavky, lebo som si uvedomovala, aký neľahký život mal náš slovenský rodák v boji s mafiou a Marconim v USA. Smutné je i to akého sklamania sa dočkal r. 1921, pri návrate do Česko-Slovenska, keď mu zamietli jeho žiadosť o miesto stredoškolského profesora, lebo vraj na to nemá vzdelanie.

Ani sa nečudujem, že práve tejto hre Stanislava Štepku *Niekto to rád slovenské*, udelil Literárny fond *Cenu za pôvodnú literárnu tvorbu za rok 2008* a Radošinské naivné divadlo dostalo ocenenie za uvedenie tejto inscenácie. Radošinské naivné divadlo je vlastne v tomto smere "národným divadlom", lebo celá jeho tvorba je pôvodná, reflektujúc život slovenskej dediny i mesta, určená pre najširšie vrstvy divákov. Predstavenie, ktoré sme videli umocnilo v nás presvedčenie, že autor hry si naozaj zaslúži porovnanie so slávnym francúzskym dramatikom Moliérom.

Vďaka vám, Majstre Stanislav Štepka, za tú poklonu pred obrazom Rev. Jozefa Murgaša v závere hry, za všetkých nás Slovákov.

A ešte môj sen, ktorého by som sa rada dožila. Bola by som šťastná, keby sa pri príležitosti 150. výročia narodenia Jozefa Murgaša r. 2014 odohralo toto predstavenie v Tajove. V tom roku sa ukončí digitalizácia všetkých materiálov súvisiacich s osobou Jozefa Murgaša, na ktorej spolupracuje Spolok slovenského dedičstva vo Wilkes-Barre s obcou Tajov. Dúfame, že v Tajove bude mať kde Radošinské naivné divadlo vystúpiť a Tajovčania tak nadviažu na úspešný telemost, ktorý pripravili pri príležitosti 80. výročia úmrtia svojho slávneho rodáka.

# Spomienková oslava slovenskej štátnosti v New Yorku

I. Zbor Slovenskej ligy v New Yorku usporiadal v nedeľu dňa 14. marca o 1:00 hodine odpoludnia v spoločenskej hale Slovenského kostola sv. Jána Nepomuckého na 411 East, 66<sup>th</sup> Street v New York City Spomienkovú oslavu slovenskej štátnosti, za spolupráce Slovenskej ligy v Amerike, Spolku sv. Štefana a Spolku sv. Matúša Prvej Katolíckej Slovenskej Jednoty, Slovenského katolíckeho Sokola a ostatných fraternalistických slovenských spolkov.

Oslava bola zahájená slovenskou svätou omšou za prvého prezidenta Slovenského štátu Msgr. Dr. Jozefa Tisu. Slávnostným rečníkom na tejto spomienkovej oslave bol predseda I. Zboru Slovenskej ligy v NYC Milan R. Dait, ktorý svoj obsiahly referát zameral výlučne na boj za práva na sebaurčenie slovenského národa po II. svetovej vojne, až do vyhásenia Slovenskej republiky 1. 1.1993. Uviedol zujímavé skutočnosti, ktoré mnohým sú takmer neznáme:

5. apríla 1945 v Košiciach na zasadaní Národnej rady vyhlásili Program prvej vlády Národného frontu Čechov a Slovákov, ktorý

ratifikova úplné podriadenie Sovietskému zväzu (ZSSR) ako na poli vojenskom, tak i medzinárodne politickom. Pôvodne povojnová Česko-Slovenská republika mala byť federatívnou republikou dvoch samostatných národov – Čechov a Slovákov, ale na zasadaní komunistov 30. mája sa slovenskí komunisti vzdávajú boja za toto usporiadanie, čo malo za následok úplné podriadenie sa Čechám. Toto bol začiatok plnenia Benešového politického programu a jeho strany (Memoranda o Slovensku) na úplné asimilovanie Slovákov. Ich program? "... politika musí smerovať k tomu, aby Slovenský národ bol po všetkých stránkach oslabený tak, že nebude môcť pomýšľať na vytvorenie samostatného štátu".

Spolu so sovietskou armádou, prišla i NKVD a podľa ich zverejnených archívov bolo zo Slovenska od jesene 1944 do jari 1945 deportovaných takmer 70,000 Slovákov do sovietskych trestných táborov, z ktorých asi tretina zahynula, lebo nevydržala útrapy vyšetrovania a neľudské transporty do trestných táborov na Sibíri. Ďalším odmietla pražská vláda návrat z trestných táborov ZSSR, pričom slovenské povereníctvo bolo vylúčené z rozhodovania o tejto selekcii.

Armáda Svobodu, povolala a mobilizovala slovenských vojakov a dôstojníkov a potom ich vydala do rúk NKVD a táto ich deportovala do sovietskych trestaneckých táborov. Toto bolo prevádzané na základe toho, že slovenskí vojaci a príslušníci domobrany boli považovaní za nepriateľské vojsko, na rozdiel od vojska Protektorátu Čechy a Morava!!!

V apríli 1945 Slovenská liga v Amerike predložila kongresu Spojených národov a organizácii svetovej bezpečnosti dokument v ktorom žiadala: "... aby slovenskému národu bolo dovolené rozhodnúť o svojom osude slobodnými voľbami pod dozorom výboru Spojených národov ..."

Pod vedením a vzorom NKVD, boli na Slovensku zriadené takzvané zaisťovacie tábory napr. v Novákoch od jari do 16. novembra 1945 zomrelo 188 osôb z toho 113 detí mladších ako 7 rokov.

Podľa dokumentu Hlavného veliteľstva VB – 6 oddelenie utvorilo na Slovensku 49 táborov, sústreďovací v Petržalke, pracovné Patronka, Nemšová, Sv. Jur, Podbánske, Nové Zámky a ďalších 43 zaisťovacích táborov na Slovensku, kde bolo väznených 22,515, z toho 9,872 mužov, 8,014 žien a 4,629 detí.

4. októbra 1945 americké ministerstvo zahraničia odmietlo výhrady britskej vlády proti vydaniu slovenských politických osobností Československu, čo sa stalo 27. októbra 1945 a o 2 dni v putách doviezli z Prahy prezidenta Slovenského štátu Dr. Jozefa Tisu a uväznili ho v Bratislave.

28. augusta 1945 Prvá katolícka slovenská jednota (PKSJ) adresovala prezidentovi a kongresu USA rozsiahle memorandum o práve Slovákov na samostatnosť.
