### Who can apply?

Applicants of Slovak heritage are eligible to apply as high school seniors, or during any year of **full-time enrollment** in an accredited College/University. Applicants can apply each year in college (up to 4 years).

Applicants must complete and sign an official Scholarship application obtained from a branch officer, the Home Office or www.fcsu.com and mail it to: Stephen C. Matula Scholarship, FCSU, 6611 Rockside Rd, #300, Independence, OH 44131. Applicants must provide a high-resolution headshot photo and also email it to scholarship@fcsu.com.

Winners will be chosen by the Scholarship Committee and checks will be payable to the winner's educational institution after submitting proof of college enrollment.

Winners must provide a report on their progress in college, including transcript and a summary of use of the funds by the end of the school year.
